M {Theory on the Stiefelm anifold and 3d Conform al Field Theories

A bstract

We compute the mass and multiplet spectrum of M {theory compactied on the product of AdS_4 spacetime by the Stiefelm anifold $V_{(5,2)} = SO(5)=SO(3)$, and we use this information to deduce via the AdS/CFT map the primary operator content of the boundary N = 2 conformal eld theory. We make an attempt for a candidate supersymmetric gauge theory that, at strong coupling, should be related to parallel M 2{branes on the singular point of the non{compact Calabi{Yau four{fold} $P_{a=1}^{P} z_a^2 = 0$, describing the cone on $V_{(5,2)}$.

1 Introduction

Duality between large N eld theories on D3{branes placed at conical singularities and Type IIB theory compacti cations on a 5d manifold have been the subject of many investigations in the last couple of years [1]-[3] (for a rewiew see [4]). In particular, in [5] an N = 1 superconform al Yang {M ills eld theory has been constructed which turned out to be dual to Type IIB theory compacti ed on the T¹¹ = SU (2)²=U (1) manifold. Solid evidence on such duality was developed in [6, 7, 8] and in [9], where a one{to{one correspondence was established between the Kaluza {K lein (KK) supergravity spectrum on T¹¹ [10] and the boundary superconform al operators. In the case of M 2 and M 5 branes the AdS=C F T conjecture was rst studied for maxim al supersymmetry in compacti cations on spheres S⁷ and S⁴ [11,12,13] and then further extended to lower N for sphere-orbifolds and other brane system s [14,15].

In [16] the question was raised whether one could similarly construct a SuperConform al Field Theory (SCFT) in three dimensions which is dual for large brane- ux N to M { theory compactified on AdS_4 M₇ [16, 17, 18], where M₇ is one among the compact E instein manifolds that were classified [19] and analysed in the eighties [20, 21]. Such three{dimensional SCFT's would then be defined as the conformal limit of the world{ volume theory of N M 2{branes positioned at a conical singularity of M₃ Y₈, where Y₈ is the cone over M₇.

Three-dimensional SCFT's are more di cult to analyze because they emerge in nonperturbative limit of conventional gauge quantum eld theories. The origin of this di – culty is well known, and can be traced back to the fact that the three dimensional bare gauge coupling constant is dimensionful, so that a conform all description of the theory dual to supergravity is only possible in the infrared limit, where the gauge coupling blows up and the gauge elds are integrated out.

In this regime, the SCFT is described as the low energy theory of N coincident M 2{ branes, where N is the number of units of ux of the dual of the eleven {dimensional four{ form on the internal manifold M₇. Indeed, compactications of M {theory on a circle leads to a D2{brane description in type IIA theory whose world{volume gauge theory is not conformal and whose near horizon geometry generically is not AdS [15, 22, 4]. The superconformal description is recovered in the strong coupling limit of type IIA decompactication, when $g_{eff}^2 >> N^{1=2}$, $u << g_{YM}^2$, where $g_{eff}^2 = g_s N = u$ [4] and u is the energy scale. When the radius of the circle goes to in nity, the gauge coupling also blows up and we reach the M2{brane description in the infrared of the three{dimensional gauge theory. Its relevant degrees of freedom are given in terms of the d= 3 chiral multiplets and are related to the KK excitations of d = 11 supergravity. Vice{versa, if g_{eff}^2 ! 0 and u ! 1, we are describing the ultraviolet limit of the d= 3 Yang{M ills theory (for a thorough discussion of the above considerations see [15, 22, 4]).

It is also in portant to observe that, although the d = 3 ultraviolet gauge theory has

both a Coulom b and a Higgs branch, in the $AdS_4=C F T_3$ correspondence one is mainly interested in the Higgs branch, parametrized by the vev's of the scalars of the chiral multiplets. The Coulom b branch scalars, belonging to the vector multiplets, are excluded since their vev's can be safely put to zero.

In [23] by a thorough study of the KK excitations and $O Sp(4\frac{1}{2})$ multiplets [24] on the M¹¹¹ = SU(3) SU(2) U(1)=SU(2) U(1) U(1) [25] and Q¹¹¹ = SU(2)³=U(1)² [26] m anifolds, the relevant N = 2 SCFT's have been constructed on the basis of the mass spectrum, and conjectured to be dual to M -theory com pactications.

In the above construction, it was important that both M¹¹¹ and Q¹¹¹ adm it a description in terms of toric geometry [27]. This allowed to identify the fundamental degrees of freedom of the underlying SCFT and thus to nd the abelian gauge theories, whose moduli space of vacua (the Higgs branch component) is isomorphic to the conifolds over the two seven {manifolds.

This paper analyses the case of M {theory compactified on the real Stiefelm anifold $V_{(5,2)}$ SO (5)=SO (3) with SO (3) canonically embedded in SO (5). The relevant four-fold cone whose base is $V_{(5,2)}$ was identified in [5].

The Stiefelm anifold is peculiar among the Einstein spaces leading to N = 2 supersymmetry in that it does not adm it a toric description [27]. Nevertheless, we shall see that it is possible to build up the single brane (N = 1) theory and to conjecture its N > 1extension by perform ing the follow ing steps.

We rstanalyse the full KK mass spectrum and O Sp(2j4) supermultiplets for the $V_{(5;2)}$ manifold: this is in complete analogy with the procedure in [9] for T¹¹ and in [23, 25] for som e M -theory examples. A relevant point of our analysis with respect to [23] is the absence of Bettimultiplets since there are no non {trivial Betti num bers on $V_{(5;2)}$

Thus, there is no continuous baryonic symmetry [28, 29, 18, 9, 10] in the corresponding SCFT.

The second step is to construct adm issible superconform all boundary operators to be put in dual correspondence with those KK supermultiplets undergoing shortening when the required unitarity bounds on the OSp(4;2) representations are saturated. To arrive to a well founded conjecture for the SCFT operators, we are guided by the consideration of the classical equation describing the eight dimensional cone Y₈ over V_(5;2). It turns out that the solution of the cone equation [5]

where A^{i} , B^{i} are in the 4 of Sp(4) SO(5) and $_{ij}^{a}$ are the gam m a matrices in ve dimensions. The vanishing of a SU(2) D {term xes the residual SL(2;C) invariance of equations (1.3) and (1.4). The above solution (1.6) is obtained by a procedure quite analogous to that employed in [5] to solve the cone equation on T¹¹ in term softwo objects A^{i} , B^{i} belonging to the representation (1=2;0) (0;1=2) of SU(2) SU(2). There, the analogous of SL(2;C) invariance was given by equation (13) of [5], namely invariance under complex rescalings.

This discussion gives us a little but useful information on the gauge group G of the theory in the ultraviolet regime. More precisely, since the equation for the vanishing of the D {term s is SU (2) valued, the gauge group should reduce to SU (2) for a single M 2{brane at the conical singularity. Then, in virtue of the fact that the conifold coordinate z^a does indeed appear in the KK spectrum and is a gauge singlet, we arrive at the conclusion that for N > 1 the basic singleton S_i, transform ing in the 4 of SO (5), must be in a pseudoreal representation of G labeled by the index . A lbeit this requirements could be satisfied by several groups, we are led to conjecture the simple choice G = USp(2N) O (2N 1), where the index of S_i belongs to the bifundamental representation⁴ of G.

Once we have some solid base for the choice of the basic degrees of freedom in the dual three{dimensional N = 2 SCFT, we can perform the last step and show that it is possible to construct a complete set of conform alprim any operators matching all the KK multiplets previously obtained.

In establishing such correspondence we follow the procedure already employed in [9] for the T^{11} case. In particular we nd that, as for T^{11} , there are long multiplets with rational protected dimensions⁵.

It is interesting to note that since in the infrared limit the gauge eld is integrated out, one may expect that it should be related in the SCFT to some composite eld in terms of the singleton S_i . In fact we not in the gravitino sector a composite eld X obeying D X = 0 whose component has the right quantum numbers of a gauge eld, being a singlet of the avour group SO (5) and having R {symmetry y = 0.

In the rest of the paper, section 2 brie y deals with the harm onic analysis on the Stiefel manifold while section 3 contains the results on the full mass spectrum and its assembling into $0 \text{ Sp}(4\frac{1}{2})$ supermultiplets, with particular emphasis on the shortening patterns due to saturation of unitarity bounds.

Section 4, relying on the solution of the conifold equation, proposes a candidate for the classical N = 1 theory which is supported by the condition of vanishing D {term s. The N > 1 extension is then conjectured to be related in the ultraviolet to a gauge theory of D 2-branes given by the product of two non {sim ply laced groups G = U S p(2N) 0 (2N 1) with chiral multiplet S_i transforming in the spinor representation of the avour group SO (5) and in the bifundam ental of G.

Some considerations are also given on the possible existence of a superpotential, at least in the N = 1 case. In section 5, after a short sum mary of the conform all operators related to the shortenings of KK representations, we construct a set of conform all operators which can be put in correspondence with the various supermultiplets. Finally, we give a sum mary of our result in Section 5 while some of the more technical aspects regarding useful tools for the harm onic analysis are contained in two appendices.

2 The mass spectrum of $V_{(5;2)}$

Harmonic analysis on the coset space $V_{(5,2)}$ SO (5)=SO (3) yields the complete mass spectrum, which as in the other N = 2 supersymmetric compactications, is arranged into O sp(4j2) representations. Referring to [10] and references therein for the relevant details concerning harmonic expansion on a generic coset manifold, we give below the essential ingredients for carrying out the computations and collect our results in tables for the various supermultiplets.

As in any KK compactication, after the linearization of the equations of motion of the eductuations, one is left with a dimensional edus $\int_{[1;2;3]}^{fJg} (x;y)$

Here the eld $\begin{bmatrix} fJg \\ [1;2;3] \end{bmatrix}$ (x;y) depends on the coordinates x of AdS₄ and y of V_(5,2), and transform s irreducibly in the representations fJg of SO (3;2) and $\begin{bmatrix} 1; 2; 3 \end{bmatrix}$ of SO (7). 2_x is the kinetic operator for a eld of quantum num bers fJg f; sg in four{dimensional AdS space and \square_y is the Laplace{Beltram i operator for a eld of spin $\begin{bmatrix} 1; 2; 3 \end{bmatrix}$ in the internal space V_(5,2). (In the following we mostly om it the index fJg on the elds. The symbol $\begin{bmatrix} 1; 2; 3 \end{bmatrix}$ denotes the quantum num bers of the SO (7) representation in the Young tableaux form alism .)

M ore speci cally, one expands the d = 11 supergravity elds $[_{1;2;3}](x;y)=fh_{ab}$, A_{abc} , ag ($a = (a;), a = 1; \dots; 4$, $= 1; \dots; 7$) in the harm onics of $V_{(5;2)}$ transforming irreducibly under the isometry group of $V_{(5;2)}$, and computes the action of X_y on these

harm onics. The eigenvalues are simply related to the AdS mass.

The two necessary ingredients in this computation are the geometric structure and the harm onics of the coset space.

G com etry

W e give here a brief description of the essential geom etrical elem ents of the Stiefelm an ifold such as the m etric and the R iem m anian curvature, that are used to build the invariant Laplace {B eltram i operators.

W e rem ind that the Stiefelm anifold, beside SO (5), has an extra isometry SO $(2)_R$ that can be identifyed with the R {symmetry group [19]

where the embedding of the SO $(2)_{H}$ into SO (5) SO $(2)_{R}$ is diagonal and the embedding of SO (3) in SO (5) is the canonical one, namely the fundamental of SO (5) breaks under SO (3) as 5 ! 3 + 1 + 1 (other embeddings yield dierent inequivalent M $_{7}$ with N \notin 2).

We call ; = 1;:::5 the SO (5) indices, I = 1;2;3 the SO (3) indices and A = 1;2 the SO (2) ones. The adjoint generators of SO (5) and SO $(2)_R$ ' U $(1)_R$ are respectively T ;U.

For the canonical embedding of SO (3) in SO (5), = (I;A), we can de ne $J_K = \frac{1}{2} K_{IJ} T_{IJ}$ as the SO (3) generators and N $T_{45} + U$ as the SO (2)_H generator. The coset generators are given by T_{IA} (T_m ; T_{m}) (m;rft = 1;2;3), T_7 T_{45} U.

Since the vielbeins are coset{algebra valued, we use the same convention for labelling the vielbein directions in the coset space.

G iven the structure constants C $^{\rm a}{}_{\rm bc}$ of the coset, the R iem ann tensor is de ned by the form ula

whose derivation we give in Appendix A. Here we simply point out that the r(a) are the rescalings of the vielbeins needed to obtain an E instein space and that the C^{a}_{bc} are certain speci c combinations of the structure constants.

The harm on ics

The harm onics on the coset space $V_{(5,2)}$ are labelled by two kind of indices, the rst giving the speci c representation of the isom etry group SO (5) U_R (1) and the other referring to the representation of the subgroup H SO (3) SO (2). The harm onic is thus denoted by $Y_{(q_H)}^{(M,N,Q)}(y)$, where M N are the quantum num bers of the SO (5) representation, Q is the U_R (1) charge and q_H are the H {quantum num bers.

The above results in ply that an SO (7) eld [1;2;3](x;y) can be splitted into the direct sum of H irreducible fragments labelled by q_H . The analysis of the reduction of the SO (7) representation under the H group reported in Appendix B, yields that the vector and spinor SO (7) representations break as

and by taking suitable combinations one can also derive all the other tensor decompositions.

The generic eld [1; 2; 3](x; y) can then be expanded as follows

O ne can now proceed with the KK analysis, in plementing the above informations in all the Laplace (Beltram i operators and computing the eigenvalues of the various harmonics and thus the masses of the KK states.

A lthough straightforward in principle, this analysis can become quite cum bersom e for some of the higher spin operators. Luckily, it is not really necessary to complete the whole task. In fact, due to the N = 2 supersymmetry, this peculiar compactication falls in the class considered in [24], where the O Sp(4;2) multiplet structure was elucidated, together with the mass values expected for states of given quantum numbers. Most of these multiplets can be led by using only our results for the simpler operators, while the entries in the remaining slots can be determined with the help of supersymmetry. From the scalar, spinor and vector eigenvalues, we have obtained the masses for all the graviton and gravitinos and for some of the vectors, spinors and scalars, which let us lithe ve types of supermultiplets presented in Tables 2{6, with all the shortening patterns. A prelim inary analysis of the rank of the two{form matrix yields that we can have at most two more vector multiplets, which we guess do not undergo shortening.

Indeed, as in the T¹¹ case [10,9], all the mass eigenvalues depend on the G (quantum num bers only through the function H_0 , which is the scalar laplacian eigenvalue. For the Stiefelm anifold, such eigenvalue is given by

Since for a given number of preserved supersymmetries, the structure of the linearized equations, supersymmetry relations and supermultiplets are xed, we can suppose that also the mass formulae in terms of H₀ are universal for all seven-dimensional N = 2 supersymmetric compactications. By this we mean that not only the number and type of multiplets for dimensional cations are the same, but also the H₀ mass dependence should be equal.

This is exactly what we nd by comparing our case with the M¹¹¹ compactication [25], and we expect such agreement to hold also for the Q¹¹¹ space. Of course, the shortening patterns as well as the possible presence of Betti multiplets will be model dependent features, as they derive either from certain functions of H₀ taking rational values or from non{trivial Betti numbers of the relevant manifold. However, in this respect, the two vectormultiplets mentioned before have $= \frac{1}{2} + \frac{1}{4}^{p} \overline{4 + H_{0}}$ and $= \frac{1}{2} + \frac{1}{4}^{q} \overline{H_{0}}$ (M; N; Q + $\frac{3}{2}$) 28, and satisfy no shortening conditions. This makes us condent that all the relevant output derived from the supergravity analysis is correct.

3 The AdS₄ $V_{(5;2)}$ multiplet structure.

We report below in tables 2{6 the ve fam ilies of supermultiplets we have found: one graviton multiplet, two gravitino multiplets and two vector multiplets.

Each table has vemain columns. The rst column contains the spin quantum number of the state, while in the second we give its ^(s) value. The basic value of assigned to each multiplet is the one belonging to a vector eld, a spin 1/2 or a scalar for the graviton, gravitino and vector multiplets respectively. In the third column we write the R {symmetry of the state where the value y is assigned to the state with ^(s) = . We use here $y = \frac{2}{3}Q$, since this varies in integer steps according with the usual convention on the unit value of the R {charge of the coordinate [24]. The fourth column shows the speci c eld of the KK spectrum that is associated with the given OSp(4;2) state, according to the notations of [24]. The fith column contains the mass of the state⁸ given in term s of H₀.

 $^{^8}$ W e give the value of the m ass for the ferm ions and the m ass squared for the bosons.

For generic SO (5) quantum num bers and R {sym m etry values, the multiplets of tables 2{6 are long multiplets of OSp(4.2). However, group theory predicts [24] shortening in correspondence with speci c threshold values of the quantum numbers. These give rise to chiral (), sem i{long (?) or massless () multiplets. The above symbols appear in the extra left columns to denote the surviving states in the shortened multiplets. In absence of these sym bols no shortening of any kind can occur for that multiplet.

4 Classical $V_{(5,2)}$ cone equation and CFT

This supergravity solution has no moduli, as in eleven dimensional supergravity there is no dilaton and the vev's of the elds giving the $AdS_4 V_{(5,2)}$ compactication is uniquely xed. The only \setminus {angle" we could introduce is a shift in the vacuum value of the three{ form $A_{a\hat{b}\hat{c}}$ by a closed non{exact three{form on the internal indices. But we know that $H_3(V_{(5,2)};Z)$ is at most discrete torsion [23] and therefore there are no \setminus {angles". The absence of moduli rejects in the CFT de nition implying that the interacting xed point is isolated in the parameter space.

This seems to be related to the geom etrical nature of this manifold. It has been shown [27] that, at variance with the M¹¹¹ and Q¹¹¹ cases, the Stiefelm anifold does not adm it a description in terms of toric geometry and thus it is very dicult to see if it can be found as a partial resolution of some orbifold. If this could be done (like for the Q¹¹¹ manifold [27]), it would imply that there exists a ux from the orbifold CFT to this infrared point [5,18], but it does not seem to be the case. Recent supergravity calculations [32] seem to con rm this fact at least for uxes connecting manifolds with the same topology.

The Conform al Field Theory

In the same spirit of [5], the basic degrees of freedom of the desired CFT can be understood upon solving" the (4.1) equation. This can be done as follows: we set

The above discussion in plies that the correct gauge group G to be used for N coincident branes should reduce to SU(2) for N = 1. Hence, choosing G to reduce for N = 1 to SU(2), equation (4.17) xes the SL(2;C) residual invariance. This gauge xing is quite analogous to the one used in [5], where the com plexi cation of the U(1) residual sym m etry in the solution of the cone on T¹¹ is given by a com plex rescaling of the relevant variables.

Given the above information, we can try to guess G, when N > 1. The product of two unitary group is excluded, since the coordinate, as in T¹¹ (but not on the spheres), appears in the KK spectrum and it is a gauge singlet so that the spinor S_i must be in a pseudoreal representation of G (In a pseudoreal representation CS = S, C² = 1 and thus the gauge singlet is contained in the antisymmetric product (S S)_{asy}).

The baryonic symmetry is related to the existence of U (1) Bettimultiplets in the KK spectrum [31, 10, 23], which only occur if there are non-trivial Betti numbers b_i ; i \in 1;7.

However, $V_{(5,2)}$ has the same real hom ology the seven-sphere S⁷, and thus a continuous baryonic symmetry is ruled out.

Thus we propose that the CFT describing a large number of M 2{branes on the (4.1) singularity is given by the infrared xed point of an USp(2N) O(2N 1) gauge theory where the basic degrees of freedom are chiralmultiplets Sⁱ lying in the 4 of SO(5), with R { sym m etry charge Q = 1=2 (or y = 1=3) and in the (2N; 2N 1) irrep. of the gauge group. In the brane construction of gauge theories usually there can be other matter elds in sym m etric and antisym m etric representations. We assume here that such representations decouple at the conform al IR xed point.

The chiral eds (singletons) of the conform all edd theory have $= jyj = \frac{1}{3}$. This means that owing to the interacting point they acquire an anom alous dimension $= \frac{1}{6}$. This makes the conform all dimension violate the unitarity bound $= \frac{1}{2}$, but since the singleton edd is not a gauge group singlet it is not an observable of the theory. The analogous phenom enon occurs for the ve{dimensional case T¹¹, where $A_B = \frac{3}{4} < 1$ and for the proposed CFT's dual to the seven {dimensional manifolds M¹¹¹ and Q¹¹¹ [23].

As already remarked, the gauge theory exists only in the ultraviolet lim it where it is not conform aland where the gauge vector potential, which is a singlet of them atter group SO (5) is in the adjoint representation of USp(2N) O (2N 1). We could dualize it, at least in the C oulom b branch, and then reintroduce it in the CFT. However, from the K K analysis, we see that we have no states corresponding to products of this true singleton eld (with $= \frac{1}{2}$) and therefore we have no coordinates for the C oulom b branch.

As we will see later, it is also essential to introduce a superpotential whose Jacobian ideal gives the needed vanishing relations for the correct matching of the chiral primaries with the supergravity hypermultiplets. This is given generically by the sixth power of the singleton elds

Let us consider the previous structures for N = 1, when we can drop the trace symbol. We easily see that they are the six a priori existing singlets which can be obtained from the product of six 4 spinor representations of Sp(4). It seems more problematic to nd the appropriate singleton combinations which appear as sem iconserved spin 1=2 super elds in the CFT corresponding to short gravitino multiplets on the supergravity side. In the theory at hand there is no eld like the W of the T¹¹ case [5,9] and thus there is no natural candidate for these operators. We also have to be careful not to use sim ple descendants of prim ary operators and this makes the task more di cult. A nyway, once we have the isom etry group quantum numbers, from the KK analysis, we can see that the appropriate combinations of the S₁ are uniquely xed, and will be written explicitly below.

The correspondence

G iven the structure of the O Sp(4/2) multiplets of eleven {dimensional supergravity compacti ed on $AdS_4 = V_{(5/2)}$, we can make the comparison between these results and the CFT predictions. We can also make use of these results to explicitly determ ine the expression of the ferm ionic operators related to the short gravitino multiplets.

A long the lines of the ve{dimensional case of type IIB supergravity on AdS_5 T¹¹ [9,10], we look for rational conform ald in ensions occurring in the KK multiplets and see whether they correspond to the right shortenings needed to be related to the previously described conform all operators.

From the energy values of the multiplets, it is easy to see that a rational conform al dimension can be obtained only if $H_0 + 36$ or $H_0 + 24$ are squares of rational num bers.

As in the T¹¹ case, we obtain rationality when we saturate the bound on the R (charge of a given harm onic, i.e. when in the Young Tableaux all the boxes which can be charged have the sam e R (charge. This occurs for the representations¹⁰ [k; $0 \frac{1}{2_{3k}}$ of SO (5)_{U_R(1)} in the H₀ + 36 case and for [k; $0 \frac{1}{1+\frac{2}{3}k}$ in the H₀ + 24 case. The corresponding square roots are given by $6 + \frac{8}{3}k$ and $4 + \frac{8}{3}k$ respectively. We have solved the rationality constraint for the m ore generic case of [m + n + k; m $\frac{1}{1+\frac{2}{3}k}$, and we have found that there are two other in nite series of operators with rational dimension, for m and n satisfying the following relations

This gives sequences of numbers with no simple rationale. A nyway we will see that as for T^{11} , beside the case m = n = 0, only another couple of SO (5) U_R (1) quantum numbers, is related to shortenings, while all the others correspond to the rational long multiplets partially noticed in [7] and completely clari ed in [9]. Here these couples are m = 1; n = 0 and m = 1; n = 1 respectively.

Let us now introduce these conditions on the SO (5) U_R (1) quantum numbers in the values of the supergravity multiplets and see when the shortening occurs.

W e start with the graviton and vector multiplets for which we have some expectations to be veried and then pass to the gravitino multiplets. The graviton multiplet has

These states do not satisfy the shortening condition $= 1 + s + \frac{1}{3}j$, but they can be put in correspondence with the rational non supersymmetry protected operators¹¹

We point out that in the L operator, only the irreducible a[bc] representation survives once we use the {matrices identities and the D {term equations.

Let us note explicitly that, as anticipated in the introduction the type II short gravitino multiplet $\operatorname{Tr} X$ has a lowest component of R {symmetry y = 1, so that its component, which we call \widetilde{W} , has y = 0. Moreover, it is a singlet under SO (5) so that in the infrared lim it \widetilde{W} has the same quantum numbers (apart from the conform ald in ension) as the original gauge eld in the ultraviolet lim it.

W e may compare this result with the gravitino sector super eld of the four dimensional SCFT dual to the T¹¹ compactication of Type IIB theory and called L^{1k} in [9].

There, the vector eld strength super eld W is the singleton of the conform al theory, so that it does not appear in the spectrum of T¹¹ compactication. In the present case instead, Tr [X ^k] does indeed appear in the spectrum of $V_{(5,2)}$ being a composite eld of singletons. Furtherm ore, L^{1k}₋ does not exist for k = 0, since in this case it would reduce to [9]

6 Summary

In order to collect our results, we present a table where we list the multiplet type as well as spin, representation and energy of the highest states for M {theory compacti ed on the Stiefelm anifold, and m atch them with the boundary conform al super elds. These results m erely rely on the AdS/CFT correspondence.

It remains an open problem to make an explicit construction of the ultraviolet description of the underlying eld theory in terms of D 2{brane gauge theory.

This form of the R iem ann tensor is more general than the one presented in [35], where the nalresult depended only on the C $^{a}_{bc}$ and not on the C $^{a}_{bc}$ due to the hypothesis that the K illing metric be completely diagonal.
