On the Stringy Nature of W inding M odes in N oncom m utative T herm alField T heories

ABSTRACT

We show that them al noncomm utative eld theories adm it a version of 'channel duality' rem iniscent of open/closed string duality, where non-planar them all bops can be replaced by an in nite tower of tree-level exchanges of e ective elds. These e ective elds resemble closed strings in three aspects: theirm ass spectrum is that of closed-string w inding m odes, their interaction vertices contain extra m oduli, and they can be regarded as propagating in a higher-dim ensional bulk' space-time. In noncommutative models that can be embedded in a D-brane, we show the precise relation between the e ective winding elds' and closed strings propagating o the D-brane. The w inding elds represent the coherent coupling of the in nite tower of closed-string oscillator states. We derive a sum rule that expresses this e ective coupling in term s of the elem entary couplings of closed strings to the D-brane. We furtherm ore clarify the relation between the e ective propagating dimension of the w inding elds and the true codim ension of the D-brane.

1. Introduction

It has been realized that noncom m utative eld theories (N CFT) em erge as e ective eld theories of string/M -theory compacti cations in the presence of constant antisym m etric tensor elds [\[1\]\[2\]\[3\]](#page-22-0). T his result has triggered a renewed interest in the study of both perturbative $[4]$ [5][6] and nonperturbative $[7]$ aspects of noncom m utative eld theories. The stringy connection of N C FT opens up the interesting possibility of trying to understand som e of their physical features by em bedding them in string theory. In particular a num ber of NCFT have been obtained as a low-energy lim it of open-string theories in $B - e$ ld backgrounds $[8][9][10][11][12][13]$ $[8][9][10][11][12][13]$. A s a m atter of exam ple, one can try to understand the nonlocality inherent in these quantum eld theories in term s of string theory after an appropriate low-energy \lim it is taken $[3]$.

A m ong the m ost intriguing features ofN C FT is a peculiar m ixing between infrared and ultraviolet scales [\[5\]\[6\]](#page-22-0). On physical grounds it can be understood as the result of the uncertainty principle between two noncom m uting spatial dim ensions, since probing ultraviolet physics in one direction leads to infrared e ects in the other. A t a m ore technical level, thism ixing re ects itself in the appearances of extra poles at zero m om entum in som e am plitudes in the lim it where the ultraviolet cuto is sent to in nity. The authors of R efs. [\[5\]\[6](#page-22-0)] interpreted these poles as resulting from the interchange of a new eld with kinetic kernel @ @ @ (2) θ . It would be very interesting to see if there is a stringy interpretation for these particles.

One of the obvious ways of spotting stringy behavior in NCFT would be to look at situations w here the presence of extended objects is m adem anifest, as for exam ple studying these theories in spaces with nontrivial topology or at nite tem perature [\[14\]\[15\]\[16\]](#page-23-0). In Refs. [\[17\]\[18](#page-23-0)] it was pointed out that the two loop therm al partition function of some N C FT can be cast in a way that indicates the presence of states whose energy scales with the inverse tem perature as j' j, with ' some integer number. This would suggest that N C FT contains certain extended degrees of freedom that are able to w rap around the euclidean tim e.

In this paper we will try to understand w hether some kind of w inding m odes can be identi ed in noncom m utative therm al perturbation theory, extending on the work of $[17]$ $[17]$. A ctually, we shall see that the w inding m odes form ally identied in therm odynam ical quantities can be associated to e ective elds w ith special propagators, much in the same fashion as the $-$ elds of R efs. [\[5\]\[6\]](#page-22-0). In fact, the UV / IR interpretation of these propagators is the sam e once we realize that the tem perature acts as an ultraviolet cuto in the eld theory.

T herefore, this raises the question of w hether the 'w inding elds' could be interpreted

as 'o -brane' closed-string m odes that survive the Seiberg {W itten (SW) decoupling lim it. We nd that this expectation is not fulled, at least in a literal sense. In particular, any closed-string picture amounts to the exchange of the in nite tower of closed-string excitations in the bulk, and therefore it is not a very transparent way of describing the dynam ics. Instead, each winding eld describes a sort of coherent exchange of an in nite num ber of closed-string m odes. One of our results is the derivation of a sum rule for the e ective coupling of the winding elds, in term s of the elem entary couplings of closed strings to a D-brane. In fact, the interactions of these w inding elds are not specied solely in tem s of standard interaction vertices, except in very special kinem atical situations. G enerically, the vertices contain additional m odular param eters that m ust be integrated over.

The paper is organized as follows. In Secs. 2 and 3 we extend the analysis of Refs. [17][18] to m ore general diagram s in NCFT at nite temperature and try to cast the bop am plitudes in a 'dual channel' picture, in term s of tree-level exchanges. In Sec. 4 we will obtain these am plitudes by studying the low energy SW lim it from string theory in order to identify the low-energy winding modes with undecoupled winding strings. Finally in Sec. 5 we will sum m arize our conclusions.

2. W inding m odes in noncommutative quantum eld theory: an elementary exam ple

The simplest situation where one can form ally identify 'winding modes' is that of the two-loop contribution to the free energy in a $^{-4}$ theory. The planar diagram is independent of the deform ation param eter , but a non-trivial phase $(p;q) = p$ q enters in the loop integral in the non-planar case²

The ultraviolet divergences of this integral can be appropriately elim inated by renom alization of the $T = 0$ lim it, as usual in them al eld theory [19]. In fact, the ultraviolet structure of this diagram is m ibler than that of the planar counterpart, because the divergence contributed by one of the loops is e ectively cut-o by the noncommutative phase

provided (p^2) (p)² is non-vanishing. This is an exam ple of the UV/R m ixing of [\[5](#page-22-0)], nam ely this divergence w ill reappear disquised as an infrared e ect as $p!0$.

In Ref. [\[17\]](#page-23-0) it was pointed out that one could 'integrate out' one of the loops and replace it by a statistical sum over objects living a the form ally T -dualtem perature $1=(T)$, thus representing analogues of w inding m odes. The essential phenom enon can be understood by sim ply looking at the one-loop self-energy tadpole diagram (Fig. 1A)

we can perform the gaussian integralover q. A fter a further Poisson resum m ation in the them al frequency running in the loop we obtain

w here we have changed variables to the 'dual' Schw inger param eters $= 1=4t$. This form is very convenient to perform the subtraction of the $T = 0$ self-energy, since we simply have to restrict the integer sum to $' \notin 0$.

For $d < 4$, the explicit power of $s^{\frac{d-4}{2}}$ in the proper time integral can be 'integrated in' into the exponent by introducing 4 d extra gaussian variables z_2 and we can write the fullnon-planar loop in the follow ing suggestive form

That is, we have w ritten the original loop diagram in a 'dualchannel' in term sof an in nite num ber of tree-level exchanges of particles \cdot with m om enta p, m ass proportional to $j'j$ and extra m om entum variables in $d^2 = 4$ d transverse dimensions (Fig. 1B). This com plete expression renom alizes the m ass of the particle running in the second loop³.

The m ass of the $\rightarrow -$ elds, scaling as integer m ultiples of the them allength, is characteristic of w inding m odes of closed strings. The e ective coupling squared of these particles to the elds in external legs is given by

Thus, if the original eld was m assive, the coupling to the \rightarrow -eld is suppressed at high values of m om entum and w inding number ', i.e. only elds with w inding numbers j' (M)¹ contribute signi cantly to the tree-level exchange. The most interesting case is that of a m assless eld theory. In this case the e ective coupling is constant and weights all w inding num bers dem ocratically, w ith the coupling strength $q = q = (2)$. Finally, if the $4-$ eld is tachyonic, the whole expression is meaningless, since it diverges at the s = 0 end. For this m atter this 'channel duality' in NCFT is rem iniscent of open/closed-string channel duality in string theory. Since NCFT can be obtained in m any cases as low-energy lim its of open-string theories, we nd it natural that the 'dual channel', obtained through a m odular transform ation $t = 1=4s$, exhibits the open-string tachyon as an ultraviolet divergence.

It is m ost interesting to compare the winding $\rightarrow -$ elds we have de ned with the $$ particles of [5][6]. The structure of the propagator shows that these elds are form ally sim ilar

namely, they have a 'static' kinetic term with the kemel $\theta = (p^2)$ for a eld noncanonical dimension. Furtherm ore, at least as long as d 4, the non-standard power of the propagator can be understood in term s of a free propagation in a 4 d dimensional transverse bulk'. The e ective m ass j 'jplays also the role of the inverse ultraviolet cuto

 1 in the treatm ent of [5] and, in the absence of the explicit ultraviolet cuto, the original ultraviolet divergence is back as an infrared divergence at $p!0$. In our expression, this shows up as a pole in the zero-winding sector. It is precisely this contribution that is subtracted when renom alizing the self-energy by the zero-tem perature one⁴. Therefore,

 $3\,$ 0 ne could proceed in the standard way and perform a resum m ation of ring diagram s.

 4 N otice that this procedure is dierent from the one followed in [17] where the authors worked w ith the two-loop free energy for $4\,$ NCFT before subtracting the zero tem perature counterterm s. In that case the ultraviolet divergence in one of the original loops partially transforms into an infrared one after Poisson resummation and integration over the loop momenta. This is just a consequence of UV/R m ixing.

we con m that j 'jplays the role of a requlator.

O ne in portant di erence between our tree-level exchange interactions and the - elds of [5][6] is that our ultraviolet cuto \overline{J} , has a physical interpretation, and we are free from the arbitrariness of the choice of W ilsonian cuto s. In particular we can integrate out the com plete non-planar loop in term s of the in nite tower of tree exchanges of \rightarrow particles. The m anipulation is not a priori restricted to the extrem e ultraviolet part.

O ne interesting aspect of the tree-exchange 'dual' representation (2.5) is that it adm its an interpretation for the planar diagram too. The only di erence in the planar case com es from setting $p = 0$. Therefore, the planar them all bop can be replaced in this case by

Now we must work with the fully renormalized quantity ($\frac{4}{5}$ 0 in the winding sum) and the propagator of the \rightarrow particles is inserted form ally at zero noncom mutative m om entum , ie. we have a sum over zero-m om entum tadpoles of the $-$ - elds. This is also rem iniscent of the closed-string interpretation, because closed strings have tree-level tadpoles on Dbranes. Now we would be inclined to interpret the residue of the propagator poles as the product of the couplings g g_{vac} (Fig. 2).

3. Integrating out a general loop

In the above example we have seen how the e ect of a them al tadpole loop in a noncom mutative ⁴ theory adm its a 'dual channel' interpretation in term s of a the treelevel interchange of some 'w inding' θ -eld with inverse propagator $2\theta^2 + (\theta)^2$ which m ixes with the fundam ental -quantum. It would be interesting to decide to what extent this duality between them al loops and tree-level \cdot -exchanges is a general feature of noncom mutative eld theory at nite tem perature, or just a property of a particular class of diagram s and theories.

3.1. G eneric one-bop diagram in noncom mutative n theory

The rst case we can consider is the generalization of the example studied in the previous section, a generic one-loop diagram with $N = N_{+} + N$ vertices in the noncom m utative version of n eld theory in d dim ensions (Fig. 3), w here we will take N vertices as 'tw isted', so the am plitude w ill be nonplanar w henever $N = 6$ N. Thus, the fully am putated am plitude can be w ritten as

As in the simpler case of the tadpole of the 4 theory, whenever $d < 2N + 2$ we can replace the factor $s^{\frac{d-2N-2}{2}}$ by an integral over 2 + 2N d extra variables, so we can nally write the diagram in the form of a tree-level exchange of e ective elds propagating in $d^2 = 2N + 2$ d additional bulk 'dimensions,

In the same spirit of the $4\,$ tadpole one would like to interpret the am plitude (3.5) as a 'dual channel' representation of the original loop diagram in term s of a tree-level exchange of \cdot -particles with propagators (2.7), so the function $f('p_a;z_?)$ would be interpreted as the product of the couplings in Fig. 3B

How ever, such an identi cation is rather problem atic. Unlike the case of the 4 tadpole, there seem s to be no unambiguous way to de ne the individual couplings $g_{(nN+1)}$ and

 $g_{(\pi^{\text{NN}})}$, since their product [\(3.6\)](#page-8-0) is expressed in term s of a function which does not factorize into the contributions of the two vertices. M oreover, because of the integration over the Feynm an param eters in Eq. (3.4) , the interaction on the two vertices cannot be disentangled, even for m assless elds. It is only in the tadpole case $(N = 1)$ that the integration over Feynm an param eters disappears and the w hole loop can be understood as resulting from the m ixing of the e k with an eective $-e$ k, thus generalizing the result of the previous section to n .

T herefore, even if we can form ally replace the generic therm all loop by the exchange of an eective \cdot -particle, we cannot assign ordinary Feynm an rules to this eld, since the total am plitude is expressed as a convolution of the two interaction vertices, and not just a product as it is the case of ordinary (and noncom mutative) quantum e ld theory. We sum m arize this state of a airs by saying that the vertices of the $\rightarrow -$ elds have relative m odulithat m ust be integrated over.

In principle, the \rightarrow - elds introduced here could become loonal dellel else, with standard Feynm an rules, w hen considering only the behaviour of the diagram at singularities of the integralover Feynm an param eters. W e suspect that this is the precise link between the $-$ elds de ned here and the $-$ elds of ref. [\[5\]\[6\]](#page-22-0).

The appearance of m oduli in the 'dualchannel vertices' will nd a string-theory explanation in the next section. First, we shall discuss some special instances in which the form alism sim plies.

3.2. Som e specialcases at two bops

T he previous exam ple seem s to indicate that, although in general we can replace nonplanar loops in NCFT by tree-level exchanges of an in nite tower of some e ective $-$ elds, in a generic situation the nonlocal character of this eld m akes the e ective description not very transparent. Here we w ill further comment on two examples where this e ective description is useful.

Let us rst consider noncommutative super Yang{M ills (NCSYM) theories at nite tem perature. The two loop free energy density can be written for U (N) N C SYM_d as [\[16](#page-23-0)]

w here $C_{\text{sc}} = 16;4;1$ for theories w ith 16,8 and 4 supercharges respectively [\[20\]](#page-23-0), $!_{\text{p}} = \dot{\text{pj}}$ and $n_{b(f)}(p) = (e^{-ipj} - 1)^{-1}$ are the Bose{E instein and Ferm i{D irac distribution functions.

It is interesting to notice how, f_{D} or $N \subset SYM$ theories, the 'nonplanar' part of the two-loop free energy [the last term in (3.7)] factorizes into the product of two independent loop contributions only linked through the noncommutative phase, much in the same fashion of 4 N C FT. Follow ing R ef. [\[17\]](#page-23-0) we can now integrate one of these loops to try to spot w inding states (Fig. 4). W hen $d < 4$ again we can introduce 4 d extra variables $z₂$ to w rite

That is, we nd a standard tower of \cdot particles, restricted to odd w inding num bers. From this expression we learn that, in general, the ferm ion loops will give rise to \cdot particles w ith negative norm for even \prime . For the supersym m etric case, there is a cancellation w ith the tower com ing from the bosonic loop and we nd the projection onto odd w inding num bers. We shall give a string theory explanation of this phenom enon in the next section.

N otice that the factorization of the two-loop free energy into contribution of two independent bops is not a general property of any quantum eld theory. In particular, for 3 NCFT the integrand of F(;) does not have this property even in the m assless case. W hat is special about N C SYM is the fact that m any of the individual diagram s contributing to (3.7) have loops with two external insertions, so one would need at least one Feynm an param eter in order to form ally 'integrate out' the loop, along the lines of the general discussion above. Yet, the com plete two-loop diagram show s factorized form and one can introduce e ective \rightarrow particles with standard Feynm an rules (apart from the negative-norm feature in the ferm ionic case).

The reason behind this simpli cation is two-fold. First, gauge symmetry relates the ³-like diagram sto the 4 -like diagram s. Second, the theory ism assless, so that the eec-tive coupling [\(2.6\)](#page-5-0) is a m om entum -independent pure num ber, and thus both 4 -like loops

are completely disentangled from the kinematical point of view. Therefore, this factorization is, in principle, speci c of two-loop diagram s in m assless theories whose symmetries can relate all diagram s, contributing to a given physical quantity, to 4 -like ones. A nother exam ple, considered in $[17]$, is the m assless W ess $\{Zum$ ino m odel, where supersymmetry plays the relevant role. In the m assless lim it the W ess{Zum ino m odel reduces itself to a supersym m etric version of 4 NCFT. Thus the factorization of the two-loop free energy follow s from the factorization of the corresponding diagram in 4 theory under the substitution $n_b(p)$! $n_b(p)$ + $n_f(p)$. In the NCSYM case it is not supersymmetry, but rather gauge symmetry, the one playing the simplifying role, because the two-loop factorization is true already for nonsupersymm etric noncommutative Y ang {M ills theories [16].

4. W indings and closed strings

4.1. Heuristic considerations

G iven that m any $NCFT$ derive from open-string theory in background $B - e$ ds in the SW $\lim_{h \to 0}$ in $\lim_{h \to 0}$ is natural to associate the winding m odes of the previous representations to closed strings in interm ediate states. N am ely, the structure of (2.5) is rem iniscent of a closed-string tree-level propagator between boundary states of a D_{d-1} brane (Fig. 5). H euristically, we expect

and we see that our fam iliar com bination $21^2 + (p)^2$ scales together and dom inates over the other term s in the SW lim it, since ${}^{\circ\alpha}M_{\text{cl}}^2$ ${}^{\circ}N_{\text{osc}}$! 0. This is the m ain evidence for the stringy origin of the w inding m odes. Indeed, we have N eum ann boundary conditions in the therm alcircle, and therefore the closed-string cylinder can w ind in this direction. On the other hand, there cannot be m om entum ow through the N eum ann directions unless it is explicitly inserted via the open-string vertices into the boundary states, but there is an arbitrary ow of m om entum in D irichlet {D irichlet directions. In the noncom mutative directions, having a nonzero $B - eI$, one could have m om entum ow induced just by the B - eld. The boundary conditions set to zero only a linear combination of m om entum and w inding num bers. H owever, since we are assum ing a noncom pact D -brane in spatial directions, there are no w inding m odes in spatialdirections and thus no extra m om entum ow induced by the $B - eId$.

If we are willing to naively neglect the nom inally subleading term s in (4.5) we can alm ost get (4.1) w ith the coupling of the \rightarrow elds de ned through the 'sum rule' over all $\c{closed-string}$ elds \dagger i (the oscillator excitations)

in the SW lim it, perhaps w ith appropriate powers of 0 in front. A ccording to this picture, the low-energy \cdot - elds are not som e low-lying closed-string m odes that fail to decouple. In fact, the w hole in nite tow er of closed-string m odes fails to decouple, but the interaction w ith the boundary states de nes an e ective coupling for the $\rightarrow -e\mathbf{Id}$, w hich represents

the coherent exchange of an in nite num ber of closed-string excitations. Form ally, the SW lim it squeezes the complete tower of string excited states into an approximately continuous band, as compared to the gap of the winding modes

This is an interesting comprom ise between the general lore that the closed-string channel should be intractable whenever the open-string channel is simple [11], and the factual existence of the dual channel representation in term s of the $\rightarrow -$ elds.

A ctually, the sum rule (4.6) is too naive. The rst indication that something ism issing in (4.6) is the fact that a naive attempt to associate the z_2 degrees of freedom with D irichlet{D irichlet m om enta p_2 in the D-brane codim ension fails quantitatively, because in generald_? $6 d^2 = 2 + 2N$ d for a D_{d 1} brane. The resolution of the puzzle am ounts to recognize that one cannot simply neglect α_{M}^2 in the closed-string propagator, as com pared to 2^2 , even in the low-energy SW lim it, because there are an in nite number of states contributing to the sum. In other words, the truncated sum rule (4.6) is not convergent in general.

The second reason for concern lies in the de nition of the low-energy e ective coupling g as a proper e ective vertex. In the full string theory diagram, the boundary states with open-string insertions have moduli (the K oba {N ielsen param eters) that must be integrated over. Therefore, the stringy diagram does not have in general the structure of an ordinary tree-level exchange, since both vertices are convoluted in an integral over K oba{N ielsen param eters. Only at the boundaries of the m oduli space, when the string diagram degenerates into proper eld theory diagram s, one nds standard Feynm an rules. This means that the correct sum rule replacing (4.6) must hold for the integrand over m oduli space (including the K oba{N ielsen m oduli).

4.2. O pen-string channel

In the rem ainder of this section we obtain the correct sum rule by careful consideration of the general one-loop open-string diagram. This is a weighted sum over spin structures f q, each one given by a path integral on the annulus with arbitrary vertex operator insertions on both the inner (\cdot) and outer (+) boundaries

w here is the modulus of the annulus, y are the K oba $\{N\}$ ielsen parameters in each boundary, $V(p, y; j)$ is the norm alized correlator of vertex operators in the spin structure

, and Z () is the norm alization, i.e. the path integral without vertex insertions. The power of G_s com es from the norm alization of the vertex operators with the open-string coupling de ned in $[3]$

The complete amplitude has an appropriate power of the Regge slope N_0 so that the SW \lim in it with xed g_{YM} leads to the eld-theoretical expression of the amplitude. This depends on the overall dim ension of the am plitude and the num ber of insertions.

The function V (p γ ;) is a polynomial in external eld polarizations, the ferm ionic G reen function G_F and derivatives of the bosonic G reen function G_B on the annulus with appropriate B -dependent boundary conditions, tim es the contraction of the tachyonic part of the vertices

This G reen function can be param etrized completely by the open-string metric G and noncommutativity parameters , except for a single constant term from the purely bosonic component [21], which contributes to nonplanar diagrams and depends explicitly on the sigm a model metric q. The precise details of this lim it in various exam ples of the bosonic theory at zero tem perature can be found in recent papers [\[8\]\[9](#page-22-0)[\]\[10\]\[11\]\[12\]\[13\]](#page-23-0). T he im portant feature is that the SW lim it is dom inated by m assless open strings (in the bosonic exam ples one is forced to discard the open-string tachyon by hand). Thus, in comparing w ith (3.1) , we m ust set $M = 0$ and interpret the norm alized K oba{N ielsen param eters $x = y =$ as Feynm an param eters of the eld theory diagram.

O n general grounds, the m assless open-string dom inance m eans that w e do not expect the closed-string channel expression to be $\sin p$ is, in the sense of being saturated by a nite num ber of closed-string elds.

4.3. The closed-string channel sum rule

Ideally, we would like to specify explicitly, in the closed-string Fock space, the boundary states appearing in $eq. (4.1)$ $eq. (4.1)$. This is a very complicated task in general, and can be carried out in detail only for the 'vacuum' boundary states p_{d-1} i w ithout open-string vertex insertions. On the other hand, we can obtain explicitly the overlap in (4.1) , by direct m odular transform ation of the open-string channel expression (4.8) .

In order to keep track of the right norm alization of w inding m odes, we perform a Poisson resum m ation of the discrete frequency sum s

w here F is the space-tim e ferm ion num ber in the open-string channel. It is correlated w ith the closed-string sector in the cylinder channel in such a way that $F = 0$ corresponds

to the N S {N S sector of the D p-brane boundary state, w hereas $F = 1$ leads to the R { R exchange [\[22](#page-23-0)]. Therefore, we have found that the winding modes of closed strings in the R {R sector are weighted by the so-called A tick {W itten phase $(1)'$ [\[23\]](#page-23-0), the extra m inus sign com ing from the G SO projection, or m ore elem entarily, from the overallm inus sign of ferm ion loops in space-time. We recognize in the phase $(-1)^{i+1}$ the eect pointed out in eq. [\(3.8\)](#page-10-0). N am ely, ferm ionic loops in the 'open-string channel' lead to phases in w inding m odes in the 'closed-string channel'. In particular, in the supersym m etric case we also nd a projection onto odd w inding num bers in the full string theory expression. The closed-string interpretation also explains the 'negative norm' of the tower of even $_{2'}$ -elds com ing from a ferm ion loop ; it is just an eect of the D-brane carrying 'axionic' charge w ith respect to these elds.

In view of the closed-string propagator in (4.2) , the appropriate m odular transform ation to obtain $\exp(-z - z)$ is $z = 2^{-2} = 1$. The non-trivial piece of the overlap [\(4.1](#page-11-0)) is that of the oscillator degrees of freedom. We de ne

N um erical constants have been absorbed in the de nition of the boundary states. The m odular anom aly, depending on the total dim ension w here the string oscillates ($D = 10$ for superstrings), is captured by looking at the case w ithout insertions, where an explicit construction of the boundary states exists. Taking into account the factor of $\frac{d-1}{2}$ from the integral over world-volume m om enta in the evaluation of $Z()$, we nd the total m oduli-space m easure to be

We see explicitly how the proper counting of transverse dim ensions, as read-o from the powers of Schw inger param eters, is working ne thanks to the m odular anom aly in (4.17).

where the sum over closed-string states j i runs over all oscillator degrees of freedom of the closed strings in the bulk. In comparing (4.21) with the eld-theoretical expression in (3.4) , we must take into account that M = 0 and (3.4) was derived for a purely bosonic bop, hence there is no non-trivial A tick {W itten phase in (3.4) . Furtherm ore, (4.21) was derived under the assum ption that external states were bosonic and static, i.e. externalm om enta have vanishing time components. That explains the absence of the phase $\exp[i \int_{a}^{F} x_a (Q_a^0)^2]$ in (4.21).

We conclude this subsection with some observations on the interpretation of (4.21) :

i) In term s of the dim ensionless closed-string modulus, the SW lim it in (4.21) takes $_2$! 0. In this region of moduli space, the in nite tower of closed-string elds contributes to the sum rule, which is by no means saturated by a few closed-string elds. This was already obvious from the fact that the open-string channel expression was saturated by m assless open strings.

ii) The sum rule (4.21) replaces the naive one in (4.6) . One of the defects of (4.6) , the m ism atch between the powers of the Schw inger parameter and the true number of transverse dimensions of the brane, is resolved by noticing that the sum rule includes a non-trivial power of $s^{\frac{m}{2}}$, together with an explicit exponential kemel, which gives back the eld-theoreticalm easure in (3.2) in the SW lim it, and ensures the convergence of the sum over closed-string states. In fact, since this lim it takes $\frac{1}{2}$ $\frac{1}{3}$! 0, the way to

evaluate the in nite sum over states in (4.21) is to perform a modular transform ation back to the open-string variables. In this process we get the appropriate powers of the Schwinger param eter from the modular anom aly of the oscillator traces (Jacobi's theta functions).

This discussion m akes also m anifest the form alcharacter of the extra 'oulk dimensions' $d^2 = 2N + 2$ d of the winding elds , something already clear from the fact that d^2 depends on the number of insertions in the loop. We see that, in those models with a string-theory embedding, there is a 'bulk' codim ension $d_2 = D$ d, but its relation with $d^?$ is rather indirect.

iii) A nother de ciency of (4.6), the absence of K oba (N ielsen param eters, is rem edied in (4.21) . The interpretation of the full diagram in the NCFT as a tree-level exchange of $-$ elds was all right provided we make a further convolution of the vertices with Feynm an param eters. We now understand this feature as a residue of the full string picture, since K oba{N ielsen param eters m ap consistently to Feynm an param eters in the SW \lim in it. Therefore, the \sim - ekl picture of the NCFT m in ics closely the structure of the closed-string channel in the full string theory.

iv) The sum rule (4.21) holds for the integrand of them oduli-space integral. Therefore, it holds independently of the possible occurrence of open- or closed-channel tachyons in the full string theory. This is in contrast with (4.6) , which would be invalidated by openstring tachyons, and perhaps also by closed-string tachyons. It would be very interesting to study particular exam ples in detail to see the interplay between the various open/closed tachyons that could appear, including the nite tem perature H agedom tachyon.

v) Our discussion is tailored to the case of them al am plitudes. However, it is clear that the general features generalize to other toroidal compacti cations with various degrees of supersym m etry.

4.4. An illustrative example

Unlike Eq. (4.6) , the sum rule (4.21) is valid point by point in the (s, x) moduli space. As a consequence, it is well de ned even for tachyonic theories for which the integrated expressions would diverge due to the contribution com ing from the moduli space boundaries. This being so, we can illustrate our sum rule (4.21) by considering the sim plest possible exam ple and take the two-point function of open-string tachyons on a D_{d-1} brane of the D = 26 critical bosonic string theory. In order to avoid unneccessing complications we will consider the static amplitude where incoming states do not carry time components of the momenta. Thus, the amplitude in the open-string channel can be

In this exam ple we explicitely see how the coupling between j n i and the boundary state w ith a tachyon insertion is in general nonvanishing for all values of n and thus all closedstring oscillator levels run in the cylinder. A s a consequence, the e ective \rightarrow elds cannot be seen as some undecoupled winding string state in the SW lim it, but rather as a superposition of all m assive closed-string m odes with coherent couplings to the elementary quanta of the NCFT.

5. Concluding rem arks

In the present paper we have tried to identify the stringy connection of the recently conjectured winding modes emerging in NCFT [17]. We have seen how a thermal loop in NCFT can be represented in a 'dual channel' picture as an in nite tower of tree-level exchanges of some e ective elds \cdot with m asses proportional to $j'j('2 Z)$ and kinetic term @ (e) in the e ective action. The scaling of the m asses of these elds with the length of the euclidean time suggests a winding mode interpretation for them.

In m any respects these elds are similar to the $-$ elds introduced in Refs. [5][6]. It is in portant to notice how ever that there are a number of di erences. First of all, in the them al case we have not just one, but an in nite tower of e ective elds replacing the them alloop in nonplanar am plitudes. As a consequence, one is able to replace the whole them alloop by a tree-level exchange of these elds and not just the high energy part as in [5]. M ost in portantly, the \rightarrow - elds have nonstandard Feynm an rules. If the nonlocality in NCFT is just encoded in a nonpolynom ialdependence of the interaction vertices on the incoming m om enta, in the perturbation theory for the e ective \rightarrow -eks the interaction vertices are convoluted in nite dimensional integrals over the Feynm an parameters of the originaldiagram.

A ctually, both features, w inding-like m asses and integration over the relative m oduli of the interaction vertices, strongly suggest a stringy interpretation. We have found that such interpretation exists in those models which can be obtained from a D-brane theory

in the presence of a constant B – eld in the SW $\lim_{x \to 0}$. In this case, we found that the scaling of the m asses of the $\rightarrow -$ elds with the length of the therm al circle is a residue of w inding closed-string states, w hereas the convolution over the vertex m odulidescend from the integration over the K oba {N ielsen m oduli of the D -brane boundary states.

It is how ever in portant to notice that the ω inding states' identi ed in [17] have no simple interpretation in terms of individual string states that fail to decouple in the SW \lim in it. On the contrary, the \leftarrow elds have to be considered form aldevices to represent a coherent coupling of an in nite number of closed-string states. These elds have e ective couplings to the ordinary elds that can be derived from the elem entary coupling of closed strings to D-brane boundaries via 'sum rules' involving the full tower of closed-string oscillator m odes in the bulk. This is a rather unusual picture, and essentially is telling us that the SW lim it is not an ordinary low-energy lim it in the closed-string channel since all m assive states are squeezed below the gap of the w inding m odes. As a consequence, the resulting NCFT present a degenerate version of the open/closed string duality of the original string theory: the ordinary 'open' representation of the Feynm an diagram in NCFT and the 'closed' dual channel in term s of the w inding $-$ elds.
