# Com plex structure m oduli stability in toroidal com pacti cations

A bstract: In this paper we present a classi cation of possible dynam ics of closed string m oduliw ithin speci c toroidal com pacti cations of Type II string theories due to the NS-NS tadpole terms in the reduced action. They appear as potential terms for the m oduli w hen supersymm etry is broken due to the presence of D-branes. We particularise to speci c constructions w ith two, four and six-dim ensional tori, and study the stabilisation of the com plex structure m oduli at the disk level. We nd that, depending on the cycle on the com pact space where the brane is wrapped, there are three possible cases: i) there is a solution inside the com plex structure m oduli space, and the con guration is stable at the critical point, ii) the m oduli elds are driven towards the boundary of the m oduli space, iii) there is no stable solution at the m inim um of the potential and the system decays into a set of branes.

# 1. Introduction

B ranes at angles [1] provide a very rich fram ework for the construction of com pactications with a chiral spectrum of a very similar structure to the one of the standard model [2,3,4, 5,6,7]. G enerically these models are non-supersymmetric, although some supersymmetric constructions can also be obtained [4]. These con gurations are T-dual pictures of branes carrying non trivial bundles wrapping the compact space [8,9,2,10].

There are two types of closed string tadpoles, the N eveu-Schwarz (N eveu-Schwarz (N S-NS) and the R am ond-R am ond (R-R) tadpoles. The cancellation of the R-R tadpoles is a necessary condition for the consistency of the theory. In particular, R-R tadpole cancellation conditions guarantee the absence of chiral anomalies in the low -energy e ective theory [1, 2]. However, even if the R-R tappoles cancel, when supersymmetry is not preserved the NS-NS tadpoles m ay appear. The system seems to be consistent, but som e potentials for the NS-NS elds are generated, signalling that the con guration is not in a stable vacuum, and the string vacuum has to be rede ned. This problem has been addressed in several papers [11, 7].

We analyse this problem of the uncancelled NS-NS tadpoles in the context of intersecting branes models, see also Ref. [5]. Given a cycle of a homology class on an arbitrary compactication space, we can wrap a brane on it. The system will try to minim ise the volume of the brane, inducing a variation of the metric moduli space. When the D-branes wrap a half homology cycle, one can see that the potential depends only on the complex structure moduli. A nother way to see it is through the appearance of a NS-NS tadpole term that enters in the elective action as a potential for the complex structure moduli ed. One can check that this potential is proportional to the modulus of the periods:

where is the norm alised n-form in a general complex n-dimensional manifold, and is a cycle in that class. This form speci es the complex structure of the manifold. Sometimes, depending on the complex structure, this brane is unstable against its decay into other branes.

In this paper we have concentrated on tori of di erent (even) dimensions, and an arbitrary number of branes. The questions we address here are the following: given a hom ology class, where is the com plex structure moduligoing to? Is there a minimum? Is the brane that wraps this cycle stable at the minimum? This problem is analogous to that studied by M oore [12] and D enef [13], in their case related to the construction of stable BPS black holes. We have realised that the minima in both cases are exactly the same. Here we analysed some of the results of R ef. [12] and extrapolated the analysis of the minima to our case. D i erent phenom ena can take place in the ow of these com plex structure moduli, like crossing lines of marginal stability that make some branes decay into others [13], etc.

W e give here our main conclusions, and leave the description of the details for the following sections. For the 2-dimensional torus the complex structure moduli elds are driven to the boundary of moduli space. In the 4-dimensional torus we md a well dimensional behaviour depending on the wrappings of the branes around the homology cycles. In this case, we analysed a large number of examples, although a general description is absent, as we will discuss below. The most interesting case, however, is the 6-dimensional torus, where we md three dimensional torus interesting case. A stable minim a can be localised in the interior of the manifold of the complex structure moduli. This will only happen if the cycle is not factorizable<sup>1</sup>. ii) In the case there is only one factorizable cycle, the com plex structure m oduli are stabilised at som e points on the boundary. iii) W hen the cycle can be decom posed into two factorizable cycles, one can easily see that the m inim um is at som e point in the interior of the m oduli space, but the brane has decayed into a pair of factorizable cycles. How ever, one can get stable con gurations in the interior of the m oduli space if one considers more than one factorizable brane. Exam ples of all the di erent types of behaviours w ill be constructed. Note that we have not im posed here the R-R tadpole cancellation conditions, although the dynam ics w ill not be a ected if we im pose them , as we w ill discuss later.

When Ramond-Ramond tadpole conditions are imposed, there are, in addition to the vacua where all branes annihilate, some specic vacua where the non-supersymmetric sectors decouple. A trivial example where this happens is that of a pair brane-antibrane at distant points in a compact space. If the distance is larger than the string scale there will be no tachyonic modes. The potential due to the NS-NS tadpoles is proportional to the inverse of the volume of the compact space, and arises from the sum over the winding modes. This means that the potential will be minimised when the volume etends to in nity and the two D-branes are very far from each other. That is what we already know: tadpoles appear in compact spaces, but when the volume goes to in nity its elect is like in a non-compact space. Of course, this is only a tree-level result and quantum corrections are expected. For example, at one-loop, there is an interaction between the pair due to the exchange of massless string excitations. Tree-level and one-loop interactions give two competing elects that can change the direction of the ow.

M oreover, this uncancelled tadpoles could have very interesting physical applications. For instance, the scalar potentials arising from dynam ical variations of internal com pacti – cation spaces (i.e. com plex structures) could be used as in aton potentials for cosm ological in ationary scenarios from strings [14].

In the follow ing sections we will give an introduction to com plex structures and m oduli spaces, in order to understand the classi cation of such scalar potentials. We will also give the necessary stability criteria that may help determ ine phenom enological consequences like in ation. The outline of the paper is the following: in Section 2 we give a general discussion of toroidal compactications; Sections 3, 4 and 5 discuss some remarkable cases for the two, four and six-dimensional tori, respectively. In the last two Sections we review the work of Moore [12], and give the stability criteria around the various critical points, as well as the general solution for the 6-dimensional torus.

#### 2. D iscussion of the models

#### 2.1 M oduli of com plex structures

Consider a the 2n-dimensional tori and de ne a holom orphic n-form  $_0$ , written as  $_0 = dz_1 \wedge ::: \wedge dz_n$ , where the complex coordinates z depend on real coordinates x and y as

 $dz_i = dx_i + i_j dy_i$ . The  $i_j$  are complex numbers that specify the complex structure of the manifold. The atmetric on the torus can be written in terms of the complex coordinates as  $ds^2 = dzdz$ , and the Kahler form is  $! = dz^{-} dz$ . The volume of the manifold can be written in terms of the  $_0$  form as:

O ne can always de ne a norm alised n-form such that its total volum e is norm alised to 1, i.e.  $e^{K=2}_{0}$ . The volum e (2.1) de nes a Kahler potential for the complex structure moduli, K =  $\ln(Vol)$ , and an induced Kahler metric,  $g_{IJ} = Q_I Q_J K$ , which norm alises the complex structure kinetic term s,

where I;J are coordinates in the complex structure moduli, the <sub>ij</sub> for instance. These kinetics terms are obtained from the reduction of the Hilbert-Einstein action on the particular manifold. The dependence on the dilaton comes from the closed-string tree-level amplitude.

#### 2.2 Description of the system

W e will consider only D 6-branes of Type IIA string theory,<sup>2</sup> wrapping 3-cycles on the 6-dim ensional com pact space, and expanding along the other 4-dim ensional M inkowski coordinates. The D 6-brane will try to m inim ise its volum e within the same hom ology class. D epending on the point on the moduli space, the D-brane system can be stable or unstable to the decay to other D-branes whose sum belongs to the same e class. The com plex structure m oduli will vary due to the potential of the NS-NS tadpoles, triggering di erent e ects along their evolution. This can be generalised to T-dual con gurations of Type I theory by including orientifold planes and the orientifold in ages of the branes. W e will brie y discuss this case in relation to the R-R tadpole conditions, but we will not analyse it in detail given the huge num ber of objects involved.

In this section wew ill review how to obtain these NS-NS tadpoles, the R-R tadpole cancellation conditions, the evolution of com plex structure modulidue to the NS-NS tadpoles, the possible decays of D-branes through the lines of marginal stability and a discussion about the stability of the critical points of the potential.

# 2.3 R-R Tadpoles

In order to obtain a consistent com pacti cation one has to impose the cancellation of all the R am ond R am ond tadpoles. In particular, they guarantee that the low energy chiral spectrum is anomaly free. These tadpole conditions tell us that the sum of the R R charges of all branes m ust be equal to zero in the case of Type IIA com pacti cations, or equal to

for Type IIA theory, and

$$a = q_0 \circ ; \qquad (2.4)$$

for the dual of Type I theory, where  $q_0$  is the R-R charge of the orientifold plane and  $_{0}$  is the cycle where it is wrapped. These conditions tell us that, whatever the combinations and decays of branes, the system must have a total R-R charge equal to zero (in the Type IIA case) or equal to  $q_0$  (in the T-dual of Type I).

In this paper we will analyse con gurations where the R-R tadpole conditions are not explicitly satis ed. Only in the last part of the paper we will comment about a way to cancel them by including other branes and antibranes.

The idea is to study the ows of the com plex structure elds in these systems for a sm all set of branes, extracting some general features, and then try to in pose these constraints in a more com plicated system where the number of branes is substantially increased and the analysis is not as straightforward. One can always consider adding to one of these simple models some branes, with the charges necessary to cancel the R-R tadpoles, but which are kept as spectators. For exam ple, if we put a brane in a cycle we can always put an antibrane in the same cycle<sup>3</sup> but at large distances from the brane so that they do not develop a tachyonic mode. The R-R tadpoles are immediately cancelled but the NS-NS are added, giving just a factor two in the potential for the com plex structure. The di erence will appear at one-loop in the open string description (D-brane interaction), but we only consider the disk (tree-level) term. Higher order terms will change the structure of the minima, as we will discuss later. Note that these conditions do not need to be imposed if there are some non-compact coordinates transverse to the branes, as happens in the dyonic black hole constructions of R ef. [15].

#### 2.4 NS-NS Tadpoles

Let us turn now to the more dynamical NS-NS tadpoles. These tadpoles can be written as the volume of the cycle where the D-brane is wrapped, divided by the squared root of the whole volume of the manifold. This can be obtained directly by identication of the tadpole from the cylinder amplitude. In the general case, one obtains these terms by integration of the D-brane action in the compact space. If the NS-NS tadpoles are not cancelled, potential terms will appear in the elective action.

W e will consider that each D-brane is volum e-m inim ising and that it preserves som e supersymmetry. In our particular case, this means that the brane is wrapping a special Lagrangian manifold. Then the modulus of the period where a BPS D-brane is living gives

its volume, and the NS-NS tadpole can be easily written as:

where a is the cycle on which the brane w raps. If there is more than one BPS brane the potential becomes  $\frac{7}{2}$

In the T-dual description of Type I theory one should also take into account the contribution from the  $2^{9 p}$  orientifold p-planes. Each of these planes has a tension and a R-R charge equal to  $2^{p 4}$  times the tension and the R-R charge of the brane (counting the orientifold in ages of the brane as independent). For the case of 0 6-planes, there are 8 of them, with a tension and R-R charge 4 times the brane's. That gives, independently of the dimension of the 0-planes, a contribution to the NS-NS tadpoles [5]:

The NS-NS tadpoles are always positive de nite. This is obvious for the Type IIA case, where the tadpoles are the sum of a set of positive real numbers, which means that for this case the absolute minimum of the potential will be the vacuum, a system where all the branes have been annihilated (like in the brane-antibrane case), or when the cycles where the D-branes are wrapped have degenerated to zero volume, in the boundary of moduli space. Indeed, as we will see, depending on the starting point, the system can evolve to the com plete absence of branes or tow ards points where the volume of the branes vanish.

For the T-dual picture of Type I theory one can easily prove that the NS-NS tadpoles,

are always positive de nite, by using the triangle inequality and the R-R tadpole conditions (2.4). This means that an absolute minimum of this con guration will occur when the periods of the branes have the same phases and the same charges as those of the orientifold plane, i.e. all the branes will try to be parallel to the orientifold plane R ef. [5]. The system will be supersymmetric in this case. Of course, another possibility, analogous to the one in the Type II case, is that in which the branes evolve to a system where some cycles can degenerate, or more complicated possibilities if bound states are considered. In this paper we will not analyse con gurations with orientifold planes, but is de nitely worth studying the extrapolation of our analysis to that case.

#### 2.5 The evolution of the com plex structure moduli elds

Here we will discuss the dynamics of the moduli elds. From the point of view of the elds four dimensional theory, the action for the complex structure moduli elds is of the form

This elective action has been obtained by dimensional reduction of the 10-dimensional one, where the total volume factors have been absorved in the redenitions of the elds. From this action, we will see that the complex structure moduli  $Z^{I}$  will evolve towards some critical points of the moduli space, which we will characterise below.

Since the variations of the complex structure moduli elds are area-preserving, the P lanck constant in the H ilbert-E instein term does not vary, and therefore the analysis of the stability of the critical points of these potentials V ( $;Z^{I}$ ) can be done in the  $Z^{I}$ , i.e. the <sub>ij</sub> coordinates. The stability criteria will not change under the rede nition of  $Z^{I}$ , needed for obtaining canonically norm alised kinetic terms in the Lagrangian (2.9), only the speed of approach to the critical points. Therefore, in all the gures below, we have drawn the potential V (; ) in the <sub>ij</sub> coordinates. We have also assumed that the dilaton is xed. Note that, when correctly norm alised, the tree-level potential will be proportional to the string coupling constant,  $g_s = e$ . Now, since this potential is always positive, the dilaton will evolve towards weak coupling.

#### 2.6 Lines of m arginal stability

Two branes that are intersecting can have tachyonic modes in the spectrum of open string excitations between them. The presence of tachyons is related to the possibility of the decay of the system to another one with the same charges but with a lower volume. Locally these intersecting branes can be seen as two planes. Depending on the dimension of these planes, they can minim ise their area [16, 17]. Som ething similar happens in general Calabi-Yau's where branes can decay to more stable systems by changing their complex structure [18]. This is a geometrical condition known as the angle criterion [16], that coincides with the computation of the lowest string mode in the NS-NS sector. For every pair of branes intersecting at a point one can de ne som e angles follow ing the procedure given in R efs. [19, 16]. This procedure gives m angles for m-dimensional planes intersecting at a point in a 2m-dimensional space. These angles are called characteristic angles.

W e will brie y describe here the six-dim ensional toroidal case for factorizable branes. See also R efs. [3, 10]. There are 4 scalar elds that can become tachyonic, with m asses,

where the angles  $_{1} 2$  [0; ]. The above masses are related to stability conditions for the pair of branes. If there is no tachyon (notice that only one of the scalar elds can be tachyonic at a time) the two brane system is stable, made of two BPS branes breaking all the supersymmetries. If one of the scalars becomes massless then the system becomes supersymmetric, with the number of supersymmetries related to the number of scalar elds that become massless at the same time. These conditions can be represented in a three dimensional gure in the angle space.<sup>4</sup> The conditions bound a tetrahedron where the

di erent regions are split into:

N on-supersymm etric and non-tachyonic (inside the tetrahedron),

N = 1 supersymmetric (faces of the tetrahedron),

N = 2 supersym m etric (edges of the tetrahedron),

N = 4 supersymmetric (vertices of the tetrahedron),

N on-supersymm etric and tachyonic (outside the tetrahedron).



Lower dimensional cases can be derived from this one by taking one (four-dimensional torus) or two (two-dimensional torus) angles to zero. In the two-dimensional case the sys-

tem is always tachyonic, signalling the instability of the system to the decay to a lower volume brane. In the four-dimensional case, the system can be supersymmetric or unstable, without the possibility of getting a conguration of two branes that can be volume minimising.

### 2.7 Critical points

In the 2-dimensional case, the minima of the potential (2.6) can be studied directly. In the 4-dimensional case, most of the congurations can also be analysed directly. The most interesting case is the 6-dimensional torus. A swe have already mentioned, the stable points of the NS-NS potential coincide with the nalpoints of the ow of the attractor equations considered in Refs. [15, 13, 12]. We will follow the analysis of these equations done by Moore in Ref. [12].

In particular, in a 6-dimensional space, M oore shows that if  $\frac{1}{2}$  (z) j has a stationary point in z () 2 M with  $\frac{1}{2}$  (z)  $j \in 0$  then the 3-form dual to the cycle can be decomposed as  $= {}^{3,0} + {}^{0,3}$ . This stationary point, if it is in the interior of the complex structure moduli space, it must be a local minimum. Then, at the critical point,  ${}^{3,0}$  should be proportional to the form, up to a phase,  ${}^{3,0} = iC$ , where C is a complex number. Since 2 H  ${}^{3}$ (X;Z), then  ${}^{0,3} = iC$ . The splitting condition above thus translates into

Choosing a sym plectic basis for H<sup>3</sup>(X;Z), with internal product  $(_{I}; ^{J}) = {}^{R}_{I} {}^{A} = {}^{J}_{I}$ , we can write the cycle  $= p^{I}_{I} q_{J}^{J}$ , where the coe cients  $p_{I};q_{J}$  are integers. The form can be written as  $= X^{I}_{I} + F_{J}^{J}$ , and the splitting condition becomes

where X<sup>I</sup> and F<sup>I</sup> are the periods along the  $_{I}$  and  $^{I}$  cycles, respectively, X<sup>I</sup> =  $_{R}^{K}$  =  $_{R}^{I}$ . These are  $b_{3}$  equations for  $b_{3}$  real variables (where  $b_{3}$  is the dimension number of H<sup>3</sup>(X;R)), so we can expect the solutions to be isolated points in the complex structure moduli space.

## 3. The two-dim ensional torus

In the case of two-dimensional tori, the special Lagrangian submanifolds are straight lines in the covering space of the torus. There is one for each homology class fn[a] + m [b]g. The moduli of these curves is M = R and correspond to translations in the transverse directions to the branes. They can be complexied if W ilson lines are taken into account, see for instance R ef. [13].

In this case, the holom orphic 1-form is  $_0 = dz$ , where dz = dx + dy, and Im > 0. The metric on the torus is  $ds^2 = dzdz$  and the Kahler form is  $! = dz^{-} dz$ . The volume of the torus then becomes Z

The K ahler potential for the complex structures is then  $K = \ln(Vol) = \ln(Im)$ . The K ahler metric in the half plane of complex structures becomes

which has the interpretation of the volum e of the cycle relative to the square root of the volum e of the whole torus.

The potential obtained from the NS-NS tadpoles is related to the periods of the brane w rapping the cycle by Eq. (2.5). In this case we have

In the two-dimensional torus we can distinguish two cases:

if m = 0, i.e. a brane only wrapping the [a] cycle, the minimum is at Im ! 1, see Fig. 2.

ifm & O the minimum is at ! n=m, a real num ber, see Fig. 3.

In both cases the system is driven by this potential to the boundary of the com plex structure m oduli space, where the volum e of the cycle where the brane is w rapped goes to zero. The brane is stable against decays into other type of branes.

The Lagrangian for the com plex structure m oduli is of the form

By performing a T-duality along the (1;0) direction one can understand this ow as the one responsible for the contraction of the manifold to a point when the D-brane wraps the whole manifold, or its expansion, when T-duality takes the brane to a lower dimensional one, as already mentioned in the introduction.

#### 4. The four-dim ensional torus

In this case, the holom orphic 2-form of the 4-dimensional torus is  $_0 = dz_1 \wedge dz_2$ , where  $dz_i = dx_i + _{ij}dy_i$  and  $_{ij}$  is a 2x2 complex matrix that characterises the complex structure of the torus. The metric on the torus is  $ds^2 = _{i}^{P} dz_i dz_i$ , and the Kahler form,  $! = _{i}^{P} dz_i \wedge dz_i$ . The volume of the torus becomes

The Kahler potential for the complex structures is as usual,  $K = \ln(Vol)$ . The Kahler metric in the plane of complex structures,  $g_{ij} = 0_i 0_j K$ . The normalised 2-form becomes

Now we have the 2-cycles dual to the form s dx<sup>1</sup> ^ dx<sup>2</sup>, dx<sup>i</sup> ^ dy<sup>j</sup>, dy<sup>1</sup> ^ dy<sup>2</sup> that form a basis of H <sup>2</sup>(X ; R). Let us denote the wrapping num bers along these cycles by  $q_{0}$ ,  $q_{ij}$ ,  $q_{0}$ . The periods of the cycles where the branes are wrapped are given by

Note that in this case we are in a point in the complex structure moduli space where some cycles have zero volume, those with coordinates  $q_{12}$  and  $q_{21}$ . Now let us consider the following subcases:

a.1) If the cycle is also factorizable into two 1-cycles, each one wrapping a two-dimensional torus, then we can denote these 1-cycles by  $(r_1;s_1)$  and  $(r_2;s_2)$ . The potential is now

The problem of analysing this potential reduces to that of the two-dimensional torus. The system is then driven to the boundaries of the complex structure moduli where the 1-cycles collapse.

a.2) We do not consider the cycle factorizable but we keep the same complex structure in both two-dimensional tori, i.e.  $_1 = _2 =$ . Let us de neq  $q_{11} + q_{22}$ . Then the potential becomes

The behaviour of this potential is determ ined by the sign of the discrim inant,  $= q^2 4q_0q_0$ , of the polynom ial:

The dierent cases are:

a.2.i) If > 0, then the two roots are real and are at the boundary. The minimum is in a line joining the two roots. The value of the minimum of the potential is di erent from zero,  $V_0() = e = q_0^2$ . See Figs. 6 and 7. Note that the factorizable cycle cases are of this type.

a.2.ii) If = 0, then the two roots are real and coincide. The minimum is at the root, in the boundary. The value of the minimum of the potential is at zero. See Figs. 8 and 9.

a.2.iii) If < 0, then the two roots are complex conjugates. The minimum is at the root, in the interior of the moduli space of complex structures. The value of the minimum of the potential is at zero. Following the analysis of M oore [12], it seems that there is no BPS state at this point. We will see in some specie cexam ples that this is indeed the case. When < 0 the system will cross a line of marginal stability and the brane is expected to decay into another system. Note that this will never be the case when the cycle is factorizable. See Figs. 10 and 11. We will analyse examples of line-crossing in the more interesting case of 6-dimensions.

b) The general case in which the complex structure part of the metric does factorise will not be analysed here. Naive extrapolation from the 6-dimendional analysis ( $T^6 = T^4 T^2$ ) indicates that the system is driven to the boundary ( = 0). This was expected, since there is a 2-dimensional torus that has always this behaviour.

#### 5. The six-dim ensional torus

The w rapping num bers along these cycles are  $q_0$ ,  $Q_{ij}$ ,  $P^{ij}$ ,  $p^0$ , respectively. And the periods of the cycles where the branes are w rapped can be written as

a.1) If the cycle is also factorizable into two 1-cycles, each one wrapping a two dimensional torus. Let us denote these 1-cycles by  $(r_1;s_1)(r_2;s_2)(r_3;s_3)$ . The potential is now :

The problem of analysing this potential reduces to the two dimensional torus problem. The system is then driven to the boundaries of the complex structure moduli where the 1-cycles collapse.

a.2) We do not consider a factorizable cycle, but we keep the same complex structure in all two-dimensional tori, i.e.  $_{i}$  = . Let us de ne 3q  $_{i}Q_{ii}$  and 3p  $_{i}P^{ii}$ . Then the potential becomes

The behaviour of this potential is determ ined by the sign of the discrim inant, =  $12p^2q^2$ (3pq +  $p^0q_0$ )<sup>2</sup> + 4( $p^0q^3$  =  $q_0p^3$ ), of the polynom ial:

The discrim inant gives the number and the type of solutions to p(). As in the four dimensional case, there are 3 subcases:

a.2.i) if > 0, there are three real roots, all di erent. The minimum is in the interior of the complex structure moduli space. The minimum of the potential is not vanishing. Following the interpretation of M core [12], this means that the corresponding BPS state must exist. See Figs. 12 and 13. Note that this possibility can be achieved with a factorizable cycle. The analysis seems to be in contradiction with the case a.1). But now we are doing a partial analysis by considering all the complex structures equivalent.

However one can get this kind of con gurations by taking three factorizables cycles. For example, take (1;0)(1;0)(1;0), (0; 1)(0;1)(0;1) and (1;1)(1;1)(1;1). We will see this example in detail in the last section.

a.2.ii) if = 0, there are three real roots, but two of them are equal. The minimum is at the boundary. The potential goes to zero at that point in the boundary. See Figs. 14 and 15. Notice that this possibility can be achieved with a factorizable cycle.

a.2.iii) if < 0, there is one real root and two complex conjugates. The minimum is in the interior of the complex structure moduli. The potential goes to zero at that point. See Figs. 16 and 17. Note that this possibility cannot be achieved with a factorizable

cycle. Following M oore we can suspect that the BPS state does not exist. One interesting case when precisely this happens is if we take the combination of two factorizable cycles: (1;0)(1;0)(1;0) and (0;1)(0;1)(0;1). It is easy to check that the minimum is when the two states do not form a bound state. The minimum is at = i, where the two branes have angles  $_i = =2$ , i.e. at the centre of the tetrahedron de ned by the masses of the scalars that can become tachyons, see Fig. 1. They cannot decay into a bound state.

b) If the metric is factorisable in two tori, one 4-dimensional, the other 2-dimensional,  $T^6 = T^4 - T^2$ , we recover the previous lower-dimensional cases, and the system will be driven to the boundary. An speci c example of this behaviour is to consider that the 3-cycles are factorised into 2-cycles wrapping the 4-dimensional torus and only 1-cycle in the 2-dimensional torus. Then, from the general analysis to be discussed below, one can see that = 0.

c) If the metric cannot be factorised. In this case we have to study the general solution, as described in Ref. [12]. A swe have seen above, the central charge can be taken to be in this case

Let us now compare with the factorizable cycles we are familiar with. Consider generically three 1-cycles  $(n_1; m_1)(n_2; m_2)(n_3; m_3)$ . Then

It is easy to check that in this case, D = 0 and det R = 0, so there is no solution inside the complex structure moduli space, but only at the boundaries. This agrees with the previous results that for factorizable cycles the minimum of the potential is at the boundary.

Let us now consider the sum of the (1;0)(1;0)(1;0) and (0;1)(0;1)(0;1) cycles. In this case q = p = 1, and Q = P = 0. Then D = 1 is a negative number, which indicates that the bound state will decay into two states. It is easy to prove that for a pair a factorizable branes D = I, where I is the number of intersections between the two branes, a topological number. Then we can say that the bound state of two branes is always unstable and will decay to a two brane system. If the com plex structure is factorizable one can easily check that this happens when the angles are (=2; =2; =2), i.e. at the centre of the tetrahedron of Fig. 1. The proof is easy, applying SL  $(2;ZZ)^3$  transform ations one can take a general two brane factorizable con guration to a : (1;0)(1;0)(1;0) and  $b: (n_1;m_1)(n_2;m_2)(n_3;m_3)$ . The minimum, as we have said, will be a two-state system. Then the potential is proportional to the sum of the norm s of the periods on these cycles. If the com plex structure is factorizable, the minimum will be at:

The angles  $_{i}$  are de ned through

such that at the factorizable m in in um they all become i = -2. The potential at the m in in um is precisely  $V_0 = 2e$   $\overline{jIj}$ .

Note that by adding more factorizable branes we will never recover a general cycle because  $Q_{ij} = P_{ij} = 0$ , for if j. That is, factorizable cycles only span diagonal Q and P m atrices.

A nother very interesting example is the following: Three factorizable cycles:

(1;0)(1;0)(1;0), (0; 1)(0;1)(0;1) and (1;1)(1;1)(1;1) com bine into a general cycle:  $q_0 = p_0 = 0, Q = P = 1$ . Following the same procedure, one can see that D = 3 > 0, such that the initial brane con guration decays to the com bined system in the minimum. The minimum has a complex structure  $= (\frac{1}{2} + i\frac{-3}{4})11$ . See Fig. 18, where the potential is plotted keeping the complex structure diagonal and equal for the two dimensional tori. The value of the potential at the minimum is, as expected,  $V_0() = e^{\frac{p}{3}}$ .

# 6. Stabilising com plex structure m oduli. Exam ples.

In the above examples we have seen di erent types of behaviours. The evolution of the complex structure elds can drive them to the boundary of the moduli space, to a point in the interior of the moduli space, or can make the brane system to decay by crossing lines of marginal stability. We will described these three very distinct behaviours in this section, with speci c examples.

# 6.1 At the boundary

The simplest example one can construct with this kind of behaviour is a brane wrapping a (0;1) cycle in a two dimensional torus. To cancel the Ram ond-Ram ond tadpoles one can put an antibrane on the same cycle but far away from the other in such a way that

there is no tachyonic mode between them . Of course, the one-loop corrections in the open string description (tree-level in the closed string) will make these two branes approach one another. However, at large distances it is su cient to analyse only the tree-level potential. W ithin this aproximation, we not that the elective scalar potential is of the form

The m inim um of this potential is at ! 0, i.e. at the boundary. Since there is one brane that is always m inim ising the volume, the D-brane will never decay to another system, but the brane and antibrane will separate, while the area is kept xed.

A nalogously, a brane w rapping a (1;0) cycle and an antibrane w rapping the same cycle in the opposite side of the torus will cancel the R-R tadpoles and produce a potential of the form

M in imisation of this potential drives the brane to  $Im \ ! \ 1$ , which means that the two branes will separate and the tachyon will never appear.

This is a very interesting behaviour that contrasts with the one-loop correction responsible for the interaction between the two branes. By adding this interaction, we nd two competing e ects: NS-NS tadpoles will take branes far apart from eachother, while the D-brane interaction will bring them closer and closer. There is a limiting case in which the two D-branes are just in opposite places in the compact space. The one-loop e ect is vanishing (it is a critical but unstable point) and the two branes will separate, never decaying into the vacuum. A lternatively, one can in agine the branes at a distance such that the two e ects compensate eachother: the NS-NS tadpole potential, at tree-level, being m om entarily cancelled by the one-loop interaction. An interesting physical application of this unstable equilibrium is precisely that which m ay drive a relatively long period of in ation [14].

#### 6.2 At a point in the interior

The simplest system with this kind of behaviour is a six-dimensional torus with a bound state of two D 6-branes, (1;0)(1;0)(1;0) and (0;1)(0;1)(0;1). A swe have seen in the previous section, the minimum is at the interior of the complex structure moduli space, where the bound state has decayed to the two-brane system. This system is T-dual to a D 9 D 3-brane system.

A nother system , described above, is the bound state of D 6-branes: (1;0)(1;0)(1;0), (0; 1)(0;1)(0;1) and (1;1)(1;1)(1;1). In this case the bound state is stable in them inim um of the potential. Of course, this system does not satisfy the R am ond-R am ond tadpole conditions. However, we can always put an antibrane w rapped on the same cycle, but far away in the com pact space, as we have already discussed above.

#### 7. Conclusions and applications

In this paper we have applied som e previous results of M oore [12], derived in the context of BPS quantum black holes, to the analysis of stability of the critical points of the scalar potential due to the NS-NS tadpoles in the context of non-supersymmetric toroidal com pacti cations, when supersymmetry is broken by the presence of the D-branes. By studying the structure of the potential for some set of branes we have found that the minim a can be located at the boundary or at a point in the interior of the com plex structure moduli space. Yet another possibility is that, in the evolution to the minimum, the system decay to another one, across lines of marginal stability.

As we have seen in the last section, som etim as the minimum of the potential is not in the vacuum for Type II strings as one would expect, but at a point where the nonsupersymmetric spectra decouple. This is analogous to a system of D-branes located at far away points in the compactied space, as in the example mentioned in the introduction. NS-NS tadpoles induce a potential that drives the system to the decompactication limit. That is the usual runaway behaviour for non-supersymmetric compactications.

It is also interesting to analyse how the ow is corrected by higher loop e ects. For instance, the interaction between two branes due to the exchange of closed string modes is a one-loop e ect (in the open string description) and can change drastically the behaviour of the system . One can imagine some points where the attraction of a brane-antibrane system (a one loop e ect) is compensated by the disk potential (the NS-NS tadpole). This competing e ects can have very interesting applications for cosm ological scenarios, see for instance R efs. [14].

Som e studies for factorizable cycles and m etric have been carried out recently for the Type 0' in R ef. [7], where the system seems to be driven to a point in the interior of the com plex structure m oduli space and for Type I string theory in R ef. [5]. It would be very interesting to analyse the general structure of the m inim a, i.e. for non-factorisable cycles and m etrics, within the context of non-supersymm etric strings and also for the Type I, where som e com plex m oduli elds are projected out by the orientifold projection.
