The supernova associated with GRB 020405

A bstract. We use the very simple and successful Cannonball (CB) m odel of gam m a ray bursts (GRBs) and their afterglows (AGs) to analyze the observations of the m ibly extinct optical AG of the relatively nearby GRB 020405. We show that GRB 020405 was associated with a 1998bw-like supernova (SN) at the GRB's redshift that appeared dimmer and redder than SN 1998bw because of extinction in the host and our Galaxy. The case for the SN/GRB association | advocated in the CB model| is becoming indubitable. We discuss the extent to which the GRB/SN connection is model-dependent.

1. Introduction

In the Cannonball M odel of GRBs (Dar and De Rujula 2000, brie y reviewed in De Rujula 2002ab) long duration GRBs are produced by highly relativistic jetted plasm oids (cannonballs) in core-collapse supernovae akin to SN 1998bw (D ar and P laga 1999; D ar 1999a; D ar and DeRujila 2000 and references therein). Possible evidence for an SN 1998bw-like contribution to a GRB afterglow (D ar 1999a; C astro-T irado & G orosabel 1999) was rst reported by B loom et al. (1999) for GRB 980326, but its unknown redshift prevented a categorical conclusion. The AG of GRB 970228 (at a redshift $z = 0.695$) appears to be overtaken by a light curve akin to that of SN 1998bw (at $z_{bw} = 0.0085$), when properly scaled by their diering redshifts (D ar 1999b; R eichart 1999; G alam a et al. 2000). Evidence of a similar associations was found for GRB 000418 (D ar and D e R u jula 2000; D ado et al. 2002a), G R B 980703 (Holland et al. 2000), GRB 991208 (Castro-Tirado et al. 2001), GRB 990712 (B pmsson et al. 2001), GRB 970508 (Sokolov et al. 2001), GRB 000911 (Lazzati et al. 2001; D ado et al. 2002b), G R B 010921 (D ado et al. 2002c) and GRB 011121 (B bom et al. 2002a; D ado et al. 2002d). In the CB m odel, even the very nearby GRB 980425 and its associated SN (1998bw) are \nomal": only the low redshift and relatively large view ing angle are unique (D ar and De Rujula 2000, Dado et al. 2002e).

Unlike supemovae of type Ia (SN e Ia), core-collapse supernovae (SN e II/Ib/Ic) are far from being standard candles. But if their ejecta are fairly asymmetric | as they would be if a fair fraction of them em it two opposite jets of cannonballs | m uch of the diversity could be due to the varying angles from which we see their non-spherically expanding shells. Exploiting this possibility to its extreme, ie., using SN 1998bw as an ansatz standard candle, D ar and DeRujila (2000) and Dado et al. (2002a) have shown that the optical AG of all relatively nearby GRBs with known redshift (all G RBswith $z < 1.12$) contain evidence or clear hints for an SN 1998bw-like contribution to their opticalAG, suggesting that m ost | and perhaps all of the long duration GRBs are associated with 1998bw-like supemovae (in the more distant GRBs, the ansatz standard candle could not be seen, and it was not seen). In several of the above cases, how ever, scarcity of data, lack of spectral inform ation and multicolour photom etry and the uncertain extinction in the host galaxy prevented a m conclusion. Thus, every new instance is still interesting, it m ight take a few more clear cases to reach a generally accepted conclusion.

On 2002 April 5.028773 UT the long duration (40s) GRB 020405 was detected and localized by U lysses, M ars Odyssey - HEND, and BeppoSAX (Hurley et al. 2002). Its optical AG was rst detected in the R-band, 17.5 h after the burst (Price et al. 2002a) and its fading was followed in the I, R, V and B bands (Castro-T irado et al. 2002; Palazzi et al. 2002; H prth et al. 2002a, b; P rice et al. 2002b; Gal-Yam et al. 2002; Covino et al. 2002a, b,c; B ersier et al. 2002). Its redshift, $z = 0.69$, was determined (M asettiet al. 2002, P rice et al. 2002c) from em ission lines of its likely host galaxy. The optical AG was well tted by a t^{1:72} power-law decay, but the late time R-band m easurem ents with the M agellanic 6.5m B aade telescope, on April 18th, and with the 100" du Pont telescope at Las Cam panas, on M ay 3rd, lie signi cantly above the powerlaw extrapolation (Bersier et al. 2002).

The late time AG of GRB 020405 was observed with HST at severalepochs spanning 19-31 days after the GRB and, to rem ove the host contribution, two m onths after the GRB (Price et al. 2002d). An excess of ux was found

in the HST im ages, com pared to an extrapolation of the light-curve from early times and was identied as a SN associated with GRB 020405, redder than a SN 1998bw displaced to $z = 0.69$, and dim m er than this ansatz by about one halfm agnitude (Price et al. 2002d).

In this letter we use the C annonball M odel to estim ate the extinction in the host galaxy of GRB 020405, and to predict the late time optical AG. We show that the evidence from H ST is clear:G R B 020405 was indeed associated w ith a standard-candle 1998bw-like supernova at $z = 0.69$, appearing som ew hat dim m er and redder just because of the extinction in the host galaxy and in ours.

2.T he C B m odel

In the CB m odel, long-duration GRBs and their AGs are produced in core collapseSN e by jetsofhighly relativistic \cannonballs" that pierce through the SN shell. C rossing this shell with a large Lorentz factor $\,$, the surface of a CB is collisionally heated to keV tem peratures and the radiation it em its w hen it reaches the transparent outskirts of the shell | boosted and collim ated by the CB's m otion| isa single -ray pulse in a G R B.T he cadence of pulses re
ects the chaotic accretion processes and is not predictable, but the individual-pulse tem poral and spectral properties are. A long list of general properties (D ar and De Rujula 2001) of GRB pulses is reproduced in the CB -m odel, in w hich, unlike in the standard \backslash reball" m odels (for a review, see, e.g.G hisellini 2001) the GRBs' 's have a therm al | as opposed to synchrotron| origin.

A CB exiting a SN shell soon becom es transparent to its own enclosed radiation. At that point, it is stillexpanding and cooling adiabatically and by brem sstrahlung.T he brem ss spectrum is hard and dom inates the very early X-ray AG (for a m inute or two) with a uence of predictablem agnitude decreasing with time as t⁵ untilsynchrotron em ission from the ISM electrons that enter the CB takes over. A ll X-ray AG s are compatible in m agnitude and shape with this prediction (D ar and D e Rujula 2002a) for the very early AG, for which, as far as we know, there is no standard (reball-model) counterpart. T he opticalA G s for w hich the data also start very early after the GRB show an early decline / t^{-2} . This initial decline is produced when the CB is plowing through a $r²$ density-pro le of the \w ind" from the SN progenitor (D ado et al. 2002a). In the reball m odels, the absence of $\wedge w$ indy" signatures is a problem : of the score of

observed cases,only onehas\clearevidencefora w ind-fed circum burstm edium " (Price et al.2002).

In the CB m odel the AG s observed at later tim es have three origins: the ejected CBs, the concom itant SN explosion, and the host galaxy. These com ponents are usually unresolved in them easured \G R B afterglow s", so that the corresponding light curves and spectra are the cum ulative energy ux density $F_{AG} = F_{CBs} + F_{SN} + F_{HG}$. The contribution of the host galaxy (HG) is usually determ ined by

late tim e observationsw hen the C B and SN contributions becom e negligible.

Let the energy
ux density of SN 1998bw at redshift $z_{bw} = 0.0085$ (G alam a et al. 1998) be F_{bw} [;t]. For a sim ilar SN placed at a redshift z:

where A ($;z$) is the attenuation along the line of sight and D_L (z) is the lum inosity distance (we use a cosm ology w ith $M_{\text{M}} = 0:3$, $= 0:7$ and $H_0 = 65$ km /s/M pc).

In its rest fram e the optical AG of a CB is given by:

w here f is a norm alization constant (see D ado et al. 2002e for its theoretical estimate), (t) is the Lorentz factor of the CB, $p = 2:2$ is the spectral index of the radiating electrons in the CB and $_b$ is the \injection bend" frequency. For an interstellar density n_p :

The theoreticalm otivation, as well as the excellent observational support for this \bend", are discussed in D ado et al.(2002e).A n observer in the G R B progenitor's rest system, view ing a CB at an angle, sees its radiation D oppler-boosted by a factor :

where the approxim ation is valid in the dom ain of interest for G R B s: large and sm all . The cannonballs' A G spectral energy density $\mathbf{F}^{\text{obs}}_{\texttt{CB}}$ seen by a cosm ological observer at a redshift z (D ar and D e R u jula, 2000), is:

where $_0 = (0)$, and x_1 $_{\textrm{m ax}}^2$ n_p) characterizes the C B's slow -down in term s of $N_{C B}$: its baryon num ber, and R_{max} : its radius (it takes a distance $x_1 = 0$ for the CB to half its original Lorentz factor).

The selective extinction, A (;t) in Eq. (1), can be estim ated from the dierence between the observed spectral index at very early tim e when the CBs are stillnear the

SN and that expected in the absence of extinction. Indeed, the CB m odelpredicts | and the data con m with precision | the gradual evolution of the eective optical spectralindex towards the constant value 1:1 observed in all\late" A G s(D ado etal.2002a).T he \late" index is independent of the attenuation in the host galaxy, since at $t > 1$ (observer's) days after the explosion, the CBs are typically already m oving in the low colum n density, optically transparent halo of the host galaxy.

The comparison of the predictions of Eq. (5) w ith the observations of optical and X-ray AG light curves and of broad-band spectra isdiscussed in D ado etal.(2002a and 2002e, respectively). The results | for all G R B s of know n redshift| involve a total of only ve param eters, and are very satisfactory. The CB-m odel results concerning X-ray lines in GRB AG sare also exceptionally predictive, simple and encouraging (D ado et al. 2002f).

3.G R B 020405 in the C B m odel

 W e have rst tted the CB-m odel predictions to the B, V, R and I light curves of the AG of GRB 020405, as observed during the rst 5 days after burst. In using Eq. [\(2\)](#page-1-0), we assumed an electron spectral index $p = 2:2$, com patible with that of all other GRB AGs (Dado et al. 2002a). The tted param eters are: $_0 = 645$, = 0:42 m rad, and $x_1 = 0.31$ M pc. A fter correcting for selective extinction in our G alaxy $(E(B \t V) = 0.054$ m ag towards GRB 020405; Schlegel et al. 1998), Bersier et al.(2002) found that the broad band BV R I spectrum of the AG , 1.3 days after the burst, had a spectral shape Fobs $1:43$ 0:08. In the CB m odel, the unextinct spectral index in optical and nearby frequencies evolves from

0.5 to 1:1, as the injection bend frequency of Eq. (3) (3) dim inishes with time. At the time of these observations, our t to the AG time-evolution results in a predicted index $0:8$ 0:1. If the dierence with the observed index is due to selective extinction in the host galaxy, then E (B V) = 0:24 0:05 and the attenuation factors in the I, R, V and B bands (e.g., W hittet 1992) are, respectively, A (;z) 0:58;0:50;0:42 and 0:34. These attenuations, together with the G alactic extinction, were used to dim the contribution to the AG of a SN 1998bw-like supernova at the redshift of GRB 020405. The resulting late-time I, R , V and B light curves are presented in F ig. (1).

T he agreem ent between theory and observations in Fig. (1) is surprisingly good, in view of the large observational uncertainties and the theoretical approximations. The presence of an SN 1998bw-like signal is completely convincing. W ith our consistent estim ate of extinction in the host galaxy, the underlying SN is indistinguishable, w ithin errors, from a standard candle SN 1998bw.

4.T he G R B /SN association in various m odels

In the CB m odel, GRBs are associated with SNe. The m odel is so sim ple and predictive that it allowed us to use, in the case of GRB 011121, the rst 2 days of R band data to t the param eters describing the CBs' contribution to the AG. These tted param eters were used to predict explicitly the AG evolution and that the SN will tower in all bands over the CB's declining light curve at day 30 after burst (D ado et al. 2001). The comparison w ith the data, gathered later, vindicated the presence of a SN 1998bw-like signal (D ado et al. 2002d), as in G R B 020405 and all the other cases for w hich the SN was, in practice,detectable (D ado et al.2002a).To w hat extent is the GRB/SN association model-dependent?

T here are other m odels that link long-duration G R Bs w ith SN explosions: the hypernova m odel (Paczynski 1998), the collapsarm odel (W oosley 1993) the supranova m odel (V ietriand Stella 1998) and the currently favoured conical jet m odels (see, e.g. R ossiet al. 2002, Zhang and M eszaros 2002, Salm onson and G alam a 2002, G ranot et al. 2002), in w hich the authors depart from the earlier view that it is a good approxim ation (R hoades,1999) to consider conical jets of various opening angles, pointing exactly to the observer, and having a uniform Lorentz factor (in the CB model the viewing angle is the only

one that m atters, and there is no need to introduce η ist pro les" of varying rapidity). A common feature of all these models is that they are not su ciently specic to repeat the CB-m odel exercise of the previous paragraph. In the jetted models, for instance, the AGs (unlike the sm oothly-varying data) have \breaks". The early data on GRB 011121 do not tell w here the break \is": they cannot be extrapolated.

In the CB model, the exceptionally close-by GRB 980425 ($z = 0.0085$) and its associated SN 1998bw are not intrinsically exceptional. Because it was viewed at an exceptionally large angle (8 m rad), the GRB's -ray uence was comparable to that of m ore distant ones, viewed 1 m rad. That is why its opticalAG wasdom inated $a⁺$ by the SN, except, perhaps, for the last measured point (Dar and DeRujila 2000). The X-ray AG is also of \normal" magnitude, it is not emitted by the SN; its tted param eters allowed us to predict successfully the magnitude of the cited last optical point (D ado et al. 2002a). The norm alization, time and frequency dependence of the radio AG of this GRB are also \nom al", and due to the CB, not the SN (D ado et al. 2002e). SN 1998bw, deprived of its \abnom al" X -ray and radio em issions (which it did notem it!), loses most of its \peculiarity". G iven that GRB 980425 and SN 1998bw are not exceptional, the use of this SN as a standard candle to look for in other AG s (D ar 1999b) is, in the CB m odel, entirely natural. The surprise is how well this ansatz works (D ado et al. 2002a).

In the hypemova and collapsarm odels the parent star is supposed to be exceptionally m assive. In the supranova model, it must have exploded months before the GRB em ission. M oreover, in these m odels, and in the currently favoured ptted models, GRB 980425 stands in a class by itself. Thus, there is every reason not to expect its associated SN (1998bw) to be similar to the SNe associated with other GRBs. In the CB model | and in the data | the opposite is true.

5.Conclusion

In D ar and D eR u μ la (2000) we argued that long-duration GRBsm ay all be associated with 1998bw-like supemovae, and that the apparent variability of core-collapse SN em ay to a large extent be due to a spread of view ing angles, relative to the CB-em ission axis. In Dado et al. (2002a) we showed how surprisingly successful the ansatz of an associated supernova identical to 1998bw was, when confronted with the observations for optical and X-ray AG s. The AGs of some GRBs discovered after these quoted works | GRB 000911 (Dado et al. 2002b), GRB 010921 (D ado et al. 2002c), GRB 011121 (D ado et al. 2002d) and GRB 020405, discussed here| strengthen the conclusion: so far, in all AGs in which a SN like SN 1998bw could be seen (in practice, in the cases with redshift $z < 1:12$), it was seen, and it was compatible in magnitude and colour w ith an SN 1998bw standard-candle!

It goes w ithout saying that there are no standard candles. It is just that the current data are not precise enough to detect signi cant deviations. But the important fact is that the SN 1998bw-like supernovae allegedly associated w ith all long-duration GRBs (D ado et al. 2002a, and references therein) happen to be there.
