# Lattice Perturbation T heory in N oncom m utative G eom etry and Parity A nom aly in 3D N oncom m utative Q ED

A bstract:W e form ulate lattice perturbation theory for gauge theories in noncom m utative geom etry. We apply it to three-dim ensional noncom mutative QED and calculate the e ective action induced by D irac ferm ions. In particular \parity invariance" of a m assless theory receives an anom aly expressed by the noncom mutative C hern-S in ons action. The  $\infty$ e cient of the anom aly is labelled by an integer depending on the lattice action, w hich is a noncom m utative counterpart of the phenom enon know n in the com m utative theory. The parity anom aly can also be obtained using G insparg-W ilson ferm ions, where them asslessness is quaranteed at nite lattice spacing. This suggests a natural de nition of the lattice-regularized Chern-Sim ons theory on a noncommutative torus, which could enable nonperturbative studies of quantum H all system s.

# 1. Introduction

Quantum eld theory on noncommutative spaces has been a subject of much activity in recent years (see [1, 2] for comprehensive reviews). This attention was originally triggered by its intimate relationship with string theory, but the study of noncommutative eld theories has interest in its own. From a m athem atical physics point of view they provide uswith a class of nonlocal quantum eld theories which nonetheless seem to be well de ned. A lso, since noncommutative eld theories are essentially theories of dipoles [3] they can be also useful in the analysis of system swith dipolar excitations in condensed matter physics.

In this context, noncomm utative Chem-Simons (NCCS) theory in  $(2 + 1)$ -dim ensions is specially appealing because of its applications to quantum  $H$  all system s  $[4, 5]$ . Here the noncom mutativity is introduced only in the spatial direction and the resulting deform ation of the ordinary gauge invariance into \star-gauge invariance" is essential for the description of the system which has the area preserving dieom orphism invariance [4]. Rem arkably, a

nite-N m atrix m odel of N C C S theory is found to have physical states which have one-toone correspondence w ith Laughlin-type wave functions [6]. It has also been pointed out that instabilities of the NCCS theory can describe the transition to the W igner crystal, where spontaneous breakdow n of translational invariance is caused by the noncom m utativity [7].

In studying noncom mutative eld theories it is often useful to consider its matrixm odel description. This is rem iniscent of its string/M -theoretic connections  $[8, 9]$ . Here the space-tim e degrees of freedom and the internal (\color") degrees of freedom are treated on equal footing, and  $\star$ -gauge invariance" is simply described by the global U(1) sym m etry w hich acts on them atrix indices. Them atrix m odeldescription is also useful for regularizing noncom m utative eld theories  $[9, 10, 11, 12, 13]$ , since nite-N tw isted reduced m odels  $[14]$  are interpreted as a lattice form ulation of noncommutative eld theories  $[11]$ , 12,13]. Such a lattice form ulation provides them ost reliable m ethod to study the quantum dynam ics of noncom m utative eld theories in a fully nonperturbative m anner. R ecently, the lattice regulatization hasbeen applied to two-dim ensionalnoncom m utative Yang-M ills theory [15, 16], where (nonperturbative) renorm alizability was dem onstrated for the rst time in a noncommutative eld theory (see also [17]). There the same theory was shown to have an intriguing infrared property w hich m ay be described as the A haronov-Bohm e ect w ith them agnetic eld identied w ith the inversenoncom mutativity param eter. The lattice form ulation has also been used to explore the phase diagram of noncommutative scalar eld theories  $[16, 18]$ , w hich is expected to be richer than in the commutative case, as indicated by a self-consistent H artree approxim ation [19]. In particular, as conjectured by R ef.  $[19]$ , the ordered phase is found to split into a uniform  $\mu$  ordered phase and a phase dom inated by the stripe pattern. In the latter phase, nonzero m om entum m odes acquire vacuum expectation values, and therefore translational invariance is spontaneously broken.

The aim of this paper is two-fold. First we form ulate perturbation theory for the lattice noncom m utative gauge theory. A lthough the m ost im portant virtue of the lattice regularization lies in its capability of nonperturbative studies, it has also been used to clarify subtle issues in perturbative aspects of gauge theories. We consider this particularly im portant because the lattice construction of noncom m utative chiral gauge theories suggests a new m echanism of gauge anom aly cancellation, which is not yet known in the continuum [20]. As an application of the lattice perturbation theory, we pick up a noncom mutative version of three-dim ensional Q ED, w here the lattice calculation indeed plays a crucial role in revealing peculiar properties of the parity anom aly, given in term  $s$  of noncom m utative C hem-S in onsaction. The coecient of the anom aly is labelled by an integer depending on the lattice action, w hich is a counterpart of the phenom enon observed by C oste and Luscher [21] in the com m utative theory. The com m utative lim it is sm ooth w hen the ferm ions are in the fundam ental representation, but it is not for ferm ions in the ad pint representation due to a characteristic property of noncom mutative eld theories known as the UV/IR mixing [22]. A s a special case our result includes C hu's result [23] obtained in the continuum by using the Pauli-V illars regularization.

A notheraim ofthiswork isto constructa lattice regularization ofN C C S theory,w hich has in portant applications to quantum H all system s as m entioned above. In general, de ning a C hem-S in onsterm on the lattice is not straightforward due to its topological nature. A recent proposal[24]is to utilize G insparg-W ilson ferm ions in odd dim ensions and to de ne the C hem-S in ons term using the parity violating part of the eective action induced by the ferm ion. W e show that this proposal works also in the noncom m utative case. A s we m entioned above, the parity anom aly in the three-dim ensional noncom  $m u$ tative Q ED is given by the N C C S term in the continuum lim it of the lattice theory we started w ith. T he sam e result can be obtained from G insparg-W ilson ferm ions, w here the m asslessness is guaranteed at nite lattice spacing. This suggests a natural de nition of the lattice-regularized C hem-S in ons theory on a noncom mutative torus, w hich could enable nonperturbative studies of quantum H all system s. In this regard, we recall that a nite-N m atrix m odelhas been proposed as a regularized description ofN C C S theory on a cylinder [25]. A lthough our theory can also be m apped to a nite-N m atrix m odel, the two proposals appear to be quite dierent.

The rest of the paper is organized as follows. In Section  $2$ , we review the lattice form ulation ofnoncom m utative gauge theoriesand form ulate a perturbation theory based on Feynm an rules. In Section  $3$ , we present calculations of the parity anom aly in noncom m utative  $QED$ . In Section 4 we discuss the parity anom aly using G insparg-W ilson ferm ions, w hich leads to a proposal for a lattice-regularized noncom mutative C hem-S in on theory. Section 5 is devoted to sum m ary and discussions. Finally, in A ppendix A a calculation of the parity-violating term s in the e ective action by the direct evaluation of the ferm ionic determ inant is presented, w hile A ppendix B contains som e details of the com putation of the Feynm an integrals involved in the diagram m atic calculation of Section 3.

# 2. Lattice perturbation theory in noncom m utative geom etry

In this section we begin by review ing the lattice form ulation of noncom m utative gauge theories developed in Ref.  $[11, 12, 13]$  (see  $[26, 27, 28]$  for review s). In the literature it is comm on to start from a nite-N matrix model, which is then shown to be equivalent to the lattice form ulation of a noncommutative eld theory. Indeed, the m atrix m odel representation has proven useful for num erical analyses  $[15,16,18,20]$ . H ere we will work directly w ith the lattice form ulation and derive the Feynm an rules, which are used in the perturbative evaluation of the e ective action induced by ferm ions. A lthough we will focus on noncom m utative  $QED \text{ in } d = 2m + 1$  dim ensions, the lattice perturbation theory can be form ulated for any other noncom mutative eld theories in the same way.

#### 2.1 N oncom m utative Q ED on the lattice

In noncom m utative geom etry, space-tim e coordinates are treated as H erm itian operators obeying the commutation relation  $[x; x] = i$ , where is a real anti-sym m etric m atrix. In  $(2m + 1)$  dim ensions, due to a property of antisym m etric m atrices, coordinates can always be chosen in such a way that one of them com mutes with all the others, resulting in

We regard the commuting coordinate  $\hat{x}_d$  as the Euclidean time after the W ick rotation. Field theories on a noncomm utative geom etry can be obtained by replacing an ordinary eld

 $(x)$  by an operator  $(x)$ . An equivalent way to describe noncommutative eld theories, which we are going to use in what follows, is to keep the ordinary  $e^{kt}$  (x) but to replace the ordinary product of elds, say  $_1(x)$  and  $_2(x)$ , by the star-product

In order to consider the lattice reqularization of such theories, we introduce a  $(2m + 1)$ dim ensional toroidal lattice  $L_f$  de ned by

where a is the lattice spacing and L<sub>1</sub> = L<sub>2</sub> =  $_{2\overline{m}}$   $\overline{m}$  L, L<sub>d</sub> = T. We have assumed L;T 2 N to be odd [13]. The dim ensionful extent of the lattice is  $\prime = aL$  in the 2m spatial directions and  $= aT$  along the Euclidean time. The elds on the lattice are assum ed to obey the periodic boundary condition in all directions<sup>1</sup>.

In order to construct a lattice counterpart of the star-product  $(2.3)$ , we de ne the Fourier transform

H ere and henceforth we assume that the summ ation over a m om entum is restricted to the Brillouin zone; namely  $(2.6)$  with  $(L)$  $1)=2$  n  $(L)$  $1)=2$ .

The above lattice form ulation naturally results from matrix model description of noncommutative eld theories, and most importantly it preserves all the algebraic properties of the star-product. M or ever the de nition  $(2.7)$  is consistent with the periodicity of the lattice m om entum  $(2.6)$  due to  $(2.8)$ . One can also rew rite this denition  $(2.7)$  in an integral form as

where the sum m ation over  $y$  and  $z$  is taken only over the spatial lattice. This expression is consistent with the periodicity of the elds again due to  $(2.8)$ . As is clear from these observations, the lattice reqularization of noncomm utative eld theories inevitably requires the noncommuting directions to be compacti ed in a particular way (2.8) consistent with the noncommutativity. This reects the UV / IR m ixing  $[22]$  at a fully nonperturbative level  $[12, 13]$ .

U ltim ately we have to take the continuum  $\lim_{x \to a} 1$  and the lattice size should be sent to in nity L; T ! 1. These two lim its should be taken m ore carefully in noncommutive eld theories than in commutative ones because we have an extra scale parameter related to a and  $L$  by  $(2.8)$ . In any case we have a hierarchy of the scales

in the reqularized theory. In order to obtain nite, the physical extent of the spatial direction  $' =$  aL should inevitably go to in nity. In either case, the ferm ion action  $(2.16)$  is star-gauge invariant.

The second term in the D irac-W ilson operator  $(2.17)$  is the W ilson term, which is introduced to give species doublers a m ass of order  $O(1=a)$ . In the original proposal, the coe cientr was taken to be unity, but it can take other values, even negative ones, as far as its m agnitude is of order one.

## 2.2 Feynm an rules

Let us proceed to form ulate the perturbation theory for the noncom m utative Q ED on the lattice. A s in the com m utative case we start w ith expanding the link variable U (x) in term s of the lattice gauge  $e$ k A  $(x)$  as

T hat the ferm ion propagator  $(2.23)$  is identical to the one for the commutative lattice Q ED is because the  $-$ dependent phase arising from the star-product  $(2.7)$  disappears trivially in the quadratic term in the action (Set  $p = 0$  in (2.7) and consider the anti-symmetry of  $_{ij}$ ). The eect of the noncommutativity will show up only in the interaction vertices in the form of a phase depending on the m om enta ow ing into them. For the one-photon vertex we nd

together with a sum m ation over an internalm om entum for each loop  $\frac{1}{a^d L^{d-1}T}$ P  $_{\rm p}$ . Finally, each ferm ion loop w ill carry a m inus sign. Vertices w ith m ore than two photon lines can be obtained in a sim ilar way.

Together w ith the ferm ion propagator  $(2.23)$ , the Feynm an rules of noncom m utative lattice Q ED also requires the photon and ghost propagators as wellas the photon-ghost and photon self-interaction vertices. In the case of the propagators, because the bilinear term s in the action are independent of the noncom m utativity param eter, they are identical to the one for ordinary Q ED [29]. For the interaction vertices, as it is also the case in the continuum  $[30]$ , they can be read o from the ones for nonabelian com m utative gauge theories given in [29] by sim ply replacing the structure constants of the gauge group by the appropriate noncom m utative phases. In the calculation of the  $e$  ective action, however, we w illneed only the ferm ion-photon vertices.

# 2.3 P erturbative evaluation of the e ective action

The e ective action for the gauge eld is de ned in term s of the ferm ion determ inant as

In fact, diagram s containing vertices with three or m ore photons are irrelevant in the continuum lim it since they are weighted w ith higher powers of the lattice spacing a [29,31]. Therefore we can om it the last diagram in  $(2.35)$ . A pplying the Feynm an rules, we thus obtain the follow ing expression.

 $w$  here by  $\csc v$  perm utations" we indicate the contributions of the other two diagram s obtained from the second one in Eq.  $(2.35)$  by perform ing cyclic perm utations on the labels of the external legs. The expressions for the commutative case can be obtained simply by om itting the factors  $W^{(1)}$ ,  $W^{(2)}$  in the above equations.

# 3. T he parity anom aly in 3D noncom m utative Q E D

From now on we will consider the three-dim ensional case (i.e.  $d$  2m + 1 = 3) and study the parity anom aly in noncom m utative Q ED on the lattice. Parity anom aly has been studied intensively in com mutative gauge theories, both in the continuum [32,33] and on the lattice [21]. It has a w ide application in condensed m atter physics [34] including the

quantum Halle ect [35]. We will rst brie y review the known results in the commutative case.

### 3.1 A brief review of the commutative case

In three-dim ensionalm assless  $QED$  there is a con-ict between parity symm etry and gauge invariance at the quantum level. As pointed out in [36] and elaborated in [32], a parity invariant regularization of the fem ion detem inant leads to non-invariance of the one-loop e ective action under large gauge transform ations due to the spectral ow of the eigenvalues of the D irac operator, a phenom enon similar to the one behind W itten's global anom aly [37]. On the other hand, a gauge invariant regularization of the theory, like Pauli-V illars, induces a Chem-Sim ons action at one loop that breaks parity invariance, with precisely the coe cient required to compensate the variation of the m assless ferm ion determ inant under large gauge transform ations.

Despite any sim ilarities, parity anom aly in three-dim ensional QED is dierent from ordinary anomalies in that the coe cient of the anomaly depends on the reqularization scheme. This peculiar aspect of parity anomaly has been clari ed by Coste and Luscher [21] by using the lattice reqularization, which provides the most rigid way to calculate the anom aly while preserving gauge invariance. Here we summ arize the main results of Ref. [21]. First, when  $M$  ! 0, one obtains in the continuum limit

The term proportional to the Levi-C ivita tensor is parity odd, and hence signals the parity anom aly. (Note that the continuum action for a m assless D irac ferm ion in three dim ensions is invariant under parity transform ation.) The coe cient of the parity anom aly includes a param eter n, which can take any integer value depending on the lattice action chosen, i.e. on the details of the ultraviolet reqularization. The essential point, however, is that this regularization am biguity does not a ect the existence of the parity anom aly itself, since this is always nonzero for any n 2 Z. For the standard W ilson ferm ion, one obtains  $n = 0$ ; 1, depending on whether the sign of the W ilson term is positive or negative. In this case the parity anom aly arises because the W ilson term breaks parity on the lattice, and this breaking persists in the continuum lim it. On the other hand, if one uses the G insparg-W ilson ferm ion, whose action is invariant under the generalized parity transform ation, the parity anom aly (3.1) arises from the measure [24], thus realizing Fujikawa's philosophy for anom alies at a fully regularized level.

In the in nite  $m$  ass  $\lim_{n \to \infty} m$  the other hand, the result for the vacuum polarization is given by

where the integer  $n$  is the same parameter as the one introduced in  $(3.1)$  for the same lattice action. Thus in general the ferm ion does not decouple completely in the in nite

m ass lim it but it leaves behind a certain local term as a rem nant. In fact the freedom of the integer parameter  $n$  in both  $(3.1)$  and  $(3.2)$  is closely related to the fact that the of the limit M ! 1. By choosing dierent lattice rem nant  $(3.2)$  depends on the sign action, one essentially introduces di erent num bers of heavy ferm ions which have m asses of order  $0$  (1=a). The sign of the m asses can be assigned as one w ishes, and this results in the arbitrariness represented by n.

#### 3.2 The noncom mutative case

Before we present our results on the noncommutative case, let us remark on what we m ean by \parity" when we discuss parity anom aly in noncommutative QED. Conventional parity refers to a re ection in one spatial direction. In the Euclidean formulation in three dim ensions, one can combine the conventional parity transform ation with the 180 degrees rotation in the rem aining two directions, to arrive at the transform ation

which leaves them assless D irac action in the continuum invariant. In the noncommutative case, the introduction of the noncomm utativity m atrix breaks parity in the conventional sense, but it preserves the invariance under  $(3.3)$ . It is this invariance of the m assless D irac action that we refer to when we say 'parity anomaly' in noncommutative  $QED$ .

Our next task is to compute the e-ective action  $(2.32)$  as discussed in Section 2.3 and to see how the results of C oste and Luscher [21] are modied by noncommutative geometry. We analyze separately the cases of fem ions in the fundam ental and ad joint representation. We will use a representation of the three-dim ensional D irac m atrices satisfying

# 3.2.1 Fundam ental ferm ions

We begin with the coe cient (p) of the bilinear term in the e ective action  $(2.33)$ for the gauge eld. For fundam ental ferm ions the noncom mutative phases in Eq. (2.36) cancelout. The resulting expression is exactly the same as in the commutative case and in particular the result does not depend on how we take the  $\lim_{x \to 0}$  is L ! 1, T ! 1 and a ! 0, as far as the physical extent of the space-time  $(1 - aL)$  and  $= aT$  ) goes to in nity. For instance we m ay take the large volume  $\lim_{x \to 0} L$  ! 1 and T ! 1 at xed lattice spacing a and then take the continuum lim it a ! 0. Then the rest of the calculation proceeds exactly as in Ref. [21]. Let us introduce the symbol

In the lim its  $M$  !  $0, M$  ! 1, we obtain results identical to the commutative case  $(3.1)$ ,  $(3.2)$ .

Let us proceed to com pute the coe cient  $(p)$  of the trilinear term in the eective action  $(2.33)$  for the gauge eld. Two types of diagram s contribute to this term. In both cases it is easy to check that the corresponding noncom m utative phases are identical and factor out of the sum over the loop m om entum. The sum multiplying the global

noncom m utative phase is independent of  $\,$ , and it can be evaluated in the same lim it as before. T huswe arrive at the expression

From these results we see that the cubic term in the noncom mutative C hern-S in ons action em erges in the lim its M ! 0 and M ! 1 w ith coecients consistent w ith the quadratic term calculated above. This is expected from the star-gauge invariance, w hich ism anifestly preserved in the lattice regularization.

It is straightforw and to calculate now the e ective action  $[A]_a^{\text{(fund)}}$  $e^{(\text{mna})}$  in position space for m assless ferm ions. By using Eqs.  $(3.10)$  and  $(3.15)$  in the lim it M  $\,$  ! 0 we nd for the parity violating part

In particular, since the N C C S term is not invariant under the parity transform ation  $(3.3)$ , we have a parity anom aly as in the commutative case.

It is im portant to notice that in the ! 0 lim it we retrieve the results obtained in R ef.  $[21]$  for ordinary (com m utative) Q ED. The fact that the com m utative lim it turned out to be sm ooth in the present case is due to the cancellation of the noncom m utative phases involving loop m om enta, w hich would otherw ise cause the UV/IR m ixing. Such a cancellation can be understood in a transparent way [22] if one uses the so-called double-line notation know n from large-N gauge theory. Feynm an rules should be re-derived accordingly and in particular each of the interaction vertices w ill have a single noncom m utative phase factor instead of a sum of phases. U sefulness of the double-line notation in noncom m utative

eld theories can be understood if one recalls that the algebraic property of the star-product is the sam e as that of m atrix product. In the double-line notation,  $\phi$  hanar diagram s" can be dened as diagram s w hich can be draw n on a plane w ithout any crossings of lines. In fact for any planar diagram s the noncommutative phase factors out of the m om entum integration, leaving a global phase depending only on external m om enta  $[39, 40, 41]$ . For fem ions in the fundam ental representation, the interaction  $w$  ith the gauge  $ed$  occurs only on one side of the ferm ion propagator (represented as a double-line), and therefore all the diagram s that appear in the calculation of the e ective action are actually planar.

## 3.2.2 A d pint ferm ions

C ontrary to the case studied above, the e ective action for noncom m utative gauge theories w ith ferm ions in the adjoint representation does not have a sm ooth commutative limit. N ote that the original theory in the  $\qquad$ ! 0 lim it is just a free m assless ferm ion and a free photon, which is parity invariant. However, if we take the continuum lim it for nite

we w ill see that the adjoint ferm ions induce the NCCS action, which reduces to an ordinary (com m utative) U (1) C hern-Sim ons term in the ! 0 lim it. U sing a Pauli-V illars ferm ion of m ass M  $_{\text{req}}$  as a regulator in the continuum [23] this is the result of the fact that the two lim its  $\cdot$  ! 0 and M  $_{\text{req}}$  ! 1 do not commute with each other, a phenom enon characteristic of noncom m utative quantum eld theories both at zero [22] and nite tem perature [44]. This com es about because of the existence of nonplanar diagram s in w hich the UV divergences are regulated at the scale<sup>3</sup>  $\dot{p}$ j.

P lugging in the factors W  $^{(1)}$ , W  $^{(2)}$  for the ad joint ferm ions (2.27), (2.30), the expression (2.36) for the two-point function becom es

w here  $(p)_{\text{fund}}$  is the two-point function for ferm ions in the fundam ental representation calculated above. In the language of the double-line notation (See the end of Sec.  $3.2.1$ ), the rst term represents the contribution from the planar diagram and the other two term s correspond to the nonplanar contributions. Interestingly the third term, which is the non-planar contribution from the tadpole diagram, exactly vanishes in the continuum lim it. Therefore the e ect of the tadpole diagram is just to subtract the zero-m om entum contribution from the planar term  $s$ , which has the  $e$  ect of m aking the am plitude nite in the continuum  $\lim_{t \to \infty}$  is seen above. Note that the second term of (3.19) is nite by itself, since the noncom m utative phase introduces an e ective cuto to the loop m om entum at the scale  $p$ j.

To obtain the continuum lim it ofthe second term we have to take into account that this lim it has to be taken at the sam e tim e w ith the large volum e lim it in such a way that  $/$   $a<sup>2</sup>L$  is kept xed. A long but straightforward calculation shows that the resulting integrals can be w ritten in term s of m odied Bessel functions of the second kind. T he resulting two-point function has the form given in Eq.  $(3.9)$  now w ith (see A ppendix B for details)

U sing the asymptotic expansion for large argum ents of the Bessel functions, K (z)  $e^{z} = \overline{2}$  z it is easy to see that the nonplanar term s in the am plitude are exponentially suppressed in the lim it of large M (cf.  $[23]$ ). In the M  $\,$ ! 0 lim it, on the other hand, one nds that the nonplanar contributions to the parity violating term vanishes. Thus in both lim its we nd that the parity violating term in the eective action com es solely from the planar part, and its m agnitude is tw ice the one for fundam ental ferm ions. Later we w ill o er a physical explanation of this phenom enon.

For nite values of the noncom mutative param eter the three-dim ensional Euclidean group SO  $(3)$  is broken down to SO  $(2)$ , acting as rotations on the noncom mutative plane. An im portant consequence of the sm ooth com mutative lim it ( ! 0) of noncom mutative Q ED w ith fundam ental ferm ions is that the full Euclidean group SO (3) is restored in that lim it. T his m eans that the \generalized parity" anom aly studied here is m apped to the usual parity anom aly of commutative  $QED$ . On the other hand, for ad pint ferm ions the situation is radically dierent, since the Euclid-breaking term in the eective action, third equation in  $(3.20)$ , does not disappear in the commutative lim it and actually induces divergences w hen  $\cdot$  0, w hile keeping the SO (2) sym m etry unbroken (see the discussion at the end of this subsection). The reason is that in this case, because of UV/IR m ixing, the noncom m utative theory is not a sm ooth deform ation of (free) com m utative  $QED$  w ith neutral ferm ions.

Let us now turn to the evaluation of the three-point function. A fter a short m anipulation of the noncom mutative phases, the three-point function can be w ritten as

As it was the case also for the two-point functions, all the term s contributing to A (p<sub>1</sub>;  $p_2$ ;  $\lambda_P$  vanish both in the lim it M  $\;$  ! 0, due to the global factor of M in front of the integral, and as M  $\,$  ! 1, this time due to the exponentialdam ping of the modied Bessel function for large values of the argum ent. The nal conclusion is that in the continuum lim it

As a consequence, in these two lim its, the coe cient of the Chem-Sim ons action is only detem ined by the rst term on the right-hand side of  $(3.21)$  and its value is consistent w ith the one calculated above from the two-point function. This, again, follows from the fact that the lattice regularization preserves star-gauge invariance.

 $W$  e can now study the parity-odd part of the induced e ective action in the  $\text{lim } t \to M$  ! 0. From the two- and three-point am plitudes calculated above we nd that  $[A]_e^{(adj)} =$ 2  $[A]_a^{\text{(fund)}}$  where  $[A]_a^{\text{(fund)}}$  is given in Eq. (3.18). Note that we have considered that the ad pint fem ions are of D irac type. Them inim alform of the anom aly, how ever, is obtained by in posing the M a jorana condition. In this case there is an extra factor of  $\frac{1}{2}$  in front of the fem ionic determ inant and the e ective action for M a prana fem ions in the ad pint representation agrees with Eq.  $(3.18)$  [23].

To conclude, let us try to understand in physical term s the vanishing of the nonplanar contribution to the parity-violating part of the e ective action in the lim it of zero ferm ion m ass. As m entioned in Section 3.1 the parity anomaly in commutative gauge theories results from the impossibility of nding a parity-invariant UV cuto which at the same time preserves Lorentz and gauge symmetries. This is clear from the analysis of [32] where the introduction of a parity-invariant UV cuto in the integrals results in the presence of a tem  $q^2$ in the two-point function which breaks the W ard identity.

Because of the presence of the noncommutative phases depending on the loop mom entum, we can see the nonplanar contribution to the two-point function of m assless noncom mutative QED as a regularization of the corresponding am plitude in ordinary (com  $m$  utative)  $m$  assless  $QED$ . In this case the noncom  $m$  utative  $m$  om entum  $pi$  $1$  plays the role of an UV cuto. Moreover, this cuto preserve the parity invariance of the theory. Therefore one expects that the parity-breaking term s in the am plitudes will vanish. Indeed, using the nonplanar part in  $(3.20)$  we nd the two-point function of m assless QED in this reqularization to be

i.e. the two-point function does not contain parity-breaking term s and satis es the W ard identity. H owever, because of the presence of the last term, it breaks Euclidean sym m etry. Thus the \ -reqularization" of m assless Q ED provides a regularization schem e in which both parity and gauge sym m etries are m aintained at the cost of breaking Euclidean (or Lorentzian) invariance. In the  $\lim_{n \to \infty}$  in which the cuto is sent to in nity,  $\lim_{n \to \infty}$  ! 1, the coe cient of the rst term in the right-hand side of (3.26) tends to g  $^{2}$ =(16 $\dot{\rm p}$ j) w hereas the second Euclid-breaking term diverges linearly w ith . Euclidean invariance can be restored by introducing a Pauli-V illars ferm ion w ith m ass M  $_{\text{req}}$  w hich subtracts the divergent part of the two-point function  $(3.26)$ . H owever, this procedure results in the breaking of parity invariance and as a consequence a C hern-Sim ons term is again induced in the lim it M  $_{\text{req}}$  ! 1 . This is som ew hat rem iniscent to the analysis of nonplanar anom alies in noncom m utative gauge theories presented in [43].

# 4. N oncom m utative C hern-Sim ons theory on the lattice

In this section our results in the previous sections are used to de ne a lattice-regularized noncom m utative C hem-S in onstheory follow ing the proposalm ade in R ef.  $[24]$  in the com m utative case. The basic idea is to use the parity breaking part of the eective action induced by theG insparg-W ilson ferm ion.Sincem asslessnessoftheG insparg-W ilson ferm ion is quaranteed on the lattice, one obtains the correct noncom m utative C hern-S in ons action in the continuum lim it without ne-tuning.

The D irac operator D for the G insparg-W ilson ferm ion is characterized by the G insparg-W ilson relation  $[45]$ w hich, in the form applicable to both even and odd dim ensions, is given by [24]

This relation guarantees that the ferm ion action including the operator D is invariant under a generalized chiral symm etry [46], which reduces to the ordinary chiral symm etry in the continuum lim it. The role of the  $\backslash$  5-H erm iticity" is played in odd dim ensions by the property

So far we have discussed general properties of the G insparg-W ilson operator, which satises (4.1). In fact the unitary operator V has to be chosen appropriately in order to guarantee that the operator D has sensible properties as a D irac operator such as locality (w ith exponentially decaying tails) and the absence of species doublers. Such an operator has been derived from the overlap form alism [47], and it is given explicitly by [48]

where  $D_w$  (r = 1) is the D irac-W ilson operator, which has the form (2.17) with ordinary covariant derivatives. The noncom m utative version of the G insparg-W ilson ferm ion can be obtained by  $\sin p$  using the covariant derivatives (2.19) or (2.21) depending on the representation, instead of the usual ones w ithout star-products. In even dim ensions G insparg-W ilson ferm ions played a crucial role in introducing chirality on a discretized noncom m utative torus[20]. R ecently an analogous construction hasbeen worked outon a fuzzy sphere [49].

For the choice  $(4.8)$ , detV in  $(4.7)$  is nothing but the phase of detA<sub>w</sub>, which is essentially the ferm ion determ inant of the W ilson-D irac operator w ith  $r = 1$  and  $M = 1=a$ . T hus one can translate the result obtained for the W ilson ferm ion in the in nite m ass lim it into the parity anom aly for the G insparg-W ilson ferm ion. In the commutative case this is how the correct parity anom aly has been reproduced by  $[50]$  in the overlap form alism  $^4$ . In the noncommutative case, on the other hand, our results in the previous section with  $r = 1$  in the lim it M  $\;$  1 im plies that the parity anom aly obtained for G insparg-W ilson ferm ions coincides w ith the result for W ilson ferm ions w ith  $r = 1$  in the m assless lim it M ! 0.

As in the com m utative case  $[24]$ , the parity anom aly for the G insparg-W ilson ferm ion suggests a natural de nition of the noncom mutative C hern-Sim ons term on the lattice. N am ely we de ne  $\pm$  as  $S_{CS}$  in

determ inant as we discussed in the previous paragraph. A ccording to our calculations, the quantity  $S_{CS}$  indeed becom es the noncom m utative C hern-S in ons action in the continuum lim it. In the continuum, on the other hand, noncom m utative Chern-Sim onsterm is known to transform as  $[52]^\circ$

under a gauge transform ation, where is the w inding num ber characterizing this gauge transform ation. T he gauge invariance requires the coecient of the noncom m utative C hem-S in ons action to be quantized. That Eq.  $(4.10)$  de nes S<sub>CS</sub> only up to modulo 2 is therefore not a problem for m ost practical purposes. Note in this regard that the right-hand side of eq. (4.10) is indeed m anifestly gauge invariant.

# 5. C oncluding rem arks

In the present paper we have studied the em ergence of parity anom aly on the lattice for three-dim ensional noncom m utative  $QED$ , both w ith ferm ions in the fundam ental and the ad pint representation. Induced C hern-S in ons actions in noncom m utative gauge theories have been studied in the continuum in [23,54]using the Pauli-V illars regularization (see also [55] for an incom plete list of references). H ow ever, them ain advantage of the lattice analysis presented here lies in m aking explicit the dependence of the coecient of the induced C hem-Sim ons term on the regularization schem e used. Thus, the results obtained in R ef.  $[23]$ corresponds to the cases  $n = 0$ ; 1 in our analysis using the lattice regularization. Notice that the quantization of the schem e-dependent term in the e ective action is consistent w ith the star-gauge invariance of the ferm ion determ inant under \large" transform ations [52], as required by the fact that the lattice regularization respects star-gauge invariance.

W e have also proposed a lattice-regularized C hern-S in ons action on a noncom m utative torus using G insparg-W ilson ferm ions. A s the lattice form ulation of noncommutative eld theories has been useful to extract their interesting nonperturbative dynam ics  $[15,16,18]$ , we hope that the lattice form ulation of noncom mutative C hern-S in ons action is useful to deepen our understanding of quantum H all system s.

Finally we would like to emphasize that the lattice noncommutative eld theories studied in the present paper can be m apped on to a nite N m atrix m odel. The anom aly calculation in m atrix m odels has recently attracted attention in the context of large-N gauge theory [56,57]and noncom m utative geom etry [58,49]. W e expect that the calculation m ethod developed in this paper is usefulto study various anom alies in noncom m utative geom etry. In particular we would like to revisit the gauge anom aly cancellation in chiral gauge theories on a noncom m utative torus [20]. We hope that such developm ents w ill eventually lead us to a deeper understanding of the stringy nature of the space-time structure.

#### B .2 A djoint ferm ions

In the case w hen the ferm ions are in the adjoint representation, the evaluation of the Feynm an integrals is m ore involved due to the presence of noncom m utative phases dependent on the loop m om entum. Let us focus rst on the two-point function. A s explained above, contrary to the planar part w here the tadpole diagram introduces the zero m om entum subtraction that  $m$  akes the w hole am plitude  $n$  ite, in the nonplanar sector the tadpole diagram cancels exactly. This can be seen by noticing that, up to a total derivative term that cancels in the continuum lim it, the nonplanar contribution of the tadpole diagram in the continuum lim it is given by

In our case the constant ! is replaced by . Thus, for large values of the ferm ion m ass and at xed incom ing m om enta the argum ent of the Bessel functions is very large and the corresponding integrals vanish exponentially. In the same  $w$  ay, if M  $\;$  ! 0 at nitem om enta

is nonzero and the corresponding integrals rem ain nite. Thus, because of the presence of an overall power of  $M$  in front of  $(B.13)$ , all the integrals contributing to the function A  $(p_1; p_2; )_{N \in \mathbb{N}}$  w ill vanish in that lim it.
