Uni ed Theories from Fuzzy Extra D im ensions

A bstract: We combine and exploit ideas from Coset Space D in ensional Reduction (CSDR) m ethods and N on-commutative G eom etry. W e consider the dimensional reduction of gauge theories de ned in high dimensions where the compact directions are a fuzzy space (m atrix m anifold). In the CSDR one assumes that the form of space-time is M $D = M$ 4 S=R with S=R a hom ogeneous space. Then a gauge theory with gauge group G de ned on M D can be dimensionally reduced to M 4 in an elegant way using the sym m etries of $S=R$, in particular the resulting four dim ensional gauge is a subgroup of G. In the present work we show that one can apply the CSDR ideas in the case where the com pact part of the space-time is a nite approximation of the hom ogeneous space $S=R$, ie. a fuzzy coset. In particular we study the fuzzy sphere case.

Introduction $\mathbf 1$

Coset Space D in ensional Reduction (CSDR) [1, 2] is a uni cation schen e for obtaining realistic particle models from gauge theories on higher D-dimensional spaces M D . It suggests that a uni cation of the gauge and H iggs sectors of the Standard M odel can be achieved in higher than four dimensions. Moreover the addition of fem ions in the higher-dim ensional gauge theory leads naturally, after CSDR, to Yukawa couplings in four dim ensions.

We study CSDR in the non-commutative context and set the rules for constructing new particle m odels that m ight be phenom enologically relevant. One could study CSDR w ith the whole parent space M^D being non-commutative or with just non-commutative M inkow ski space or non-commutative internal space. We specialize here to this last

situation and therefore eventually we obtain Lorentz covariant theories on com m utative M inkowski space. We further specialize to fuzzy non-commutativity, i.e. to matrix type non-com m utativity. Thus, following [7], we consider non-com m utative spaces like those studied in refs. $[3,4,5]$ and im plem enting the CSD R principle on these spaces we obtain new particle m odels.

2 Fuzzy sphere

The fuzzy sphere [6,5] is a m atrix approximation of the usual sphere S 2 . The algebra of functions on S^2 (for exam ple spanned by the spherical harm onics) is truncated at a given frequency and thus becom es nite dim ensional. The truncation has to be consistent with the associativity of the algebra and this can be nicely achieved relaxing the com m utativity property of the algebra. The fuzzy sphere is the \space" described by this non-com m utative algebra. The algebra itself is that of N N m atrices. M ore precisely, the algebra of functions on the ordinary sphere can be generated by the coordinates of The algebra of functions on the ordinary sphere can be generated by the coordinates of R^3 m odulo the relation $\frac{3}{a-1}x_a x_a = r^2$. The fuzzy sphere S_F^2 at fuzziness level N $\frac{1}{a-1}$ is the non-commutative m anifold whose coordinate functions iX $_A$ are N N herm itian m atrices proportional to the generators of the N -dim ensional representation of SU (2). m aunces proporuonal to the generators of the N-aim ensional representation
They satisfy the condition $\frac{3}{a-1}X_aX_a = \frac{r^2}{a}$ and the commutation relations

where C_{aôc} = $\mathbf{u}_{\hat{\mathbf{a}}\hat{\mathbf{b}}\hat{\mathbf{c}}}$ = \mathbf{v} while the proportionality factor goes as N 2 for N large. Indeed it can be proven that for N ! 1 one obtains the usual commutative sphere.

On the fuzzy sphere there is a natural SU (2) covariant di erential calculus. This calculus is three-dim ensional and the derivations e_a along X $_a$ of a function f are given by e_a (f)= $[X_a, f]$: A ccordingly the action of the Lie derivatives on functions is given by

these Lie derivatives satisfy the Leibniz rule and the SU (2) Lie algebra relation

In the N $!$ 1 lim it the derivations e_a becom e $e_a = C_{a\hat{b}e}x^{\hat{b}}e^c$ and only in this commutative lim it the tangent space becom es two dim ensional. The exterior derivative is given by

this form ula will be fundam ental for form ulating the CSD R principle on fuzzy cosets.

The dierential geometry on the product space M inkow skitimes fuzzy sphere, M 4 S_F, is easily obtained from that on M⁴ and on S_F^2 . For example a one-form A de ned on M⁴ S²_F is written as

One can also introduce spinors on the fuzzy sphere and study the Lie derivative on these spinors. A lthough here we have sketched the di erential geometry on the fuzzy sphere, one can study other (higher dim ensional) fuzzy spaces (e.g. fuzzy \mathbb{CP}^M) and with sim ilar techniques their di erential geometry.

CSDR over fuzzy coset spaces 3

F irst we consider on M⁴ (S=R)_F a non-commutative gauge theory with gauge group $G = U(P)$ and exam ine its four dim ensional interpretation. The action is

where T r denotes integration over the fuzzy coset (S=R)_F described by N N m atrices, and tr_G is the gauge group G trace. The higher-dimensional eld strength F_{MN} decom posed in four-dimensional space-time and extra-dimensional components reads as follows (F ${}_{i}$ F ${}_{6}$, F₃^c); explicitly the various components of the eld strength are given by

Under an in nitesimal G gauge transform ation = (x, x^a) we have

thus $F_{M N}$ is covariant under local G gauge transform ations: $F_{M N}$! $F_{M N}$ + [$F_{M N}$]. This is an in nitesim al abelian U (1) gauge transform ation if is just an antiherm itian function of the coordinates x iX d while it is an in nitesim al nonabelian U (P) gauge transform ation if is valued in $Lie(U(P))$, the Lie algebra of herm itian P P m atrices. In the following we will always assume $Lie(U(P))$ elements to commute with the coordinates X^a. In fuzzy/non-commutative gauge theory and in Fuzzy-CSDR a fundamental role is played by the covariant coordinate,

This eld transform s indeed covariantly under a gauge transform ation, $('a) = [f'a]:$ In term s of $'$ the eld strength in the non-commutative directions reads,

where the potential term V (') is the $F_{A\hat{b}}$ kinetic term (recall $F_{A\hat{b}}$ is antiherm it ian so that $V(')$ is hem itian and non-negative)

This action is naturally interpreted as an action in four dimensions. The in nitesimal G gauge transform ation with gauge parameter (x, x^a) can indeed be interpreted just as an M 4 gauge transform ation. We write

where T are hem it ian generators of U(P), (x, x^a) are N N antihem it ian m atrices and thus are expressible as (x) ^h T^h w ith T^h antihem itian generators of U(N). Now the Lie algebra is the tensor product of $Lie(U(N))$ and $Lie(U(P))$, it is indeed $Lie(U(NP))$. Sim ilarly we rew rite the gauge ebl A as A $(x, x^a) = A (x, x^a)T = A^{h} (x)T^h T$ and interpret it as a Lie(U (N P)) valued gauge eld on M⁴. Sim ilarly we treat \prime _a.

Up to now we have just performed a fuzzy Kaluza-K lein reduction. Indeed in the commutative case the expression (15) corresponds to rew riting the initial lagrangian on M⁴ S² using spherical ham on ics on S². Here the space of functions is nite dimensional and therefore the in nite tower of modes reduces to the nite sum given by Tr.

Next we reduce the num ber of gauge elds and scalars in the action (15) by applying the CSDR scheme. Since Lie SU (2) acts on the fuzzy sphere (SU (2)=U (1)_F, and m ore in general the group S acts on the fuzzy coset $(S=R)_F$, we can state the CSDR principle in the same way as in the continuum case, i.e. the elds in the theory must be invariant under the in nitesim alsU(2), respectively S , action up to an in nitesim algauge transform ation

where A is the one-form gauge potential A = A dx + A_a $^{\circ}$, and W_b depends only on the coset coordinates X $^{\circ}$ and (like A ; A_a) is antihem itian. We thus write W $_{\hat{b}}$ = $W_{\hat{p}}T$; = 1;2::: P^2 ; where $T^{\hat{i}}$ are herm it ian generators of U(P) and $(W_{\hat{p}}^{\hat{i}})^y = W_{\hat{p}}^{\hat{i}}$, here Y is hem itian conjugation on the X a 's. Now in order to solve the constraints (17) we cannot follow the strategy adopted in the commutative case, where the constraints were studied just at one point of the coset (say $y^a = 0$). This is due to the intrinsic nonboality of the constraints. On the other hand the speci c properties of the fuzzy case (e.g. the fact that partial derivatives are realized via commutators, the concept of covariant coordinate) allow to simplify and eventually solve the constraints. Indeed in tem s of the covariant coordinate $r_{\hat{d}} = X_{\hat{d}} + A_{\hat{d}}$ and of

the CSDR constraints assume a particularly simple form, namely

In addition we have a consistency condition following from the relation $[L_a, L_{\hat{b}}] = C_{a\hat{b}}^c L_{\hat{c}}$:

where $!_a$ transform s as $!_a$! $!_a^0 = g!_a g^{-1}$: O ne proceeds in a similar way for the spinor elds [7].

4 Solving the CSDR constraints for the fuzzy sphere

We consider (S=R) $_F = S_F^2$, i.e. the fuzzy sphere, and to be de nite at fuzziness level N $\overline{1}$ (N N m atrices). We study rst the basic example where the gauge group $G = U(1)$. In this case the $!_a = !_a (X^b)$ appearing in the consistency condition (21) are N N antiherm itian m atrices and therefore can be interpreted as elements of Lie(U (N)). On the other hand the $!_A$ satisfy the commutation relations (21) of Lie(SU(2)). Therefore in order to satisfy the consistency condition (21) we have to embed Lie(SU(2)) in Lie(U(N)). Let T^h w ith $h = 1$;::; (N)² be the generators of Lie(U(N)) in the fundam ental representation, we can always use the convention h = (a, u) with $a = 1,2,3$ and $u = 4,5, \ldots, N^2$ where the $T^{\hat{a}}$ satisfy the SU (2) Lie algebra,

The constraint (19), $[!_{\hat{b}};A] = 0$, then in plies that the four-dim ensional gauge group K is the centralizer of the in age of SU (2) in U (N) , i.e.

where the last U(1) is the U(1) of U(N) ' SU(N) U(1). The functions A $(x;X)$ are arbitrary functions of x but the X dependence is such that A $(x;X)$ is Lie(K) valued instead of $Lie(U(N))$, i.e. eventually we have a four-dimensional qauge potential A (x) w ith values in $Lie(K)$. Conceming the constraint (20), it is satis ed by choosing

ie. the unconstrained degrees of freedom correspond to the scalar eld '(x) which is a singlet under the four-dim ensional gauge group K.

The choice (23) de nes one of the possible embedding of $Lie(SU(2))$ in $Lie(U(N))$. For example we could also embed Lie(SU(2)) in Lie(U(N)) using the irreducible N dim ensional rep. of SU (2), i.e. we could identify $!_a = X_a$. The constraint (19) in this case in plies that the four-dim ensional gauge group is $U(1)$ so that $A(x)$ is $U(1)$ valued. The constraint (20) leads again to the scalar singlet $'(x)$.

In general, we start with a U (1) gauge theory on M⁴ S_F. We solve the CSDR constraint (21) by embedding SU(2) in U(N). There exist p_N embeddings, where p_N is the number of ways one can partition the integer N into a set of non-increasing positive integers [6]. Then the constraint (19) gives the surviving four-dimensional gauge group. The constraint (20) gives the surviving four-dim ensional scalars and eq. (24) is always a solution but in general not the only one. By setting \prime a = \prime a we obtain always am in imum of the potential. This m inimum is given by the chosen embedding of SU (2) in U (N).

In the G = U(P) case, $!_a = 1_a(X^b) = 1_a^b$; T^hT is an NP N P hem itian m atrix and in order to solve the constraint (21) we have to embed $Lie(SU(2))$ in $Lie(U(NP))$. All the results of the $G = U(1)$ case holds also here, we just have to replace N with NP.

O ne proceeds in a simular way for more general fuzzy coset (S=R)_F (e.g. fuzzy CP^M = SU $(M + 1) = U (M))$ described by N N matrices. The results are again similar, in particular one starts with a gauge group G = U (P) on M⁴ (S=R)_F, and then the CSDR constraints in ply that the four-dim ensional gauge group K is the centralizer of the in age $S_{U(NP)}$ of S in U (N P), $K = C_{U(NP)}(S_{U(NP)}).$

D iscussion and Conclusions 5

The Fuzzy-CSDR has dierent features from the ordinary CSDR leading therefore to new four-dim ensional particle m odels. Here we have stated the rules for the construction of such models; it may well be that Fuzzy-CSDR provides more realistic four-dimensional theories. Having in m ind the construction of realistic models one can also combine the fuzzy and the ordinary CSDR scheme, for example considering M⁴ S⁰=R⁰ (S=R)_F.

A m a prdi erence between fuzzy and ordinary CSDR is that in Fuzzy-CSDR the spontaneous symmetry breaking mechanism takes already place by solving the Fuzzy-CSDR contraints. The fourd in ensional Higgs potential has the typical \m exican hat" shape, but it appears already spontaneously broken. Therefore in four dim ensions appears only the physical H iggs eld that survives after a spontaneous symmetry breaking. Correspondingly in the Yukawa sector of the theory [7] we obtain the results of the spontaneous sym m etry breaking, i.e. m assive ferm ions and Yukawa interactions am ong ferm ions and the physical H iggs $ell.$ We see that if one would like to describe the spontaneous sym m etry breaking of the SM in the present fram ework, then one would be naturally led to large extra dim ensions.

A fundam entaldi erence between the ordinary CSDR and its fuzzy version is the fact that a non-abelian gauge group G is not really required in high dimensions. Indeed the presence of a U (1) in the higher-dim ensional theory is enough to obtain non-abelian gauge theories in four dimensions.
