# Uni ed Theories from Fuzzy Extra Dim ensions

A bstract: We combine and exploit ideas from Coset Space D in ensional Reduction (CSDR) methods and Non-commutative G eometry. We consider the dimensional reduction of gauge theories dened in high dimensions where the compact directions are a fuzzy space (matrix manifold). In the CSDR one assumes that the form of space-time is M $^{\rm D}=$ M $^{\rm 4}$ S=R with S=R a homogeneous space. Then a gauge theory with gauge group G dened on M $^{\rm D}$  can be dimensionally reduced to M $^{\rm 4}$  in an elegant way using the symmetries of S=R, in particular the resulting four dimensional gauge is a subgroup of G. In the present work we show that one can apply the CSDR ideas in the case where the compact part of the space-time is a nite approximation of the homogeneous space S=R, i.e. a fuzzy coset. In particular we study the fuzzy sphere case.

#### 1 Introduction

Coset Space D in ensional R eduction (CSDR) [1,2] is a uni cation scheme for obtaining realistic particle models from gauge theories on higher D-dimensional spaces M $^{\rm D}$ . It suggests that a uni cation of the gauge and Higgs sectors of the Standard Model can be achieved in higher than four dimensions. Moreover the addition of fermions in the higher-dimensional gauge theory leads naturally, after CSDR, to Yukawa couplings in four dimensions.

We study CSDR in the non-commutative context and set the rules for constructing new particlem odels that might be phenom enologically relevant. One could study CSDR with the whole parent space  $M^D$  being non-commutative or with just non-commutative M inkowski space or non-commutative internal space. We specialize here to this last

situation and therefore eventually we obtain Lorentz covariant theories on commutative M inkowski space. We further specialize to fuzzy non-commutativity, i.e. to matrix type non-commutativity. Thus, following [7], we consider non-commutative spaces like those studied in refs. [3, 4, 5] and implementing the CSDR principle on these spaces we obtain new particle models.

## 2 Fuzzy sphere

The fuzzy sphere [6,5] is a matrix approximation of the usual sphere  $S^2$ . The algebra of functions on  $S^2$  (for example spanned by the spherical harmonics) is truncated at a given frequency and thus becomes nite dimensional. The truncation has to be consistent with the associativity of the algebra and this can be nicely achieved relaxing the commutativity property of the algebra. The fuzzy sphere is the \space" described by this non-commutative algebra. The algebra itself is that of N N matrices. More precisely, the algebra of functions on the ordinary sphere can be generated by the coordinates of R  $^3$  modulo the relation  $^{P}$   $^3_{\hat{a}=1}$   $x_{\hat{a}}x_{\hat{a}}=r^2$ . The fuzzy sphere  $S^2_F$  at fuzziness level N 1 is the non-commutative manifold whose coordinate functions iX  $_{\hat{a}}$  are N N hermitian matrices proportional to the generators of the N-dimensional representation of SU (2). They satisfy the condition  $^{P}$   $^3_{\hat{a}=1}$   $X_{\hat{a}}X_{\hat{a}}=r^2$  and the commutation relations

$$[X_{\hat{a}};X_{\hat{b}}] = C_{\hat{a}\hat{b}\hat{c}}X_{\hat{c}}; \qquad (1)$$

where  $C_{\hat{a}\hat{b}\hat{c}} = "_{\hat{a}\hat{b}\hat{c}} = r$  while the proportionality factor goes as N  $^2$  for N large. Indeed it can be proven that for N ! 1 one obtains the usual com m utative sphere.

On the fuzzy sphere there is a natural SU(2) covariant dierential calculus. This calculus is three-dimensional and the derivations  $e_a$  along  $X_a$  of a function for are given by  $e_a(f) = [X_a; f]$ : A coordingly the action of the Lie derivatives on functions is given by

$$L_{\hat{a}}f = [X_{\hat{a}};f]; \tag{2}$$

these Lie derivatives satisfy the Leibniz rule and the SU (2) Lie algebra relation

$$[L_{\hat{a}}; L_{\hat{b}}] = C_{\hat{a}\hat{b}\hat{c}} L_{\hat{c}}$$

In the N ! 1  $\lim$  it the derivations  $e_a$  become  $e_a = C_{abc} x^b Q^c$  and only in this commutative  $\lim$  it the tangent space becomes two dimensional. The exterior derivative is given by

$$df = [X_{\hat{a}}; f]^{\hat{a}}$$

with  $^{\hat{a}}$  the one-form s dual to the vector  $elds\ e_{\hat{a}}$ ,  $< e_{\hat{a}}$ ;  $^{\hat{b}} > = \frac{\hat{b}}{P^{\hat{a}}}$ . The space of one-form s is generated by the  $^{\hat{a}}$ 's in the sense that for any one-form  $! = \frac{\hat{b}}{1} f_{\hat{a}} (dh_{\hat{a}}) t_{\hat{a}}$  we can always write  $! = \frac{\hat{b}}{\hat{a}} \frac{1}{2} t_{\hat{a}}$  with given functions  $!_{\hat{a}}$  depending on the functions  $f_{\hat{a}}$ ,  $h_{\hat{a}}$  and  $t_{\hat{a}}$ . The action of the Lie derivatives on one-form s is given by

$$L_{\hat{a}}(\hat{b}) = C_{\hat{a}\hat{b}\hat{c}}^{\hat{c}} \tag{5}$$

and it is easily seen to commute with the exterior dierential d. On a general one-form  $!=!_{\hat{a}}$  we have  $L_{\hat{b}}!=L_{\hat{b}}(!_{\hat{a}}$   $)=[X_{\hat{b}};!_{\hat{a}}]$   $=[X_{\hat{b}};!_{\hat{a}}]$   $=[X_{\hat{b}};!_{\hat{a}}]$  and therefore

$$(L_{\hat{b}}!)_{\hat{a}} = [X_{\hat{b}};!_{\hat{a}}] \quad !_{\hat{c}}C^{\hat{c}}_{\hat{b}\hat{a}};$$

this form ula will be fundam ental for form ulating the CSDR principle on fuzzy cosets.

The dierential geometry on the product space M inkowskitimes fuzzy sphere, M  $^4$   $S_F^{\,2}$  , is easily obtained from that on M  $^4$  and on  $S_F^{\,2}$  . For example a one-form A de ned on M  $^4$   $S_F^{\,2}$  is written as

$$A = A dx + A_{\hat{a}}^{\hat{a}}$$

with  $A = A (x; X_{\hat{a}})$  and  $A_{\hat{a}} = A_{\hat{a}} (x; X_{\hat{a}})$ .

One can also introduce spinors on the fuzzy sphere and study the Lie derivative on these spinors. Although here we have sketched the dierential geometry on the fuzzy sphere, one can study other (higher dimensional) fuzzy spaces (e.g. fuzzy C P  $^{\rm M}$ ) and with similar techniques their dierential geometry.

## 3 CSDR over fuzzy coset spaces

First we consider on M $^4$  (S=R)<sub>F</sub> a non-commutative gauge theory with gauge group G = U(P) and exam ine its four dimensional interpretation. The action is

where Tr denotes integration over the fuzzy coset (S=R) $_F$  described by N N m atrices, and  $tr_G$  is the gauge group G trace. The higher-dimensional eld strength  $F_M$  N decomposed in four-dimensional space-time and extra-dimensional components reads as follows (F ; $F_{ab}$ ); explicitly the various components of the eld strength are given by

Under an in nitesim alg gauge transform ation =  $(x; X^{\hat{a}})$  we have

$$A_{\hat{a}} = [X_{\hat{a}}; ] + [; A_{\hat{a}}]; \tag{11}$$

thus  $F_{M\ N}$  is covariant under local G gauge transform ations:  $F_{M\ N}$  !  $F_{M\ N}$  + [; $F_{M\ N}$ ]. This is an in nitesimal abelian U (1) gauge transformation if is just an antihermitian function of the coordinates x; X  $^{\hat{a}}$  while it is an in nitesimal nonabelian U (P) gauge transformation if is valued in Lie(U (P)), the Lie algebra of hermitian P P matrices. In the following we will always assume Lie(U (P)) elements to commute with the coordinates X  $^{\hat{a}}$ . In fuzzy/non-commutative gauge theory and in Fuzzy-CSDR a fundamental role is played by the covariant coordinate,

This eld transforms indeed covariantly under a gauge transform ation,  $('_{\hat{a}}) = [;'_{\hat{a}}]$ : In terms of 'the eld strength in the non-commutative directions reads,

and using these expressions the action reads

$$A_{YM} = {}^{Z} d^{4}x Tr tr_{G} \frac{1}{4}F^{2} + \frac{1}{2}(D'_{a})^{2} V(') ; \qquad (15)$$

where the potential term V(') is the  $F_{\hat{a}\hat{b}}$  kinetic term (recall  $F_{\hat{a}\hat{b}}$  is antiherm itian so that V(') is herm itian and non-negative)

$$V(') = \frac{1}{4} Trtr_{G} \sum_{\hat{a}\hat{b}}^{X} F_{\hat{a}\hat{b}} F_{\hat{a}\hat{b}} = \frac{1}{4} Trtr_{G} ['_{\hat{a}};'_{\hat{b}}]['^{\hat{a}};'^{\hat{b}}] 4C_{\hat{a}\hat{b}\hat{c}}'^{\hat{a},\hat{b},\hat{c}} + 2r^{2/2} :$$

This action is naturally interpreted as an action in four dimensions. The in nitesimal G gauge transformation with gauge parameter  $(x; X^{a})$  can indeed be interpreted just as an M  $^{4}$  gauge transformation. We write

$$(x ; X^{\hat{a}}) = (x ; X^{\hat{a}})T = h; (x )T^{h}T ;$$
 (16)

where T are herm itian generators of U (P), (x; X $^{\hat{a}}$ ) are N N antiherm itian matrices and thus are expressible as (x)  $^{\hat{h}}$  T $^{\hat{h}}$  with T $^{\hat{h}}$  antiherm itian generators of U (N). Now the Lie algebra is the tensor product of Lie(U (N)) and Lie(U (P)), it is indeed Lie(U (NP)). Similarly we rewrite the gauge eld A as A (x; X $^{\hat{a}}$ ) = A (x; X $^{\hat{a}}$ )T = A $^{\hat{h}}$ ; (x) T $^{\hat{h}}$ T and interpret it as a Lie(U (NP)) valued gauge eld on M $^{\hat{a}}$ . Similarly we treat  $^{\prime}$ <sub> $\hat{a}$ </sub>.

Up to now we have just performed a fuzzy Kaluza-Klein reduction. Indeed in the commutative case the expression (15) corresponds to rewriting the initial lagrangian on M $^4$ S $^2$ using sphericalharmonics on S $^2$ . Here the space of functions is nited in ensional and therefore the in nite tower of modes reduces to the nite sum given by Tr.

Next we reduce the number of gauge elds and scalars in the action (15) by applying the CSDR scheme. Since Lie SU (2) acts on the fuzzy sphere (SU (2)=U (1)) $_{\rm F}$ , and more in general the group S acts on the fuzzy coset (S=R) $_{\rm F}$ , we can state the CSDR principle in the sameway as in the continuum case, i.e. the elds in the theory must be invariant under the in nitesimal SU (2), respectively S, action up to an in nitesimal gauge transformation

$$L_{\beta}' = {}^{W_{\beta}}' = W_{\beta}'; \qquad L_{\beta}A = {}^{W_{\beta}}A = DW_{\beta}; \qquad (17)$$

where A is the one-form gauge potential  $A=A\ dx+A_a^{\hat{a}}$ , and  $W_{\hat{b}}$  depends only on the coset coordinates  $X^{\hat{a}}$  and (like  $A;A_a$ ) is antiherm itian. We thus write  $W_{\hat{b}}=W_{\hat{b}}T$ ; = 1;2::: $P^2$ ; where  $T^{\hat{a}}$  are herm itian generators of U (P) and  $(W_{\hat{b}}^{\hat{a}})^y=W_{\hat{b}}^{\hat{a}}$ , here  $Y^{\hat{a}}$  is herm itian conjugation on the  $X^{\hat{a}}$ 's. Now in order to solve the constraints (17) we cannot follow the strategy adopted in the commutative case, where the constraints were studied just at one point of the coset (say  $Y^{\hat{a}}=0$ ). This is due to the intrinsic nonlocality of the constraints. On the other hand the special properties of the fuzzy case (e.g. the fact that partial derivatives are realized via commutators, the concept of covariant coordinate) allow to simplify and eventually solve the constraints. Indeed in terms of the covariant coordinate  $Y_{\hat{a}}=X_{\hat{a}}+A_{\hat{a}}$  and of

the CSDR constraints assume a particularly simple form, namely

$$[!_{\hat{b}};A] = 0;$$

In addition we have a consistency condition following from the relation  $[L_a; L_{\hat{b}}] = C_{\hat{a}\hat{b}}^{\hat{c}} L_{\hat{c}}$ :

$$[!_{\hat{a}};!_{\hat{b}}] = C_{\hat{a}\hat{b}}!_{c}; \tag{21}$$

where  $!_{\hat{a}}$  transforms as  $!_{\hat{a}}$ !  $!_{\hat{a}}^0 = g!_{\hat{a}}g^{-1}$ : One proceeds in a similar way for the spinor elds [7].

## 4 Solving the CSDR constraints for the fuzzy sphere

We consider (S=R)\_F =  $S_F^2$ , i.e. the fuzzy sphere, and to be denite at fuzziness level N 1 (N N matrices). We study rst the basic example where the gauge group G = U (1). In this case the  $!_{\hat{a}} = !_{\hat{a}} (X^{\hat{b}})$  appearing in the consistency condition (21) are N N antihermitian matrices and therefore can be interpreted as elements of Lie(U (N )). On the other hand the  $!_{\hat{a}}$  satisfy the commutation relations (21) of Lie(SU (2)). Therefore in order to satisfy the consistency condition (21) we have to embed Lie(SU (2)) in Lie(U (N )). Let The with h = 1;:::;(N)^2 be the generators of Lie(U (N )) in the fundamental representation, we can always use the convention h =  $(\hat{a};u)$  with  $\hat{a} = 1;2;3$  and  $u = 4;5;:::;N^2$  where the Therefore is a satisfy the SU (2) Lie algebra,

$$[T^{\hat{a}};T^{\hat{b}}] = C^{\hat{a}\hat{b}}T^{\hat{c}} : \tag{22}$$

Then we de ne an embedding by identifying

$$!_{\hat{a}} = T_{\hat{a}} : \tag{23}$$

The constraint (19),  $[!_{\hat{D}};A] = 0$ , then implies that the four-dimensional gauge group K is the centralizer of the image of SU (2) in U (N), i.e.

$$K = C_{U(N)}(SU((2))) = SU(N 2) U(1) U(1);$$

where the last U(1) is the U(1) of U(N) 'SU(N) U(1). The functions A (x;X) are arbitrary functions of x but the X dependence is such that A (x;X) is Lie(K) valued instead of Lie(U(N)), i.e. eventually we have a four-dimensional gauge potential A (x) with values in Lie(K). Concerning the constraint (20), it is satisfied by choosing

$$'_{\hat{a}} = r'(x)!_{\hat{a}};$$

i.e. the unconstrained degrees of freedom correspond to the scalar  $% \left( x\right) =x^{\prime }$  eld  $^{\prime }\left( x\right)$  which is a singlet under the four-dimensional gauge group K .

The choice (23) de nes one of the possible embedding of Lie(SU(2)) in Lie(U(N)). For example we could also embed Lie(SU(2)) in Lie(U(N)) using the irreducible N dimensional rep. of SU(2), i.e. we could identify  $!_{\hat{a}} = X_{\hat{a}}$ . The constraint (19) in this case implies that the four-dimensional gauge group is U(1) so that A(x) is U(1) valued. The constraint (20) leads again to the scalar singlet '(x).

In general, we start with a U (1) gauge theory on M  $^4$  S $_F^2$ . We solve the CSDR constraint (21) by embedding SU (2) in U (N ). There exist  $p_N$  embeddings, where  $p_N$  is the number of ways one can partition the integer N into a set of non-increasing positive integers [6]. Then the constraint (19) gives the surviving four-dimensional gauge group. The constraint (20) gives the surviving four-dimensional scalars and eq. (24) is always a solution but in general not the only one. By setting  $'_{\hat{a}} = !_{\hat{a}}$  we obtain always a m in im um of the potential. This m in im um is given by the chosen embedding of SU (2) in U (N ).

In the G=U(P) case,  $!_{\hat{a}}=!_{\hat{a}}(X^{\hat{b}})=!_{\hat{a}}^{h'}T^{h}T$  is an NP NP herm itian matrix and in order to solve the constraint (21) we have to embed Lie(SU(2)) in Lie(U(NP)). All the results of the G=U(1) case holds also here, we just have to replace N with NP.

One proceeds in a sim ilar way form ore general fuzzy coset (S=R) $_F$  (e.g. fuzzy CP $^M$  = SU (M + 1)=U (M )) described by N N matrices. The results are again similar, in particular one starts with a gauge group G = U (P) on M $^4$  (S=R) $_F$ , and then the CSDR constraints in ply that the four-dimensional gauge group K is the centralizer of the image SU (NP) of S in U (NP), K = CU (NP) (SU (NP)).

#### 5 Discussion and Conclusions

The Fuzzy-C SDR has dierent features from the ordinary C SDR leading therefore to new four-dimensional particle models. Here we have stated the rules for the construction of such models; it may well be that Fuzzy-C SDR provides more realistic four-dimensional theories. Having in mind the construction of realistic models one can also combine the fuzzy and the ordinary C SDR scheme, for example considering M $^4$  S $^0\!=\!\!R^0$  (S=R)\_F.

A major di erence between fuzzy and ordinary CSDR is that in Fuzzy-CSDR the spontaneous sym metry breaking mechanism takes already place by solving the Fuzzy-CSDR contraints. The four dimensional Higgs potential has the typical \mexican hat" shape, but it appears already spontaneously broken. Therefore in four dimensions appears only the physical Higgs eld that survives after a spontaneous sym metry breaking. Correspondingly in the Yukawa sector of the theory [7] we obtain the results of the spontaneous sym metry breaking, i.e. massive fermions and Yukawa interactions among fermions and the physical Higgs eld. We see that if one would like to describe the spontaneous sym metry breaking of the SM in the present fram ework, then one would be naturally led to large extra dimensions.

A fundam ental di erence between the ordinary CSDR and its fuzzy version is the fact that a non-abelian gauge group G is not really required in high dim ensions. Indeed the presence of a U (1) in the higher-dim ensional theory is enough to obtain non-abelian gauge theories in four dim ensions.
