SEIZURE OF 1.5 GRAMMES OF OPIUM DROSS MADE AT VANCOUVER, B.C. ON 17 JANUARY 1947

- 1. Name of person or Vallace "Leo" Shirley (Canadian: Irish) persons implicated: (Occupation: Nil - Previously: Bookkeeper) (Born: 8 September, 1900)
- 2. Date of Seizure: December 21, 1946 and January 17, 1947
- 3. Place of Seizure: Vancouver, B.C.
- 4. Kind and quantity of drug seized: <u>Opium: Dross</u>: <u>30 grs</u>.

Decks: $3\frac{1}{2} = 20$ grs. $1 = \frac{3}{23}$ " (1.5 grammes)

- 5. Act and Section under Opium and Narcotic Drug Act Sec. 4(d) which charged: "Illegal Possession of Opium"
- 6. Result of prosecution:
 - (a) Date sentenced: January 17, 1947
 - (b) Where sentenced: Vancouver, B.C.
 - (c) Sentence: 2 years: fined \$200* or 2 mcnths
- 7. REMARKS: Six convictions for breaches of the Drug Act have been previously registered against subject. Shirley is a well-known local character and is handicapped by the wearing of an artificial leg.

Soon after his release on November 18th, 1946 from jail, where he had been serving a Drug Act sentence, he began peddling narcotics and on December 21, 1946 it was learned he had been asked to give up his hotel room and look elsewhere for accommodation. Officers who had been observing his activities saw him entering another hotel and in the lobby he was accosted. A subsequent search disclosed two jars of opium (15 grains (0.9 gramme) in each) in his vest pockets. Stuffed in his sock was found the addict's usual paraphernalia. He was arrested, duly warned and charged. Through questioning, Shirley indicated that the opium found on his person had been cached for some time and had only recently come to light. In view of his disability he was allowed his freedom pending trial. After his release he continued his peddling activities and on January 17th 1947 an agent was able to purchase a deck of opium (3 grains(0.2 gramme)) for which he paid Shirley \$5.00. He was immediately re-arrested by officers who had been trailing him and, although a search of his person for narcotics was a negative one, three and a half decks of opium (20 grains(1.3 grammes)) contained in a small match box, were found nearby. He was brought to trial the same day, and having pleaded Guilty, was sentenced as stated.

Shirley died in the B.C. penitentiary on October 15, 1947.
