THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/690 of the European Parliament and of the Council establishing a Programme for single market, competitiveness of enterprises, including small and medium-sized enterprises, the area of plants, food and feed, and European statistics and repealing Regulations (EU) No 99/2013, (EU) No 1287/2013, (EU) No 254/2014, (EU) No 258/2014, (EU) No 652/2014 and (EU) 2017/826,

Whereas:

- (1) In order to ensure the implementation and development of the Single Market Programme under Regulation (EU) 2021/690 of the European Parliament and of the Council, Implementing Decision C(2022) 724 was adopted for the year 2022.
- (2) The Annexes to Decision C(2022) 724 need to be amended as regards the implementation of actions under the activities "Operation and development of the internal market of goods and services" (budget line 03.020101), "Company law" (budget line 03.020104), "Competition policy for a stronger union in the digital age" (budget line 03.020105), "Improving the competitiveness of enterprises, particularly SMEs, and supporting their access to markets" (budget line 03.0202), European Standardisation (budget line 03.020301), "Ensuring high level of consumer protection and product safety" (budget line 03.020401), "Producing and disseminating high quality statistics on Europe" (budget line 03.0205) and "Contributing to a high level of health for humans, animals and plants along the food chain" (budget line 03.0206).
- (3) Decision C(2022) 724 should therefore be amended accordingly.
- (4) The measures provided for in Annex II to this Decision, which concern the specific objective referred to in Article 3(2), point (b) of Regulation (EU) 2021/690, improving the competitiveness of enterprises, particularly SMEs, are in accordance with the opinion of the Committee established by Article 21(1) of that Regulation.
- (5) The measures provided for in Annex III to this Decision, which concern the specific objective referred to in Article 3(2), point (e), of Regulation (EU) 2021/690, contributing to a high level of health for humans, animals and plants along the food

chain and in related areas, are in accordance with the opinion of the Standing Committee on Plants, Animals, Food and Feed.

HAS DECIDED AS FOLLOWS:

Article 1

The annexes to Decision C(2022) 724 are amended in accordance with the Annexes to this Decision.

Article 2

The amounts set in Article 2 of Decision C(2022) 724 are amended as follows:

- (1) The maximum Union contribution of EUR 510 992 688 is replaced by EUR 511 492 688.
- (2) In point (1) of the first paragraph, the amount of EUR 84 609 150 is replaced by EUR 85 109 150.
- (3) The amount of EUR 8 197 275 for external revenues is replaced by EUR 8 697 275.
