The Meeting Was Cancelled, But the Work Continues!

With the Spring Meeting of the Ohio Society of Pathologists cancelled, we missed seeing familiar faces in Dublin. However, the society continues to work on your behalf! Members of the OSP Board of Governors have worked together and independently to continue efforts to promote the practice of pathology in Ohio. In lieu of our semi-annual business meeting for the general membership, some of the more important points are highlighted below.

Out-of-Network Billing Legislation Update

Ohio politicians have their sights on the elimination of balance ("surprise") billing for out-of-network services. All parties, including the OSP, are interested in removing this burden from our patients. However, the OSP believes the solution needs to hold physicians and insurance companies equally accountable. Such legislation is likely to have profound effects beyond the actual billing for out-of-network services. Specifically, legislation that has currently been drafted, including House Bill 388, could have a catastrophic impact on the ability of pathologists to negotiate fair contracts with insurance companies, resulting in decreased reimbursement across the board.

House Bill 388 passed through voting in the Ohio House of Representatives. The bill lacks many features recommended by medical specialty consensus groups, providing no method of ensuring network adequacy or the presence of a transparent pricing

database. Instead, the bill utilizes a payment formula that the OSP and CAP view as extremely detrimental to physicians in the contracting process.

The OSP Board of Governors has worked alongside Barry Ziman (CAP, Director of Legislative and Political Affairs), Dr. Jonathan Myles, MD (CAP, Economic Affairs Committee Chair), and Columbus-based lobbyists David Corey (PACA, inc) and Mike Dittoe (High Bridge Consulting). The coalition is working to implement critical changes in the bill as it goes through the Ohio Senate.

What can you do?
