This is regarding Pre-qualifiers submitted by School of Engineering, Cochin University of Science and Technology, Cochin University Post, Cochin 682 022, Kerala for the UG Engineering programs in whose case the period of accreditation in Tier I January 2013 document has expired on 30.06.2021.

2.
