

## **Casper Area Economic Summary**




Average weekly wages for all industries by county Casper area, fourth quarter 2023 (U.S. = \$1,435; Area = \$1,228)




Over-the-year change in the <u>prices paid by urban</u> <u>consumers</u> for selected categories

### 12-month percent change in CPI-U, July 2024




Average annual spending and percent distribution for selected categories


