

Household Type and Tenure Data Proposed for 2020 Census Detailed Race, Ethnicity, and American Indian and Alaska Native Tribes and Villages

Adaptive Design Summary

Detailed Demographic and Housing Characteristics File B (Detailed DHC-B)

The 2020 Census produced data for nearly 1,500 detailed race and ethnic groups and detailed American Indian and Alaska Native (AIAN) tribes and villages—the most in U.S. Census Bureau history.

The [Detailed DHC-A data product](#), released in September 2023, consists of total population and age data for these groups. The Detailed DHC-B, which will be released in September 2024, produces household type

and tenure data for the same groups. (“Tenure” means whether the house is owned or rented.)

To protect individuals’ confidential census responses, both the Detailed DHC-A and Detailed DHC-B use a process called “adaptive design.” The privacy-protected population size of each group at each of the geographic levels below determines the amount of detailed data the group receives.

Detailed Groups:

Detailed groups include individual race, ethnicity, and AIAN tribes and villages.

Examples of detailed groups include German, Lebanese, Mexican, Jamaican, Nigerian, Chinese, the Navajo Nation, Samoan, Brazilian, etc.
