## GOVERNMENT'S RESPONSE TO ORDER TO SHOW CAUSE AND NOTICE OF WITHDRAWAL OF COMPLAINT

By Order to Show Cause dated May 5, 2011, the Court directed the United States Department of Housing and Urban Development ("HUD") to show cause as to "why the instant action should not be dismissed for failure to prosecute."

There has been no "failure to prosecute" this action by HUD. Rather, HUD has been unable to take any prosecutorial action because it has been unable to properly serve the Complaint on Respondent Ladarius F. Patrick, and thus no response and request for a hearing has been filed by Respondent. The applicable regulations state that the Complaint "shall be mailed, by registered or certified mail, or shall be delivered through such other means by which *delivery may be confirmed*." 24 C.F.R. § 28.25(a) (emphasis added); see also 31 U.S.C. § 3803(d)(1). On January 4, 2011, HUD issued a Complaint to Respondent by certified mail to the last known addresses where public records showed Respondent resided: (1) 2550 Sandy Plains Road Apt, Marietta, GA 30066-5700 (Certified Mail #70081830000233255940); (2) 3108 Dee Ann Drive, Memphis, TN 38119-9129). See Complaint, p. 21 (Certificate of Service); Exhibit A (Certified

Mail Receipts). The envelope containing the Complaint mailed to the Marietta, Georgia address was delivered on January 6, 2011, as indicated by U.S. Postal Service records. See Exhibit B. However, the return receipt card was not signed by Respondent; rather it was signed by a "J. Jones." See Exhibit C. The envelope containing the Complaint mailed to the Memphis, Tennessee address was returned as "undeliverable," as indicated by U.S. Postal Service records and the envelope that was returned to HUD with a "not at this address" notation written on it by the U.S. Postal Service. Exhibit D and E. Subsequent efforts by HUD to locate Respondent and hand deliver the Complaint to him have been unsuccessful.

The foregoing demonstrates that HUD has been unable to confirm delivery of the Complaint to Respondent as required by 24 C.F.R. § 28.25(a). No proper service has occurred, and thus no response and request for a hearing has been received. For this reason, HUD is withdrawing the Complaint that was filed with the Court on January 4, 2011.
