



Data Use Policy: Living Planet Database

Introduction

This document provides the terms of use for data from the Living Planet Index Database (LPD) which is managed by the Indicators & Assessments Unit at the Zoological Society of London (ZSL) and WWF International (WWF). Potential users must agree to these terms of use prior to accessing the data.

Terms of use

1. The data are supplied only for conservation purposes, scientific analysis or research.
2. The recipient of the data will provide a full and appropriate acknowledgement and citation in any materials or publications derived in part or in whole from the data. The preferred citation format, changing years and date accordingly, is: "LPI 2016. Living Planet Index database. 2016. < www.livingplanetindex.org/>. Downloaded on 24 November 2016". For any publications making substantial use of the data, ZSL and WWF welcome the opportunity for co-authorship, collaboration and comment prior to publication. 3. Reproduction of the underlying dataset or products derived from it, either whole or in part, for direct financial gain is prohibited without prior written permission of ZSL and WWF. If you require permission please contact us at the address below.
