Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

A complete set of Bidding Documents may be acquired by interested bidders from the Bids and Awards Committee Secretariat upon payment of a non-refundable fee ("Fee") based on the standard rates set by the GPPB Resolution No. 04-2012.
