# Precision Electroweak Measurements and Constraints on the Standard Model

The ALEPH, CDF, D0, DELPHI, L3, OPAL, SLD Collaborations, the LEP Electroweak W orking Group, the Tevatron Electroweak W orking Group, and the SLD electroweak and heavy avour groups

Prepared from Contributions to the 2009 Sum mer Conferences.

#### A bstract

This note presents constraints on Standard M odel param eters using published and prelim inary precision electrow eak results measured at the electron-positron colliders LEP and SLC. The results are compared with precise electrow eak measurements from other experiments, notably CDF and D at the Tevatron. Constraints on the input parameters of the Standard Model are derived from the combined set of results obtained in high-Q² interactions, and used to predict results in low-Q² experiments, such as atomic parity violation, Meller scattering, and neutrino-nucleon scattering. The main changes with respect to the experimental results presented in 2008 are new combinations of results on the Weboson mass and the mass of the top quark.

#### 1 Introduction

The experim ental results used here consist of the naland published Z-pole results [1] m easured by the ALEPH, DELPHI, L3, OPAL and SLC experim ents, taking data at the electron-positron colliders LEP and SLC. In addition, published and prelim inary results on the mass and width of the W boson, measured at LEP-II and the Tevatron, and the mass of the top quark, measured at the Tevatron only, are included. This report updates our previous analysis [2].

The m easurem ents allow to check the validity of the Standard M odel (SM ) and, within its fram ework, to infer valuable inform ation about its fundam ental param eters. The accuracy of the W - and Z-boson m easurem ents m akes them sensitive to the m ass of the top quark m  $_{\rm t}$ , and to the m ass of the H iggs boson m  $_{\rm H}$  through loop corrections. While the leading m  $_{\rm t}$  dependence is quadratic, the leading m  $_{\rm t}$  dependence is logarithm ic. Therefore, the inferred constraints on m  $_{\rm t}$  are m uch stronger than those on m  $_{\rm t}$ .

#### 2 M easurem ents

The measurement results considered here are reported in Table 1. Also shown are their predictions based on the results of the SM  $\,$  to these combined high-Q  $^2$  measurements, as reported in the last column of Table 2.

The m easurem ents obtained at the Z pole by the LEP and SLC experim ents ALEPH, DELPHI, L3, OPAL and SLD, and their combinations, reported in parts a), b) and c) of Table 1, are nal and published [1].

The results on the W -boson mass by CDF [3] and D [4] in Run-I, and the W -boson width by CDF [5] and D [6] in Run-I, are combined by the Tevatron Electroweak W orking G roup based on a detailed treatment of common systematic uncertainties [7]. Including also results based on Run-II data on m w by CDF [8,9] and D [10], and on w by CDF [11] and D [12], the combined Tevatron results are [13,14]: m w = 80:420 0:031 GeV, w = 2:050 0:058 GeV. Combining these results with the preliminary LEP-II combination [16], m w = 80:376 0:033 GeV and w = 2:196 0:083 GeV, the resulting averages used here are:

For the mass of the top quark, m<sub>t</sub>, the published Run-I results from CDF [17] and D [18], and preliminary and published results based on Run-II data from CDF [19] and D [20], are combined by the Tevatron E lectroweak W orking G roup with the result:  $m_t = 173:1 - 1:3 \text{ GeV}$  [21] where the uncertainty now includes an estimate for colour reconnection e ects. The exact de nition of the mass of the top quark and the related theoretical uncertainty in the interpretation of the measured \pole" mass urgently require further study [22].

In addition, the following nalresults obtained in low- $Q^2$  interactions and reported in Table 3 are considered: (i) the measurements of atomic parity violation in caesium [23,24], with the numerical

result [25] based on a revised analysis of QED radiative corrections applied to the raw measurement; (ii) the result of the E-158 collaboration on the electroweak mixing angle measured in M ller scattering [27]; and (iii) the nalresult of the NuTeV collaboration on neutrino-nucleon neutral to charged current cross section ratios [28].

U sing neutrino-nucleon data with an average Q  $^2$  ' 20 G eV  $^2$ , the NuTeV collaboration has extracted the left-and right-handed couplings combinations  $g_{Lud}^2=4g_L^2~(g_{Lu}^2+g_{Ld}^2)=[1=2\sin^2_e+(5=9)\sin^4_e]_{ud}$  and  $g_{Rud}^2=4g_L^2~(g_{Ru}^2+g_{Rd}^2)=(5=9)\sin^4_e$  ud, with the parameters for example dened in [29]. The NuTeV results for the elective couplings are:  $g_{Lud}^2=0.30005-0.00137$  and  $g_{Rud}^2=0.03076-0.00110$ , with a correlation of 0.017. While the result on  $g_{Rud}$  agrees with the SM expectation, the result on  $g_{Lud}$ , relatively measured nearly eight times more precisely than  $g_{Rud}$ , shows a decit with respect to the expectation at the level of 2.9 standard deviations [28].

An additional input param eter, not shown in the table, is the Ferm i constant  $G_F$ , determ ined from the lifetime,  $G_F = 1:16637(1)$   $10^5$  GeV  $^2$  [31]. New measurements of  $G_F$  yield values which are in good agreement [32,33]. The relative error of  $G_F$  is comparable to that of m  $_Z$ ; both errors have negligible elects on the tresults.

#### 3 Theoretical and Param etric Uncertainties

Detailed studies of the theoretical uncertainties in the SM predictions due to missing higher-order electroweak corrections and their interplay with QCD corrections had been carried out by the working group on 'P recision calculations for the Z resonance' [29], and later in R eferences 34 and 35. Theoretical uncertainties are evaluated by comparing dierent but, within our present knowledge, equivalent treatments of aspects such as resummation techniques, momentum transfer scales for vertex corrections and factorisation schemes. The electroweak libraries TOPAZO [38] and ZFITTER [39].

The use of the higher-order QCD corrections [37] increases the value of  $_S$  (m  $_Z^2$ ) by 0.001, as expected. The e ect of m issing higher-order QCD corrections on  $_S$  (m  $_Z^2$ ) dom inates m issing higher-order electroweak corrections and uncertainties in the interplay of electroweak and QCD corrections. A discussion of theoretical uncertainties in the determination of  $_S$  can be found in References 29 and 40, with a more recent analysis in Reference 41 where the theoretical uncertainty is estimated to be about 0.001 for the analyses presented in the following.

The complete (ferm ionic and bosonic) two-loop corrections for the calculation of m  $_{\rm W}$  [42], and the complete ferm ionic two-loop corrections for the calculation of  $\sin^2\frac{\rm lept}{\rm e}$  [43] have been calculated. Including three-loop top-quark contributions to the parameter in the limit of large m  $_{\rm t}$  [44], ecient routines for evaluating these corrections have been implemented since version 6.40 in the seminallytical program ZFITTER. The remaining theoretical uncertainties are estimated to be 4 MeV on mand 0.000049 on  $\sin^2\frac{\rm lept}{\rm e}$ . The latter uncertainty dominates the theoretical uncertainty in SM ts and the extraction of constraints on the mass of the Higgs boson presented below. For a complete picture, the complete two-loop calculation for the partial Z decay widths should be calculated.

The theoretical errors discussed above are not included in the results presented in Tables 2 and 3. At present the impact of theoretical uncertainties on the determination of SM parameters from the

precise electroweak m easurements is small compared to the error due to the uncertainty in the value of  $(m_7^2)$ , which is included in the results.

The uncertainty in  $(m_{\tilde{z}}^2)$  arises from the contribution of light quarks to the photon vacuum polarisation,  $(m_{\tilde{z}}^2)$ :

where (0) = 1=137.036. The top contribution, 0.00007(1), depends on the mass of the top quark, and is therefore determined inside the electroweak libraries TOPAZO and ZFITTER. The leptonic contribution is calculated to third order [45] to be 0.03150, with negligible uncertainty.

For the hadronic contribution  $^{(5)}_{had}$  (m  $_{\rm Z}^2$ ), we use the result 0:02758 0:00035 [46] which takes into account published results on electron-positron annihilations into hadrons at low centre-of-m ass energies by the BES collaboration [47], as well as the revised published results from CMD-2 [48] and results from KLOE [49]. The reduced uncertainty still causes an error of 0.00013 on the SM prediction of  $\sin^2\frac{lept}{e}$ , and errors of 0.2 GeV and 0.1 on the tted values of m  $_{\rm t}$  and  $\log(m_{\rm H})$ , included in the results presented below . The election the SM prediction for m is negligible. The  $_{\rm S}$  (m  $_{\rm Z}^2$ ) values from the SM ts presented here are stable against a variation of m in the interval quoted.

There are also several evaluations of  $^{(5)}_{had}$  (m  $^2_{Z}$ ) [50{60] which are more theory-driven. One of the more recent of these (R eference 60) also includes the new results from BES, yielding 0:02749 0:00012. To show the elects of the uncertainty of (m  $^2_{Z}$ ), we also use this evaluation of the hadronic vacuum polarisation.

#### 4 Selected Results




Figure 1: LEP-I+ SLD m easurements [1] of  $\sin^2\frac{lept}{e}$  and  $\cdots$  and the SM prediction. The point with the arrow labelled shows the prediction if among the electroweak radiative corrections only the photon vacuum polarisation is included. The associated arrow shows variation of this prediction if (m $^2_Z$ ) is changed by one standard deviation. This variation gives an additional uncertainty to the SM prediction shown in the gure.

Figure 1 shows a comparison of the leptonic partial width from LEP-I, ...=83.985 0.086 MeV [1], and the electroweak mixing angle from asymmetries measured at LEP-I and SLD,  $\sin^2\frac{lept}{e}=0.23153$  0.00016 [1], with the SM shown as a function of m<sub>t</sub> and m<sub>H</sub>. Good agreement with the SM prediction using the most recent measurements of m<sub>t</sub> and m<sub>W</sub> is observed. The point with the arrow indicates the prediction if among the electroweak radiative corrections only the photon vacuum polarisation is included, which shows that the precision electroweak Z-pole data are sensitive to non-trivial electroweak corrections. Note that the error due to the uncertainty on (m<sup>2</sup><sub>Z</sub>) (shown as the length of the arrow) is not much smaller than the experimental error on  $\sin^2\frac{lept}{e}$  from LEP-I and SLD. This underlines the continued in portance of a precise measurement of (e<sup>+</sup> e ! hadrons) at low centre-of-mass energies.

Of the measurements given in Table 1, R  $^{\circ}$  is one of the most sensitive to QCD corrections. For m  $_{\rm Z}$  = 91:1875 GeV, and imposing m  $_{\rm t}$  = 173:1 1:3 GeV as a constraint,  $_{\rm S}$  = 0:1223 0:0038 is obtained. A lternatively,  $_{\rm lep}^{0}$   $_{\rm had}^{0}$  =R  $_{\rm had}^{\circ}$  = 2:0003 0:0027 nb [1] which has higher sensitivity to QCD corrections and less dependence on m  $_{\rm H}$  yields:  $_{\rm S}$  = 0:1179 0:0030. Typical errors arising from the variation of m  $_{\rm H}$  between 100 GeV and 200 GeV are of the order of 0:001, som ewhat smaller for  $_{\rm lep}^{0}$ . These results on  $_{\rm S}$ , as well as those reported in the next section, are in very good agreement with world averages ( $_{\rm S}$  (m  $_{\rm Z}^{2}$ ) = 0:118 0:002 [61], or  $_{\rm S}$  (m  $_{\rm Z}^{2}$ ) = 0:1178 0:0033 based solely on NNLO QCD results excluding the LEP-I lineshape results and accounting for correlated errors [62]).

## 5 Standard Model Analyses

In the following, several dierent SM analyses as reported in Table 2 are discussed. The  $^2$  m inim isation is performed with the program M INUIT [63], and the predictions are calculated with ZFITTER 6.43 as a function of the ve SM input parameters  $^{(5)}_{\rm had} \, (\text{m}_{\, \text{Z}}^{\, 2})$ ,  $_{\, \text{S}} \, (\text{m}_{\, \text{Z}}^{\, 2})$ ,  $_{\, \text{M}} \, (\text$




Figure 2: The comparison of the indirect constraints on m $_{\rm W}$  and m $_{\rm t}$  based on LEP-I/SLD data (dashed contour) and the direct m easurements from the LEP-II/T evatron experiments (solid contour). In both cases the 68% CL contours are plotted. Also shown is the SM relationship for the masses as a function of the Higgs mass in the region favoured by theory (< 1000 GeV) and allowed by direct searches (114 GeV to 170 GeV and > 180 GeV). The arrow labelled shows the variation of this relation if (m $_{\rm Z}^2$ ) is changed by plus/m inus one standard deviation. This variation gives an additional uncertainty to the SM band shown in the gure.

To test the agreem ent between the Z-pole data [1] (LEP-I and SLD) and the SM, at to these data is performed. The result is shown in Table 2, column 1. The indirect constraints on m $_{\rm W}$  and m $_{\rm t}$  are shown in Figure 2, compared with the direct measurements. Also shown are the SM predictions for Higgs masses between 114 and 1000 GeV. As can be seen in the gure, the indirect and direct measurements of m $_{\rm W}$  and m $_{\rm t}$  are in good agreement, and both sets prefer a low value of the Higgs mass.




Figure 3: The 68% con dence level contour in m  $_{\rm W}$  and m  $_{\rm H}$  for the t to all data except the direct m easurem ent of m  $_{\rm W}$ , indicated by the shaded horizontal band of 1 sigm a width. The vertical bands shows the 95% C L exclusion lim it on m  $_{\rm H}$  from the direct searches at LEP-II (up to 114 G eV) and the Tevatron (160 G eV to 170 G eV).

For the t shown in column 2 of Table 2, the direct m  $_{\rm t}$  m easurement is included to obtain the best indirect determination of m  $_{\rm W}$ . The result is also shown in Figure 3. Also in this case, the indirect determination of the W boson mass, 80:364 0:020 GeV, is in good agreement with the direct measurements from LEP-II and the Tevatron, measurements from LEP-II and the Tevatron are included instead of the direct measurement in order to obtain the constraint measurement with the direct measurement of measurement of the direct measurement of the direc

Finally, the best constraints on m  $_{\rm H}$  are obtained when all high-Q  $^2$  m easurem ents are used in the t. The results of this tare shown in column 4 of Table 2. The predictions of this t for observables measured in high-Q  $^2$  and low-Q  $^2$  reactions are listed in Tables 1 and 3, respectively. In Figure 5 the observed value of  $^2$   $^2$   $^2$  m in as a function of m  $_{\rm H}$  is plotted for this t including all high-Q  $^2$  results. The solid curve is the result using ZFITTER, and corresponds to the last column of Table 2. The shaded band represents the uncertainty due to uncalculated higher-order corrections, as estimated by ZFITTER.

The 95% one-sided con dence level upper lim it on m  $_{\rm H}$  (taking the band into account) is 157 G eV . The 95% C L lower lim it on m  $_{\rm H}$  of 114.4 G eV obtained from direct searches at LEP-II [64] and the region between 160 G eV and 170 G eV excluded by the Tevatron experiments [65] are not used in the determination of this lim it. Including the LEP-II direct-search lim it increases the lim it from 157 G eV to 186 G eV . Also shown is the result (dashed curve) obtained when using  $^{(5)}_{had}$  (m  $_{Z}^{2}$ ) of R eference 60.

Given the constraints on the other four SM input param eters, each observable is equivalent to a constraint on the mass of the SM Higgs boson. The constraints on the mass of the SM Higgs boson resulting from each observable are compared in Figure 6. For very low Higgs-masses, these constraints are qualitative only as the elects of real Higgs-strahlung, neither included in the experimental analyses nor in the SM calculations of expectations, may then become sizeable [66]. Besides the measurement of the W mass, the most sensitive measurements are the asymmetries, i.e.,  $\sin^2\frac{lept}{e}$ . A reduced uncertainty for the value of  $(m_Z^2)$  would therefore result in an improved constraint on  $\log m_H$  and thus  $m_H$ , as already shown in Figures 1 and 5.




Figure 4: The 68% con dence level contour in m  $_{\rm t}$  and m  $_{\rm H}$  for the t to all data except the direct m easurem ent of m  $_{\rm t}$ , indicated by the shaded horizontal band of 1 sigm a width. The vertical band shows the 95% CL exclusion lim it on m  $_{\rm H}$  from the direct searches at LEP-II (up to 114 G eV ) and the Tevatron (160 G eV to 170 G eV ).




Figure 5:  $^2$  =  $^2$   $^2$   $^2$  m in vs. m H curve. The line is the result of the tusing all high-Q  $^2$  data (last column of Table 2); the band represents an estimate of the theoretical error due to missing higher order corrections. The vertical band shows the 95% CL exclusion limit on m H from the direct searches at LEP-II (up to 114 GeV) and the Tevatron (160 GeV to 170 GeV). The dashed curve is the result obtained using the evaluation of  $^{(5)}$  had  $^{(5)}$  from R eference 60. The dotted curve corresponds to a tincluding also the low-Q  $^2$  data.




Figure 6: Constraints on the mass of the Higgs boson from each pseudo-observable. The Higgs-boson mass and its 68% CL uncertainty is obtained from a ve-parameter SM to the observable, constraining  $\binom{(5)}{\text{had}} \left( \text{m} \frac{2}{2} \right) = 0.02758$  0.00035,  $_{\text{S}} \left( \text{m} \frac{2}{2} \right) = 0.118$  0.003,  $_{\text{m}} = 91.1875$  0.0021 GeV and  $_{\text{m}} = 173.1$  1.3 GeV. Because of these four common constraints the resulting Higgs-boson mass values are highly correlated. The shaded band denotes the overall constraint on the mass of the Higgs boson derived from all pseudo-observables including the above four SM parameters as reported in the last column of Table 2. The vertical line denotes the 95% CL lower limit from the direct search for the Higgs boson. Results are only shown for Higgsmass sensitive observables.

#### 6 Conclusions

The prelim inary and published results from the LEP, SLD and Tevatron experiments, and their combinations, test the Standard M odel (SM) at the highest interaction energies. The combination of the many precise electroweak results yields stringent constraints on the SM and its free parameters. Most measurements agree well with the predictions. The spread in values of the various determinations of the electroweak mixing angle in asymmetry measurements at the Z pole is somewhat larger than expected [1].

# Prospects for the Future

Them easurem ents from data taken at or near the Z resonance, both at LEP as well as at SLC, are nal and published [1]. Some improvements in accuracy are expected in the high energy data (LEP-II), where each experiment has accumulated about 700 pb  $^{1}$  of data, when combinations of the published nal results are made. The measurements from the Tevatron experiments will continue to improve with the increasing data sample collected during Run-II. The measurements of mw are likely to reach a precision comparable to the uncertainty on the prediction obtained via the radiative corrections of the Z-pole data, providing an important test of the Standard Model. The large data samples to be collected at the LHC set the stage for further improvements. Work is needed in reconciling the denition of the top-quark mass in the theory and its extraction from the collider data.
