CHARACTERIZATIONS OF OUTER MEASURES ASSOCIATED WITH LATTICE MEASURES

Abstract. Let *ν* be a finite countably subadditive outer measure defined on all subsets of a set *X*, take a collection $\mathbb C$ of subsets of *X* containing *X* and \emptyset , we derive an outer measure ρ using ν on sets in \mathbb{C} . By applying this general framework on two special cases in which $v = \mu''$, one where $\mu \in M_{\sigma}(\mathcal{L})$ and the other where $\mu \in M_{\sigma}(\mathcal{L}_1)$, $\mathcal{L}_1 \subseteq \mathcal{L}_2$ being lattices on a set *X*, we obtain new characterizations of the outer measure μ'' . These yield useful relationships between various set functions including μ_i , μ_j , μ'' , and μ' .

1. Introduction. In this paper, we establish a general framework for the study of outer measures associated with a lattice measure, in particular, of two previously studied outer measures: μ' which is finitely subadditive and μ'' which is countably subadditive. Our terminology is consistent with standard usage in [\[1, 2, 4\]](#page-12-0); a summary of notations and terminology as well as a brief background is given in [Section 2.](#page-1-0)

Let *ν* be a finite countably subadditive outer measure defined on all subsets of a set *X*, take a collection $\mathbb C$ of subsets of *X* containing *X* and \emptyset , we derive an outer measure *ρ* using *ν* on sets in C. We examine two special cases: one in which C is derived from sets related to a lattice $\mathcal L$ of subsets of *X*; another in which there are two lattices $\mathcal L_1 \subseteq \mathcal L_2$ on *X* and \mathbb{C} is derived from \mathcal{L}_2 . In the former, we take $v = \mu''$, where $\mu \in M_{\sigma}(\mathcal{L})$; in the latter $v = \mu''$, where $\mu \in M_{\sigma}(\mathcal{L}_1)$. We obtain new characterizations of μ'' . This is developed in [Section 3,](#page-2-0) which ends with three immediate consequences of this new framework: a shorter proof of an old result on $\mu' = \mu''$ under the condition that $\mathcal L$ is a δ -lattice; letting $\mathbb C$ be derived from $\mathcal L_2 = S_{\mathbf u''}$ in the second case yields $\mathbf u'' = (\mathbf u'')^0$, where the latter is an outer measure previously studied [\[2, 4\]](#page-12-0) and the regularity of *µ* for $\mu \in M^{\sigma}(\mathcal{L}_1)$.

In [Section 4,](#page-4-0) we define the notion of condition M on μ ["] and examine the case of a single lattice to obtain useful inequalities [\(Theorem 4.7,](#page-5-0) Corollaries [4.8](#page-6-0) and [4.9\)](#page-6-0) to relate various set functions $\mu_i,\ \mu_j,\ \mu^{\prime\prime}$, and $\mu^\prime.$ We introduce three "regularity"-type conditions on $\mu \in M_{\sigma}(\mathcal{L})$ and study the relationship between them as well as their effect on the equalities of some of the set functions. The inequalities obtained are used to provide alternate proofs on results on equalities of μ' and μ'' on either $\mathcal L$ or \mathcal{L}' . Under the condition of normality of \mathcal{L} , we also prove how one of these conditions results in the equality of $\mu \in M(\mathcal{L})$ and $\nu \in M_{\sigma}(\mathcal{L})$.

In [Section 5,](#page-8-0) we examine the case of a pair of lattices on *X* and introduce six conditions relating to outer measures μ'' and ν'' , where $\mu \in M_{\sigma}(\mathcal{L}_1)$ and $\nu \in M_{\sigma}(\mathcal{L}_2)$, an extension of μ . The relationships between these conditions are studied. Parallel to [Section 4,](#page-4-0) sets of inequalities relating to various set functions [\(Theorem 5.4](#page-11-0) and [Corollary 5.5\)](#page-11-0) are obtained and used to show how the conditions introduced in this section result in the equalities of some of the set functions on \mathcal{L}_2^\prime and how they relate to the conditions introduced in [Section 4](#page-4-0) on μ ["] on \mathcal{L}_1 .

2. Notations and background. On a nonempty set *X*, a lattice \mathcal{L} of subsets of *X* contains *X* and \emptyset , the algebra generated by $\mathcal L$ is denoted by $A(\mathcal L)$ and the σ -algebra generated by $\mathcal L$ is denoted by $\sigma(\mathcal L)$.

LATTICE PROPERTIES. L is *normal* if and only if for all $A, B \in \mathcal{L}, A \cap B = \emptyset$, there exist C and D in $\mathcal L$ such that

A \subseteq C', \quad B \subset D', \quad \text{and} \quad C' \bigcap D' = \emptyset,
$$

L is a *δ-lattice* if and only if it is closed under countable intersections.

 \mathcal{L}_1 and \mathcal{L}_2 are lattices on *X*, where \mathcal{L}_1 ⊆ \mathcal{L}_2 . \mathcal{L}_1 *coseparates* \mathcal{L}_2 if for B_1 and B_2 in \mathcal{L}_2 , $B_1 \cap B_2 = \emptyset$, there exist A_1 and A_2 in \mathcal{L}_1 such that $B_1 \subseteq A'_1$, $B_2 \subseteq A'_2$, and $A'_1 \cap A'_2 = \emptyset$.

We consider the set $M(\mathcal{L})$ of all non-trivial, non-negative, finitely additive bounded measures on $A(\mathcal{L})$.

MEASURE PROPERTIES. $M_R(\mathcal{L})$ is the set of all \mathcal{L} -regular measures on $A(\mathcal{L})$: $\mu \in$ $M_R(\mathcal{L}) \subseteq M(\mathcal{L})$ if and only if for any $A \in \mathbf{A}(\mathcal{L})$,

$$
\mu(A) = \sup \{ \mu(L) \mid L \subseteq A, L \in \mathcal{L} \}. \tag{2.2}
$$

 $M_{\sigma}(\mathcal{L})$ is the set of all σ *-smooth measures on* $\mathcal{L} : \mu \in M_{\sigma}(\mathcal{L}) \subseteq M(\mathcal{L})$ if and only if for any sequence,

, $L_n \in \mathcal{L}$, $L_n \downarrow \emptyset$, we have $\lim_n \mu(L_n) = 0$. (2.3)

M^{*σ*} (*L*) is the set of all *σ-smooth measures on* **A**(*L*) : $\mu \in M^{\sigma}(\mathcal{L}) \subseteq M(\mathcal{L})$ if and only if for

\{A_n \in \mathbf{A}(\mathcal{L}) \mid n = 1, 2, \dots\}, \quad A_n \downarrow \emptyset, \ \lim_{n} \mu(A_n) = 0. \tag{2.4}
$$

Note that $\mu \in M^{\sigma}(\mathcal{L})$ if and only if μ is countably additive and can be extended uniquely to $\sigma(\mathcal{L})$, and that an \mathcal{L} -regular measure which is σ -smooth on \mathcal{L} is σ -smooth on $A(\mathcal{L})$. *M*^{*σ*}_{*R*} (*L*) is the set of all *L*-regular measures which are *σ*-smooth on **A**(*L*). *M*(*σ*,*L*) is the set of all measures *strongly* σ *-smooth on* \mathcal{L} : $\mu \in M(\sigma, \mathcal{L}) \subseteq M(\mathcal{L})$ if and only if for any

\{L_n \in \mathcal{L}, n = 1, 2, \ldots\}, \quad L_n \downarrow, \bigcap_n L_n \in \mathcal{L} \text{ then } \mu\left(\bigcap_n L_n\right) = \lim_{n \to \infty} \mu(L_n). \tag{2.5}
$$

Note that if $\mu \in M(\sigma, \mathcal{L})$, then μ is countably subadditive on \mathcal{L}' , i.e., for $L_n \in \mathcal{L}$ and $\bigcup_{n=1}^{\infty} L'_n \in \mathcal{L}'$, $\mu(\bigcup_{n=1}^{\infty} L'_n) \leq \sum_{n=1}^{\infty} \mu(L'_n)$.

If, in addition, a measure is 0-1 valued, we say that it belongs to $I(\mathcal{L})$, replacing M by *I* in each of the terms above.

For $\mu_1, \mu_2 \in M(\mathcal{L})$, we say that $\mu_1 \leq \mu_2(\mathcal{L})$ if and only if $\mu_1(L) \leq \mu_2(L)$ for any $L \in \mathcal{L}$. Note that in the case that $\mu_1 \leq \mu_2(\mathcal{L})$, we have:

- (i) $\mu_1 \in M_R(\mathcal{L})$ implies that $\mu_1 = \mu_2$;
- (ii) $\mu_2 \in M_{\sigma}(\mathcal{L})$ implies that $\mu_1 \in M_{\sigma}(\mathcal{L})$.

Associated outer measures. We summarize some known results (cf. [\[1\]](#page-12-0)) on two outer measures μ'' and μ' .

For $E \subseteq X$, $\mu \in M(\mathcal{L})$, $\mu'(E) = \inf \{ \mu(L') \mid E \subset L', L \in \mathcal{L} \}$, and $\mu''(E) = \inf \{ \sum_i \mu(L'_i) \mid E \subset L'_i, L'_i \in \mathcal{L} \}$ $E \subset \bigcup_i L'_i$, $L_i \in \mathcal{L}$ }. To avoid a trivial μ'' in the case of 0-1 valued measures, we usually assume $\mu \in M_{\sigma}(\mathcal{L})$ when μ'' is considered. The set of all $\mu'' - [\mu' -]$ measurable sets is denoted by $S_{\mu''}$ [$S_{\mu'}$]: for $E \subseteq X$, $E \in S_{\mu''}$ if and only if $\mu''(A) = \mu''(A \cap E) + \mu''(A \cap E')$ for all $A \subseteq X$. For a finitely subadditive *outer measure* v , v is *regular* if for any $A \subseteq X$, there exists $E \in S_\nu$ such that $A \subseteq E$ and $\nu(A) = \nu(E)$. If $\mu \in I(\mathcal{L})$ [$I_\sigma(\mathcal{L})$], then $\mu'[\mu'']$ is regular. We have the following results.

(1) $\mu'(\emptyset) = 0$; μ' is monotone and is a finitely subadditive outer measure. $S_{\mu'}$ is an algebra and $\mu'|_{S_{\mu'}}$ is finitely additive measure.

(2) μ ^{*''*} is a countably additive outer measure. S_{μ} ^{*''*} is a σ -algebra and μ ^{''} $|S_{\mu}$ ['] is countably additive.

(3) In general, we have the following relationships:

$$
\mu \preceq \mu'(\mathcal{L}), \quad \mu = \mu'(\mathcal{L}'), \qquad \mu'' \preceq \mu(\mathcal{L}'), \quad \mu'' \preceq \mu'.
$$
 (2.6)

(4) $\mu \in M_R(\mathcal{L})$ if and only if $\mu = \mu'(\mathcal{L})$.

(5) If
$$
\mu \in M_{\sigma}(\mathcal{L})
$$
, then

- (a) $\mu''(X) = \mu(X)$;
- (b) $\mu \leq \mu''(\mathcal{L})$ [\[1\]](#page-12-0).
- (6) If $\mu \in M(\sigma, \mathcal{L})$, then $\mu'' = \mu(\mathcal{L}')$ [\[4\]](#page-12-0).
- (7) If $\mu \in M_{\sigma}(\mathcal{L})$, μ'' is regular and $\mu'' = \mu(\mathcal{L}')$, then $\mu \in M(\sigma, \mathcal{L})$ [\[4\]](#page-12-0).
- (8) If $\mu \in M_{\sigma}(\mathcal{L})$, μ'' is regular and $\mu'' = \mu(\mathcal{L})$, then $\mu \in M^{\sigma}(\mathcal{L})$ [\[1\]](#page-12-0).

Using these outer measures, we have two "regularity"-type of conditions on the measure $\mu : M_w(\mathcal{L})$ is the set of all *weakly regular measures* on $A(\mathcal{L}) : \mu \in M_w(\mathcal{L}) \subseteq$ *M*(\mathcal{L}) if and only if for any $L \in \mathcal{L}$,

$$
\mu(L') = \sup \{ \mu'(\tilde{L}) \mid \tilde{L} \subseteq L', \ \tilde{L} \in \mathcal{L} \}. \tag{2.7}
$$

 $M_{\nu}(\mathcal{L})$ is the set of all *vaguely regular measures on* $\mathbf{A}(\mathcal{L}) : \mu \in M_{\nu}(\mathcal{L}) \subseteq M_{\sigma}(\mathcal{L})$ if and only if for any $L \in \mathcal{L}$,

$$
\mu(L') = \sup \{ \mu''(\tilde{L}) \mid \tilde{L} \subseteq L', \ \tilde{L} \in \mathcal{L} \}. \tag{2.8}
$$

In general, $M_R(\mathcal{L}) \subseteq M_w(\mathcal{L})$. If \mathcal{L} is normal, then $M_R(\mathcal{L}) = M_w(\mathcal{L})$ (cf. [\[1\]](#page-12-0)).

3. Framework. We consider a finite countably subadditive outer measure *ν* defined on all subsets of a set *X*. Initially, $\mathbb C$ is a collection of subsets of *X* containing \emptyset and *X*. In addition, let ℂ be closed under countable union. We define a set function *ρ*

using $v :$ for $E \subset X$,

$$
\rho(E) = \inf \{ \nu(C), \ E \subset C \in \mathbb{C} \}. \tag{3.1}
$$

We show that ρ is an outer measure with $v \leq \rho$: the definition yields easily that ρ has value zero at the null set, it is monotone and $v \leq \rho$. To see that it is countably subadditive, suppose $E_i \subset X$, for any $\epsilon > 0$, we can find $C_i \in \mathbb{C}$ such that $\nu(C_i)$ < $\rho(E_i) + \epsilon/2^i$ and $E_i \subset C_i$. So $\sum_1^{\infty} \nu(C_i) < \sum_1^{\infty} \rho(E_i) + \epsilon$ and $\bigcup_i E_i \subset \bigcup_i C_i \in \mathbb{C}$. Since *v* is countably subadditive and ρ is defined as a lower bound of all $\nu(C)$, $C \in \mathbb{C}$, we have

$$
\rho\left(\bigcup_{i} E_{i}\right) \leq \nu\left(\bigcup_{i} C_{i}\right) \leq \sum_{1}^{\infty} \nu(C_{i}) < \sum_{1}^{\infty} \rho(E_{i}) + \epsilon. \tag{3.2}
$$

By applying this general setting to two special cases, we gain two new perspectives for our applications: one with one lattice $\mathcal L$ on X; another with two lattices $\mathcal L_1$ and $\mathcal L_2$ on *X*, with $\mathcal{L}_1 \subset \mathcal{L}_2$.

PROPOSITION 3.1. Let $\mathbb C$ be the collection of all countable unions of sets from $\mathcal L'$ and $\nu = \mu''$, where $\mu \in M(\mathcal{L})$. Then $\rho = \mu''$ and $\mu''(E) = \inf \{ \mu''(\bigcup_{1}^{\infty} L'_i), E \subset \bigcup_{1}^{\infty} L'_i, L_i \in \mathcal{L} \}.$

PROOF. (a) In general, $\mu'' = \nu \leq \rho$.

(b) Suppose that there exists $E \subset X$ such that $\mu''(E) < \rho(E)$. Then there exists a sequence $\{L_i\} \subset \mathcal{L}$ such that $E \subset \bigcup_{1}^{\infty} L'_i = C \in \mathbb{C}$ and

$$
\sum_{1}^{\infty} \mu(L'_i) < \rho(E) \le \mu''\left(\bigcup_{1}^{\infty} L'_i\right)\left(E \subset \bigcup_{1}^{\infty} L'_i\right) \le \sum_{1}^{\infty} \mu''(L'_i) \le \sum_{1}^{\infty} \mu(L'_i),\tag{3.3}
$$

a contradiction. This gives a new characterization of μ'' .

PROPOSITION 3.2. With $\mathcal{L}_1 \subset \mathcal{L}_2$, let $\mathbb C$ to be all countable unions of sets from \mathcal{L}_2' and $v = \mu''$, where $\mu \in M(\mathcal{L}_1)$. Then $\rho = \mu''$ and

$$
\mu''(E) = \inf \left\{ \mu''\left(\bigcup_{1}^{\infty} L'_{2_i}\right), \ E \subset \bigcup_{1}^{\infty} L'_{2_i}, \ L_{2_i} \in \mathcal{L}_2 \right\}.
$$
 (3.4)

 \Box

PROOF. As before, if $E \subset \bigcup_{1}^{\infty} L'_{i} = C \in \mathbb{C}$, $\{L'_{i}\} \subset \mathcal{L}'_{2} \subset \mathcal{L}'_{1}$, the inequalities hold and the same contradiction is arrived.

These two characterizations of μ " can be shown independently of our new setting and *ρ*:

(I) By monotonicity and definition of μ'' , we see that

$$
\mu''(E) \le \inf \left\{ \mu''\left(\bigcup_{1}^{\infty} L'_i\right), \ E \subset \bigcup_{1}^{\infty} L'_i, \ L_i \in \mathcal{L} \right\}.
$$
 (3.5)

Suppose that it were a strict inequality, there is a sequence $\{L_i\}$ in $\mathbf{\mathcal{L}}$ with

$$
\sum_{i=1}^{\infty} \mu(\tilde{L}'_i) < \inf \mu''\left(\bigcup_{i} L'_i\right) \le \inf \sum_{i=1}^{\infty} \mu''(L'_i) \le \sum_{i=1}^{\infty} \mu(L'_i),\tag{3.6}
$$

a contradiction.

(II) The inequality $\mu''(E) \le \inf \{ \mu''(\bigcup_{1}^{\infty} L'_{2_i}) E \subset \bigcup_{1}^{\infty} L'_{2_i}, L_{2_i} \in \mathcal{L}_2 \}$ follows from monotonicity and μ'' being the infimum. A strict inequality leads to a contradiction as in (I). \Box

Applications. (1) Using the first new characterization, we can provide a short proof of a previously known result on two outer measures μ'' and μ' .

THEOREM 3.3. If \mathcal{L} is a δ -lattice, $\mu \in M(\sigma, \mathcal{L})$, then $\mu'' = \mu'$.

PROOF. (a) In this case, $\mu \leq \mu''(\mathcal{L}')$: if $A \in \mathcal{L}'$, $L_i \in \mathcal{L}$, and $A \subset \bigcup_{1}^{\infty} L'_i = (\bigcap L_i)' =$ *L'* \in *L'*, then *µ*(*A*) \leq *µ*(*L'*) \leq $\sum_{i=1}^{\infty}$ *µ*(*L'_i*), using *σ*-smoothness for the last inequality. So $\mu(A) \leq \mu''(A)$. The reverse inequality holds in general.

(b) Now, we have

$$
\mu''(E) = \inf \left\{ \mu''\left(\bigcup_{1}^{\infty} L_i'\right), E \subset \bigcup_{1}^{\infty} L_i', L_i \in \mathcal{L} \right\} = \inf \left\{ \mu''(L'), E \subset L', L \in \mathcal{L} \right\}
$$
\n
$$
= \inf \left\{ \mu(L'), E \subset L', L \in \mathcal{L} \right\} = \mu'(E),
$$
\n(3.7)

using (a).

(2) As a special case of [Proposition 3.2](#page-3-0) above, if we have $\mu \in M_{\sigma}(\mathcal{L}_1)$ and $\mathcal{L}_1 \subset S_{\mu''}$, take $\mathcal{L}_2 = \mathbf{S}_{\mu''}$, $\mathbb C$ to be the collection of all countable unions of sets from \mathcal{L}_2' and $v = \mu''$. Then we have $\mu'' = (\mu'')^0$, where in general, for a finitely subadditive outer measure *λ* and *λ*-measurable sets **S**_{*λ*}, $λ⁰(E) = inf{λ(*M*)}$, $E \subset M$, $M \in S_λ$): by [Proposition 3.2,](#page-3-0) we have

$$
\mu''(E) = \inf \left\{ \mu''\left(\bigcup_{1}^{\infty} L'_{2i}\right), E \subset \bigcup_{1}^{\infty} L'_{2i}, L_{2i} \in \mathcal{L}_2 \right\} = \inf \left\{ \mu''(M), E \subset M, M \in \mathbf{S}_{\mu''} \right\} (3.8)
$$

since $S_{\mu''}$ is a σ -algebra, $\bigcup_{1}^{\infty} L'_{2_i} = M \in S_{\mu''}$. This is a special case of a finitely sub-additive outer measure previously studied [\[2, 4\]](#page-12-0). Since in this case μ ["] is countably additive, the equality $\mu'' = (\mu'')^0$ is equivalent to μ'' being regular [\[2\]](#page-12-0).

(3) In the classical treatment, with $\mu \in M^{\sigma}(\mathcal{L})$ and the covering class $\mathbb C$ of measurable sets generated by the classical outer measure μ^* , μ^* is a regular outer measure. In our setting, if $\mu \in M^{\sigma}(\mathcal{L}_1)$ and $\mathbb C$ is the collection of all countable unions of sets from \mathcal{L}_2' , $\mathcal{L}_2 = S_{\mu''}$, and $\nu = \mu''$, we obtain the regularity for μ'' : for all positive integers *n*, there exists $M_n \in S_{\mu''}$, $E \subset M_n$ and $\mu(M_n) \leq \mu''(E) + (1/n)$, we may construct M_n $\downarrow \bigcap M_n = M_0 \in \mathbb{S}_{\mu''}$. So $\lim_{n \to \infty} \mu(M_n) \leq \mu''(E)$. Since $\mu \in M^{\sigma}(\mathcal{L}_1)$, $\lim_{n \to \infty} \mu(M_n) =$ $\mu(M_0) = \mu''(E)$. \Box

4. Case of a single lattice: comparing some set functions. Grassi, Knight, and Vlad looked into the effects of various conditions on outer measures. We combine these with additional new conditions. Using our new characterizations in Propositions [3.1](#page-3-0) and [3.2,](#page-3-0) we relate various inner and outer measures by several useful inequalities to obtain results on outer measures.

DEFINITION 4.1. Let $\mu \in M(\mathcal{L})$. For any $E \subseteq X$, the inner measure

$$
\mu_i(E) = \sup \{ \mu(L), \ L \subset E, \ L \in \mathcal{L} \}. \tag{4.1}
$$

The inner measure μ_i is finitely additive on \mathcal{L}' ; for properties (cf. [\[3, 5\]](#page-12-0)).

DEFINITION 4.2. Let $\mu \in M_{\sigma}(\mathcal{L})$. For any $E \subseteq X$, define the set function

$$
\mu_j(E) = \mu(X) - \mu''(E'). \tag{4.2}
$$

If μ ["] is a regular, then μ_i is an inner measure [\[2\]](#page-12-0).

Vlad showed that $\mu_i \leq \mu_j \leq \mu'' \leq \mu'$ [\[4\]](#page-12-0).

We define the notion of condition M.

DEFINITION 4.3. For $\mu \in M_{\sigma}(\mathcal{L})$, we say that μ'' satisfies condition M if a necessary and sufficient condition for a set $E \in \mathbf{S}_{\mu''}$ is that $\mu''(X) = \mu''(E) + \mu''(E').$

As in the classical case, if μ'' is a regular outer measure, then μ'' satisfies condition M.

On the other hand, the outer measure μ' is not regular in general but always satisfies condition M (see [\[1\]](#page-12-0)).

PROPOSITION 4.4. (a) If $\mu \in M_{\sigma}(\mathcal{L})$ satisfies condition M and $\mu''(E) = \mu_i(E)$ for $E \subseteq$ *X,* then $E \in \mathbf{S}_{\mu^{\prime\prime}}$;

(b) *If* $E \in S_{\mu''}$, then $\mu''(E) = \mu_i(E)$.

PROOF. (a) By assumption,

$$
\mu''(E) = \mu_j(E) = \mu(X) - \mu''(E') = \mu''(X) - \mu''(E'), \tag{4.3}
$$

therefore $E \in S_{\mu''}$ since μ satisfies condition M.

(b) If $E \in S_{\mu''}$, then

$$
\mu_j(E) = \mu(X) - \mu''(E') = \mu''(X) - \mu''(E')
$$

=
$$
\mu''(E) + \mu''(E') - \mu''(E') = \mu''(E).
$$
 (4.4)

LEMMA 4.5. *If* $\mu \in M_{\sigma}(\mathcal{L})$ *and* $\mu_j = \mu(\mathcal{L})$ *, then* $\mu'' = \mu(\mathcal{L}')$ *.* **PROOF.** For $L \in \mathcal{L}$, if $\mu(L) = \mu_j(L) = \mu(X) - \mu''(L')$, then

PROPOSITION 4.6. (a) *If* $\mu \in M(\sigma, \mathcal{L})$ *, then* $\mu_i = \mu(\mathcal{L})$ *.* (b) If $\mu \in M_{\sigma}(\mathcal{L})$, $\mu_i = \mu(\mathcal{L})$ and μ'' is a regular outer measure, then $\mu \in M(\sigma, \mathcal{L})$.

Proof. (a) For $L \in \mathcal{L}$, $\mu_j(L) = \mu(X) - \mu''(L') = \mu(X) - \mu(L') = \mu(L)$, since $\mu'' = \mu(\mathcal{L}')$ if $\mu \in M(\sigma, \mathcal{L})$ [\[4\]](#page-12-0).

(b) Using the lemma, we have a regular outer measure μ'' which is equal to μ on $\mathcal{L}',$ implying that $\mu \in M(\sigma, \mathcal{L})$ (see [\[4\]](#page-12-0)).

Hence for $\mu \in M_{\sigma}(\mathcal{L})$, under regularity of μ'' , strongly σ -smoothness is equivalent to $\mu_i = \mu(\mathcal{L})$.

Now, we establish the following sets of inequalities.

THEOREM 4.7. *For* $\mu \in M_{\sigma}(\mathcal{L})$, $E \subseteq X$ *, we have:*

\mu_i(E) \le \mu_j(E) \le \sup \left\{ \mu''\left(\bigcup_{1}^{\infty} L_i\right), \bigcap L_i \subset E, \ L_i \in \mathcal{L} \right\} \le \mu''(E) \le \mu'(E). \tag{4.6}

PROOF. We need only prove the second and third inequalities. We have

which is an upper bound for all such intersections.

COROLLARY 4.8. *On* \mathcal{L}' *: for* $L \in \mathcal{L}$ *,*

COROLLARY 4.9. (a) $\mu_i(L') \leq \sup\{\mu''(\tilde{L}), \ \tilde{L} \subseteq L', \ \tilde{L} \in \mathcal{L}\} \leq \sup\{\mu''(\bigcap_{1}^{\infty} L_i), \ \bigcap L_i \subset$ L' , $L_i \in \mathcal{L}$ $\leq \mu''(L') \leq \mu'(L') = \mu(L')$.

(b)
$$
\mu_i(L') \leq \sup{\{\mu''(\tilde{L}), \tilde{L} \subseteq L', \tilde{L} \in \mathcal{L}\}} \leq \sup{\{\mu'(\tilde{L}), \tilde{L} \subseteq L', \tilde{L} \in \mathcal{L}\}} \leq \mu'(L') = \mu(L').
$$

We consider three more "regularity"-type conditions on $\mu \in M_{\sigma}(\mathcal{L})$: (1) For

Together with the notions of weakly regularity and vaguely regularity, we have the following results, some of which are known, but the proofs here are different due to our general setting.

PROPOSITION 4.10. (a) $\mu \in M_{\nu}(\mathcal{L}) \Rightarrow (4.9)$ holds and $\mu'' = \mu' = \mu(\mathcal{L}')$ *.*

(b) *(4.9) holds*⇒*(4.10) holds.*

(c) If (4.9) holds and μ'' is a regular outer measure, then $\mu \in M(\sigma, \mathcal{L})$ and $\mathcal{L} \subset S_{\mu''}$.

(f) If (4.10) holds, $\mu_j(L') = \sup \{ \mu''(\bigcap L_i), \bigcap L_i \subseteq L', L_i \in \mathcal{L} \}$ for all $L \in \mathcal{L}$ and μ'' *satisfies condition M, then* $\mathbf{\Sigma} \subset \mathbf{S}_{\mathbf{u}''}$.

 μ (g) $\mu \in M_R^{\sigma}(\mathcal{L}) \Rightarrow \mu = \mu_i = \mu_j = \mu'' = \mu'$ on $\mathcal{L}.$

(h) If (4.11) holds, either μ'' is regular or satisfies condition M, then $\mathcal{L} \subset S_{\mu''}$.

(i) If $\mu \in M_{\sigma}(\mathcal{L})$, $\mu = \mu''(\mathcal{L})$ and μ'' is regular, then $\mathcal{L} \subset S_{\mu''}, \mu \in M(\sigma, \mathcal{L})$, and (4.9) *holds.*

(j) If (4.9) holds and $\mathcal{L} \subset S_{\mathcal{U}'},$ then $\mu = \mu''(\mathcal{L})$ and hence $\mu \in M^{\sigma}(\mathcal{L})$.

(k) *(4.11)*⇒*(4.10).*

 \Box

PROOF. Let $L \in \mathcal{L}$ throughout the proof.

(a) Using the inequalities established in [Corollary 4.8,](#page-6-0) we have,

\n(4.12)

(b) Follows from the same set of inequalities.

(c) We have

\mu(L') = \sup \left\{ \mu''\left(\bigcap_{i} L_{i}\right), \bigcap_{i} L_{i} \subseteq L', L_{i} \in \mathcal{L} \right\} \leq \mu''(L') = \mu'(L') = \mu(L'). \tag{4.13}
$$

Since $\mu = \mu''(\mathcal{L}')$ and μ'' is regular, $\mu \in M(\sigma, \mathcal{L})$ (see [\[4\]](#page-12-0)). Also,

Since μ ["] is regular and therefore satisfies condition M, by [Proposition 4.4\(](#page-5-0)a), $L \in S_{\mu}$ ["]. So $\mathcal{L} \subset S_{\mathcal{U}'}$.

(d) Since $\textbf{\textit{L}} \subset \textbf{S}_{\mu''}, \ \mu''(L') \leq \mu''(X) - \mu''(L) = \mu_j(L').$ By [Corollary 4.8,](#page-6-0) therefore

yielding equalities and weak regularity.

(f) By assumption,

$$
\mu''(L') = \sup \left\{ \mu''\left(\bigcap_i L_i\right), \bigcap_i L_i \subseteq L', \ L_i \in \mathcal{L} \right\} = \mu_j(L'), \tag{4.17}
$$

so $\mu''(X) = \mu''(L) + \mu''(L')$, which implies that $\mathcal{L} \subset \mathbf{S}_{\mu''}$ since μ'' satisfies condition M. (g) Since $\mu \in M_R^{\sigma}(\mathcal{L})$, $\mu = \mu'' = \mu'(\mathcal{L})$. Also, $\mu = \mu_i(\mathcal{L})$. By [Corollary 4.8,](#page-6-0) we have $\mu = \mu_i = \mu'_i = \mu'' = \mu'$ on \mathcal{L} .

(h) By assumption and [Corollary 4.8,](#page-6-0) we have

(i) If $\mu = \mu''(\mathcal{L})$, then $\mu = \mu_i \leq \mu_j \leq \mu'' = \mu(\mathcal{L})$ yielding all equalities. Since μ'' is regular, by [Proposition 4.6\(](#page-5-0)b), $\mu \in M(\sigma, \mathcal{L})$. Now

These results provide a new proof of an old theorem.

THEOREM 4.11 (T. Wibisono [\[6\]](#page-12-0)). (a) *If* $\mu \in M^{\sigma}(\mathcal{L})$, $\mu = \mu''(\mathcal{L})$ *and* μ'' *satisfies condition M, then* $\mathbf{\underline{f}} \subset \mathbf{S}_{\mu''}, \ \mu \in M^{\sigma}(\mathbf{\underline{f}})$ *and* $\mu'' = \mu' = \mu(\mathbf{\underline{f}}').$ (b) If $\mu \in M(\sigma, \mathcal{L})$ and $\mathcal{L} \subset S_{\mu''}$, then $\mu = \mu''(\mathcal{L})$.

Proof. By [Theorem 4.7,](#page-5-0) for $L \in \mathcal{L}$, $\mu(L) = \mu_i(L) \leq \mu_j(L) \leq \mu''(L) \leq \mu'(L)$. So $\mu =$ $\mu''(\mathcal{L})$ implies that $\mu_j = \mu''(\mathcal{L})$. With $\mu \in M^{\sigma}(\mathcal{L})$ and μ'' satisfies condition M, this implies that \mathcal{L} ⊂ **S**_μ^{*n*} by [Proposition 4.4\(](#page-5-0)a). Also, $\mu_j(L') = \mu(X) - \mu''(L) = \mu(X) - \mu(L) =$ $\mu(L')$. Hence by [Corollary 4.8,](#page-6-0)

which means that [\(4.9\)](#page-6-0) holds. Applying [Proposition 4.10\(](#page-6-0)j), we get $\mu \in M^{\sigma}(\mathcal{L})$.

(b) If $\mu \in M(\sigma, \mathcal{L})$, then $\mu_j = \mu(\mathcal{L})$ by [Proposition 4.6\(](#page-5-0)a). By [Proposition 4.4\(](#page-5-0)b), $\mathcal{L} \subset S_{\mu''}$ implies that $\mu_i = \mu''(\mathcal{L})$. Hence $\mu = \mu''(\mathcal{L})$. \Box

Corollary 4.12. *Under the conditions of Theorem 4.11(a), condition [\(4.9\)](#page-6-0) holds.*

THEOREM 4.13. *Under the conditions that* $\mu \in M(\mathcal{L})$, $\nu \in M_{\sigma}(\mathcal{L})$, $\mu \leq \nu(\mathcal{L})$, $\mu(X) =$ $v(X)$ *and* \pounds *is normal, if* μ'' *satisfies condition [\(4.11\)](#page-6-0), i.e.,*

for $L \in \mathcal{L}$ *, then* $\mu'' = \nu''(\mathcal{L}')$ *.*

PROOF. (a) We know that $\mu'' \ge \nu''$ in general.

(b) Since \pounds is normal, for all $\tilde{L} \subseteq L'$, there exist $L_1, L_2 \in \pounds$ such that $\tilde{L} \subseteq L'_1 \subseteq L_2 \subseteq L'$. We have

5. Case of a pair of lattices: comparing similar set functions. In this section, we have two lattices on *X* : $\mathcal{L}_1 \subseteq \mathcal{L}_2$, we consistently use $A \in \mathcal{L}_1$ and $B \in \mathcal{L}_2$.

THEOREM 5.1 (T. Wibisono [\[6\]](#page-12-0)). *If* $\mu \in M_{\sigma}(\mathcal{L}_1)$, μ'' satisfies condition M and

then

 $(a) \mathcal{L}_2 \subseteq S_{\mathcal{U}''};$ (b) $\mu''|_{A(\mathcal{L}_2)} \in M_R^{\sigma}(\mathcal{L}_2)$, $\mu \leq \mu''|_{A(\mathcal{L}_1)}(\mathcal{L}_1)$, and $\mu''|_{A(\mathcal{L}_1)} \in M_R^{\sigma}(\mathcal{L}_1)$.

Proof. (a) We have

\mu''(B') = \sup \{ \mu(A), \ A \subseteq B', \ A \in \mathcal{L}_1 \} = \mu_i(B') = \mu_j(B')
$$
 (5.2)

using [Corollary 4.8.](#page-6-0) Since μ ["] satisfies condition M, by [Proposition 4.4\(](#page-5-0)a), $\mathcal{L}_2 \subseteq S_{\mu}$ ".

(b) Since μ'' is countably additive on $S_{\mu''}$ and by part (a), $A(\mathcal{L}_2) \subseteq S_{\mu''}, \mu''|_{A(\mathcal{L}_2)} \in$ $M^{\sigma}(\mathcal{L}_2)$. The inequalities

Now, we consider $\mu \in M_{\sigma}(\mathcal{L}_1)$ extended to $\nu \in M_{\sigma}(\mathcal{L}_2)$ and five conditions on ν, ν'' , or μ'' , including the one in Wibisono's theorem: recall that $B \in \mathcal{L}_2$.

We have the following relationships and a result similar to that of Wibisono's.

PROPOSITION 5.2. (a) *Condition* $(1) \Rightarrow v \in M_v(\mathcal{L}_2)$ *.*

(b) If \mathcal{L}_1 *is a* δ *-lattice, then* (1) \Leftrightarrow (2). (c) If $v \in M(\sigma, \mathcal{L}_2)$, then (2) \Leftrightarrow (3). (d) *(2)*⇒*(3).* (e) *(4)*⇒*(3).* (f) *(5)*⇒*(4).*

(g) If (4) holds and v'' satisfies condition M, then $\mathcal{L}_2 \subseteq S_{v''}$ and $v''|_{A(\mathcal{L}_2)} \in M_R^{\sigma}(\mathcal{L}_2)$. *[This is a weaker version of Wibisono's theorem.]*

 (h) (5)⇒*ν''* = μ'' (\mathcal{L}'_2)*.* (i) If $\mu''(B') = \sup \{ \mu''(A), A \subseteq B', A \in \mathcal{L}_1 \}$ and \mathcal{L}_1 coseparates \mathcal{L}_2 , then $v'' = \mu''(\mathcal{L}'_2)$. **PROOF.** (a) Since $\mathcal{L}_1 \subseteq \mathcal{L}_2$,

\leq \nu''(B') \leq \nu'(B') = \nu(B'),
$$
\n(5.5)

the last two inequalities follow from [Corollary 4.8.](#page-6-0) Hence we have equalities and (3) holds.

(e) Since $\mathcal{L}_1 \subseteq \mathcal{L}_2$, it follows from the definition of the outer measures that $v'' \leq \mu''$. By (4),

as above. Hence $v''(B') = \mu''(B')$ since the reverse inequality is true in general; (4) follows.

 (g) If

\nu''(B') = \sup \{ \nu(\tilde{B}), \ \tilde{B} \subseteq B', \ B \in \mathcal{L}_2 \}
$$
\n
$$
(5.9)
$$

for any $B' \in \mathcal{L}_2$ implies that $v''|_{A(\mathcal{L}_2)} \in M_R^{\sigma}(\mathcal{L}_2)$.

(h) By assumption,

$$
\mu''(B') = \sup \{ \mu(A), \ A \subseteq B', \ A \in \mathcal{L}_1 \} \le \nu''(B')
$$
 (5.10)

as in (e), which implies $v'' = \mu''(\mathcal{L}'_2)$.

(i) For each $A \subseteq B'$, since \mathcal{L}_1 coseparates \mathcal{L}_2 , there exist A_1 and A_2 in \mathcal{L}_1 such that $A \subseteq A'_1 \subset A_2 \subseteq B'$. So

$$
\mu''(A) \le \mu''(A'_1) \le \mu(A'_1) = \nu(A'_1) \le \nu(A_2) \le \nu''(A_2) \le \nu''(B'). \tag{5.11}
$$

Therefore,

$$
\mu''(B') = \sup \{ \mu(A), \ A \subseteq B', \ A \in \mathcal{L}_1 \} \le \nu''(B'), \tag{5.12}
$$

implying $v'' = \mu''(\mathcal{L}'_2)$.

Conclusions in parts (h) and (i) that $v'' = \mu''(\mathcal{L}'_2)$ are useful because if that is true, many of the conditions (1), (2), (3), (4), and (5) as well as others coincide. Related to this is the following condition: in the same setting,

$$
\mu''(B') = \sup \bigg\{ \nu''\bigg(\bigcap_{1}^{\infty} A_n\bigg), \bigcap_{1}^{\infty} A_n \subseteq B', A_n \in \mathcal{L}_1 \bigg\}.
$$
 (#)

PROPOSITION 5.3. *Condition* $(\#)\Rightarrow v'' = \mu''(\mathcal{L}'_2)$ *and condition* (3).

PROOF. If $\bigcap_{1}^{\infty} A_n \subseteq B'$, $A_n \in \mathcal{L}_1$ then

$$
\mu''(B') = \sup \left\{ \nu''\left(\bigcap_{1}^{\infty} A_n \right), \bigcap_{1}^{\infty} A_n \subseteq B', A_n \in \mathcal{L}_1 \right\} \leq \nu''(B'). \tag{5.13}
$$

 \Box

The reverse inequality holds in general. Therefore $v'' = \mu''(\mathcal{L}'_2)$ and (3) follows. We also have a set of useful inequalities for the case of a pair of lattices.

THEOREM 5.4. *If* $\mu \in M_{\sigma}(\mathcal{L}_1)$ *is extended to* $\nu \in M_{\sigma}(\mathcal{L}_2)$, $\mathcal{L}_1 \subseteq \mathcal{L}_2$, then for an $E \subseteq X$:

- (a) $\mu_i(E) \leq \mu_j(E) \leq \nu_j(E) \leq \sup \{ \nu''(\bigcap_n B_n), \bigcap_n B_n \subseteq E, B_n \in \mathcal{L}_2 \} \leq \nu''(E) \leq \nu'(E);$ (b) $\mu_i(E) \leq \mu_j(E) \leq \nu_j(E) \leq \sup \{ \nu''(\bigcap_n B_n), \bigcap_n B_n \subseteq E, B_n \in \mathcal{L}_2 \} \leq \nu''(E) \leq \mu''(E) \leq$ *µ (E);*
- (c) $\sup \{ \nu''(\bigcap_n B_n), \bigcap_n B_n \subseteq E, B_n \in \mathcal{L}_1 \} \leq \sup \{ \mu''(\bigcap_n B_n), \bigcap_n B_n \subseteq E, B_n \in \mathcal{L}_2 \} \leq$ $\mu''(E)$;
- (d) $\sup \{v''(\bigcap_n A_n), \bigcap_n A_n \subseteq E, A_n \in \mathcal{L}_1\} \leq \sup \{v''(\bigcap_n B_n), \bigcap_n B_n \subseteq E, B_n \in \mathcal{L}_2\}$
- (e) $\sup \{ \nu''(\bigcap_n A_n), \bigcap_n A_n \subseteq E, A_n \in \mathcal{L}_1 \} \leq \sup \{ \mu''(\bigcap_n A_n), \bigcap_n A_n \subseteq E, A_n \in \mathcal{L}_1 \}$ \mathcal{L}_1 \leq sup { $\mu''(\bigcap_n B_n)$, $\bigcap_n B_n \subseteq E$, $B_n \in \mathcal{L}_2$ }.

PROOF. The inequalities follow from [Theorem 4.7](#page-5-0) or $\mathcal{L}_1 \subseteq \mathcal{L}_2$ or $v'' \leq \mu''$. \Box

COROLLARY 5.5. *For* $B \in \mathcal{L}_2$ *, we have:*

$$
\mu_i(B') \le \mu_j(B') \le \sup \left\{ \mu''\left(\bigcap_{n} A_n \right), \bigcap_{n} A_n \subseteq B', A_n \in \mathcal{L}_1 \right\}
$$

$$
\le \mu''(B') \le \mu'(B') = \mu(B');
$$

\n
$$
\mu_i(B') \le \mu_j(B') \le \nu_j(B') \le \sup \left\{ \nu''\left(\bigcap_{n} B_n \right), \bigcap_{n} B_n \subseteq B', B_n \in \mathcal{L}_2 \right\}
$$

\n
$$
\le \nu''(B') \le \nu'(B') = \nu(B').
$$
\n(5.14)

It follows from the inequalities in Corollary 5.5 that an equality of certain set functions above yields one of the conditions discussed and subsequent consequences.

NOTE 5.6. (a) If $\mu_i(B') = \nu''(B')$, then we have condition (4). (b) If $\mu_i(B') = \mu''(B')$, then we have condition (5).

In addition, one of the conditions result in other equalities.

Theorem 5.7. (a) *Condition (4)*⇒

$$
\mu_i(B') = \mu_j(B') = \nu_j(B') = \sup \left\{ \nu''\left(\bigcap_{1}^{\infty} B_n\right), \bigcap_{1}^{\infty} B_n \subseteq B', B_n \in \mathcal{L}_2 \right\} = \nu''(B') \quad (5.15)
$$

and v'' *satisfies condition* [\(4.10\)](#page-6-0) *on* \mathcal{L}_2 *.*

(b) *Condition (5)*⇒

$$
\mu_i(B') = \mu_j(B') = \sup \left\{ \mu''\left(\bigcap_{1}^{\infty} A_n \right), \bigcap_{1}^{\infty} A_n \subseteq B', A_n \in \mathcal{L}_1 \right\} = \mu''(B') \tag{5.16}
$$

and μ ^{*"*} *satisfies condition* [\(4.10\)](#page-6-0) *on* \mathcal{L}_1 *.*

(c) *Condition (3)*⇒

$$
\nu''(B') = \sup \left\{ \nu''\left(\bigcap_{1}^{\infty} B_n\right), \bigcap_{1}^{\infty} B_n \subseteq B', B_n \in \mathcal{L}_2 \right\} \tag{5.17}
$$

and v'' *satisfies condition* [\(4.10\)](#page-6-0) *on* \mathcal{L}_2 *.*

(d) Condition (2)⇒

$$
\sup \left\{ \nu''\left(\bigcap_{1}^{\infty} B_n\right), \bigcap_{1}^{\infty} B_n \subseteq B', B_n \in \mathcal{L}_2 \right\} = \nu''(B') = \nu'(B') = \nu(B') \tag{5.18}
$$

and ν satisfies condition [\(4.10\)](#page-6-0) on L2*.*

(e) *Condition [\(#\)](#page-10-0)*⇒

$$
\sup \left\{ \mu''\left(\bigcap_{1}^{\infty} A_n\right), \bigcap_{1}^{\infty} A_n \subseteq B', A_n \in \mathcal{L}_1 \right\} = \mu''(B') = \mu'(B') = \mu(B')
$$
(5.19)

and μ ^{*"*} *satisfies condition* [\(4.10\)](#page-6-0) *on* \mathcal{L}_1 *.*

PROOF. (a) and (b) follow directly from [Corollary 5.5;](#page-11-0) (c) and (d) from [Theorem 5.4\(](#page-11-0)d) and the same corollary; (e) from [Theorem 5.4\(](#page-11-0)e) and the corollary. \Box

Call for Papers

This subject has been extensively studied in the past years for one-, two-, and three-dimensional space. Additionally, such dynamical systems can exhibit a very important and still unexplained phenomenon, called as the Fermi acceleration phenomenon. Basically, the phenomenon of Fermi acceleration (FA) is a process in which a classical particle can acquire unbounded energy from collisions with a heavy moving wall. This phenomenon was originally proposed by Enrico Fermi in 1949 as a possible explanation of the origin of the large energies of the cosmic particles. His original model was then modified and considered under different approaches and using many versions. Moreover, applications of FA have been of a large broad interest in many different fields of science including plasma physics, astrophysics, atomic physics, optics, and time-dependent billiard problems and they are useful for controlling chaos in Engineering and dynamical systems exhibiting chaos (both conservative and dissipative chaos).

We intend to publish in this special issue papers reporting research on time-dependent billiards. The topic includes both conservative and dissipative dynamics. Papers discussing dynamical properties, statistical and mathematical results, stability investigation of the phase space structure, the phenomenon of Fermi acceleration, conditions for having suppression of Fermi acceleration, and computational and numerical methods for exploring these structures and applications are welcome.

To be acceptable for publication in the special issue of Mathematical Problems in Engineering, papers must make significant, original, and correct contributions to one or more of the topics above mentioned. Mathematical papers regarding the topics above are also welcome.
