# Rules for our website

What are the rules of the game when you use our website? What should you do and what not?

These 'more information' sections include more difficult language. But they also apply to you. Do you think you don't understand the rules completely? Please ask your parents or the people taking care of you to help you understand. And of course, you can also ask us!

Welcome to Poki! In this section we explain our rules, more formally called Terms of Use. So if we say rules and if we say Terms of Use, we mean the same thing. In these more complicated more-information-parts, we stick to the formal reference and call them Terms of Use.

These Terms of Use apply to all users visiting <u>poki.com</u> ('Website') fromPortugal.\* <u>Poki.com</u> is owned and operated by Poki B.V. (also referred to as 'Poki', 'we', 'our' or 'us'). Poki is an entity established under the laws of the Netherlands. Besides these Terms of Use, the other information included in our Privacy Statement is also applicable to our users.

Our Website may include access to virtual environments, games and other content for use on personal computers, tablets, mobile devices or phones. All users of the Website ('Website Visitors') are subject to the following terms and conditions of use (these 'Terms of Use').

Please read these Terms of Use carefully before accessing or using any part of this Website. By accessing or using this Website, you agree that you have read, understand and agree to be bound by these Terms of Use, as updated from time to time by Poki. If you do not agree to these Terms of Use, do not access or use any part of this Website.

Players that wish to save and access their progress across devices or browsers are recommended to create an account on Poki ("Poki Accounts"). Players can create an account and sign in via Google, Roblox and Passkey. Poki also uses Poki Accounts to determine which advertisements may be shown to the players. Poki Accounts are also used to save settings, progress and other game related data. This ensures players can access their progress across devices and browsers. Poki is not responsible and/or liable for any loss of access to Poki Accounts, loss of progress data or similar issues. All conditions and terms of use as set out in these Terms of Use are also applicable to the use of Poki Accounts.

# 4. Use of the website and Poki Accounts

Don't do anything bad or mean to others, when you use our website or an account. What does that mean? It means you shouldn't do things that are against the law in any country. You also shouldn't act against our Rules. Here are some examples of what you shouldn't do:

- Don't put up mean or rude things on our website like words or pictures that can make someone else feel bad.
