Abstract. Our concern is with Riemannian symmetric spaces Z = G/K of the non-compact type and more precisely with the Poisson transform \mathcal{P}_{λ} which maps generalized functions on the boundary ∂Z to λ -eigenfunctions on Z. Special emphasis is given to a maximal unipotent group N < G which naturally acts on both Z and ∂Z . The N-orbits on Z are parametrized by a torus $A = (\mathbb{R}_{>0})^r < G$ (Iwasawa) and letting the level $a \in A$ tend to 0 on a ray we retrieve N via $\lim_{a\to 0} Na$ as an open dense orbit in ∂Z (Bruhat). For positive parameters λ the Poisson transform \mathcal{P}_{λ} is defined an d injective for functions $f \in L^{2}(N)$ and we give a novel characterization of $\mathcal{P}_{\lambda}(L^2(N))$ in terms of complex analysis. For that we view eigenfunctions $\phi = \mathcal{P}_{\lambda}(f)$ as families $(\phi_a)_{a \in A}$ of functions on the N-orbits, i.e. $\phi_a(n) = \phi(na)$ for $n \in \mathbb{N}$. The general theory then tells us that there is a tube domain $\mathcal{T} = N \exp(i\Lambda) \subset N_{\mathbb{C}}$ such that each ϕ_a extends to a holomorphic function on the scaled tube $\mathcal{T}_a = N \exp(i \operatorname{Ad}(a)\Lambda)$. We define a class of N-invariant weight functions \mathbf{w}_{λ} on the tube \mathcal{T} , rescale them for every $a \in A$ to a weight $\mathbf{w}_{\lambda,a}$ on \mathcal{T}_a , and show that each ϕ_a lies in the L^2 -weighted Bergman space $\mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda,a}) := \mathcal{O}(\mathcal{T}_a) \cap L^2(\mathcal{T}_a, \mathbf{w}_{\lambda,a})$. The main result of the article then describes $\mathcal{P}_{\lambda}(L^2(N))$ as those eigenfunctions ϕ for which $\phi_a \in \mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda,a})$ and

$$\|\phi\| := \sup_{a \in A} a^{\operatorname{Re} \lambda - 2\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}} < \infty$$

holds.

1. Introduction

This article considers range theorems for the Poisson transform on Riemannian symmetric spaces Z in the context of horospherical complex geometry.

We assume that Z is of non-compact type and let G be the semisimple Lie group of isometries of Z. Then Z is homogeneous for G and identified as Z = G/K, where $K \subset G$ is a maximal compact subgroup and stabilizer of a fixed base point $z_0 \in Z$. Classical examples are the real hyperbolic spaces which will receive special explicit attention at the end of the article.

The Poisson transform maps sections of line bundles over the compact boundary ∂Z to eigenfunctions of the commutative algebra of G-invariant differential operators $\mathbb{D}(Z)$ on Z. Recall that $\partial Z = G/\overline{P}$ is a real flag manifold for $\overline{P} = MA\overline{N}$ a minimal parabolic subgroup originating from an Iwasawa decomposition $G = KA\overline{N}$ of G. The line bundles we consider are parametrized by the complex characters λ of the abelian group A, and we write \mathcal{P}_{λ} for the corresponding Poisson transform. We let N be the unipotent radical of the parabolic subgroup P = MAN opposed to \overline{P} .

The present paper initiates the study of the Poisson transform in terms of the N-geometry of both Z and ∂Z . Identifying the contractible group N with its open dense orbit in ∂Z , functions on N correspond to sections of the line bundle via extension by zero. On the other hand $N \setminus Z \simeq A$. Hence, given a function $f \in L^2(N)$ with Poisson transform $\phi = \mathcal{P}_{\lambda}(f)$, it is natural to consider the family ϕ_a , $a \in A \simeq N \setminus Z$, of functions restricted to the N-orbits $Na \cdot z_0 \subset Z$. A basic observation then is that the functions ϕ_a extend holomorphically to N-invariant tubular neighborhoods $\mathcal{T}_a \subset N_{\mathbb{C}}$ of N. Our main result, Theorem 1.1, identifies for positive parameters λ the image $\mathcal{P}_{\lambda}(L^2(N))$ with a class of families ϕ_a in weighted Bergman spaces $\mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda,a})$ on these tubes \mathcal{T}_a .

Range theorems for the Poisson transform in terms of the K-geometry of both ∂Z and Z were investigated in [10] for spaces of rank one. Note that $\partial Z \simeq K/M$ and that every line bundle over K/M is trivial, so that sections can be identified with functions on K/M. On the other hand $K \setminus Z \simeq A/W$ with W the little Weyl group, a finite reflection group. Given a function $f \in L^2(K/M)$ the image $\phi = \mathcal{P}_{\lambda}(f)$ therefore induces a family of partial functions $\phi_a : K \to \mathbb{C}$ with $\phi_a(k) := \phi(ka \cdot z_0)$ on the K-orbits in Z parametrized by $a \in A$. As ϕ is continuous, we have $\phi_a \in L^2(K)$, and [10] characterizes the image $\mathcal{P}_{\lambda}(L^2(K/M))$ in terms of the growth of $\|\phi_a\|_{L^2(K)}$ and suitable maximal functions. Interesting follow up work includes [2] and [12].

To explain our results in more detail, we first describe our perspective on eigenfunctions of the algebra $\mathbb{D}(Z)$. The Iwasawa decomposition G=KAN allows us to identify Z=G/K with the solvable group S=NA. Inside $\mathbb{D}(Z)$ one finds a distinguished element, the Laplace–Beltrami operator Δ_Z . Upon identifying Z with S we use the symbol Δ_S instead of Δ_Z . Now it is a remarkable fact that all Δ_S -eigenfunctions extend to a universal S-invariant domain $\Xi_S \subset S_{\mathbb{C}}$. In fact, Ξ_S is closely related to the crown domain $\Xi \subset Z_{\mathbb{C}} = G_{\mathbb{C}}/K_{\mathbb{C}}$ of Z, and we refer to Section 3 for details. In particular, there exists a maximal domain $0 \in \Lambda \subset \mathfrak{n} = \mathrm{Lie}(N)$ such that

$$\Xi_S \supset S \exp(i\Lambda)$$
. (1.1)

The domain Λ has its origin in the unipotent model of the crown domain [14, Sect. 8] and, except in the rank one cases, its geometry is not known. Proposition 3.1 implies that Λ is bounded for a class of classical groups, including $G = GL(n, \mathbb{R})$. It is an interesting open problem whether Λ is bounded or convex in general.

Now let $\phi: S \to \mathbb{C}$ be an eigenfunction of Δ_S . For each $a \in A$ we define the partial function

$$\phi_a: N \to \mathbb{C}, \quad n \mapsto \phi(na).$$

Because eigenfunctions extend to Ξ_S , we see from (1.1) that ϕ_a extends to a holomorphic function on the tube domain

$$\mathcal{T}_a := N \exp(i\Lambda_a) \subset N_{\mathbb{C}} \tag{1.2}$$

with

$$\Lambda_a = \operatorname{Ad}(a)\Lambda. \tag{1.3}$$

(1.4)

The general perspective of this paper is to view an eigenfunction ϕ as a family of holomorphic functions $(\phi_a)_{a\in A}$ with ϕ_a belonging to $\mathcal{O}(\mathcal{T}_a)$, the space of all holomorphic functions on \mathcal{T}_a .

We now explain the Poisson transform and how eigenfunctions of the algebra $\mathbb{D}(Z)$ can be characterized by their boundary values on ∂Z . Fix a minimal parabolic subgroup P = MAN with $M = Z_K(A)$. If $\theta : G \to G$ denotes the Cartan involution with fixed point group K, we consider $\overline{N} = \theta(N)$ and the parabolic subgroup $\overline{P} = MA\overline{N}$ opposite to P. Because $N\overline{P} \subset G$ is open dense by the Bruhat decomposition, it proves convenient to identify ∂Z with G/\overline{P} . In the sequel we view $N \subset \partial Z = G/\overline{P}$ as an open dense subset.

For each $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ one defines the Poisson transform (in the N-picture) as

$$\mathcal{P}_{\lambda}: C_{c}^{\infty}(N) \to C^{\infty}(S) ,$$

$$\mathcal{P}_{\lambda}f(s) = \int_{N} f(x)\mathbf{a}(s^{-1}x)^{\lambda+\rho} dx \qquad (s \in S) ,$$

where $\mathbf{a}: KA\overline{N} \to A$ is the middle projection with respect to the opposite Iwasawa decomposition, $a^{\lambda} := e^{\lambda(\log a)}$ for $a \in A$ and $\rho := \frac{1}{2} \sum_{\alpha \in \Sigma^{+}} (\dim \mathfrak{g}^{\alpha}) \cdot \alpha \in \mathfrak{g}^{*}$ is the Weyl half sum with respect to P.

In this article we restrict to parameters λ with Re $\lambda(\alpha^{\vee}) > 0$ for all positive coroots $\alpha^{\vee} \in \mathfrak{a}$, denoted in the following as Re $\lambda > 0$. This condition ensures that the integral defining the Harish-Chandra **c**-function

$$\mathbf{c}(\lambda) := \int_{N} \mathbf{a}(n)^{\lambda + \rho} \ dn$$

converges absolutely.

Recall the Harish-Chandra isomorphism between $\mathbb{D}(Z)$ and the W-invariant polynomials on $\mathfrak{a}_{\mathbb{C}}^*$, where W is the Weyl group of the pair $(\mathfrak{g},\mathfrak{a})$. In particular, spec $\mathbb{D}(Z) = \mathfrak{a}_{\mathbb{C}}^*/W$, and for each $[\lambda] = W \cdot \lambda$ we denote by $\mathcal{E}_{[\lambda]}(S)$ the corresponding eigenspace on $S \simeq Z$. The image of the Poisson transform consists of eigenfunctions, im $\mathcal{P}_{\lambda}(C_c^{\infty}(N)) \subset \mathcal{E}_{[\lambda]}(S)$. Because $\mathbf{a}(\cdot)^{\lambda+\rho}$ belongs to $L^1(N)$ for $\operatorname{Re} \lambda > 0$, \mathcal{P}_{λ} extends from $C_c^{\infty}(N)$ to $L^2(N)$.

The goal of this article is to characterize $\mathcal{P}_{\lambda}(L^2(N))$. As a first step towards this goal, for $f \in L^2(N)$ and $\phi = \mathcal{P}_{\lambda}(f)$ in Lemma 5.1 we note the estimate

$$\|\phi_a\|_{L^2(N)} \le a^{\rho-\operatorname{Re}\lambda} \mathbf{c}(\operatorname{Re}\lambda) \|f\|_{L^2(N)}$$

for all $a \in A$.

The basic observation in this paper is that the kernel $n \mapsto \mathbf{a}(n)^{\lambda+\rho}$ underlying the Poisson transform (1.4) extends holomorphically to $\mathcal{T}^{-1} := \exp(i\Lambda)N$ and remains N-integrable along every fiber, i.e. for any fixed $y \in \exp(i\Lambda)$ the kernel $n \mapsto \mathbf{a}(yn)^{\lambda+\rho}$ is integrable over N. This allows us to formulate a condition for positive left N-invariant continuous weight functions \mathbf{w}_{λ} on the tubes $\mathcal{T} = N \exp(i\Lambda)$, namely (see also (5.9))

$$\int_{\exp(i\Lambda)} \mathbf{w}_{\lambda}(y) \|\delta_{\lambda,y}\|_{L^{1}(N)}^{2} dy < \infty, \qquad (1.5)$$

where the function $\delta_{\lambda,y}$ is defined in (5.4). In the sequel we assume that \mathbf{w}_{λ} satisfies condition (1.5) and define rescaled weight functions

$$\mathbf{w}_{\lambda,a}: \mathcal{T}_a \to \mathbb{R}_{>0}, \quad ny \mapsto \mathbf{w}_{\lambda}(\mathrm{Ad}(a^{-1})y) \qquad (y \in \exp(i\Lambda_a))$$

on the scaled tubes \mathcal{T}_a . The upshot then is that $\phi_a \in \mathcal{O}(\mathcal{T}_a)$ lies in the weighted Bergman space

$$\mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda, a}) := \{ \psi \in \mathcal{O}(\mathcal{T}_a) \mid \|\psi\|_{\mathcal{B}_{a, \lambda}}^2 := \int_{\mathcal{T}_a} |\psi(z)|^2 \mathbf{w}_{\lambda, a}(z) dz < \infty \}$$

where dz is the Haar measure on $N_{\mathbb{C}}$ restricted to \mathcal{T}_a .

This motivates us the definition of the following Banach subspace of $\mathcal{E}_{[\lambda]}(S) \subset \mathcal{O}(\Xi_S)$

$$\mathcal{B}(\Xi_S, \lambda) := \{ \phi \in \mathcal{E}_{[\lambda]}(S) \mid \|\phi\| := \sup_{a \in A} a^{\operatorname{Re} \lambda - 2\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}} < \infty \}.$$

It will be consequence of Theorem 1.1 below that $\mathcal{B}(\Xi_S, \lambda)$ as a vector space does not depend on the particular choice of the positive left N-invariant weight function \mathbf{w}_{λ} satisfying (1.5). The main result of this article now reads:

Theorem 1.1. Let Z = G/K be a Riemannian symmetric space and $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ be a parameter such that $\operatorname{Re} \lambda > 0$. Then

$$\mathcal{P}_{\lambda}: L^2(N) \to \mathcal{B}(\Xi_S, \lambda)$$

is an isomorphism of Banach spaces, i.e. there exist c, C > 0 depending on \mathbf{w}_{λ} such that

$$c\|\mathcal{P}_{\lambda}(f)\| \le \|f\|_{L^{2}(N)} \le C\|\mathcal{P}_{\lambda}(f)\| \qquad (f \in L^{2}(N)).$$

Let us mention that the surjectivity of \mathcal{P}_{λ} relies on the established Helgason conjecture (see [11, 6]) and the Bergman inequality.

We now recall that \mathcal{P}_{λ} is inverted by the boundary value map, that is

$$\frac{1}{\mathbf{c}(\lambda)} \lim_{\substack{a \to \infty \\ a \in A^{-}}} a^{\lambda - \rho} \mathcal{P}_{\lambda} f(na) = f(n) \qquad (n \in N),$$

where the limit is taken along a fixed ray in the interior of the negative Weyl chamber A^- .

Define the positive constant

$$w(\lambda) := \left[\int_{\exp(i\Lambda)} \mathbf{w}_{\lambda}(y) \ dy \right]^{\frac{1}{2}}.$$
 (1.6)

We observe that this constant is indeed finite, see Subsection 5.3. There we obtain a corresponding norm limit formula:

Theorem 1.2. For any $f \in L^2(N)$, $\phi = \mathcal{P}_{\lambda}(f)$ we have

$$\frac{1}{w(\lambda)|\mathbf{c}(\lambda)|} a^{\operatorname{Re}\lambda - 2\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}} \to \|f\|_{L^2(N)} \qquad (f \in L^2(N))$$
(1.7)

for $a \to \infty$ on a ray in A^- .

Let us emphasize that the weight functions \mathbf{w}_{λ} are not unique and it is natural to ask about the existence of optimal choices, i.e. choices for which \mathcal{P}_{λ} establishes an isometry between $L^2(N)$ and $\mathcal{B}(\Xi_S, \lambda)$, in other words whether a norm-sup identity holds:

$$\sup_{a \in A} \frac{1}{w(\lambda)|\mathbf{c}(\lambda)|} a^{\operatorname{Re}\lambda - 2\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}} = \|f\|_{L^2(N)} \qquad (f \in L^2(N)). \tag{1.8}$$

The answer is quite interesting in the classical example of the real hyperbolic space

$$Z = SO_e(n+1,1)/SO(n+1) \simeq \mathbb{R}^n \times \mathbb{R}_{>0} = N \times A$$

where the study was initiated in [18] and is now completed in Section 6. Here $N = \mathfrak{n} = \mathbb{R}^n$ is abelian and we recall the classical formulas for the Poisson kernel and **c**-function

$$\mathbf{a}(x)^{\lambda+\rho} = (1+|x|^2)^{-(\lambda+n/2)} \qquad (x \in N = \mathbb{R}^n),$$
$$\mathbf{c}(\lambda) = \pi^{n/2} \frac{\Gamma(2\lambda)}{\Gamma(\lambda+n/2)},$$

where we write $|\cdot|$ for the Euclidean norm. It is now easily seen that $\Lambda = \{y \in \mathbb{R}^n \mid |y| < 1\}$ is the open unit ball. A natural family of weights to consider are powers of the Poisson kernel parametrized by $\alpha > 0$

$$\mathbf{w}_{\lambda}^{\alpha}(z) = (2\pi)^{-n/2} \frac{1}{\Gamma(\alpha)} \left(1 - |y|^2 \right)_{+}^{\alpha - 1} \qquad (z = x + iy \in \mathcal{T} = \mathbb{R}^n + i\Lambda), \qquad (1.9)$$

where $(\cdot)_+$ denotes the positive part. These weights satisfy condition (1.5) exactly for $\alpha > \max\{2s - 1, 0\}$ where $s = \operatorname{Re} \lambda$, see Lemma 6.1. Moreover, in Theorem 6.5 we establish the following:

- (1) Condition (1.5) is only sufficient and Theorems 1.1, 1.2 hold even for $\alpha > \max\{2s \frac{n+1}{2}, 0\}$.
- (2) For α as in (1) and $\lambda = s > 0$ real the norm-sup identity (1.8) holds.

Let us stress that (1.8) is a new feature and isn't recorded (and perhaps not even true) for the range investigations with respect to the K-geometry in the rank one case: there, one verifies lim-sup identities which are even weaker than the norm-limit formula in Theorem 1.2, see [10].

2. NOTATION

Most of the notation used in this paper is standard for semisimple Lie groups and symmetric spaces and can be found for instance in [9] for the semisimple case and, for the general setting, in [20].

Let G be the real points of a connected algebraic reductive group defined over \mathbb{R} and let \mathfrak{g} be its Lie algebra. Subgroups of G are denoted by capitals. The corresponding subalgebras are denoted by the corresponding fraktur letter, i.e. \mathfrak{g} is the Lie algebra of G etc.

We denote by $\mathfrak{g}_{\mathbb{C}} = \mathfrak{g} \otimes_{\mathbb{R}} \mathbb{C}$ the complexification of \mathfrak{g} and by $G_{\mathbb{C}}$ the group of complex points. We fix a Cartan involution θ and write K for the maximal compact subgroup that is fixed by θ . We also write θ for the derived automorphism of \mathfrak{g} . We write $K_{\mathbb{C}}$ for the complexification of K, i.e. $K_{\mathbb{C}}$ is the subgroup of $G_{\mathbb{C}}$ consisting of the fixed points for the analytic extension of θ .

The Cartan involution induces the infinitesimal Cartan decomposition $\mathfrak{g} = \mathfrak{k} \oplus \mathfrak{s}$. Let $\mathfrak{a} \subset \mathfrak{s}$ be a maximal abelian subspace. The set of restricted roots of \mathfrak{a} in \mathfrak{g} we denote by $\Sigma \subset \mathfrak{a}^* \setminus \{0\}$ and write W for the Weyl group of Σ . We record the familiar root space decomposition

$$\mathfrak{g} = \mathfrak{a} \oplus \mathfrak{m} \oplus \bigoplus_{\alpha \in \Sigma} \mathfrak{g}^{\alpha} ,$$

with $\mathfrak{m} = \mathfrak{z}_{\mathfrak{k}}(\mathfrak{a})$.

Let A be the connected subgroup of G with Lie algebra \mathfrak{a} and let $M = Z_K(\mathfrak{a})$. We fix a choice of positive roots Σ^+ of \mathfrak{a} in \mathfrak{g} and write $\mathfrak{n} = \bigoplus_{\alpha \in \Sigma^+} \mathfrak{g}^{\alpha}$ with corresponding unipotent subgroup $N = \exp \mathfrak{n} \subset G$. As customary we set $\overline{\mathfrak{n}} = \theta(\mathfrak{n})$ and accordingly $\overline{N} = \theta(N)$. For the Iwasawa decomposition $G = KA\overline{N}$ of G we define the projections $\mathbf{k} : G \to K$ and $\mathbf{a} : G \to A$ by

$$g \in \mathbf{k}(g)\mathbf{a}(g)\overline{N} \qquad (g \in G).$$

Let κ be the Killing form on \mathfrak{g} and let $\widetilde{\kappa}$ be a non-degenerate $\mathrm{Ad}(G)$ -invariant symmetric bilinear form on \mathfrak{g} such that its restriction to $[\mathfrak{g},\mathfrak{g}]$ coincides with the restriction of κ and $-\widetilde{\kappa}(\cdot,\theta\cdot)$ is positive definite. We write $\|\cdot\|$ for the corresponding norm on \mathfrak{g} .

3. The complex crown of a Riemannian symmetric space

The Riemannian symmetric space Z=G/K can be realized as a totally real subvariety of the Stein symmetric space $Z_{\mathbb{C}}=G_{\mathbb{C}}/K_{\mathbb{C}}$:

$$Z = G/K \hookrightarrow Z_{\mathbb{C}}, \quad gK \mapsto gK_{\mathbb{C}}.$$

In the following we view $Z \subset Z_{\mathbb{C}}$ and write $z_0 = K \in Z$ for the standard base point. We define the subgroups $A_{\mathbb{C}} = \exp(\mathfrak{a}_{\mathbb{C}})$ and $N_{\mathbb{C}} = \exp(\mathfrak{n}_{\mathbb{C}})$ of $G_{\mathbb{C}}$. We denote by $F := [A_{\mathbb{C}}]_{2-\text{tor}}$ the finite group of 2-torsion elements and note that $F = A_{\mathbb{C}} \cap K$. Our concern is also with the solvable group S = AN and its complexification $S_{\mathbb{C}} = A_{\mathbb{C}}N_{\mathbb{C}}$. Note that $S \simeq Z$ as transitive S-manifolds, but the natural morphism $S_{\mathbb{C}} \to Z_{\mathbb{C}}$ is neither onto nor injective. Its image $S_{\mathbb{C}} \cdot z_0$ is Zariski open in the affine variety $Z_{\mathbb{C}}$ and we have $S_{\mathbb{C}}/F \simeq S_{\mathbb{C}} \cdot z_0$.

The maximal $G \times K_{\mathbb{C}}$ -invariant domain in $G_{\mathbb{C}}$ containing e and contained in $N_{\mathbb{C}}A_{\mathbb{C}}K_{\mathbb{C}}$ is given by

$$\widetilde{\Xi} = G \exp(i\Omega) K_{\mathbb{C}} ,$$
 (3.1)

where $\Omega = \{Y \in \mathfrak{a} \mid (\forall \alpha \in \Sigma)\alpha(Y) < \pi/2\}$. Note in particular that

$$\widetilde{\Xi} = \left[\bigcap_{g \in G} g N_{\mathbb{C}} A_{\mathbb{C}} K_{\mathbb{C}} \right]_{0} \tag{3.2}$$

with $[\ldots]_0$ denoting the connected component of $[\ldots]$ containing e.

Taking right cosets by $K_{\mathbb{C}}$, we obtain the G-domain

$$\Xi := \widetilde{\Xi}/K_{\mathbb{C}} \subset Z_{\mathbb{C}} = G_{\mathbb{C}}/K_{\mathbb{C}} , \qquad (3.3)$$

commonly referred to as the *crown domain*. See [7] for the origin of the notion, [15, Cor. 3.3] for the inclusion $\widetilde{\Xi} \subset N_{\mathbb{C}}A_{\mathbb{C}}K_{\mathbb{C}}$ and [14, Th. 4.3] for the maximality.

We recall that Ξ is a contractible space. To be more precise, let $\widehat{\Omega} = \operatorname{Ad}(K)\Omega$ and note that $\widehat{\Omega}$ is an open convex subset of \mathfrak{s} . As a consequence of the Kostant convexity theorem it satisfies $\widehat{\Omega} \cap \mathfrak{a} = \Omega$ and $p_{\mathfrak{a}}(\widehat{\Omega}) = \Omega$, where $p_{\mathfrak{a}}$ is the orthogonal projection $\mathfrak{s} \to \mathfrak{a}$. The fiber map

$$G \times_K \widehat{\Omega} \to \Xi; \quad [g, X] \mapsto g \exp(iX) \cdot K_{\mathbb{C}}$$

is a diffeomorphism by [1, Prop. 4, 5 and 7]. Since $G/K \simeq \mathfrak{s}$ and $\widehat{\Omega}$ are both contractible, also Ξ is contractible. In particular, Ξ is simply connected.

As $\Xi \subset S_{\mathbb{C}} \cdot z_0$ we also obtain a realization of Ξ in $S_{\mathbb{C}}/F$ which, by the contractibility of Ξ lifts to an S-equivariant embedding of $\Xi \hookrightarrow S_{\mathbb{C}}$. We denote the image by Ξ_S . Let us remark that Ξ_S is not known explicitly in appropriate coordinates except when Z has real rank one, which was determined in [4].

We recall $\mathbf{a}: G \to A$ the middle projection of the Iwasawa decomposition $G = KA\overline{N}$ and note that \mathbf{a} extends holomorphically to

$$\widetilde{\Xi}^{-1} := \{ g^{-1} : g \in \widetilde{\Xi} \} . \tag{3.4}$$

Here we use that $\widetilde{\Xi} \subset \overline{N}_{\mathbb{C}} A_{\mathbb{C}} K_{\mathbb{C}}$ as a consequence of $\Xi \subset N_{\mathbb{C}} A_{\mathbb{C}} K_{\mathbb{C}}$ and the G-invariance of Ξ . Moreover, the simply connectedness of Ξ plays a role to achieve $\mathbf{a}: \widetilde{\Xi}^{-1} \to A_{\mathbb{C}}$ uniquely: A priori \mathbf{a} is only defined as a map to $A_{\mathbb{C}}/F$. We denote the extension of \mathbf{a} to $\widetilde{\Xi}^{-1}$ by the same symbol.

Likewise one remarks that $\mathbf{k}: G \to K$ extends holomorphically to $\widetilde{\Xi}^{-1}$ as well.

3.1. Unipotent model for the crown. Let us define a domain $\Lambda \subset \mathfrak{n}$ by

$$\Lambda := \{ Y \in \mathfrak{n} \mid \exp(iY) \cdot z_0 \subset \Xi \}_0$$

where the index $\{\cdot\}_0$ refers to the connected component of $\{\cdot\}$ containing 0. Then we have

$$\Xi = G \exp(i\Lambda) \cdot z_0$$

by [14, Th. 8.3]. In general the precise shape of Λ is not known except for a few special cases, in particular if the real rank of G is one (see [14, Sect. 8.1 and 8.2]).

Proposition 3.1. For $G = GL(n, \mathbb{R})$ the domain $\Lambda \subset \mathfrak{n}$ is bounded.

Remark 3.2. A general real reductive group G can be embedded into $GL(n, \mathbb{R})$ with compatible Iwasawa decompositions. Then it happens in a variety of cases that the crown domain $\Xi = \Xi(G)$ for G embeds into the one of $GL(n, \mathbb{R})$. For example this is the case for $G = SL(n, \mathbb{R})$, $Sp(n, \mathbb{R})$, Sp(p, q), SU(p, q), and we refer to [16, Prop. 2.6] for a complete list. In all these cases Λ is then bounded as a consequence of Proposition 3.1.

Proof of Proposition 3.1. Define

$$\Lambda' = \{ Y \in \mathfrak{n} \mid \exp(iY)N \subset K_{\mathbb{C}}A_{\mathbb{C}}\overline{N}_{\mathbb{C}} \}_0$$

and note that $\Lambda' = -\Lambda$. Now (3.2) for N replaced by \overline{N} implies $\Lambda \subset \Lambda'$. We will show an even stronger statement by replacing Λ by Λ' ; in other words we search for the largest tube domain $T_{N,\Lambda'} := \exp(i\Lambda')N$ contained in $K_{\mathbb{C}}A_{\mathbb{C}}\overline{N}_{\mathbb{C}}$ and show that the tube has bounded base.

As usual we let $K_{\mathbb{C}} = \mathrm{SO}(n,\mathbb{C})$, $A_{\mathbb{C}} = \mathrm{diag}(n,\mathbb{C}^*)$ and $\overline{N}_{\mathbb{C}}$ be the unipotent lower triangular matrices. We recall the construction of the basic $K_{\mathbb{C}} \times \overline{N}_{\mathbb{C}}$ -invariant functions on $G_{\mathbb{C}}$. With e_1, \ldots, e_n the standard basis of \mathbb{C}^n we let $v_i := e_{n-i+1}$, $1 \le i \le n$. Now for $1 \le k \le n-1$ we define a holomorphic function on $G_{\mathbb{C}} = \mathrm{GL}(n,\mathbb{C})$ by

$$f_k(g) = \det (\langle g(v_i), g(v_j) \rangle_{1 \le i, j \le n-k}) \qquad (g \in G_{\mathbb{C}})$$

where $\langle z, w \rangle = z^t w$ is the standard pairing of \mathbb{C}^n . As the standard pairing is $K_{\mathbb{C}}$ -invariant we obtain that f_k is left $K_{\mathbb{C}}$ -invariant. Furthermore from

$$f_k(g) = \langle g(v_1) \wedge \ldots \wedge g(v_{n-k}), g(v_1) \wedge \ldots \wedge g(v_{n-k}) \rangle_{\bigwedge^{n-k} \mathbb{C}^n}$$

we see that f_k is right- $\overline{N}_{\mathbb{C}}$ -invariant. In particular we have

$$f_k(\kappa a \overline{n}) = a_{k+1} \cdot \ldots \cdot a_n \qquad (\kappa \in K_{\mathbb{C}}, \overline{n} \in \overline{N}_{\mathbb{C}})$$

for $a = \operatorname{diag}(a_1, \ldots, a_n) \in A_{\mathbb{C}}$. Hence f_k is not vanishing on $K_{\mathbb{C}}A_{\mathbb{C}}\overline{N}_{\mathbb{C}}$ and in particular not on the tube domain $T_{N,\Lambda'}$ which is contained in $K_{\mathbb{C}}A_{\mathbb{C}}\overline{N}_{\mathbb{C}}$.

The functions f_k are right semi-invariant under the maximal parabolic subgroup $\overline{P}_k = L_k \overline{U}_k$ with $L_k = \operatorname{GL}(k,\mathbb{R}) \times \operatorname{GL}(n-k,\mathbb{R})$ embedded block-diagonally and $\overline{U}_k = \mathbf{1}_n + \operatorname{Mat}_{(n-k)\times k}(\mathbb{R})$ with $\operatorname{Mat}_{(n-k)\times k}(\mathbb{R})$ sitting in the lower left corner. We obtain with $U_k = \mathbf{1}_n + \operatorname{Mat}_{k\times (n-k)}(\mathbb{R})$ an abelian subgroup of N with $\mathfrak{u}_k = \operatorname{Mat}_{k\times (n-k)}(\mathbb{R})$ and record for $Z = X + iY \in \mathfrak{u}_{k,\mathbb{C}}$ that

$$f_k(\exp(Z)) = \det(\mathbf{1}_{n-k} + Z^t Z)$$
.

From this we see that the largest U_k -invariant tube domain in $U_{k,\mathbb{C}} = \operatorname{Mat}_{k\times(n-k)}(\mathbb{C})$ to which f_k extends to a zero free holomorphic function is given by

$$T_k = \operatorname{Mat}_{k \times (n-k)}(\mathbb{R}) + i \Upsilon_k$$

where

$$\Upsilon_k = \{ Y \in \operatorname{Mat}_{k \times (n-k)}(\mathbb{R}) \mid \mathbf{1}_{n-k} - Y^t Y \text{ is positive definite} \}$$

is bounded and convex.

With $\mathfrak{n}_k = \mathfrak{l}_k \cap \mathfrak{n}$ we obtain a subalgebra of \mathfrak{n} such that $\mathfrak{n} = \mathfrak{n}_k \ltimes \mathfrak{u}_k$ is a semi-direct product with abelian ideal \mathfrak{u}_k . Accordingly we have $N \simeq U_k \times N_k$ under

the multiplication map and likewise we obtain, via Lemma 3.3 below, for each k a diffeomorphic polar map

$$\Phi_k : \mathfrak{u}_k \times \mathfrak{n}_k \times N \to N_{\mathbb{C}}, \quad (Y_1, Y_2, n) \mapsto \exp(iY_1) \exp(iY_2) n.$$

Note that

$$\Phi_k^{-1}(T_{N,\Lambda'}) = \Lambda_k' \times N$$

with $\Lambda'_k \subset \mathfrak{u}_k \times \mathfrak{n}_k$ a domain containing 0. Now let $\Lambda'_{k,1}$ be the projection of Λ'_k to \mathfrak{u}_k and likewise we define $\Lambda'_{k,2} \subset \mathfrak{n}_k$. Note that $\Lambda'_k \subset \Lambda'_{k,1} \times \Lambda'_{k,2}$. We now claim that $\Lambda'_{k,1} \subset \Upsilon_k$. In fact let $Y = Y_1 + Y_2 \in \Lambda'_k$. Then $\exp(iY_1) \exp(iY_2) \in T_{N,\Lambda'}$ and thus, as f_k is right $N_{k,\mathbb{C}}$ -invariant,

$$0 \neq f_k(\exp(iY_1)\exp(iY_2)) = f_k(\exp(iY_1)).$$

Our claim follows.

To complete the proof we argue by contradiction and assume that Λ' is unbounded. We will show that this implies that $\Lambda'_{k,1}$ becomes unbounded, a contradiction to the claim above. Suppose now that there is an unbounded sequence $(Y^m)_{m\in\mathbb{N}}\subset \Lambda'$. We write elements $Y\in\mathfrak{n}$ in coordinates $Y=\sum_{1\leq i< j\leq n}Y_{i,j}$. Let now $1\leq k\leq n-1$ be maximal such that all $Y^m_{i,j}$ stay bounded for $j\leq k$. Our choice of parabolic subgroup then is \overline{P}_k .

By assumption we have that $Y_{i,k+1}^m$ becomes unbounded for some $1 \leq i \leq k$. Let $l \geq i$ be maximal with this property. We write elements $Y \in \mathfrak{n}$ as $Y_1 + Y_2$ with $Y_1 \in \mathfrak{u}_k$ and $Y_2 \in \mathfrak{n}_k$. Now for any $Y = Y_1 + Y_2 \in \mathfrak{n}$ we find unique $\widetilde{Y}_1, X \in \mathfrak{u}_k$ such that

$$\exp(iY) = \exp(i(Y_1 + Y_2)) = \exp(i\widetilde{Y}_1) \exp(iY_2) \exp(X) \tag{3.5}$$

as a consequence of the fact that Φ_k is diffeomorphic and the identity

$$\exp(iY)U_{k,\mathbb{C}} = \exp(iY_2)U_{k,\mathbb{C}}$$

in the Lie group $N_{\mathbb{C}}/U_{k,\mathbb{C}}$.

By Dynkin's formula and the abelianess of \mathfrak{u}_k we infer from (3.5)

$$iY = ((i\widetilde{Y}_1 * iY_2) * X) = i\widetilde{Y}_1 + iY_2 + X + \sum_{j=1}^{n-1} c_j i^{j+1} (\operatorname{ad} Y_2)^j \widetilde{Y}_1 + \sum_{j=1}^{n-1} d_j i^j (\operatorname{ad} Y_2)^j X$$

for certain rational constants $c_j, d_j \in \mathbb{Q}$. In particular, comparing real and imaginary parts on both sides we obtain two equations:

$$Y_1 = \widetilde{Y}_1 + \sum_{j=1}^{n_1} c_{2j} (-1)^j (\operatorname{ad} Y_2)^{2j} \widetilde{Y}_1 + \sum_{j=0}^{n_2} d_{2j+1} (-1)^j (\operatorname{ad} Y_2)^{2j+1} X$$
 (3.6)

$$X = \sum_{j=0}^{n_1} c_{2j+1} (-1)^j (\operatorname{ad} Y_2)^{2j+1} \widetilde{Y}_1 - \sum_{j=1}^{n_2} d_{2j} (-1)^j (\operatorname{ad} Y_2)^{2j} X, \tag{3.7}$$

where $n_1 = \lfloor \frac{n-1}{2} \rfloor$ and $n_2 = \lceil \frac{n-1}{2} - 1 \rceil$.

Our claim now is that $(\widetilde{Y}_1^m)_{l,k+1}$ is unbounded. If l=k, then we deduce from (3.6) that $(Y_1^m)_{k,k+1} = (\widetilde{Y}_1^m)_{k,k+1}$ is unbounded, i.e., our desired contradiction. Now suppose l < k. We are interested in the entries of \widetilde{Y}_1 in the first column and for that we let $\pi_1 : \mathfrak{u}_{k,\mathbb{C}} = \operatorname{Mat}_{k\times(n-k)}(\mathbb{C}) \to \mathbb{C}^k$ be the projection onto the first column. We

decompose $\mathfrak{l}_k = \mathfrak{l}_{k,1} + \mathfrak{l}_{k,2}$ with $\mathfrak{l}_{k,1} = \mathfrak{gl}(k,\mathbb{R})$ and $\mathfrak{l}_2 = \mathfrak{gl}(n-k,\mathbb{R})$. Write $\mathfrak{u}_{k,j} = \mathbb{R}^k$ for the subalgebra of \mathfrak{u}_k consisting of the j-th column and observe

$$\pi_1([\mathfrak{l}_{k,2} \cap \mathfrak{n}_k, \mathfrak{u}_k]) = \{0\} \tag{3.8}$$

$$[\mathfrak{l}_{k,1},\mathfrak{u}_{k,j}] \subset \mathfrak{u}_{k,j}. \tag{3.9}$$

Now write $Y_2 = Y_{2|1} + Y_{2|2}$ according to $\mathfrak{l}_k = \mathfrak{l}_{k,1} + \mathfrak{l}_{k,2}$. From (3.6)–(3.7) together with (3.8)–(3.9) we then derive that

$$\pi_1(Y_1) = \pi_1(\widetilde{Y}_1) + \sum_{j=1}^{n_1} c_{2j} (-1)^j (\operatorname{ad} Y_{2|1})^{2j} \pi_1(\widetilde{Y}_1)$$

$$+ \sum_{j=0}^{n_2} d_{2j+1} (-1)^j (\operatorname{ad} Y_{2|1})^{2j+1} \pi_1(X)$$
(3.10)

and

$$\pi_1(X) = \sum_{j=0}^{n_1} c_{2j+1} (-1)^j (\operatorname{ad} Y_{2|1})^{2j} \pi_1(\widetilde{Y}_1) - \sum_{j=1}^{n_2} d_{2j} (-1)^j (\operatorname{ad} Y_{2|1})^{2j} \pi_1(X). \quad (3.11)$$

We apply this now to $Y = Y^m$ and note that $Y^m_{2|1}$ is bounded by the construction of \overline{P}_k . From (3.10) and (3.11) we obtain that $X^m_{k+1,k} = 0$ and $(\widetilde{Y}^m_1)_{k,k+1} = (Y^m_1)_{k,k+1}$ and recursively we obtain that $X^m_{i,k+1}$ and $\widetilde{Y}^m_{i,k+1}$ remain bounded for i < l. It then follows from (3.10), as $Y^m_{l,k+1}$ is unbounded, that $\widetilde{Y}^m_{l,k+1}$ is unbounded. This is the desired contradiction and completes the proof of the proposition.

Lemma 3.3. Let \mathfrak{n} be a nilpotent Lie algebra, $N_{\mathbb{C}}$ a simply connected Lie group with Lie algebra $\mathfrak{n}_{\mathbb{C}}$ and $N = \exp(\mathfrak{n}) \subset N_{\mathbb{C}}$. Let further $\mathfrak{n}_1, \mathfrak{n}_2 \subset \mathfrak{n}$ be subalgebras with $\mathfrak{n} = \mathfrak{n}_1 + \mathfrak{n}_2$ (not necessarily direct). Suppose that \mathfrak{n}_1 is abelian. Then the 2-polar map

$$\Phi: \mathfrak{n}_1 \times \mathfrak{n}_2 \times N \to N_{\mathbb{C}}, \quad (Y_1, Y_2, n) \mapsto \exp(iY_1) \exp(iY_2)n$$

is onto. If moreover, the sum $\mathfrak{n}_1 + \mathfrak{n}_2$ is direct and \mathfrak{n}_1 is an ideal, then Φ is diffeomorphic.

Proof. We prove the statement by induction on dim N. Let $Z(N_{\mathbb{C}}) \subset N_{\mathbb{C}}$ the center of $N_{\mathbb{C}}$. Note that $Z(N_{\mathbb{C}})$ is connected and of positive dimension if dim $\mathfrak{n} > 0$. Set $\widetilde{\mathfrak{n}} := \mathfrak{n}/\mathfrak{z}(\mathfrak{n})$, $\widetilde{\mathfrak{n}}_i := (\mathfrak{n}_i + \mathfrak{z}(\mathfrak{n}))/\mathfrak{z}(\mathfrak{n})$ and $\widetilde{N}_{\mathbb{C}} = N_{\mathbb{C}}/Z(N_{\mathbb{C}})$. Induction applies and we deduce that for every $n_{\mathbb{C}} \in N_{\mathbb{C}}$ we find elements $n \in N$, $Y_i \in \mathfrak{n}_i$ and $z_{\mathbb{C}} \in Z(N_{\mathbb{C}})$ such that

$$n_{\mathbb{C}} = \exp(iY_1) \exp(iY_2) nz_{\mathbb{C}}.$$

We write $z_{\mathbb{C}} = zy$ with $z \in Z(N)$ and $y = \exp(iY)$ with $Y \in \mathfrak{z}(\mathfrak{n})$. Write $Y = Y_1' + Y_2'$ with $Y_i' \in \mathfrak{n}_i$. As Y is central Y_1' commutes with Y_2' and so $y = \exp(Y_1') \exp(Y_2')$. Putting matters together we arrive at

$$n_{\mathbb{C}} = \exp(iY_1) \exp(iY_1') \exp(iY_2') \exp(iY_2) nz.$$

Now $nz \in N$ and $\exp(iY_1) \exp(iY_1') = \exp(i(Y_1 + Y_1'))$. Finally, $\exp(iY_2') \exp(iY_2) = \exp(iY_2'')n_2$ for some $Y_2'' \in \mathfrak{n}_2$ and $n_2 \in N_2 = \exp(\mathfrak{n}_2)$. This proves that Φ is surjective.

For the second part let us assume the further requirements. We confine ourselves with showing that Φ is injective. So suppose that

$$\exp(iY_1)\exp(iY_2)n = \exp(iY_1')\exp(iY_2')n'$$

and reduce both sides mod the normal subgroup $N_{1,\mathbb{C}}$. Hence $Y_2 = Y_2'$. Since we have $N \simeq N_1 \times N_2$ under multiplication we may assume, by the same argument that $n = n_1 \in N_1$ and $n' = n'_1$. Now injectivity is immediate.

4. The Poisson transform and the Helgason conjecture

4.1. Representations of the spherical principal series. Let $\overline{P} = MA\overline{N}$ and define for $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ the normalized character

$$\chi_{\lambda}: \overline{P} \to \mathbb{C}^*, \quad \overline{p} = ma\overline{n} \mapsto a^{\lambda - \rho}.$$

Associated to this character is the line bundle $\mathcal{L}_{\lambda} = G \times_{\overline{P}} \mathbb{C}_{\lambda} \to G/\overline{P}$. The sections of this line bundle form the representations of the spherical principal series: We denote the K-finite sections by V_{λ} , the analytic sections by V_{λ}^{ω} and the smooth sections by V_{λ}^{∞} . Note in particular,

$$V_{\lambda}^{\infty} = \{ f \in C^{\infty}(G) \mid f(g\overline{p}) = \chi_{\lambda}(\overline{p})^{-1} f(g), \ \overline{p} \in \overline{P}, g \in G \}$$

and that V_{λ}^{∞} is a G-module under the left regular representation. Now given $f_1 \in V_{\lambda}^{\infty}$ and $f_2 \in V_{-\lambda}^{\infty}$ we obtain that $f := f_1 f_2$ is a smooth section of $\mathcal{L}_{-\rho}$ which identifies with the 1-density bundle of the compact flag variety G/\overline{P} . Hence we obtain a natural G-invariant non-degenerate pairing

$$V_{\lambda}^{\infty} \times V_{-\lambda}^{\infty} \to \mathbb{C}, \quad (f_1, f_2) \mapsto \langle f_1, f_2 \rangle := \int_{G/\overline{P}} f_1 f_2.$$
 (4.1)

In particular, the Harish-Chandra module dual to V_{λ} is isomorphic to $V_{-\lambda}$. The advantage using the pairing (4.1) is that it easily gives formulas when trivializing \mathcal{L}_{λ} , and one securely obtains correct formulas for the compact and non-compact picture. Using this pairing we define the space of distribution vectors as the strong dual $V_{\lambda}^{-\infty} = (V_{-\lambda}^{\infty})'$. Likewise we obtain the space of hyperfunction vectors $V_{\lambda}^{-\omega}$. Altogether we have the natural chain

$$V_{\lambda} \subset V_{\lambda}^{\omega} \subset V_{\lambda}^{\infty} \subset V_{\lambda}^{-\infty} \subset V_{\lambda}^{-\omega} \, .$$

We denote by $f_{\lambda,K} \in V_{\lambda}$ the K-fixed vector with $f_{\lambda,K}(\mathbf{1}) = 1$ and normalize the identification of $\mathcal{L}_{-\rho}$ with the 1-density bundle such that $\int f_{-\rho,K} = 1$.

4.2. Definition of the Poisson transform and Helgason's conjecture. We move on with the concept of Poisson transform and the Helgason conjecture on Z = G/K which was formulated in [8] and first established in [11]; see also [6] for a novel elementary treatment. We denote by $\mathbb{D}(Z)$ the commutative algebra of G-invariant differential operators and recall that the Harish-Chandra homomorphism for Z asserts that $\mathbb{D}(Z) \simeq \operatorname{Pol}(\mathfrak{a}_{\mathbb{C}}^*)^W$ with W the Weyl group. In particular, spec $\mathbb{D}(Z) \simeq \mathfrak{a}_{\mathbb{C}}^*/W$.

For $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ we denote by $\mathcal{E}_{[\lambda]}(Z)$ the $\mathbb{D}(Z)$ -eigenspace attached to $[\lambda] = W \cdot \lambda \in \mathfrak{a}_{\mathbb{C}}^*/W$. Note that all functions in $\mathcal{E}_{[\lambda]}(Z)$ are eigenfunctions of Δ_Z to the eigenvalue

 $\lambda^2 - \rho^2$, with λ^2 abbreviating the Cartan–Killing pairing $\kappa(\lambda, \lambda)$. In case Z has real rank one, let us remark that this characterizes $\mathcal{E}_{[\lambda]}(Z)$, i.e.

$$\mathcal{E}_{[\lambda]}(Z) = \{ f \in C^{\infty}(Z) \mid \Delta_Z f = (\lambda^2 - \rho^2) f \}.$$

For $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ one defines the G-equivariant Poisson transform

$$\mathcal{P}_{\lambda}: V_{\lambda}^{-\omega} \to C^{\infty}(G/K), \quad f \mapsto (gK \mapsto \langle f, g \cdot f_{-\lambda, K} \rangle).$$

The Helgason conjecture then asserts that \mathcal{P}_{λ} is onto the $\mathbb{D}(Z)$ -eigenspace $\mathcal{E}_{[\lambda]}(Z)$ provided that $f_{K,-\lambda}$ is cyclic in $V_{-\lambda}$, i.e. $\mathcal{U}(\mathfrak{g})f_{K,-\lambda} = V_{-\lambda}$. The latter condition is always satisfied if Kostant's condition [13, Th. 8] holds: $\operatorname{Re} \lambda(\alpha^{\vee}) \geq 0$ for all positive roots α . In the sequel we abbreviate this condition as $\operatorname{Re} \lambda \geq 0$.

If Re $\lambda > 0$, then the Poisson transform is inverted by the boundary value map

$$b_{\lambda}: \mathcal{E}_{\lambda}(Z) \to V_{\lambda}^{-\omega}, \quad \phi \mapsto (g \mapsto \mathbf{c}(\lambda)^{-1} \lim_{\substack{a \to \infty \\ a \in A^{-}}} a^{\lambda - \rho} \phi(ga))$$

where $\mathbf{c}(\lambda)$ is the Harish-Chandra **c**-function:

$$\mathbf{c}(\lambda) := \int_{N} \mathbf{a}(n)^{\lambda + \rho} \ dn$$

with $\mathbf{a}: KA\overline{N} \to A$ the middle projection.

In particular, we have

$$b_{\lambda}(\mathcal{P}_{\lambda}(f)) = f \qquad (f \in V_{\lambda}^{-\omega}, \operatorname{Re} \lambda > 0).$$
 (4.2)

5. The Poisson transform in terms of S-geometry

As emphasized in the introduction our focus in this article is on the S = ANpicture of Z = G/K which we henceforth identify with S. In particular, we will
write $\mathcal{E}_{[\lambda]}(S)$ instead of $\mathcal{E}_{[\lambda]}(Z)$ etc.

We fix a parameter λ such that $\operatorname{Re} \lambda > 0$. The goal is to identify subspaces of $V_{\lambda}^{-\omega}$ for which \mathcal{P}_{λ} has a particularly nice image in terms of S-models. From what we already explained we have

$$\operatorname{im} \mathcal{P}_{\lambda} \subset \mathcal{O}(\Xi_S)$$

and, in particular, for all $\phi \in \operatorname{im} \mathcal{P}_{\lambda}$ and $a \in A$ we have $\phi_a \in \mathcal{O}(\mathcal{T}_a)$. The general problem here is that one wants to identify $V_{\lambda}^{-\omega}$ with a certain subspace of $C^{-\omega}(N)$ which is tricky and depends on the parameter λ . The compact models for the spherical principal series here are much cleaner to handle as the restriction maps

$$\operatorname{Res}_{K,\lambda}: V_{\lambda}^{\infty} \to C^{\infty}(K/M) = C^{\infty}(K)^{M}, \quad f \mapsto f|_{K}$$

are isomorphisms. In this sense we obtain a natural identification $V_{\lambda}^{-\omega} \simeq C^{-\omega}(K/M)$ as K-modules which is parameter independent. Contrary to that, the faithful restriction map

$$\operatorname{Res}_{N,\lambda}: V_{\lambda}^{\infty} \to C^{\infty}(N), \quad f \mapsto f|_{N}$$

is not onto and the image depends on λ . For a function $h \in C^{\infty}(N)$ we define a function H_{λ} on the open Bruhat cell $NMA\overline{N}$ by

$$H_{\lambda}(nma\overline{n}) = h(n)a^{-\lambda+\rho}$$
.

Then the image of $\operatorname{Res}_{N,\lambda}$ is by definition given by

$$C_{\lambda}^{\infty}(N) = \{ h \in C^{\infty}(N) \mid H_{\lambda} \text{ extends to a smooth function on } G \}.$$

In this sense $V_{\lambda}^{-\omega}$ corresponds in the non-compact model to

$$C_{\lambda}^{-\omega}(N) = \left\{ h \in C^{-\omega}(N) \mid H_{\lambda}|_{K \cap N\overline{P}} \text{ extends to a hyperfunction on } K \right\}.$$

Having said this we take an element $f \in C_{\lambda}^{-\omega}(N)$ and observe that the Poisson transform in terms of S is given by

$$\mathcal{P}_{\lambda}f(s) = \int_{N} f(x)\mathbf{a}(s^{-1}x)^{\lambda+\rho} dx \qquad (s \in S)$$
 (5.1)

with $\mathbf{a}: KA\overline{N} \to A$ the middle projection. In accordance with (4.2) we then have

$$\frac{1}{\mathbf{c}(\lambda)} \lim_{\substack{a \to \infty \\ a \in A^{-}}} a^{\lambda - \rho} \mathcal{P}_{\lambda} f(na) = f(n) \qquad (n \in N).$$

Let us note that the Hilbert model of $\mathcal{H}_{\lambda} = L^2(K/M) \subset C^{-\omega}(K/M) = V_{\lambda}^{-\omega}$ of V_{λ} corresponds in the non-compact picture to $L^2(N,\mathbf{a}(n)^{2\operatorname{Re}\lambda}dn)\supset L^2(N)$ and hence

$$L^2(N) \subset C_{\lambda}^{-\omega}(N)$$
 (Re $\lambda \ge 0$).

The main objective now is to give a novel characterization of $\mathcal{P}_{\lambda}(L^{2}(N))$ for Re $\lambda > 0$. For a function ϕ on S = NA and $a \in A$ we recall the partial functions on N defined by

$$\phi_a(n) = \phi(na) \qquad (n \in N).$$

Now, given $f \in L^2(N)$ we let $\phi := \mathcal{P}_{\lambda}(f)$ and rewrite (5.1) as

$$\frac{1}{\mathbf{c}(\lambda)} a^{\lambda - \rho} \phi_a(n) = \int_N f(x) \delta_{\lambda, a}(n^{-1}x) \ dx \tag{5.2}$$

with

$$\delta_{\lambda,a}(x) := \frac{1}{\mathbf{c}(\lambda)} a^{-2\rho} \mathbf{a}(a^{-1}xa)^{\lambda+\rho} \qquad (x \in N).$$
 (5.3)

We first note that the condition Re $\lambda > 0$ then implies that $\delta_{\lambda,a}$ is a Dirac-sequence on N for $a \to \infty$ on a ray in the negative Weyl chamber.

Lemma 5.1. Let $\phi = \mathcal{P}_{\lambda}(f)$ for $f \in L^{2}(N)$. Then the following assertions hold:

- (1) $\phi_a \in L^2(N)$ for all $a \in A$. (2) $\|\phi_a\|_{L^2(N)} \le a^{\rho \text{Re }\lambda} \mathbf{c}(\text{Re }\lambda) \|f\|_{L^2(N)}$.

Proof. Both assertions are immediate from the fact that $\|\delta_{\lambda,a}\|_{L^1(N)} \leq \frac{\mathbf{c}(\operatorname{Re}\lambda)}{|\mathbf{c}(\lambda)|}$, (5.2) and Young's convolution inequality.

5.1. Partial holomorphic extensions of eigenfunctions. Recall \mathcal{T}_a and Λ_a from (1.2), resp. (1.3), and that the Poisson transform $\phi = \mathcal{P}_{\lambda}(f)$ belongs to $\mathcal{O}(\Xi_S)$ with all partial functions ϕ_a extending to holomorphic functions on \mathcal{T}_a . For $y \in$ $\exp(i\Lambda_a)$ we thus can define

$$\phi_{a,y}(n) := \phi_a(ny) \qquad (n \in N).$$

Let $\delta_{\lambda} := \delta_{\lambda,1}$ and put

$$\delta_{\lambda,y}: N \to \mathbb{C}, \quad x \mapsto \delta_{\lambda}(y^{-1}x) \ .$$
 (5.4)

Lemma 5.2. The following assertions hold:

- (1) The function $\mathbf{v}_{\lambda}(y) := \sup_{k \in K} |\mathbf{a}(y^{-1}k)^{\lambda+\rho}|$ is finite for all $y \in \exp(i\Lambda)$.
- (2) The function $\delta_{\lambda,y}$ is integrable with $L^1(N)$ -norm

$$v_{\lambda}(y) := \|\delta_{\lambda,y}\|_{L^{1}(N)} \le \mathbf{v}_{\lambda}(y) \frac{\mathbf{c}(\operatorname{Re}\lambda)}{|\mathbf{c}(\lambda)|}.$$
 (5.5)

Proof. Part (1) is a consequence of the fact that $\mathbf{a}: G \to A$, considered as a map from $K \setminus G \to A$, extends holomorphically to $\Xi^{-1} \to A_{\mathbb{C}}$ with Ξ^{-1} considered as a subset of $K_{\mathbb{C}} \setminus G_{\mathbb{C}}$, see (3.4).

For the proof of (2) we note the identity

$$\delta_{\lambda}(y^{-1}x) = \delta_{\lambda}(x)\mathbf{a}(y^{-1}\mathbf{k}(x))^{\lambda+\rho} \qquad (x \in N, y \in \exp(i\Lambda)), \tag{5.6}$$

where $\mathbf{k}: G \to K$ is defined by the opposite Iwasawa decomposition $G = KA\overline{N}$. Combined with part (1), (5.6) implies that for all $y \in \exp(i\Lambda)$ the function $\delta_{\lambda,y}$ is integrable on N, with the asserted estimate (5.5) for its norm.

For $g, x \in G_{\mathbb{C}}$ we use the standard abbreviation $x^g := gxg^{-1}$.

Lemma 5.3. For Re $\lambda > 0$, $f \in L^2(N)$ and $\phi = \mathcal{P}_{\lambda}(f)$ we have

$$\|\phi_{a,y}\|_{L^2(N)} \le |\mathbf{c}(\lambda)| a^{\rho - \operatorname{Re}\lambda} \|\delta_{\lambda,y^{a^{-1}}}\|_{L^1(N)} \|f\|_{L^2(N)} \qquad (y \in \exp(i\Lambda_a)).$$
 (5.7)

Proof. From (5.2) we obtain

$$\frac{1}{\mathbf{c}(\lambda)} a^{\lambda - \rho} \phi_{a,y}(n) = \int_{N} f(x) \delta_{\lambda,a}(y^{-1}n^{-1}x) \ dx$$

and thus

$$\frac{1}{|\mathbf{c}(\lambda)|} a^{\operatorname{Re}\lambda - \rho} \|\phi_{a,y}\|_{L^2(N)} \le \|\delta_{\lambda,a}(y^{-1}\cdot)\|_{L^1(N)} \|f\|_{L^2(N)}. \tag{5.8}$$

Next we unwind the defintions (5.3) and (5.4) and apply the change of variable $x \mapsto a^{-1}xa$ on N:

$$\|\delta_{\lambda,a}(y^{-1}\cdot)\|_{L^{1}(N)} = \frac{a^{-2\rho}}{|\mathbf{c}(\lambda)|} \int_{N} |\mathbf{a}(a^{-1}y^{-1}xa)^{\lambda+\rho}| dx$$

$$= \frac{a^{-2\rho}}{|\mathbf{c}(\lambda)|} \int_{N} |\mathbf{a}((a^{-1}y^{-1}a)a^{-1}xa)^{\lambda+\rho}| dx$$

$$= \frac{1}{|\mathbf{c}(\lambda)|} \int_{N} |\mathbf{a}((y^{-1})^{a^{-1}}x)^{\lambda+\rho}| dx = \|\delta_{\lambda,y^{a^{-1}}}\|_{L^{1}(N)}.$$

The assertion (5.7) now follows from (5.8).

5.2. A class of weight functions. We now let $\mathbf{w}_{\lambda} : \exp(i\Lambda) \to \mathbb{R}_{>0}$ be any positive continuous function such that

$$d(\lambda) := \int_{\exp(i\Lambda)} \mathbf{w}_{\lambda}(y) \|\delta_{\lambda,y}\|_{L^{1}(N)}^{2} dy < \infty$$
 (5.9)

and define a left N-invariant function on the tube \mathcal{T}_a by

$$\mathbf{w}_{\lambda,a}: \mathcal{T}_a \to \mathbb{R}_{>0}, \quad ny \mapsto \mathbf{w}_{\lambda}(\mathrm{Ad}(a^{-1})y) \qquad (y \in \exp(i\Lambda_a)).$$

Remark 5.4. In general we expect that Λ is bounded. In view of (5.5) one may then take

$$\mathbf{w}_{\lambda} \equiv 1$$
,

as $\mathbf{v}_{\lambda}^{-2}$ is bounded from below by a positive constant. Optimal choices for \mathbf{w}_{λ} in special cases will be presented at the end of the article.

We now show that $\phi_a \in \mathcal{O}(\mathcal{T}_a)$ belongs to the weighted Bergman space

$$\mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda, a}) := \{ \psi \in \mathcal{O}(\mathcal{T}_a) \mid \|\psi\|_{\mathcal{B}_{a, \lambda}}^2 := \int_{\mathcal{T}_a} |\psi(z)|^2 \mathbf{w}_{\lambda, a}(z) dz < \infty \},$$

where dz is the Haar measure on $N_{\mathbb{C}}$ restricted to \mathcal{T}_a . In more precision with $d(\lambda)$ from (5.9) we record the following lemma

Lemma 5.5. Let Re $\lambda > 0$, $f \in L^2(N)$ and $\phi = \mathcal{P}_{\lambda}(f)$. Then we have the following inequality

$$\|\phi_a\|_{\mathcal{B}_{a,\lambda}} \le |\mathbf{c}(\lambda)| \sqrt{d(\lambda)} a^{2\rho - \operatorname{Re}\lambda} \|f\|_{L^2(N)}. \tag{5.10}$$

Proof. Starting with (5.7) the assertion follows from the estimate

$$\|\phi_{a}\|_{\mathcal{B}_{a,\lambda}} \leq a^{\rho-\operatorname{Re}\lambda} |\mathbf{c}(\lambda)| \left[\int_{\exp(i\Lambda^{a})} \mathbf{w}_{\lambda}(y^{a^{-1}}) \|\delta_{\lambda,y^{a^{-1}}}\|_{L^{1}(N)}^{2} dy \right]^{\frac{1}{2}} \|f\|_{L^{2}(N)}$$

$$= |\mathbf{c}(\lambda)| \left[\int_{\exp(i\Lambda)} \mathbf{w}_{\lambda}(y) \|\delta_{\lambda,y}\|_{L^{1}(N)}^{2} dy \right]^{\frac{1}{2}} a^{2\rho-\operatorname{Re}\lambda} \|f\|_{L^{2}(N)}$$

$$= |\mathbf{c}(\lambda)| \sqrt{d(\lambda)} a^{2\rho-\operatorname{Re}\lambda} \|f\|_{L^{2}(N)},$$

as desired. \Box

Lemma 5.5 motivates the definition of the following Banach subspace of $\mathcal{E}_{[\lambda]}(S) \subset \mathcal{O}(\Xi_S)$:

$$\mathcal{B}(\Xi_S, \lambda) := \{ \phi \in \mathcal{E}_{[\lambda]}(S) \mid \|\phi\| := \sup_{a \in A} a^{\operatorname{Re} \lambda - 2\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}} < \infty \}.$$

Indeed, (5.10) implies

$$\|\mathcal{P}_{\lambda}(f)\| \le C\|f\|_{L^{2}(N)} \qquad (f \in L^{2}(N))$$
 (5.11)

with $C := \mathbf{c}(\operatorname{Re} \lambda) \sqrt{d(\lambda)}$ and therefore the first inequality in Theorem 1.1.

Proof of Theorem 1.1. Since $\text{Re }\lambda > 0$, the Poisson transform is injective. Further, (5.11) shows that \mathcal{P}_{λ} takes values in $\mathcal{B}(\Xi_S, \lambda)$ and is continuous. In view of the open mapping theorem, it thus suffices to show that \mathcal{P}_{λ} is surjective. Note now that the weight \mathbf{w}_{λ} is uniformly bounded above and below by positive constants when restricted to a compact subset $\exp(i\Lambda_c) \subset \exp(i\Lambda)$. Hence the Bergman inequality implies the bound

$$\|\psi|_N\|_{L^2(N)} \le Ca^{-\rho}\|\psi\|_{\mathcal{B}_{a,\lambda}} \quad (\psi \in \mathcal{B}(\mathcal{T}_a, \mathbf{w}_{\lambda,a})). \tag{5.12}$$

We apply this to $\psi = \phi_a$ for some $\phi \in \mathcal{B}(\Xi_S, \lambda)$ and obtain that $a^{\lambda - \rho}\phi_a|_N$ is bounded in $L^2(N)$. Hence we obtain for some sequence $(a_n)_{n \in \mathbb{N}}$ on a ray in A^- that $a_n^{\lambda - \rho}\phi_{a_n}|_N \to h$ weakly for some $h \in L^2(N)$.

By the Helgason conjecture we know that $\phi = \mathcal{P}_{\lambda}(f)$ for some $f \in C_{\lambda}^{-\omega}(N)$ and that

$$\mathbf{c}(\lambda)^{-1} a^{\lambda - \rho} \phi_a|_N \to f \tag{5.13}$$

as appropriate hyperfunctions on N for $a \to \infty$ in A^- on a ray. Hence h = f and we obtain the second inequality of the theorem.

5.3. The norm limit formula. Define a positive constant

$$w(\lambda) := \left[\int_{\exp(i\Lambda)} \mathbf{w}_{\lambda}(y) \ dy \right]^{\frac{1}{2}}.$$
 (5.14)

Note that $w(\lambda)$ is indeed finite. This will follow from (5.9) provided we can show that $\|\delta_{\lambda,y}\|_1 \geq 1$. Now, using Cauchy's theorem we see that

$$\int_{N} \mathbf{a}(y^{-1}n)^{\lambda+\rho} dn = \mathbf{c}(\lambda)$$
 (5.15)

does not depend on $y \in \exp(i\Lambda)$. The estimate $\|\delta_{\lambda,y}\|_{L^1(N)} \ge 1$ follows.

The purpose of this section is to prove the norm limit formula as stated in the introduction.

Proof of Theorem 1.2. In the sequel we first note that for any integrable function ψ on \mathcal{T}_a we have

$$\int_{\mathcal{T}_a} |\psi(z)|^2 dz = \int_{\Lambda_a} \int_N |\psi(yn)|^2 dn dY$$

with $y = \exp(iY)$ and dY the Lebesgue measure on \mathfrak{n} . With that we rewrite the square of the left hand side of (1.7) as

$$\frac{1}{w(\lambda)^{2}|\mathbf{c}(\lambda)|^{2}}a^{2\operatorname{Re}\lambda-4\rho}\|\phi_{a}\|_{\mathcal{B}_{a,\lambda}}^{2} =$$

$$= \frac{1}{w(\lambda)^{2}|\mathbf{c}(\lambda)|^{2}}a^{2\operatorname{Re}\lambda-4\rho} \int_{\Lambda_{a}} \int_{N} |\phi_{a}(ny)|^{2}\mathbf{w}_{\lambda,a}(y) \, dn \, dY$$

$$= \frac{1}{w(\lambda)^{2}|\mathbf{c}(\lambda)|^{2}}a^{2\operatorname{Re}\lambda-2\rho} \int_{\Lambda} \int_{N} |\phi_{a}(ny^{a})|^{2}\mathbf{w}_{\lambda,1}(y) \, dn \, dY$$

$$= \frac{1}{w(\lambda)^{2}|\mathbf{c}(\lambda)|^{2}}a^{2\operatorname{Re}\lambda-2\rho} \int_{\Lambda} \int_{N} \left| \int_{N} f(x)\mathbf{a}(y^{-1}a^{-1}n^{-1}x)^{\lambda+\rho} \, dx \right|^{2}\mathbf{w}_{\lambda,1}(y) \, dn \, dY$$

$$= \frac{1}{w(\lambda)^{2}|\mathbf{c}(\lambda)|^{2}}a^{-4\rho} \int_{\Lambda} \int_{N} \left| \int_{N} f(x)\mathbf{a}(y^{-1}a^{-1}n^{-1}xa)^{\lambda+\rho} \, dx \right|^{2}\mathbf{w}_{\lambda,1}(y) \, dn \, dY .$$

Next we consider the function on N

$$\delta_{\lambda,y,a}(n) := \frac{1}{\mathbf{c}(\lambda)} a^{-2\rho} \mathbf{a} (y^{-1} a^{-1} n a)^{\lambda+\rho}$$

and observe that this defines for any fixed $y \in \exp(i\Lambda)$ a Dirac-sequence when $a \in A^-$ moves along a fixed ray to infinity, see (5.15) for $\int_N \delta_{\lambda,a,y} = 1$. We thus

arrive at

$$\frac{1}{w(\lambda)^2 |\mathbf{c}(\lambda)|^2} a^{2\operatorname{Re}\lambda - 4\rho} \|\phi_a\|_{\mathcal{B}_{a,\lambda}}^2 \\
= \frac{1}{w(\lambda)^2} \int_{\Lambda} \int_{N} \left| \int_{N} f(x) \delta_{\lambda,y,a}(n^{-1}x) \ dx \right|^2 \mathbf{w}_{\lambda,\mathbf{1}}(y) dn \ dY .$$

We define a convolution type operator

$$T_{\lambda,y,a}: L^2(N) \to L^2(N), \quad f \mapsto \left(n \mapsto \int_N f(x)\delta_{\lambda,y,a}(n^{-1}x) \ dx\right)$$

and note that by Young's convolution inequality

$$||T_{\lambda,y,a}(f)||_{L^2(N)} \le ||\delta_{\lambda,y,a}||_{L^1(N)} \cdot ||f||_{L^2(N)}$$
.

We continue with some standard estimates:

$$\left| \int_{N} \left| \int_{N} f(x) \delta_{\lambda,y,a}(n^{-1}x) \ dx \right|^{2} dn - \|f\|_{L^{2}(N)}^{2} \right| = \left| \|T_{\lambda,y,a}(f)\|_{L^{2}(N)}^{2} - \|f\|_{L^{2}(N)}^{2} \right|$$

$$= \left| \|T_{\lambda,y,a}\|_{L^{2}(N)} - \|f\|_{L^{2}(N)} \right| \cdot (\|T_{\lambda,y,a}(f)\|_{L^{2}(N)} + \|f\|_{L^{2}(N)})$$

$$\leq \|T_{\lambda,y,a}(f) - f\|_{L^{2}(N)} \cdot \|f\|_{L^{2}(N)} (1 + \|\delta_{\lambda,y,a}\|_{L^{1}(N)})$$

$$= \left\| \int_{N} (f(\cdot x) - f(\cdot)) \delta_{\lambda,y,a}(x) \ dx \right\|_{L^{2}(N)} \cdot \|f\|_{L^{2}(N)} (1 + \|\delta_{\lambda,y,a}\|_{L^{1}(N)})$$

$$\leq \|f\|_{L^{2}(N)} (1 + \|\delta_{\lambda,y,a}\|_{L^{1}(N)}) \int_{N} \|f(\cdot x) - f(\cdot)\|_{L^{2}(N)} |\delta_{\lambda,y,a}(x)| \ dx.$$

Now note that $x \mapsto \|f(\cdot x) - f(\cdot)\|_{L^2(N)}$ is a bounded continuous function and $\frac{|\delta_{\lambda,y,a}|}{\|\delta_{\lambda,y,a}\|_{L^1(N)}}$ is a Dirac-sequence for $a \to \infty$ in A^- on a ray. Hence we obtain a positive function $\kappa_f(a)$ with $\kappa_f(a) \to 0$ for $a \to \infty$ in A^- on a ray such that

$$\int_{N} \|f(\cdot x) - f(\cdot)\|_{L^{2}(N)} |\delta_{\lambda, y, a}(x)| \ dx \le \|\delta_{\lambda, y, a}\|_{L^{1}(N)} \kappa_{f}(a).$$

Putting matters together we have shown that

$$\left| \frac{1}{|\mathbf{c}(\lambda)|^{2}} a^{2\operatorname{Re}\lambda - 4\rho} \|\phi_{a}\|_{\mathcal{B}_{a,\lambda}}^{2} - \left(\int_{\Lambda} \mathbf{w}_{\lambda,\mathbf{1}} \right) \cdot \|f\|_{L^{2}(N)} \right| \\
\leq \kappa_{f}(a) \|f\|_{L^{2}(N)}^{2} \int_{\Lambda} (1 + \|\delta_{\lambda,y,a}\|_{L^{1}(N)}) \|\delta_{\lambda,y,a}\|_{L^{1}(N)} \mathbf{w}_{\lambda,\mathbf{1}}(y) \ dy .$$

Finally observe that $\|\delta_{\lambda,y,a}\|_{L^1(N)} = \|\delta_{\lambda,y}\|_{L^1(N)}$ and hence

$$\int_{\Lambda} (1 + \|\delta_{\lambda,y,a}\|_{L^{1}(N)}) \|\delta_{\lambda,y,a}\|_{L^{1}(N)} \mathbf{w}_{\lambda,\mathbf{1}}(y) \ dy < \infty ,$$

by the defining condition (5.9) for \mathbf{w}_{λ} . With that the proof of the norm limit formula (1.7), i.e. Theorem 1.2, is complete.

6. The real hyperbolic space

In this section we investigate how the main results of this article take shape in the case of real hyperbolic spaces. After recalling the explicit formulas of the Poisson kernel we provide essentially sharp estimates for $\|\delta_{\lambda,y}\|_{L^1(N)}$ which allow us to perform the construction of a family of nice explicit weight functions \mathbf{w}_{λ} satisfying (5.9). These in turn have the property that for real parameters $\lambda = \operatorname{Re} \lambda$ the weighted Bergman space $\mathcal{B}(\Xi_S, \lambda)$ becomes isometric to $L^2(N)$. In particular, the Banach space $\mathcal{B}(\Xi_S, \lambda)$ is in fact a Hilbert space for the exhibited family of weights.

6.1. **Notation.** Our concern is with the real hyperbolic space $\mathbf{H}_n(\mathbb{R}) = G/K$ where $G = \mathrm{SO}_e(n+1,1)$ and $K = \mathrm{SO}(n+1)$ for $n \geq 1$. Here $\mathrm{SO}_e(n+1,1)$ is the identity component of the group $\mathrm{SO}(n+1,1)$. The Iwasawa decomposition G = KAN is given by $N = \mathbb{R}^n$, $K = \mathrm{SO}(n+1)$ and $A = \mathbb{R}_+$ and we can identify $\mathbf{H}_n(\mathbb{R})$ with the upper half-space $\mathbb{R}_+^{n+1} = \mathbb{R}^n \times \mathbb{R}_+$ equipped with the Riemannian metric $g = a^{-2}(|dx|^2 + da^2)$. For any $\lambda \in \mathbb{C}$ which is not a pole of $\Gamma(\lambda + n/2)$ we consider the normalized kernels

$$p_{\lambda}(x,a) = \pi^{-n/2} \frac{\Gamma(\lambda + n/2)}{\Gamma(2\lambda)} a^{\lambda + n/2} (a^2 + |x|^2)^{-(\lambda + n/2)},$$

which play the role of the normalized Poisson kernel when $\mathbf{H}_n(\mathbb{R})$ is identified with the group S = NA, $N = \mathbb{R}^n$, $A = \mathbb{R}_+$. In fact, with $\mathbf{a} : G \to A$ the Iwasawa projection with respect to $G = KA\overline{N}$ as in the main text we record for $x \in N = \mathbb{R}^n$ that

$$\mathbf{a}(x)^{\lambda+\rho} = (1+|x|^2)^{-(\lambda+n/2)}$$
.

Further we have

$$\mathbf{c}(\lambda) = \pi^{n/2} \frac{\Gamma(2\lambda)}{\Gamma(\lambda + n/2)}$$

so that

$$p_{\lambda}(x,a) = \frac{1}{\mathbf{c}(\lambda)} \mathbf{a}(a^{-1}x)^{\lambda+\rho}.$$

In the sequel we assume that $s := \operatorname{Re} \lambda > 0$ and note that $\rho = n/2$.

The classical Poisson transform (normalize (5.1) by $\frac{1}{\mathbf{c}(\lambda)}$) of a function $f \in L^2(\mathbb{R}^n)$ is then given by

$$\mathcal{P}_{\lambda} f(x, a) = f * p_{\lambda}(\cdot, a)$$

$$= \pi^{-n/2} \frac{\Gamma(\lambda + n/2)}{\Gamma(2\lambda)} a^{-(\lambda + n/2)} \int_{\mathbb{R}^n} f(u) (1 + a^{-2}|x - u|^2)^{-\lambda - n/2} du$$

with * the convolution on $N = \mathbb{R}^n$. It is easy to check that $\mathcal{P}_{\lambda} f(x, a)$ is an eigenfunction of the Laplace–Beltrami operator Δ with eigenvalue $\lambda^2 - (n/2)^2$.

From the explicit formula for the Poisson kernel it is clear that for each $a \in A$ fixed, $\mathcal{P}_{\lambda} f(x, a)$ has a holomorphic extension to the tube domain

$$\mathcal{T}_a := \{x + iy \in \mathbb{C}^n \mid |y| < a\} = N \exp(i\Lambda_a) \subset N_{\mathbb{C}} = \mathbb{C}^n,$$

where $\Lambda_a = \{y \in \mathbb{R}^n : |y| < a\}$. Writing $\phi_a(x) = \mathcal{P}_{\lambda} f(x, a)$ as in (5.2) we see that

$$\delta_{\lambda,y}(x) = \frac{1}{\mathbf{c}(\lambda)} (1 + (x+iy)^2)^{-(\lambda+n/2)}.$$

A weight function \mathbf{w}_{λ} satisfying (5.9), namely

$$d(\lambda) = \int_{|y|<1} \mathbf{w}_{\lambda}(y) \|\delta_{\lambda,y}\|_{L^{1}(\mathbb{R}^{n})}^{2} dy < \infty$$

can be easily found. Indeed, as

$$(1+z^2)^{-(n/2+\lambda)} = \frac{2^{-n-\lambda}}{\Gamma(\lambda+n/2)} \int_0^\infty e^{-\frac{1}{4t}(1+z^2)} t^{-n/2-\lambda-1} dt$$

where $z^2 = z_1^2 + z_2^2 + ... + z_n^2$ we have

$$|\delta_{\lambda,y}(x)| \le c_{\lambda} \int_{0}^{\infty} e^{-\frac{1}{4t}(1-|y|^{2}+|x|^{2})} t^{-n/2-s-1} dt$$

valid for |y| < 1. From this it is immediate that we have the estimate

$$\|\delta_{\lambda,y}\|_{L^1(\mathbb{R}^n)} \le c_{\lambda}(1-|y|^2)_+^{-s}$$
.

However this bound is not optimal and we can do better with slightly more effort. This will be part of the next subsection.

6.2. Bounding $\|\delta_{\lambda,y}\|_{L^1(\mathbb{R}^n)}$ and special weights.

Lemma 6.1. For $s = \text{Re } \lambda > 0$ we have for a constant $C = C(\lambda, n) > 0$ that

$$\|\delta_{\lambda,y}\|_{L^{1}(\mathbb{R}^{n})} \simeq \begin{cases} C & \text{if } 0 < s < \frac{1}{2}, \\ C|\log(1 - |y|^{2})_{+}| & \text{if } s = \frac{1}{2}, \\ C(1 - |y|^{2})_{+}^{-s + \frac{1}{2}} & \text{if } s > \frac{1}{2}, \end{cases}$$
 (|y| < 1).

Proof. To begin with we have

$$\|\delta_{\lambda,y}\|_{L^{1}(\mathbb{R}^{n})} \approx \int_{\mathbb{R}^{n}} |1 + (x + iy)^{2}|^{-(n/2+s)} dx$$
$$\approx \int_{\mathbb{R}^{n}} (1 - |y|^{2} + |x|^{2} + 2|\langle x, y \rangle|)^{-(n/2+s)} dx.$$

With $\gamma = \sqrt{1 - |y|^2}$ we find

$$\|\delta_{\lambda,y}\|_{L^{1}(\mathbb{R}^{n})} \approx \int_{\mathbb{R}^{n}} (\gamma^{2} + |x|^{2} + 2|\langle x, y \rangle|)^{-(n/2+s)} dx$$

$$= \int_{\mathbb{R}^{n}} (\gamma^{2} + \gamma^{2}|x|^{2} + 2\gamma|\langle x, y \rangle|)^{-(n/2+s)} \gamma^{n} dx$$

$$= \gamma^{-2s} \int_{\mathbb{R}^{n}} (1 + |x|^{2} + 2|\langle x, \gamma^{-1} y \rangle|)^{-(n/2+s)} dx .$$

Set

$$I_n(s,\gamma) := \int_{\mathbb{R}^n} (1+|x|^2+2|\langle x,\gamma^{-1}y\rangle|)^{-(n/2+s)} dx.$$

Then it remains to show that

$$I_n(s,\gamma) \approx \begin{cases} \gamma^{2s} & \text{if } 0 < s < \frac{1}{2}, \\ \gamma |\log \gamma| & \text{if } s = \frac{1}{2}, \\ \gamma & \text{if } s > \frac{1}{2} \end{cases}$$
 (6.1)

We first reduce the assertion to the case n = 1 and assume $n \ge 2$. By rotational symmetry we may assume that $y = y_1e_1$ is a multiple of the first unit vector with $1/2 < y_1 < 1$. Further we write $x = (x_1, x')$ with $x' \in \mathbb{R}^{n-1}$. Introducing polar coordinates r = |x'|, we find

$$I_n(s,\gamma) = \int_{\mathbb{R}^n} (1+|x'|^2 + x_1^2 + 2\gamma^{-1}|x_1|y_1)^{-(n/2+s)} dx$$
$$\approx \int_0^\infty \int_0^\infty r^{n-2} (1+r^2 + x_1^2 + 2\gamma^{-1}x_1y_1)^{-(n/2+s)} dx_1 dr.$$

With $a^2 := 1 + x_1^2 + 2x_1y_1\gamma^{-1}$ this rewrites as

$$I_n(s,\gamma) \simeq \int_0^\infty \int_0^\infty r^{n-2} (r^2 + a^2)^{-(n/2+s)} dr dx_1$$

and with the change of variable r = at we arrive at a splitting of integrals

$$I_n(s,\gamma) \approx \int_0^\infty \int_0^\infty t^{n-2} (1+t^2)^{-\frac{n}{2}-s} a^{-n-2s} a^{n-2} a \ dt \ dx_1$$

$$= \underbrace{\left(\int_0^\infty t^{n-2} (1+t^2)^{-\frac{n}{2}-s} \ dt\right)}_{:=J_n(s)} \cdot \underbrace{\left(\int_0^\infty (1+x_1^2+2\gamma^{-1}x_1y_1)^{-s-\frac{1}{2}} \ dx_1\right)}_{=J_1(s,\gamma)}$$

Now $J_n(s)$ remains finite as long as $n \ge 2$ and s > 0. Thus we have reduced the situation to the case of n = 1 which we finally address.

It is easy to check that $I_1(s,\gamma) \simeq \gamma^{2s}$ for 0 < s < 1/2 and $I_1(s,\gamma) \simeq \gamma$ for s > 1/2. When s = 1/2 we can evaluate $\gamma^{-1}I_1(1/2,\gamma)$ explicitly. Indeed, by a simple computation we see that $\gamma^{-1}I_1(1/2,\gamma)$ is given by

$$2\int_0^\infty \frac{1}{(x_1+y_1)^2 - (y_1^2 - \gamma^2)} dx_1 = \frac{-1}{\sqrt{y_1^2 - \gamma^2}} \log \frac{y_1 - \sqrt{y_1^2 - \gamma^2}}{y_1 + \sqrt{y_1^2 - \gamma^2}}.$$

This gives the claimed estimate.

For $\alpha > 0$ we now define special weight functions by

$$\mathbf{w}_{\lambda}^{\alpha}(z) = (2\pi)^{-n/2} \frac{1}{\Gamma(\alpha)} \left(1 - |y|^2 \right)_{+}^{\alpha - 1} \qquad (z = x + iy \in \mathcal{T}). \tag{6.2}$$

As a consequence of Lemma 6.1 we obtain

Corollary 6.2. The weight $\mathbf{w}_{\lambda}^{\alpha}$ satisfies the integrability condition (5.9) precisely for

$$\alpha > \max\{2s - 1, 0\}.$$

Remark 6.3. Observe that $\mathbf{w}_{\lambda}^{\alpha}(z)$ is a power of the Iwasawa projection $\mathbf{a}(y)$. It would be interesting to explore this further in higher rank, i.e. whether one can find suitable weights which are of the form

$$\mathbf{w}_{\lambda}(ny) = |\mathbf{a}(y)^{\alpha}| \qquad (ny \in \mathcal{T})$$

for some $\alpha = \alpha(\lambda) \in \mathfrak{a}^*$.

For later reference we also record the explicit expression

$$\mathbf{w}_{\lambda,a}^{\alpha}(z) = (2\pi)^{-n/2} \frac{1}{\Gamma(\alpha)} \left(1 - \frac{|y|^2}{a^2} \right)_{+}^{\alpha - 1}$$
(6.3)

for the rescaled weights.

In the next subsection we will show that the general integrability condition for the weight function (5.9) is sufficient, but not sharp. By a direct use of the Plancherel theorem for the Fourier transform on \mathbb{R}^n we will show that one can do better for $\mathbf{H}_n(\mathbb{R})$.

6.3. Isometric identities. Let K_{λ} be the Macdonald Bessel function and $I_{\alpha+n/2}$ be the Bessel function of first kind with $\alpha > 0$. For $s := \operatorname{Re} \lambda > 0$, we define non-negative weight functions

$$w_{\lambda}^{\alpha}(\xi) := |\xi|^{2s} |K_{\lambda}(|\xi|)|^{2} \frac{I_{\alpha+n/2-1}(2|\xi|)}{(2|\xi|)^{\alpha+n/2-1}} \qquad (\xi \in \mathbb{R}^{n}).$$
 (6.4)

Theorem 6.4. Let $\alpha > 0, \lambda \in \mathbb{C}$, and $s = \operatorname{Re} \lambda > 0$. There exists an explicit constant $c_{n,\alpha,\lambda} > 0$ such that for all $f \in L^2(\mathbb{R}^n)$ and $\phi_a = \mathcal{P}_{\lambda} f(\cdot, a)$ we have the identity

$$\int_{\mathcal{T}_a} |\phi_a(z)|^2 \mathbf{w}_{\lambda,a}^{\alpha}(z) dz = c_{n,\alpha,\lambda} a^{-2s+2n} \int_{\mathbb{R}^n} |\widehat{f}(\xi)|^2 w_{\lambda}^{\alpha}(a\xi) d\xi \qquad (a > 0) \qquad (6.5)$$

where $\mathbf{w}_{\lambda}^{\alpha}$ is as in (6.2).

Proof. Let us set

$$\varphi_{\lambda,a}(x) = \pi^{-n/2} \frac{\Gamma(\lambda + n/2)}{\Gamma(2\lambda)} (a^2 + |x|^2)^{-(\lambda + n/2)}$$

so that we can write $\phi_a(z) = \mathcal{P}_{\lambda} f(z, a) = a^{\lambda + n/2} f * \varphi_{\lambda, a}(z)$. In view of the Plancherel theorem for the Fourier transform we have

$$\int_{\mathbb{R}^n} |\phi_a(x+iy)|^2 dx = a^{2s+n} \int_{\mathbb{R}^n} e^{-2y\cdot\xi} |\widehat{f}(\xi)|^2 |\widehat{\varphi}_{\lambda,a}(\xi)|^2 d\xi.$$

Integrating both sides of the above against the weight function $\mathbf{w}_{\lambda,a}^{\alpha}(z)$ we obtain the identity

$$\int_{\mathcal{T}_a} |\phi_a(z)|^2 \mathbf{w}_{\lambda,a}^{\alpha}(z) dz = a^{2s+n} \int_{\mathbb{R}^n} |\widehat{f}(\xi)|^2 v_a^{\alpha}(\xi) |\widehat{\varphi}_{\lambda,a}(\xi)|^2 d\xi$$
 (6.6)

where $v_a^{\alpha}(\xi)$ is the function defined by

$$v_a^{\alpha}(\xi) = (2\pi)^{-n/2} \frac{1}{\Gamma(\alpha)} \int_{|y| < a} e^{-2y \cdot \xi} \left(1 - \frac{|y|^2}{a^2} \right)_+^{\alpha - 1} dy.$$

Both functions $v_a^{\alpha}(\xi)$ and $\widehat{\varphi}_{\lambda,a}(\xi)$ can be evaluated explicitly in terms of Bessel and Macdonald functions. We begin with v_a^{α} and recall that the Fourier transform of $(1-|y|^2)_+^{\alpha-1}$ is explicitly known in terms of *J*-Bessel functions (see [5, Ch. II, §2.5]):

$$(2\pi)^{-n/2} \int_{\mathbb{R}^n} (1-|y|^2)_+^{\alpha-1} e^{-iy\cdot\xi} dy = \Gamma(\alpha) 2^{\alpha-1} |\xi|^{-\alpha-n/2+1} J_{\alpha+n/2-1}(|\xi|).$$

As the J-Bessel functions analytically extend to the imaginary axis, it follows that

$$(2\pi)^{-n/2} a^{-n} \int_{\mathbb{R}^n} \left(1 - \frac{|y|^2}{a^2} \right)_+^{\alpha - 1} e^{-2y \cdot \xi} dy = \Gamma(\alpha) 2^{\alpha - 1} \left(2a|\xi| \right)^{-\alpha - n/2 + 1} I_{\alpha + n/2 - 1}(2a|\xi|)$$
(6.7)

where $I_{\alpha+n/2-1}$ is the modified Bessel function of first kind. We arrive at

$$v_a^{\alpha}(\xi) = 2^{\alpha - 1} a^n (2a|\xi|)^{-\alpha - n/2 + 1} I_{\alpha + n/2 - 1}(2a|\xi|).$$
(6.8)

Moving on to $\widehat{\varphi}_{\lambda,a}(\xi)$ we use the integral representation

$$\varphi_{\lambda,a}(x) = \frac{(4\pi)^{-n/2} 2^{-2\lambda}}{\Gamma(2\lambda)} \int_0^\infty e^{-\frac{1}{4t}(a^2 + |x|^2)} t^{-n/2 - \lambda - 1} dt$$

and calculate the Fourier transform as

$$\widehat{\varphi}_{\lambda,a}(\xi) = \frac{(2\pi)^{-n/2} 2^{-2\lambda}}{\Gamma(2\lambda)} \int_0^\infty e^{-\frac{1}{4t}a^2} e^{-t|\xi|^2} t^{-\lambda-1} dt.$$

The Macdonald function of type ν is given by the integral representation

$$r^{\nu}K_{\nu}(r) = 2^{\nu-1} \int_{0}^{\infty} e^{-t - \frac{r^2}{4t}} t^{\nu-1} dt,$$

for any r > 0. In terms of this function we have

$$\widehat{\varphi}_{\lambda,a}(\xi) = \frac{(2\pi)^{-n/2} 2^{1-\lambda}}{\Gamma(2\lambda)} a^{-2\lambda} (a|\xi|)^{\lambda} K_{\lambda}(a|\xi|). \tag{6.9}$$

Using these explicit formulas we obtain from (6.6) that

$$\int_{\mathcal{T}_a} |\phi_a(z)|^2 \mathbf{w}_{\lambda,a}^{\alpha}(z) dz = c_{n,\alpha,\lambda} a^{-2s+2n} \int_{\mathbb{R}^n} |\widehat{f}(\xi)|^2 w_{\lambda}^{\alpha}(a\xi) d\xi$$

for an explicit constant $c_{n,\alpha,\lambda}$ and

$$w_{\lambda}^{\alpha}(\xi) = |\xi|^{2s} |K_{\lambda}(|\xi|)|^{2} \frac{I_{\alpha+n/2-1}(2|\xi|)}{(2|\xi|)^{\alpha+n/2-1}},$$

by
$$(6.8)$$
 and (6.9) .

In the sequel we write $\mathcal{B}_{\alpha}(\Xi_S, \lambda)$ to indicate the dependence on $\alpha > 0$. Now we are ready to state the main theorem of this section:

Theorem 6.5. For $\alpha > \max\{2s - \frac{n+1}{2}, 0\}$ the Poisson transform establishes an isomorphism of Banach spaces

$$\mathcal{P}_{\lambda}: L^2(N) \to \mathcal{B}_{\alpha}(\Xi_S, \lambda)$$
.

If moreover $\lambda = s$ is real, then \mathcal{P}_{λ} is an isometry up to positive scalar.

Proof. The behaviour of $w_s^{\alpha}(\xi)$ can be read out from the well known asymptotic properties of the functions K_{ν} and I_{α} . Indeed we can show (see Proposition 6.6 below) that there exists $c_1, c_2 > 0$ such that

$$c_1 (1 + |\xi|)^{-(\alpha + \frac{n+1}{2} - 2s)} \le w_{\lambda}^{\alpha}(\xi) \le c_2 (1 + |\xi|)^{-(\alpha + \frac{n+1}{2} - 2s)} \qquad (\xi \in \mathbb{R}^n).$$

When $2s > \frac{n+1}{2}$, we can choose $\alpha = (2s - \frac{n+1}{2}) > 0$ in Theorem 6.4 above. With this choice, note that $w_{\lambda}^{\alpha}(\xi) \leq c_3$ and consequently we have

$$\int_{\mathcal{T}_a} |\phi_a(z)|^2 \mathbf{w}_{\lambda,a}^{\alpha}(z) dz \le c_{n,\alpha,\lambda} a^{-2s+2n} \int_{\mathbb{R}^n} |\widehat{f}(x)|^2 dx.$$

This inequality implies that \mathcal{P}_{λ} is defined. The surjectivity follows as in the proof of Theorem 1.1 and with that the first assertion is established. The second part is a consequence of Theorem 6.4 and the stated monotonicity in Proposition 6.6. \square

Proposition 6.6. Let $\lambda = s > 0$ be real and $\alpha > \max\{2s - \frac{n+1}{2}, 0\}$. Then $w_s^{\alpha}(r), r > 0$, is positive and monotonically decreasing. Moreover, $w_s^{\alpha}(0) = 2^{-\alpha - \frac{n}{2} - 2s - 1} \frac{\Gamma(s)^2}{\Gamma(\alpha + \frac{n}{2})}$ and $w_s^{\alpha}(r) \sim c_{\alpha} r^{-(\alpha + \frac{n+1}{2} - 2s)}$ for $r \to \infty$.

Proof. From the definition, we have

$$w_s^{\alpha}(r) = r^{2s} K_s(r)^2 \frac{I_{\alpha+n/2-1}(2r)}{(2r)^{\alpha+n/2-1}}.$$

Evaluating $r^s K_s(r)$ and $\frac{I_{\alpha+n/2-1}(2r)}{(2r)^{\alpha+n/2-1}}$ at r=0 by making use of the limiting forms close to zero (see [17, 10.30]) we obtain $w_s^{\alpha}(0) = 2^{-\alpha-\frac{n}{2}-2s-1} \frac{\Gamma(s)^2}{\Gamma(\alpha+\frac{n}{2})}$ as claimed in the proposition. The well known asymptotic properties of $K_s(r)$ and $I_{\beta}(r)$, see [17, 10.40], proves the other claim. It therefore remains to show that $w_s^{\alpha}(r)$ is monotonically decreasing, which will follow once we show that the derivative of $w_s^{\alpha}(r)$ is negative at any r > 0.

Making use of the well known relations

$$\frac{d}{dr}(r^s K_s(r)) = -r^s K_{s-1}(r), \qquad \frac{d}{dr}(\frac{I_{\beta}(r)}{r^{\beta}}) = \frac{I_{\beta+1}(r)}{r^{\beta}}$$

a simple calculation shows that

$$\frac{d}{dr}(w_s^{\alpha}(r)) = 2r^{2s}K_s(r)(2r)^{-(\alpha+n/2-1)}F(r)$$

where $F(r) = \left(K_s(r)I_{\alpha+n/2}(2r) - K_{s-1}(r)I_{\alpha+n/2-1}(2r)\right)$. Thus we only need to check that F(r) < 0 or equivalently

$$\frac{I_{\alpha+n/2}(2r)}{I_{\alpha+n/2-1}(2r)} < \frac{K_{s-1}(r)}{K_s(r)}.$$

In order to verify this we make use of the following inequality proved by J. Segura [19, Theorem 1.1]: for any $\nu \geq 0$ and r > 0 one has

$$\frac{I_{\nu+1/2}(r)}{I_{\nu-1/2}(r)} < \frac{r}{\nu + \sqrt{\nu^2 + r^2}} \le \frac{K_{\nu-1/2}(r)}{K_{\nu+1/2}(r)}.$$

Replacing r by 2r in the first inequality, from the above we deduce that

$$\frac{I_{\nu+1/2}(2r)}{I_{\nu-1/2}(2r)} < \frac{r}{\nu/2 + \sqrt{\nu^2/4 + r^2}} \le \frac{K_{(\nu-1)/2}(r)}{K_{(\nu+1)/2}(r)}.$$

In the above we choose $\nu = 2s - 1$ so that $(\nu - 1)/2 = s - 1$ and $(\nu + 1)/2 = s$. With $\beta = \alpha + (n-1)/2$ we have

$$\frac{I_{\beta+1/2}(2r)}{I_{\beta-1/2}(2r)} < \frac{r}{\beta/2 + \sqrt{\beta^2/4 + r^2}} < \frac{r}{\nu/2 + \sqrt{\nu^2/4 + r^2}} \le \frac{K_{(\nu-1)/2}(r)}{K_{(\nu+1)/2}(r)}$$

provided $\beta > \nu$, i.e. $\alpha + (n-1)/2 > 2s-1$ which is precisely the condition on α in the statement of the proposition.

7. Remarks on the extension problem

We recall that given a function $f \in L^2(N)$ the Poisson transform $\phi = \mathcal{P}_{\lambda}(f)$ for $\text{Re } \lambda > 0$, viewed as a function on S, gives us a solution

$$\Delta_S \phi = (\lambda^2 - \rho^2) \phi$$

such that we can retrieve f through the boundary value map

$$b_{\lambda}(f)(n) = \mathbf{c}(\lambda)^{-1} \lim_{\substack{a \to \infty \\ a \in A^{-}}} a^{\lambda - \rho} \phi(na).$$

We normalize \mathcal{P}_{λ} in the sequel by $\frac{1}{\mathbf{c}(\lambda)}\mathcal{P}_{\lambda}$ and replace ϕ by $\psi(na) = a^{\lambda-\rho}\phi(na)$. Hence it is natural to ask about the differential equation which ψ satisfies. To begin with we first derive a formula for Δ_S in $N \times A$ -coordinates. Note that Δ_Z on Z = G/K descends from the Casimir operator \mathcal{C} on right K-invariant functions on G and so we start with \mathcal{C} . We assume that G is semisimple and let $\kappa: \mathfrak{g} \times \mathfrak{g} \to \mathbb{R}$ be the Cartan–Killing form. For an orthonormal basis H_1, \ldots, H_n of \mathfrak{a} with respect to $\kappa|_{\mathfrak{a}\times\mathfrak{a}}$ we form the operator $\Delta_A = \sum_{j=1}^n H_j^2$ viewed as a left G-invariant differential operator on G. Likewise we define Δ_M with respect to an orthonormal basis of \mathfrak{m} with respect to $-\kappa|_{\mathfrak{m}\times\mathfrak{m}}$. Now for each root space \mathfrak{g}^{α} , $\alpha \in \Sigma^+$ we choose a basis E_{α}^j , $1 \leq j \leq m_{\alpha} = \dim \mathfrak{g}^{\alpha}$, such that with $F_{\alpha}^j := -\theta(E_{\alpha}^j) \in \mathfrak{g}^{-\alpha}$ we have $\kappa(E_{\alpha}^j, F_{\alpha}^k) = \delta_{jk}$. Having said all that we obtain

$$C = \Delta_A - \Delta_M + \sum_{\alpha > 0} \sum_{j=1}^{m_\alpha} E_\alpha^j F_\alpha^j + F_\alpha^j E_\alpha^j.$$

Now $\kappa|_{\mathfrak{a}\times\mathfrak{a}}$ complex linearly extended identifies $\mathfrak{a}_{\mathbb{C}}$ with $\mathfrak{a}_{\mathbb{C}}^*$ and for $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$ we let $H_{\lambda} \in \mathfrak{a}_{\mathbb{C}}$ such that $\lambda = \kappa(\cdot, H_{\lambda})$. We further recall that $[E_{\alpha}^j, F_{\alpha}^j] = H_{\alpha}$. Thus we can rewrite \mathcal{C} as

$$C = \Delta_A - H_{2\rho} + \Delta_M + \sum_{\alpha > 0} \sum_{j=1}^{m_\alpha} 2E_\alpha^j F_\alpha^j.$$

Now note that $2E_{\alpha}^{j}F_{\alpha}^{j}=2E_{\alpha}^{j}E_{\alpha}^{j}+2E_{\alpha}^{j}(F_{\alpha}^{j}-E_{\alpha}^{j})$ with $F_{\alpha}^{j}-E_{\alpha}^{j}\in\mathfrak{k}$. Therefore \mathcal{C} descends on right K-invariant smooth functions on G to the operator

$$\Delta_Z = \Delta_A - H_{2\rho} + \sum_{\alpha > 0} \sum_{j=1}^{m_\alpha} 2E_\alpha^j E_\alpha^j.$$

Now if we identify Z = G/K with $N \times A$ then we see that that a point (n, a) the operator Δ_S is given in the separated form

$$\Delta_S = \Delta_A - H_{2\rho} + \underbrace{\sum_{\alpha>0} \sum_{j=1}^{m_\alpha} 2a^{2\alpha} E_\alpha^j E_\alpha^j}_{=:\Delta_N^a}$$

with Δ_N^a acting on the right of N. Hence

$$\Delta_S = \Delta_A - H_{2\rho} + \Delta_N^a.$$

Let now $\phi = \phi(n, a)$ be an eigenfunction of Δ_S to parameter $\lambda \in \mathfrak{a}_{\mathbb{C}}^*$, say

$$\Delta_S \phi = (\lambda^2 - \rho^2) \phi$$
.

We think of $\phi = \mathcal{P}_{\lambda}(f)$ for some generalized function f on N so that we can retrieve f from ϕ via the boundary value map (4.2). As motivated above we replace ϕ by $\psi(n,a) = a^{\lambda-\rho}\phi(n,a)$ and see what differential equation ψ satisfies. Since $\phi = a^{\rho-\lambda}\psi$ we have

$$(\Delta_A - H_{2\rho})a^{\rho-\lambda}\psi = a^{\rho-\lambda}(\lambda^2 - \rho^2 + \Delta_A - H_{2\rho} + \underbrace{2H_{\rho-\lambda}}_{=H_{2\rho}-H_{2\lambda}})\psi.$$

This means that ψ satisfies the differential equation

$$(\Delta_A - H_{2\lambda} + \Delta_N^a)\psi(n, a) = 0. (7.1)$$

If we assume now that $\operatorname{Re} \lambda > 0$ and $\phi = \mathcal{P}_{\lambda} f$, then we have

$$\lim_{\substack{a \to \infty \\ a \in A^{-}}} \psi(n, a) = f(n) \tag{7.2}$$

The pair of equations (7.1) and (7.2) we refer to is the extension problem with parameter λ for the operator Δ_S . Given f it has a unique solution provided Δ_S generates all of $\mathbb{D}(Z)$, that is, the real rank of G is one.

It is instructive to see what it is classically for the real hyperbolic spaces with $N = \mathbb{R}^n$. Here we use the classical (i.e. normalized Poisson transform) and the extension problem becomes, for $(x,t) \in \mathbb{R}^n \times \mathbb{R}_{>0}$ (we use the notation from the previous section),

$$\left(\partial_t^2 + \frac{1 - \lambda/2}{t} \partial_t + \Delta_{\mathbb{R}^n}\right) \psi(x, t) = 0 \qquad (x \in \mathbb{R}^n, t > 0)$$
 (7.3)

If we assume now that $\operatorname{Re} \lambda > 0$ and $\phi = \mathcal{P}_{\lambda} f$, then we have

$$\lim_{t \to 0} \psi(x, t) = f(x). \tag{7.4}$$

The general theory then tells us that there is a unique solution ψ of the extension problem (7.3) and (7.4) considered by Caffarelli and Silvestre in [3].
