ON SHARP ISOPERIMETRIC INEQUALITIES ON THE HYPERCUBE

ABSTRACT. We prove the sharp isoperimetric inequality

$$\mathbb{E} h_A^{\log_2(3/2)} \ge \mu(A)^* (\log_2(1/\mu(A)^*))^{\log_2(3/2)}$$

for all sets $A \subseteq \{0,1\}^n$, where μ denotes the uniform probability measure, $\mu(A)^* = \min\{\mu(A), 1 - \mu(A)\}, h_A$ is supported on A and to each vertex x assigns the number of neighbour vertices in the complement of A. The inequality becomes equality for any subcube. Moreover, we provide lower bounds on $\mathbb{E}h_A^\beta$ in terms of $\mu(A)$ for all $\beta \in [1/2, 1]$, improving, and in some cases tightening, previously known results. In particular, we obtain the sharp inequality $\mathbb{E}h_A^{0.53} \ge 2\mu(A)(1-\mu(A))$ for all sets with $\mu(A) \ge 1/2$, which allows us to refine a recent result of Kahn and Park on isoperimetric inequalities about partitioning the hypercube. Furthermore, we derive Talagrand's isoperimetric inequalities for functions with values in a Banach space having finite cotype: for all $f: \{-1,1\}^n \to X$, $\|f\|_{\infty} \le 1$, and any $p \in [1,2]$ we have

$$\|Df\|_p \gtrsim \frac{1}{q^{3/2}C_q(X)} \|f\|_2^{2/p} \left(\log \frac{e\|f\|_2}{\|f\|_1}\right)^{1/q}$$

where $\|Df\|_p^p = \mathbb{E}\|\sum_{1 \le j \le n} x'_j D_j f(x)\|^p$, x' is independent copy of x, and $C_q(X)$ is the cotype q constant of X. Different proofs of the recently resolved Talagrand's conjecture will be presented.

1. INTRODUCTION

Let $n \ge 1$ be an integer and $\{0,1\}^n$ be the hypercube of dimension n. One can regard $\{0,1\}^n$ as a graph where two vertices $x, y \in \{0,1\}^n$ are joined by an edge if the vectors $x = (x_1, \ldots, x_n)$ and $y = (y_1, \ldots, y_n)$ differ in exactly one coordinate. We denote such an edge by (x, y). The goal of this article is to prove several sharp isoperimetric inequalities for subsets of $\{0, 1\}^n$.

1.1. **One sided boundary.** Let $A \subset \{0,1\}^n$ and $A^c := \{0,1\}^n \setminus A$. Define the edge boundary of A by $\nabla A := \{(x,y) : x \in A, y \in A^c\}$. Associated to ∇A , we define the function $h_A : \{0,1\}^n \to \mathbb{R}$ by $h_A(x) = 0$ if $x \in A^c$, and if $x \in A$ we let $h_A(x)$ be the number of edges joining x with a vertex in A^c . Let μ be the uniform probability measure on $\{0,1\}^n$ and let \mathbb{E} denote the expectation operator. One of the goals of this paper is to investigate the quantity

$$B(t,\beta,n) = \min_{A \subset \{0,1\}^n, \mu(A)=t} \mathbb{E} h_A^\beta, \tag{1.1}$$

for any $\beta > 0$, $t \in [0, 1]$, $n \ge 1$; note that for fixed $n \ge 1$, the admissible values for $t \in [0, 1]$ are of the form $t = m/2^n$ for all integers $0 \le m \le 2^n$.

When $\beta = 1$, the quantity $\mathbb{E}h_A$ has an additional structure, i.e., $\mathbb{E}h_A = \mathbb{E}h_{A^c}$, and we have $\mathbb{E}h_A = \frac{|\nabla A|}{2^n}$, where $|\cdot|$ denotes the cardinality of a set. In this case, it is known [5] that

$$B(t,1,n) = nt - \frac{1}{2^{n-1}} \sum_{j=1}^{2^n t-1} s(j), \qquad (1.2)$$

where s(j) denotes the sum of ones in the binary representation of the integer j. The minimum in (1.1) is achieved on the set A, with $\mu(A) = t$, consisting of those vertices $x = (x_1, \ldots, x_n) \in \{0, 1\}^n$ such that $\sum_{j=1}^n 2^{j-1}x_j = \ell$, for each $\ell = 1, 2, \ldots, t2^n$. The corresponding edge isoperimetric inequality derived from (1.2) has applications in game theory [5], distributed algorithms, communication complexity and network science (see [13] and references therein).

Despite the optimality of the function B(t, 1, n), it is often more convenient to use the lower bound

$$\mathbb{E}h_A \ge \mu(A)^* \log_2\left(\frac{1}{\mu(A)^*}\right),\tag{1.3}$$

where $t^* = \min\{t, 1 - t\}$ for all $t \in [0, 1]$. This is commonly known as the classical isoperimetric inequality on the hypercube. An advantage of the inequality $B(t, 1, n) \ge t^* \log_2(1/t^*)$ is that a) the right-hand side is independent of n; b) it becomes an equality¹ at the points $t = 2^{-k}$ for $0 \le k \le n$. In this case $(\beta = 1, t = 2^{-k})$, the minimum in (1.1) is achieved on subcubes of co-dimension k, for any $0 \le k \le n$. In what follows we will be interested in $\inf_{n\ge 1} B(t, \beta, n)$.

By considering hamming balls $\{x_1 + \ldots + x_n \leq \lfloor n/2 \rfloor\}$ in (1.1) one can see that

if
$$\beta < 1/2$$
 then $\inf_{n \ge 1} B(t, \beta, n) = 0;$ (1.4)

see Section 3. On the other hand, by considering subcubes in (1.1) it follows that

$$t(\log_2(1/t))^{\beta} \ge \inf_{n\ge 1} B(t,\beta,n)$$
 at the points $t = 2^{-k}, k = 0, 1, 2, \dots$ (1.5)

A straightforward application of the Hölder inequality in (1.3) implies

$$\mathbb{E}h_A^\beta \ge \mu(A) \Big(\log_2 \Big(\frac{1}{\mu(A)} \Big) \Big)^\beta$$
 for all $\beta \ge 1$,

and combining this with (1.5) establishes $\inf_{n\geq 1} B(t,\beta,n) = t(\log_2(1/t))^{\beta}$ at $t = 2^{-k}$ for all $k \geq 0$ and all $\beta \geq 1$. From now on, we will be concerned with $1/2 \leq \beta < 1$.

The case $\beta = 1/2$ was first considered by Talagrand in [14]. By an inductive argument, he proved the reverse inequality to (1.5) up to a universal constant K > 1, namely

$$\mathbb{E}\sqrt{h_A} \ge K\mu(A)^*\sqrt{\log_2(1/\mu(A)^*)} \tag{1.6}$$

for all $A \subseteq \{0,1\}^n$. Furthermore, he also proved that

$$\mathbb{E}\sqrt{h_A} \ge \sqrt{2}\mu(A)(1-\mu(A)) \tag{1.7}$$

holds for all $A \subset \{0,1\}^n$. Bobkov and Götze [1] came up with an improved and elegant inductive argument and, in particular, one of their results implies that $\sqrt{2}$ can be replaced by $\sqrt{3}$ in (1.7). Recently, Kahn and Park [10] showed that

$$\mathbb{E}h_A^{\log_2(3/2)} \ge 2\mu(A)(1-\mu(A)), \tag{1.8}$$

and the constant 2 in the right-hand side of (1.8) is sharp: the inequality becomes an equality for subcubes of co-dimension 1 and 2. In fact, for any given $\beta \ge 1/2$, the largest possible constant C_{β} in an inequality of the form $\mathbb{E}h_A^{\beta} \ge C_{\beta}\mu(A)(1-\mu(A))$ for all $A \subseteq \{0,1\}^n$ is $C_{\beta} \le 2$; this follows from testing the inequality on a half cube. Furthermore, by considering subcubes of co-dimension 2, the constant $C_{\beta} = 2$ is only possible if $\beta \ge \log_2(3/2)$.

In this paper we prove a theorem which, in particular, reverses the inequality (1.5) for all $\beta \ge \log_2(3/2) = 0.5849...$ and therefore gives the value for $\inf_{n\ge 1} B(t,\beta,n)$ for that range of β whenever $t = 2^{-k}$, $k \ge 0$.

for that range of p whenever $t = 2^{-k}, k \ge 0$.

Theorem 1.1. Let $\beta_0 := \log_2(3/2)$. Then the inequality

$$\mathbb{E}h_A^{\beta_0} \ge \mu(A)^* (\log_2(1/\mu(A)^*))^{\beta_0} \tag{1.9}$$

holds for all $A \subset \{0,1\}^n$. In particular, if $\mu(A) \leq 1/2$ we have

$$\mathbb{E}h_{A}^{\beta} \ge \mu(A)(\log_{2}(1/\mu(A)))^{\beta} \quad \text{for all} \quad \beta \ge \log_{2}(3/2).$$
(1.10)

The equality holds in both (1.9) and (1.10) for any subcube $A \subset \{0,1\}^n$.

Note that the above theorem is a tight version of (1.8) on all subcubes. The comparison between the inequalities (1.8) and (1.9) is that the function 2t(1-t) is larger or equal than $t^*(\log_2(1/t^*))^{\beta_0}$ on [1/4, 3/4], whereas the second function is larger or equal than the first one in the complementary range. In general, a similar phenomenon happens when comparing 2t(1-t) and $t^*(\log_2(1/t^*))^{\beta}$ for other values of $1/2 \leq \beta \leq 1$: the second one is significantly larger in neighborhoods of t = 0 and t = 1 and, moreover, it satisfies (1.5). It is an interesting question to understand whether the inequality (1.9) holds for all $\beta_0 \geq 1/2$.

Let $\partial A = \operatorname{supp}(h_A) \subset A$ be the vertex boundary of A. An application of the Hölder inequality $\mathbb{E}h_A^\beta \leq (\mathbb{E}h_A^{\beta/\alpha})^{\alpha} \mu(\partial A)^{1-\alpha}$ for all $\alpha \in [0, 1]$ implies the following corollary, which sharpens the classical isoperimetric inequality (1.3).

Corollary 1.2. For $\gamma = \frac{1}{\log_2(3/2)} - 1 = 0.709...$, and any $A \subset \{0, 1\}^n$ with $\mu(A) \le 1/2$ we have

$$\mathbb{E}h_A \ge \left(\frac{\mu(A)}{\mu(\partial A)}\right)^{\gamma} \mu(A) \log_2\left(\frac{1}{\mu(A)}\right). \tag{1.11}$$

Moreover, the equality holds for any subcube.

The constant $\sqrt{3}$ in Bobkov's inequality $\mathbb{E}\sqrt{h_A} \ge \sqrt{3}\mu(A)(1-\mu(A))$ is not sharp. We obtain the following improvement.

Theorem 1.3. For any $\beta \in [1/2, \log_2(3/2)]$ we have

$$\mathbb{E}h_A^\beta \ge C_\beta \,\mu(A)(1-\mu(A)) \tag{1.12}$$

for all $A \subset \{0,1\}^n$, where $C_{\beta} = 2\sqrt{2^{\beta+1}-2}$.

The theorem applied to the case $\beta = 1/2$ gives the improved constant $C_{1/2} = 1.82... > \sqrt{3} = 1.73...$ Testing the inequality $\mathbb{E}h_A^\beta \ge C_\beta \mu(A)(1-\mu(A))$ on subcubes of co-dimension 2, we obtain the upper bound $C_\beta \le 2^{\beta+2}/3$ for $1/2 \le \beta \le \log_2(3/2)$. For $\beta = \log_2(3/2)$ the inequality (1.12) coincides with (1.8).

1.2. Separating the cube. If one considers sets $A \subset \{0,1\}^n$ with measure $\mu(A) \ge 1/2$, it is conceivable that $\mathbb{E}h_A^\beta \ge 2\mu(A)(1-\mu(A))$ could hold for a wider range of exponents $\beta \ge 1/2$. In this direction we obtain the following.

Theorem 1.4. For all $A \subset \{0, 1\}^n$,

$$\mathbb{E}h_A^{0.53} \ge 8\mu(A)(1-\mu(A)) \left[\left(1 - \frac{2\sqrt{2}}{3}\right)\mu(A) + \frac{\sqrt{2}}{3} - \frac{1}{4} \right].$$
(1.13)

By an immediate comparison of the right-hand side of (1.13) with $2\mu(A)(1 - \mu(A))$ we obtain an extension of (1.8).

Corollary 1.5. If $\mu(A) \ge 1/2$ then

$$\mathbb{E}h_A^{0.53} \ge 2\mu(A)(1-\mu(A)).$$

The above Corollary has an immediate application in isoperimetric inequalities involving partitions of $\{0,1\}^n$. Let (A, B, W) be a partition of $\{0,1\}^n$, with Wtypically thought to be small. With this setup, define $\nabla(A, B) = \{(x, y) : x \in A, y \in B\}$. For $\beta \ge 1/2$, Kahn and Park [10] considered inequalities of the form

$$|\nabla(A,B)| + Kn^{\beta}|W| \ge 2^{n-1}$$
 (1.14)

for sets A with measure $\mu(A) = 1/2$ and some absolute constant K > 0. Note that if $W = \emptyset$ (that is, $B = A^c$), then (1.14) becomes $|\nabla A| \ge |A|$, which is the classical isoperimetric inequality (1.3) for sets of measure $\mu(A) = 1/2$. They conjectured [10, Conjecture 1.3] that (1.14) should hold for $\beta = 1/2$; here $\beta \ge 1/2$ is again necessary from testing the inequality on Hamming balls (see Section 3). By an elementary argument (see the end of §2.4 for completeness), they showed that the inequality (1.8) implies (1.14) for $\beta = \log_2(3/2)$ and K = 1. Our Corollary 1.5 yields a further improvement in the exponent β .

Corollary 1.6. Let (A, B, W) be a partition of $\{0, 1\}^n$ such that $\mu(A) = 1/2$. Then $|\nabla(A, B)| + n^{0.53} |W| \ge 2^{n-1}$.

1.3. Two-sided boundary. Given $A \subseteq \{0,1\}^n$, define the two-sided boundary function $w_A : \{0,1\}^n \to \mathbb{R}$ by $w_A(x) = h_A(x)$ if $x \in A$ and $w_A(x) = h_{A^c}(x)$ if $x \in A^c$. We remark that one can obtain bounds for $\mathbb{E}w_A^\beta$ from those for $\mathbb{E}h_A^\beta$ noting that $w_A^\beta = h_A^\beta + h_{A^c}^\beta$. Indeed, if there is a function $B : [0,1] \to \mathbb{R}$ such that $\mathbb{E}h_A^\beta \ge B(\mu(A))$ holds for all $A \subseteq \{0,1\}^n$, then $\mathbb{E}w_A^\beta \ge B(\mu(A)) + B(1 - \mu(A))$. In particular, using Theorem 1.1 one obtains

$$\inf_{a \ge 1, \mu(A) = t} \mathbb{E} w_A^{\beta_0} \ge 2t^* (\log_2(1/t^*))^{\beta_0}, \qquad \beta_0 = \log_2(3/2),$$

and combining Theorem 1.1 with Theorem 1.4 one has

$$\inf_{n \ge 1, \mu(A) = t} \mathbb{E} w_A^\beta \ge t^* (\log_2(1/t^*))^\beta + P(t_*) \qquad \text{for } \beta > \log_2(3/2),$$

where $t_* := \max(t, 1 - t)$ and P is the cubic polynomial on the right-hand side of (1.13). In the particular case $\mu(A) = 1/2$ we obtain sharp lower bounds for all $\beta \ge 0.53$ using Corollary 1.5.

Corollary 1.7. For all $\beta \ge 0.53$,

$$\inf_{n\geq 1, \mu(A)=1/2} \mathbb{E} w_A^\beta = 1.$$

Moreover, for all $0.5 \leq \beta < 0.53$,

$$1 \ge \inf_{n \ge 1, \mu(A) = 1/2} \mathbb{E} w_A^\beta \ge \sqrt{2^{\beta + 1} - 2}.$$
(1.15)

The upper bound $1 \ge \inf_{n\ge 1,\mu(A)=1/2} \mathbb{E}w_A^\beta$ comes from testing on a half-cube, and the non-sharp lower bound in (1.15) in the range $0.5 \le \beta < 0.53$ follows from Theorem 1.3. This improves over a recent result in [6, Section 3.6] which says that

$$1 \ge \inf_{n \ge 1, \ \mu(A) = 1/2} \mathbb{E}w_A^\beta \ge \max\left\{\sqrt{\frac{2}{\pi}}, s_{(2\beta)'}^{2\beta}\right\} \quad \text{for } 1/2 \le \beta \le 1.$$

Here, for any $1 \leq q < \infty$, $q' = \frac{q}{q-1}$, and s_q denotes the smallest positive zero of the confluent hypergeometric functions $x \mapsto {}_1F_1\left(-\frac{q}{2}, \frac{1}{2}, \frac{x^2}{2}\right)$. We remark that $s_{p'} \geq \sqrt{\frac{2(p-1)}{p}}$ for all $p \in [1, 2]$ and $s_{p'} \to 0$ as $p \to 1$. Corollary 1.7 for $\beta = 1/2$ gives

$$\inf_{n \ge 1, \mu(A) = 1/2} \mathbb{E}\sqrt{w_A} \ge \sqrt{2^{3/2} - 2} = 0.91... > \sqrt{\frac{2}{\pi}} = 0.79...$$

Remark 1. Let C_1 be the largest constant in the L^1 Poincaré inequality

$$C\mathbb{E}|f - \mathbb{E}f| \le \mathbb{E}|\nabla f| \tag{1.16}$$

for all $f: \{-1,1\}^n \mapsto \mathbb{R}$ and all $n \geq 1$ (see Section 1.4 for the meaning of $|\nabla f|$). Let $C_{1,B}$ be the largest constant in (1.16) for all $f: \{-1,1\}^n \mapsto \{0,1\}$. Clearly $C_1 \leq C_{1,B}$. It was proved in [7] that $\frac{2}{\pi} < C_1 \leq \sqrt{\frac{2}{\pi}}$, and it is believed that $C_1 = \sqrt{\frac{2}{\pi}}$. One may suspect that $C_1 = C_{1,B}$. However, notice that for an indicator function $f = 1_A, A \subset \{-1,1\}^n$, we have

$$\frac{\mathbb{E}|\nabla f|}{\mathbb{E}|f - \mathbb{E}f|} = \frac{\mathbb{E}\sqrt{w_A}}{4\mu(A)(1 - \mu(A))};$$

see Section 1.4 for the relation between $|\nabla f|$ and w_A . On the other hand, Theorem 1.3 combined with the fact $\sqrt{w_A} = \sqrt{h_A} + \sqrt{h_{A^c}}$ shows $\sqrt{2^{3/2} - 2} \leq C_{1,B}$ which implies $C_{1,B} - C_1 \geq \sqrt{2^{3/2} - 2} - \sqrt{2/\pi} = 0.112... > 0.$

1.4. Talagrand's isoperimetric inequalities for the discrete gradient. It will be convenient to work with $\{-1,1\}^n$ instead of $\{0,1\}^{n,2}$ For any $f: \{-1,1\}^n \mapsto \mathbb{R}$ and any $x = (x_1, \ldots, x_n) \in \{-1,1\}^n$ we set

$$D_j f(x) = \frac{f(x_1, \dots, x_j, \dots, x_n) - f(x_1, \dots, -x_j, \dots, x_n)}{2}.$$

²Note that h_A and w_A can be defined analogously for sets $A \subset \{-1, 1\}^n$.

We say f is boolean if f takes values 0 or 1. Define

$$|\nabla f(x)| = \sqrt{\sum_{j=1}^{n} |D_j f|^2}, \text{ and } |Mf(x)| = \sqrt{\sum_{j=1}^{n} (D_j f)_+^2},$$

where $(a)_+ = \max\{0, a\}$ for any $a \in \mathbb{R}$. For any $A \subset \{-1, 1\}^n$, let 1_A denote the indicator function of the set A. Notice that if $x \notin A$ then $|M1_A(x)|^2 = 0$, and if $x \in A$ then $|M1_A(x)|^2$ equals 1/4 times the number of neighbors of x in A^c . Thus $|M1_A(x)|^2 = h_A(x)/4$. On the other hand, the "two-sided" gradient $|\nabla 1_A|^2$ takes the form $|\nabla 1_A(x)|^2 = h_A(x)/4 + h_{A^c}(x)/4 = w_A(x)/4$.

In this section we will be concerned with functional isoperimetric inequalities which are not sharp in terms of constants but capture the correct behaviour of the quantities involved. To this end, we introduce the notation $A \gtrsim B$ to mean that $A \geq CB$ with some universal constant C > 0.

Any function $f: \{-1, 1\}^n \to \mathbb{R}$ has a Fourier–Walsh representation

$$f(x) = \sum_{S \subset \{1, \dots, n\}} \hat{f}(S) x^S, \quad x^S = \prod_{j \in S} x_j.$$

Let $p \ge 1$, and define $||f||_p = (\mathbb{E}|f|^p)^{1/p}$. Recently, using random restriction arguments in an elegant way, Eldan–Kindler–Lifshitz–Minzer obtained the following.

Theorem A ([4]). For any $f : \{-1, 1\}^n \mapsto \{-1, 1\}$, and any $p \in [1, 2]$, we have

$$\|\nabla f\|_p \gtrsim \sup_{d \ge 0} \left(\sum_{|S| \ge d} |\hat{f}(S)|^2 \right)^{1/p} \sqrt{d}.$$

$$(1.17)$$

It was also explained in [4] that essentially by choosing $d \approx \log \frac{e}{\operatorname{Var}(f)}$, the inequality (1.17) implies Talagrand's sharp isoperimetric inequality,

$$\|\nabla f\|_p \gtrsim (\operatorname{Var}(f))^{1/p} \sqrt{\log \frac{e}{\operatorname{Var}(f)}}$$
(1.18)

for all $f : \{-1,1\}^n \mapsto \{-1,1\}$, and by choosing $d \approx \log \frac{e}{W(f)}$, where $W(f) = \sum_{i=1}^n (\mathbb{E}|D_jf|)^2$, the inequality (1.17) implies Talagrand's conjecture³

$$\|\nabla f\|_p \gtrsim (\operatorname{Var}(f))^{1/p} \sqrt{\log \frac{e}{W(f)}}$$
(1.19)

for all $f : \{-1,1\}^n \mapsto \{-1,1\}$, which was recently resolved in [3]. Notice that for *monotone* boolean functions f, i.e., $f(x) \ge f(y)$ whenever $x_i \ge y_i$ for all $i = 1, \ldots, n$, we have

$$W(f) = \sum_{j=1}^{n} \hat{f}(\{j\})^2 \le \sum_{S \neq \emptyset} \hat{f}(S)^2 = \operatorname{Var}(f).$$

Remark 2. We should point out that the inequality (1.19) for p = 1 can be obtained from Theorem 31 in [12], which states that $\mathbb{NS}_{\delta}(f) \leq \sqrt{\delta} \mathbb{E}|\nabla f|$ holds for all $\delta \in [0,1]$ and all $f : \{-1,1\}^n \to \{-1,1\}$, where $\mathbb{NS}_{\delta}(f)$ is the noise sensitivity of f. Using the bound $\mathbb{NS}_{\delta}(f) \gtrsim \operatorname{Var}(f)(1-(W(f)/\operatorname{Var}(f))^{\frac{\delta}{2-\delta}})$ from [11],

and choosing $\delta = \frac{1}{\log(\operatorname{Var}(f)/W(f))}$, where we can assume $\operatorname{Var}(f)/W(f) > 100$ by (1.18), we obtain $\mathbb{E}|\nabla f| \gtrsim \operatorname{Var}(f) \sqrt{\log \frac{\operatorname{Var}(f)}{W(f)}}$. Invoking again (1.18) we can assume $\operatorname{Var}(f) \ge \sqrt{W(f)}$ which leads us to one more proof of (1.19).

In this paper we present new arguments in obtaining (1.17) which unlike random restriction methods [4] or inductive proofs [12] extend the results to functions with values in an arbitrary Banach space having finite cotype. Recall that a Banach space $(X, \|\cdot\|)$ has Rademacher cotype $q \in [2, \infty]$ if there exists a finite C such that

$$\sum_{j=1}^n \|x_j\|^q \le C^q \mathbb{E} \|\sum_{j=1}^n \varepsilon_j x_j\|^q$$

holds for all $n \geq 1$, and all $x_1, \ldots, x_n \in X$, where $\varepsilon_1, \ldots, \varepsilon_n$, are independent identically distributed symmetric ± 1 Bernoulli random variables. The best constant $C = C_q(X)$ is called the cotype q constant of X. Let $\Delta = \sum_{j=1}^n D_j$, and let $e^{-t\Delta}$ be the heat semigroup.

Theorem 1.8. Let $f : \{-1,1\}^n \to X$, $||f||_{\infty} \leq 1$. Then for any $p \in [1,2]$ we have

$$\|Df\|_p \gtrsim \frac{1}{q^{3/2}C_q(X)} \|f\|_2^{2/p} \left(\log \frac{e\|f\|_2}{\|f\|_1}\right)^{1/q},$$

where $||Df||_p^p = \mathbb{E} ||\sum_{1 \le j \le n} x'_j D_j f(x)||^p$ and x' is independent copy of x. Remark 3. If f is boolean, then one can apply the theorem to $f - \mathbb{E}f$ and use Khintchine's inequality to recover Talagrand's isoperimetric inequality (1.18).

Theorem 1.8 will be obtained as a consequence of the following "noise sensitivity" inequality for vector valued functions.

Theorem 1.9. For all $p \in [1, 2]$ the inequality

$$\|f - e^{-t\Delta}f\|_p \lesssim C_q(X)q^{3/2}(1 - e^{-2t})^{\frac{1}{q}}\|Df\|_p, \quad t \ge 0,$$

$$(1.20)$$

holds for all $f : \{-1, 1\}^n \to X$.

Remark 4. If f is boolean, then Theorem 1.9 together with the simple estimate $\|f - e^{-\Delta/d}f\|_p \gtrsim \left(\sum_{|S| \ge d} \hat{f}(S)^2\right)^{1/p}$, $p \in [1, 2]$, implies (1.17).

2. The proofs

2.1. An inductive lemma. The next lemma is a standard inductive argument which follows the same steps as in [14, 1] with the latest upgrade found in [10].

Lemma 2.1 ([10, pp. 4217-4219]). Let $\beta \in [1/2, 1]$. If $B : [0, 1] \to [0, \infty)$ satisfies B(0) = B(1) = 0, $B(1/2) \le 1/2$, and the inequality

$$\max\{((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta}, y-x + (2^{\beta} - 1)B(y)\} + B(x) \ge 2B\left(\frac{y+x}{2}\right)$$
(2.1)

holds for all $0 \le x \le y \le 1$, then $\mathbb{E}h_A^\beta \ge B(\mu(A))$ for all $A \subset \{0,1\}^n$ and all $n \ge 1$.

This Lemma will be used in the proofs of Theorems 1.1, 1.3 and 1.4.

Remark 5. Notice that $\max\{((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta}, y-x + (2^{\beta}-1)B(y)\} = ((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta}$ if and only if $B(y) \ge y-x$.

2.2. **Proof of Theorem 1.1: logarithmic function.** The following "two-point inequality" will play a crucial role in our proofs.

Lemma 2.2. For any $\beta \in [\frac{1}{2}, 1]$ and all $0 \le x \le y \le \frac{1}{2}$ we have

$$((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta} + B(x) \ge 2B\left(\frac{y+x}{2}\right),$$
(2.2)

where $B(x) = x (\log_2(1/x))^{\beta}$.

Proof. First we rewrite the inequality (2.2) as

$$\left(y^{1/\beta}\log_2(1/y) + (y-x)^{1/\beta}\right)^\beta + x(\log_2(1/x))^\beta \ge (x+y)\left(\log_2\left(\frac{2}{x+y}\right)\right)^\beta.$$
(2.3)

We divide the proof into three steps.

<u>Step 1</u>. If the inequality holds for $\beta = 1/2$, then it holds for all $\beta \ge 1/2$. Indeed, let us rewrite the inequality (2.3) as

$$\left[\frac{y}{x+y}\left(\log_2(1/y) + \left(\frac{y-x}{y}\right)^{1/\beta}\right)^{\beta} + \frac{x}{x+y}\left(\log_2(1/x)\right)^{\beta}\right]^{1/\beta} \ge \log_2\left(\frac{2}{x+y}\right).$$
(2.4)

Next, apply $\left(\frac{y-x}{y}\right)^{1/\beta} \geq \left(\frac{y-x}{y}\right)^2$ and the fact that $\beta \mapsto (\mathbb{E}|X|^\beta)^{1/\beta}$ is non-decreasing on $[0,\infty)$ for a random variable X.

In what follows we assume $\beta = \frac{1}{2}$ in (2.3).

Step 2. The inequality for $y = \frac{1}{2}$ implies the inequality for all $y \in [x, \frac{1}{2}]$. Indeed, let x = yt where $0 \le t \le 1$, and let $a = \log_2(1/y) \in [1, \infty)$. Then (2.4) can be rewritten as

$$\left[\frac{1}{t+1}\left(a+(1-t)^{1/\beta}\right)^{\beta}+\frac{t}{t+1}(a+\log_2(1/t))^{\beta}\right]^{1/\beta}-a\geq\log_2\left(\frac{2}{t+1}\right).$$

Notice that $\varphi(a) = (\mathbb{E}(a+|X|)^{\beta})^{1/\beta} - a$ is non-decreasing on $(0,\infty)$ for a random variable X. Indeed,

$$\varphi'(a) = (\mathbb{E}(a+|X|)^{\beta})^{\frac{1}{\beta}-1}\mathbb{E}(a+|X|)^{\beta-1} - 1 \ge 0$$

by Hölder's inequality.

Hence it suffices to verify the inequality for y = 1/2. Step 3. We verify the inequality

$$\sqrt{1 + (1 - t)^2} + t\sqrt{1 + \log_2(1/t)} \ge (t + 1)\sqrt{1 + \log_2\left(\frac{2}{t + 1}\right)}, \quad t \in [0, 1].$$
(2.5)

If we denote 1 - t = s, then the inequality (2.5) takes the form

$$\sqrt{1+s^2} + (1-s)\sqrt{1-\log_2(1-s)} \ge (2-s)\sqrt{1+\log_2\left(\frac{2}{2-s}\right)}.$$
 (2.6)

Next we use two simple inequalities

$$-\log_2(1-s) \ge \frac{s}{\ln(2)} + \frac{s^2}{2\ln(2)};$$
(2.7)

$$\log_2\left(\frac{2}{2-s}\right) \le \frac{s}{2\ln(2)} + \left(1 - \frac{1}{2\ln(2)}\right)s^2.$$
(2.8)

The first inequality follows by Taylor's theorem. The second inequality follows by considering the function $g(s) = \frac{s}{2\ln(2)} + \left(1 - \frac{1}{2\ln(2)}\right)s^2 - \log_2\left(\frac{2}{2-s}\right)$. Note that g(0) = g(1) = 0. Furthermore,

$$\frac{g'(s)}{s} = -\frac{(4\ln(2) - 2)s + 5 - 8\ln(2)}{2(2 - s)\ln(2)}$$

changes sign only once from + to - on (0,1) (notice that $5 - 8\ln(2) < 0$ and $3 - 4\ln(2) > 0$). Hence $g(s) \ge 0$ on [0,1].

Next, we replace the logarithms in (2.6) by their lower and upper bounds correspondingly obtained in (2.7) and (2.8). After squaring both sides of the obtained inequality, it suffices to prove

$$1 + s^{2} + 2(1 - s)\sqrt{(1 + s^{2})\left(1 + \frac{s}{\ln(2)} + \frac{s^{2}}{2\ln(2)}\right)} + (1 - s)^{2}\left(1 + \frac{s}{\ln(2)} + \frac{s^{2}}{2\ln(2)}\right)$$
$$\geq (2 - s)^{2}\left(1 + \frac{s}{2\ln(2)} + \left(1 - \frac{1}{2\ln(2)}\right)s^{2}\right).$$

Isolating the square root term on the left-hand side of the inequality, and squaring both sides again, it suffices to prove

$$4(1-s)^{2}(1+s^{2})\left(1+\frac{s}{\ln(2)}+\frac{s^{2}}{2\ln(2)}\right) \geq \left[-(1-s)^{2}\left(1+\frac{s}{\ln(2)}+\frac{s^{2}}{2\ln(2)}\right) + (2-s)^{2}\left(1+\frac{s}{2\ln(2)}+\left(1-\frac{1}{2\ln(2)}\right)s^{2}\right) - 1-s^{2}\right]^{2}.$$

After opening the parentheses we see that the difference (the left-hand side minus the right-hand side) simplifies to $-\frac{s^2(1-s)^2}{4\ln^2(2)} \times v(s)$, where

$$v(s) = 4(\ln(2) - 1)^2 s^4 + 12(1 - \ln(2))(2\ln(2) - 1)s^3 - (17 - 18\ln(2))(2\ln(2) - 1)s^2 - (12 - 24\ln(2) + 16\ln^2(2))s + 32\ln^2(2) - 32\ln(2) + 4.$$

The factor $s^2(1-s)^2$ should not be surprising as s = 0 and s = 1 are the equality cases in (2.6) and, by the several reductions that we did, we kept the values at s = 0 and s = 1 unchanged. The signs of the coefficients in v(s), from the highest to the lowest power, are +, +, -, -, -. Therefore, by Descartes' rule of sign, the number of positive roots of the polynomial v is at most one. As v(s) is positive at infinity, and $v(1) = 32 \ln^2(2) - 32 \ln(2) + 1 < 0$ it follows that v(s) < 0 on [0, 1], and thus g(s) > 0 on [0, 1], concluding the proof of the inequality (2.5) and hence of Lemma 2.2.

The following lemma will be used for sets of measure greater than 1/2.

Lemma 2.3. For any $\beta \in [\frac{1}{2}, \ln(2)]$ and all $0 \le x \le y \le \frac{1}{2}$ we have

$$((y-x)^{1/\beta} + B(x)^{1/\beta})^{\beta} + B(y) \ge 2B\left(\frac{y+x}{2}\right),$$
 (2.9)

where $B(x) = x (\log_2(1/x))^{\beta}$.

Proof. Notice that B is non-decreasing on [0, 1/2] since

$$B'(x) = (\log_2(1/x))^{\beta - 1} \left(\log_2(1/x) - \frac{\beta}{\ln(2)} \right) \ge 0$$

for $\beta \in [1/2, \ln(2)]$. For all $0 \le x \le y \le 1/2$ we have

$$((y-x)^{1/\beta} + B(x)^{1/\beta})^{\beta} - ((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta} + B(y) - B(x) \ge 0.$$
 (2.10)

Indeed, for each $\beta \in (0, 1]$ the map $\psi(t) = ((y - x)^{1/\beta} + t^{1/\beta})^{\beta} - t$ is non-increasing on $[0, \infty)$. Thus, using the fact $B(x) \leq B(y)$ it follows that $\psi(B(x)) \geq \psi(B(y))$, which is the same as (2.10). Finally, the left-hand side of (2.9) minus the left-hand side of (2.10) coincides with the left-hand side of (2.2) and the lemma follows. \Box

The next lemma is the main technical part of [10]. We note that this result is also contained in Lemmas 2.5 and 2.6 for $\beta = \log_2(3/2)$.

Lemma 2.4 ([10, pp. 4219-4220]). The function B(x) = 2x(1-x) satisfies (2.1) for $\beta = \log_2(3/2)$.

Now we are ready to prove Theorem 1.1. Let $\beta = \beta_0 = \log_2(3/2)$ in Lemma 2.1, and consider

$$B(t) := \begin{cases} t(\log_2(1/t))^{\beta_0} & t \in [0, 1/4), \\ 2t(1-t) & t \in [1/4, 3/4], \\ (1-t)(\log_2(1/(1-t)))^{\beta_0} & t \in (3/4, 1]. \end{cases}$$
(2.11)

Notice that

$$B(t) = \max\{t^*(\log_2(1/t^*))^{\beta_0}, 2t(1-t)\} =: \max\{B_1(t), B_2(t)\}, \quad t \in [0, 1],$$

where $t^* = \min\{t, 1-t\}$. The left-hand side of the inequality (2.1) can be rewritten as $\Phi(B(x), B(y), (y-x))$, where

$$\Phi(u, v, w) := \max\{(w^{1/\beta_0} + v^{1/\beta_0})^{\beta_0}, w + (2^{\beta_0} - 1)v\} + u.$$

The map $(u, v, w) \in [0, \infty)^3 \mapsto \Phi(u, v, w)$ is non-decreasing in u and v. The goal is to show that

$$\Phi(B(x), B(y), (y-x)) \ge 2B\left(\frac{x+y}{2}\right) \tag{2.12}$$

holds for all $0 \le x \le y \le 1$ and the choice of B in (2.11). There will be six cases in total to consider.

- (i) If $x, y \in [0, 1/4]$. Then $(x + y)/2 \in [0, 1/4]$, so B in (2.12) coincides with B_1 and then (2.12) follows from Lemma 2.2.
- (ii) If $x, y \in [3/4, 1]$. Then $(x + y)/2 \in [3/4, 1]$, so B in (2.12) coincides with B_1 . Denote x = 1 - b, y = 1 - a. Then $0 \le a \le b \le 1/4$, and we have

$$\Phi(B(x), B(y), (y-x)) = \Phi(B_1(x), B_1(y), (y-x)) = \Phi(B_1(b), B_1(a), (b-a))$$

$$\geq 2B_1((a+b)/2) = 2B((x+y)/2),$$

where the inequality follows by Lemma 2.3.

(iii) If $x, y \in [1/4, 3/4]$. Then $(x + y)/2 \in [1/4, 3/4]$, so B in (2.12) coincides with B_2 and then (2.12) follows from Lemma 2.4.

(iv) If
$$x \in [0, 1/4], y \in [3/4, 1]$$
. Then $(x + y)/2 \in [1/4, 3/4]$. Therefore

$$\Phi(B(x), B(y), (y - x)) \ge \Phi(B_2(x), B_2(y), (y - x))$$

$$\ge 2B_2((x + y)/2) = 2B((x + y)/2)$$

where the second inequality follows by Lemma 2.4.

- (v) If $x \in [0, 1/4], y \in [1/4, 3/4]$. Then $(x + y)/2 \in [1/8, 1/2]$. We distinguish two cases:
 - if $(x+y)/2 \in [0, 1/4]$, then $y \le 1/2$ and we have

$$\Phi(B(x), B(y), (y-x)) \ge \Phi(B_1(x), B_1(y), (y-x))$$

$$\ge 2B_1((x+y)/2) = 2B((x+y)/2),$$

where in the second inequality we have used Lemma 2.2.

• If $(x+y)/2 \in [1/4, 3/4]$ then

. .

$$\Phi(B(x), B(y), (y - x)) \ge \Phi(B_2(x), B_2(y), (y - x))$$

$$\ge 2B_2((x + y)/2) = 2B((x + y)/2).$$

where in the second inequality we have used Lemma 2.4.

- (vi) If $x \in [1/4, 3/4], y \in [3/4, 1]$. Then $(x + y)/2 \in [1/2, 7/8]$. We distinguish two cases:
 - If $(x+y)/2 \in [1/4, 3/4]$ then we use the bound $B(y) \ge B_2(y)$ and proceed by Lemma 2.4, similarly to (iv), or the second item in (v).
 - If $(x+y)/2 \in [3/4, 1]$, then $x \ge 1/2$. As in (ii), denote x = 1-b, y = 1-a. Note that $0 \le a \le 1/4 \le b \le 1/2$ and we have

$$\Phi(B(x), B(y), (y-x)) \ge \Phi(B_1(x), B_1(y), (y-x)) = \Phi(B_1(b), B_1(a), (b-a))$$

$$\ge 2B_1((a+b)/2) = 2B((x+y)/2),$$

where in the second inequality we have used Lemma 2.3.

Thus we have verified that (2.12) holds for the choice of B in (2.11). Consequently, combining this with Lemma 2.1 we obtain

$$\mathbb{E}h_A^{\beta_0} \ge B(\mu(A)) \ge \mu(A)^* (\log_2(1/\mu(A)^*))^{\beta_0}.$$

This finishes the proof of the main inequality (1.9).

To verify (1.10), we apply Hölder's inequality to (1.9) for any $\alpha \in [0, 1]$, and any $A \subset \{0,1\}^n$ with $\mu(A) \leq 1/2$. This yields,

$$(\mathbb{E}h_A^{\beta_0/\alpha})^{\alpha}\mu(A)^{1-\alpha} \geq (\mathbb{E}h_A^{\beta_0/\alpha})^{\alpha}\mu(\partial A)^{1-\alpha} \geq \mathbb{E}h_A^{\beta_0} \geq \mu(A)(\log_2(1/\mu(A)))^{\beta_0},$$

where the first inequality uses the trivial bound $\mu(\partial A) \leq \mu(A)$. Thus we obtain $(\mathbb{E}h_A^{\beta_0/\alpha})^{\alpha}\mu(A)^{1-\alpha} \geq \mu(A)(\log_2(1/\mu(A)))^{\beta_0}$. Dividing both sides of the inequality by $\mu(A)^{1-\alpha}$ and rising it to the power $1/\alpha$ we obtain (1.10). This concludes the proof of Theorem 1.1.

2.3. Proof of Theorem 1.3: quadratic polynomial. The proof of Theorem 1.3 will be a consequence of the upcoming Lemmas 2.5 and 2.6, when combined with Lemma 2.1.

Lemma 2.5. Let $\beta \in [1/2, \log_2(3/2)]$. If $C_{\beta} = 2\sqrt{2^{\beta+1}-2}$ and $B(x) = C_{\beta}x(1-x)$, then the inequality

$$y - x + (2^{\beta} - 1)B(y) + B(x) \ge 2B\left(\frac{y + x}{2}\right)$$
(2.13)

holds for all $0 \le y \le 1$ and $0 \le x \le y - B(y)$.

Proof. Let f(x, y) be the left-hand side of (2.13) minus the right-hand side of (2.13), that is,

$$f(x,y) := C_{\beta}(2^{\beta} - 2)y(1-y) - \frac{1}{2}(x-y)(C_{\beta}(x-y) + 2).$$
(2.14)

The map $x \mapsto f(x, y)$ is concave, so in order to see that $f(x, y) \ge 0$ for $y \in [0, 1]$ and $x \in [0, y - B(y)]$, it suffices to check the two inequalities: (i) $f(y - B(y), y) \ge 0$ and (ii) $f(0, y) \ge 0$. To verify (i) we have

$$f(y - B(y), y) = \frac{C_{\beta}}{2}y(1 - y)(2^{\beta + 1} - 2 - C_{\beta}^{2}y(1 - y)).$$

Notice that $2^{\beta+1} - 2 - C_{\beta}^2 y(1-y) \ge 2^{\beta+1} - 2 - \frac{C_{\beta}^2}{4} = 0$ for all $y \in [0,1]$. To verify (ii) we have

$$2f(0,y)/y = yC_{\beta}(3-2^{\beta+1}) + 2^{\beta+1}C_{\beta} - 4C_{\beta} + 2$$

Notice that $3 - 2^{\beta+1} \ge 0$ for all $\beta \in [1/2, \log_2(3/2)]$. Furthermore, $y - B(y) \ge 0$ implies $\frac{C_{\beta}-1}{C_{\beta}} \le y$. The value of 2f(0, y)/y at the point $y = \frac{C_{\beta}-1}{C_{\beta}}$ equals to $(\sqrt{2^{\beta+1}-2}-1)^2 \ge 0$.

Lemma 2.6. Let $\beta \in [1/2, \log_2(3/2)]$. If $C_{\beta} = 2\sqrt{2^{\beta+1}-2}$ and $B(x) = C_{\beta}x(1-x)$, then the inequality

$$\left((y-x)^{1/\beta} + B(y)^{1/\beta}\right)^{\beta} + B(x) \ge 2B\left(\frac{y+x}{2}\right)$$
(2.15)

holds for all $0 \le x \le y \le 1$ such that $x \in [y - B(y), y]$.

Proof. Let g(x, y) be the left-hand side of (2.15) minus the right-hand side of (2.15), that is,

$$g(x,y) := \left[(C_{\beta}y(1-y))^{1/\beta} + (y-x)^{1/\beta} \right]^{\beta} - C_{\beta}y(1-y) - \frac{C_{\beta}}{2}(y-x)^{2}.$$

We observe that g(y, y) = 0 and, by the proof of Lemma 2.5 we have $g(y-B(y), y) = f(y - B(y), y) \ge 0$ on [0, 1], where f is as in (2.14). Then, for a fixed $y \in [0, 1]$, in order to prove that $g(x, y) \ge 0$ for all $x \in [y - B(y), y]$, it suffices to show the following two claims:

(i) the map $x \mapsto g(x, y)$ has at most one critical point on (y - B(y), y);

(ii) there exists $\epsilon > 0$ such that g(x, y) > 0 for all $x \in (y - \epsilon, y)$.

We first show (i). We have that

$$\partial_x g(x,y) = -(y-x)^{\frac{1}{\beta}-1} \left[(C_\beta y(1-y))^{\frac{1}{\beta}} + (y-x)^{\frac{1}{\beta}} \right]^{\beta-1} + C_\beta (y-x).$$
(2.16)

Let A := y - x and $B := C_{\beta}y(1-y)$. Notice that $0 \le A \le B$, and B is independent of x. We have

$$\partial_x g(x,y) = -A^{\frac{1}{\beta}-1} [B^{\frac{1}{\beta}} + A^{\frac{1}{\beta}}]^{\beta-1} + C_{\beta}A,$$

so that $\partial_x g(x, y) = 0$ is equivalent to

$$B^{\frac{1}{\beta}} + A^{\frac{1}{\beta}} = C^{\frac{1}{\beta-1}}_{\beta} A^{\frac{2\beta-1}{\beta(\beta-1)}}.$$
(2.17)

For $\beta \geq 1/2$, the left-hand side above increases in A, whereas the right-hand side decreases in A. Thus, (2.17) can hold in at most one point, establishing (i).

Item (ii) follows from noting that
$$\lim_{x \to y} \frac{\partial_x g(x,y)}{(y-x)^{\frac{1}{\beta}-1}} < 0$$
 and $g(y,y) = 0$. \Box

2.4. **Proof of Theorem 1.4: cubic polynomial.** In this section we will be concerned with the polynomial

$$B(x) = 8x(1-x) \left[\left(1 - \frac{2^{\alpha+1}}{3} \right) x + \left(\frac{2^{\alpha}}{3} - \frac{1}{4} \right) \right].$$
 (2.18)

We remark that B is chosen to satisfy B(0) = B(1) = 0, B(1/2) = 1/2 and $B(1/4) = 2^{\alpha}/4$. It will be convenient for later use to expand B as

$$B(x) = 8\left(\frac{2^{\alpha}}{3} - \frac{1}{4}\right)x - 8\left(2^{\alpha} - \frac{5}{4}\right)x^2 - 8\left(1 - \frac{2^{\alpha+1}}{3}\right)x^3.$$
 (2.19)

Theorem 1.4 follows from combining Lemma 2.1 and the upcoming Lemmas 2.7 and 2.8.

Lemma 2.7. Let $\alpha = 1/2$ and $\beta = 0.53$. The inequality

$$y - x + (2^{\beta} - 1)B(y) + B(x) \ge 2B\left(\frac{y + x}{2}\right).$$

holds for all $0 \le x \le y - B(y), 0 \le y \le 1$.

Proof. We first observe that if $B(y) \leq y$, then $y \geq 1/2$. Indeed, a computation reveals that

$$y - B(y) = \frac{8(3 - 2^{\alpha + 1})}{3}y\left(y - \frac{1}{2}\right)\left(y - \frac{2^{\alpha} - 9/8}{2^{\alpha} - 3/2}\right).$$
 (2.20)

The claim now follows trivially since $\frac{2^{\alpha}-9/8}{2^{\alpha}-3/2} < 0$ for $\alpha = 1/2 \le \log_2(3/2)$. Let

$$f(x,y) := (2^{\beta} - 1)B(y) + (y - x) - 2B\left(\frac{x + y}{2}\right) + B(x).$$
(2.21)

To verify Lemma 2.7 it suffices to show the inequality $f(x, y) \ge 0$ for all $1/2 \le y \le 1$ and all $0 \le x \le y - B(y)$. The inequality will be implied by the following 3 claims:

- (i) $f(0, y) \ge 0$ for all $y \in [1/2, 1];$
- (ii) $x \mapsto f(x, y)$ is concave on [0, y B(y)] for each fixed $y \in [1/2, 1]$;
- (iii) $f(y B(y), y) \ge 0$ for all $y \in [1/2, 1]$.

To verify (i), notice that $\varphi(y) := f(0, y)/y$ is concave parabola as

$$3\varphi''(y) = (20 - 2^{\beta+4}) (3 - 2^{\alpha+1}) < 0.$$

On the other hand, $\varphi(1/2) = 2^{\beta} - 2^{\alpha} > 0$ and $\varphi(1) = 0$. Thus $\varphi(y) \ge 0$ on [1/2, 1], and (i) follows.

To verify (ii) notice that

$$\partial_{xx}^2 f(x,y) = -2(3-2^{\alpha+1})(6x-2y+2^{\alpha+1}+1) \le 0 \quad \text{for all} \quad x,y \in [0,1].$$

Next we verify (iii). Notice that f(y - B(y), y) = B(y)G(y), where

$$\begin{aligned} G(y) &= \left(11 - \frac{70}{9} \cdot 2^{\alpha}\right) 2^{7} y^{6} + \left(2^{\alpha + 7} - 181\right) \frac{2^{6}}{3} y^{5} + \left(1453 - \frac{3082}{3} \cdot 2^{\alpha}\right) \frac{2^{3}}{3} y^{4} \\ &- \left(\frac{331}{3} - 78 \cdot 2^{\alpha}\right) 2^{4} y^{3} + \left(563 - \frac{1192}{3} \cdot 2^{\alpha}\right) \frac{2}{3} y^{2} - \left(47 - 2^{\alpha + 5}\right) \frac{2}{3} y \\ &+ 2^{\beta} - 1 \end{aligned}$$

is a polynomial of degree 6. We have $G'''(y) \ge G'''(1/2) = (5\sqrt{2}-7)2^7 \ge 0$ on [1/2, 1] since the signs of all coefficients of the polynomial G'''(y) are positive except of the free coefficient. Also $G''(1/2) = (147 - 100\sqrt{2}) \cdot 4/9 > 0$. Thus G(y) is convex on [1/2, 1]. Therefore, $G(y) \ge L(y) = G(y_0) + G'(y_0)(y - y_0)$, where $y_0 = 0.631$. Since $G'(y_0) = 0.00036... > 0$ and L(1/2) = 0.000067... > 0 it follows that $G(y) \ge 0$ on [1/2, 1].

Lemma 2.8. Let $\alpha = 0.5$ and $\beta = 0.53$. The inequality

$$((y-x)^{1/\beta} + B(y)^{1/\beta})^{\beta} + B(x) \ge 2B\left(\frac{y+x}{2}\right)$$

holds for all $0 \le x, y \le 1$ such that $x \in [\max\{y - B(y), 0\}, y]$.

Proof. Let

$$g(x,y) := \left(B(y)^{\frac{1}{\beta}} + (y-x)^{\frac{1}{\beta}} \right)^{\beta} - 2B\left(\frac{x+y}{2}\right) + B(x).$$

The goal is to show $g(x,y) \ge 0$ for all $0 \le y \le 1$ and all $\max\{y - B(y), 0\} \le x \le y$. It is clear that g(y,y) = 0. We recall from the proof of Lemma 2.7 that $\max\{y - B(y), 0\} = y - B(y)$ if and only if $y \in [1/2, 1]$. Therefore, notice that for $y \in [1/2, 1]$ we have $g(y - B(y), y) = f(y - B(y), y) \ge 0$ due to positivity of the polynomial G(y) on [1/2, 1] defined in Lemma 2.7; here f is as in (2.21). If $y \in [0, 1/2]$, then

$$g(0,y) = (B(y)^{1/\beta} + y^{1/\beta})^{\beta} - 2B(y/2) \ge (B(y)^2 + y^2)^{1/2} - 2B(y/2).$$

Next, we have

$$\frac{B(y)^2 + y^2 - (2B(y/2))^2}{3} = \frac{17 - 12\sqrt{2}}{3} \cdot y^2(1 - 2y)(1 - y)(10y^2 + y(29 + 28\sqrt{2}) + 51 + 36\sqrt{2}) \ge 0$$

for all $y \in [0, 1/2]$. So we obtain $g(\max\{y - B(y), 0\}, y) \ge 0$ for all $y \in [0, 1]$.

Thus to prove Lemma 2.8 it suffices to obtain the following two claims for each fixed $y \in [0, 1]$:

- (i) the map $x \mapsto g(x, y)$ has at most one critical point on (0, y);
- (ii) there exists $\varepsilon > 0$ such that $\partial_x g(x, y) < 0$ for all $x \in (y \varepsilon, y)$.

For the claim (ii), an immediate computation shows

$$\partial_x g(x,y) = -\left(B(y)^{\frac{1}{\beta}} + (y-x)^{\frac{1}{\beta}}\right)^{\beta-1} (y-x)^{\frac{1}{\beta}-1} - B'\left(\frac{x+y}{2}\right) + B'(x).$$

Therefore, since $\frac{1}{\beta} - 1 < 1$ it follows that $\lim_{x \to y} \frac{\partial_x g(x,y)}{(y-x)^{\frac{1}{\beta}-1}} > 0$.

To verify the claim (i), notice that

$$\begin{split} (y-x)^{1-\frac{1}{\beta}}\partial_x g(x,y) &= -\left(B(y)^{\frac{1}{\beta}} + (y-x)^{\frac{1}{\beta}}\right)^{\beta-1} + \\ 2(3-2^{3/2})(y-x)^{2-\frac{1}{\beta}}(3x+y+2^{3/2}+1). \end{split}$$

It suffices to show that for each $y \in [0, 1]$ the map

$$\psi(x) := -(B(y)^{\frac{1}{\beta}} + (y-x)^{\frac{1}{\beta}}) + [2(3-2^{3/2})(y-x)^{2-\frac{1}{\beta}}(3x+y+2^{3/2}+1)]^{\frac{1}{\beta-1}}$$

satisfies $\psi' > 0$ on (0, y). We have

$$\frac{\psi'(x)(y-x)^{-\frac{2\beta-1}{\beta(\beta-1)}+1}}{(2(3-2\sqrt{2})(3x+y+2^{3/2}+1))^{\frac{1}{\beta-1}}} = \frac{((y-x)(3x+y+2^{3/2}+1))^{\frac{1}{1-\beta}}}{\beta(2(3-2\sqrt{2}))^{\frac{1}{\beta-1}}} + \frac{2\beta-1}{\beta(1-\beta)} - \frac{3(y-x)}{(1-\beta)(3x+y+2^{3/2}+1)}.$$
(2.22)

Set x = y - t in (2.22) where $y \in [t, 1]$ and $t \in (0, 1)$. Then the right-hand side of (2.22) is increasing in y for each fixed t, and for y = t it takes the form

$$\frac{(t(t+2^{3/2}+1))^{\frac{1}{1-\beta}}}{\beta(2(3-2\sqrt{2}))^{\frac{1}{\beta-1}}} + \frac{2\beta-1}{\beta(1-\beta)} - \frac{3t}{(1-\beta)(t+2^{3/2}+1)} =:\varphi(t).$$

Clearly $\varphi(t)$ is convex on [0, 1] as it is the sum of two convex functions. Therefore $\varphi(t) \ge L(t) := \varphi(0.22) + \varphi'(0.22)(t - 0.22)$. Since $\varphi'(0.22) = 0.053... > 0$ and L(0) = 0.033... > 0 the lemma follows.

We finish this section discussing how Theorem 1.4 (or Corollary 1.5) implies Corollary 1.6. This is already contained in [10, Corollary 3.2], but we include it here for completeness.

Proof of Corollary 1.6. Let (A, B, W) be a partition of $\{0, 1\}^n$ with $\mu(A) = 1/2$. Assume that $\mathbb{E}h_A^\beta \ge P(\mu(A))$ holds for all such A. Then we have

$$P(\mu(A)) \le \mathbb{E}h_{B\cup W}^{\beta} = \mathbb{E}(h_{B\cup W}^{\beta}\mathbb{1}_B) + \mathbb{E}(h_{B\cup W}^{\beta}\mathbb{1}_W) \le \frac{|\nabla(A, B)|}{2^n} + n^{\beta}\mu(W),$$

where in the last inequality we have used the bound $h_{B\cup W} \leq n$. The desired result then follows if P(1/2) = 1/2, which is the case for the function on the right-hand side of (1.13).

2.5. **Proof of Theorems 1.8 and 1.9.** We start from an identity in [8] stating that

$$-\frac{d}{dt}e^{-t\Delta}f(x) = \frac{1}{\sqrt{e^{2t} - 1}} \mathbb{E}_{\xi} \sum_{j=1}^{n} \delta_j(t) D_j f(\xi(t)x), \qquad (2.23)$$

where $x\xi(t) = (x_1\xi_1(t), \dots, x_n\xi_n(t))$, and $\xi_i(t)$ are i.i.d. r.v. with

$$\mathbb{P}(\xi_j(t) = \pm 1) = \frac{1 \pm e^{-t}}{2}, \quad \delta_j(t) = \frac{\xi_j(t) - \mathbb{E}\xi_j(t)}{\sqrt{\operatorname{Var}(\xi_j(t))}}$$

The identity is easily verified for Walsh functions x^S , and by linearity it follows for all functions f. By (2.23) and the fundamental theorem of calculus we have

$$\|f - e^{-t\Delta}f\|_{p} \stackrel{(2.23)}{\lesssim} \int_{0}^{t} \left(\mathbb{E}\left\|\sum_{j=1}^{n} \delta_{j}(s)D_{j}f(x)\right\|^{p}\right)^{1/p} \frac{ds}{\sqrt{e^{2s} - 1}}$$
$$\lesssim C_{q}(X)\sqrt{q}\|Df\|_{p} \int_{0}^{t} (1 - e^{-2s})^{\frac{1}{q} - 1} ds$$
$$\lesssim C_{q}(X)q^{3/2}(1 - e^{-2t})^{\frac{1}{q}}\|Df\|_{p},$$

where we also used Theorem 4.1 in [8] in the second inequality. This concludes the proof of Theorem 1.9.

For Theorem 1.8, we note that since $||e^{-t\Delta}f||_{\infty} \leq ||f||_{\infty} \leq 1$ the above inequality and Minkowski's inequality imply that

$$\|f\|_{2}^{2/p} - \|e^{-t\Delta}f\|_{2}^{2/p} \lesssim C_{q}(X)q^{3/2}(1-e^{-2t})^{\frac{1}{q}}\|Df\|_{p}.$$
(2.24)

Denote $\varepsilon = 1 - e^{-2t}$. By hypercontractivity [2] and the Hölder inequality we have $\|e^{-t\Delta}f\|_2 \leq \|f\|_2 \left(\frac{\|f\|_1}{\|f\|_2}\right)^{\frac{\varepsilon}{2-\varepsilon}}$. Thus

$$\frac{1 - \left(\frac{\|f\|_1}{\|f\|_2}\right)^{\frac{2\varepsilon}{p(2-\varepsilon)}}}{\varepsilon^{1/q}} \lesssim C_q(X)q^{3/2}\frac{\|Df\|_p}{\|f\|_2^{2/p}}.$$
(2.25)

If $\frac{\|f\|_2}{\|f\|_1} < 10$, then the theorem follows by taking $t \to \infty$ in (2.24). Otherwise, choosing $\varepsilon = \frac{1}{\log \frac{\varepsilon \|f\|_2}{\|f\|_1}}$ in (2.25) proves the theorem.

3. Appendix

For completeness, we include the argument that shows the necessity of the condition $\beta \geq 1/2$ in the isoperimetric inequalities (1.1) and (1.14). In both cases, the counterexamples are given by Hamming balls. Let $a \in \{0, 1\}^n$ and r > 0. Let B(a, r) denote the Hamming ball of center a and radius r, defined with respect to the ℓ^1 -distance in $\{0, 1\}^n$. Note that the number of elements of B(a, r) is $\sum_{i=0}^{r^*} {n \choose i}$, where $r^* := \min\{\lfloor r \rfloor, n\}$. If $r \in \mathbb{N}$, $r \leq n$, the sphere S(a, r) has ${n \choose r}$ elements.

We start with the claim in (1.4). Let n be a positive even integer, $a \in \{0, 1\}^n$ arbitrary, and consider A = B(a, n/2). Clearly, $\operatorname{supp}(h_A) = S(a, n/2)$. Since $h_A(x) = n/2$ for $x \in S(0, n/2)$, and $h_A(x) = 0$ otherwise, we have

$$\mathbb{E}h_A^\beta = (n/2)^\beta \mu(\operatorname{supp} h_A) = (n/2)^\beta \mu(S(0, n/2)) = (n/2)^\beta \frac{\binom{n}{n/2}}{2^n}.$$

Thus, Stirling's approximation gives $\lim_{n\to\infty} \mathbb{E}h_A^\beta = 0$ for $\beta < 1/2$.

To verify the necessity of the condition $\beta \geq 1/2$ in (1.14) we let *n* be a positive odd integer, and let $a \in \{0,1\}^n$ be arbitrary. Consider the Hamming ball A = B(a, (n-1)/2), which has measure $\mu(A) = 2^{-n} \sum_{i=0}^{(n-1)/2} {n \choose i} = 1/2$, and let *W* be the boundary of *A*, and let $B := \{0,1\}^d \setminus (A \cup W)$. Clearly $|\nabla(A, B)| = 0$. Then the inequality (1.14) reduces to

$$K|W|n^{\beta} \ge 2^{n-1}.\tag{3.1}$$

Since $|W| = \binom{n}{(n-1)/2}$, it follows from Stirling's approximation that the condition $\beta \ge 1/2$ is necessary for the inequality $\liminf_{n\to\infty} K \frac{|W|n^{\beta}}{2^{n-1}} \ge 1$ to hold.
