ON A LEVEL ANALOG OF SELBERG'S RESULT ON S(t)

ABSTRACT. Let $S(t, f) = \pi^{-1} \arg L(1/2 + it, f)$, where f is a holomorphic Hecke cusp form of weight 2 and prime level q. In this paper, we establish an asymptotic formula for the moments of S(t, f) without assuming the GRH.

1. Introduction

For T > 0, let N(T) be the number of zeros $\rho = \beta + i\gamma$ of the Riemann zeta function $\zeta(s)$ in the rectangle $0 < \beta < 1$, $0 < \gamma \le T$. In particular, Davenport [2, Chapter 15] gives that the approximate formula of N(T) is

$$N(T) = \frac{T}{2\pi} \log \frac{T}{2\pi} - \frac{T}{2\pi} + \frac{7}{8} + S(T) + O(T^{-1}),$$

where

$$S(T) = \frac{1}{\pi} \arg \zeta \left(\frac{1}{2} + iT\right).$$

The argument of $\zeta(1/2+iT)$ is defined as the continuous variation along the horizontal segment from $\infty + iT$ to 1/2 + iT starting at $\infty + iT$ with the value 0. Understanding the complicated behavior of S(t) is an interesting topic in analytic number theory, and a series of results have emerged in recent years due to Selberg's pioneering work.

In [12, 13], Selberg showed that for any $n \in \mathbb{N}$ one has

$$\int_{T}^{2T} S(t)^{2n} dt = \frac{(2n)!}{n!(2\pi)^{2n}} T(\log\log T)^{n} + O(T(\log\log T)^{n-1/2}), \tag{1.1}$$

which can imply, on average sense, |S(t)| has order of magnitude $\sqrt{\log \log T}$. The same method can be applied to get a similar result relating to Dirichlet *L*-functions $L(s,\chi)$, where χ is the primitive Dirichlet character of modulus q. More precisely, for prime modulus q and t > 0, Selberg [14] showed that

$$\sum_{\chi \bmod q}^* S(t,\chi)^{2n} = \frac{(2n)!}{n!(2\pi)^{2n}} q(\log\log q)^n + O(q(\log\log q)^{n-1/2}),\tag{1.2}$$

where * denotes the summation goes through the primitive characters $\chi \pmod{q}$, and $S(t,\chi)$ is defined by

$$S(t,\chi) = \frac{1}{\pi} \arg L(\frac{1}{2} + it, \chi).$$

Note that the counterparts of (1.1) and (1.2) for the odd-order moments can also be obtained by making a minor adaptation in Selberg's techniques.

For higher rank L-functions, there are some analogues of (1.2) in the spectral and weight aspects, respectively. For example, under Generalized Riemann Hypothesis (GRH), Hejhal and Luo [4] (resp. Liu and Liu [10]) obtained an asymptotic formula for the spectral moments of $S_F(t) = \pi^{-1} \arg L(\frac{1}{2} + it, F)$ for each fixed t > 0, where F is the Hecke–Maass cusp form for $\mathrm{SL}_2(\mathbb{Z})$ (resp. $\mathrm{SL}_3(\mathbb{Z})$) with eigenvalue $\lambda_F = 1/4 + t_F^2$ (resp. the spectral parameter $\nu_F = (\nu_{F,1}, \nu_{F,2}, \nu_{F,3})$). Recently, when f is a holomorphic Hecke cusp form of $\mathrm{SL}_2(\mathbb{Z})$ with weight k, Liu and Shim [11] unconditionally establish the asymptotic formula for the moments of $S(t,f) = \frac{1}{\pi} \arg L(\frac{1}{2} + it, f)$, by means of the weighted version of the zero-density estimate obtained by Hough [5] in the weight aspect.

In this paper, we are devoted to get an unconditional analog for GL_2 in the level aspect without assuming the GRH. Assume q is a fixed large prime. Let $S_2(q)$ be the space of holomorphic cusp forms of weight 2 and level q equipped with the Petersson inner product

$$\langle f, g \rangle = \int_{\Gamma_0(g) \backslash \mathbb{H}} f(z) \overline{g(z)} \frac{\mathrm{d}x \mathrm{d}y}{y^2}.$$

Here $\Gamma_0(q)\backslash\mathbb{H}$ is a fundamental domain of the action of the Hecke congruence subgroup $\Gamma_0(q)$ on the upper-half plane \mathbb{H} . Let $H_2(q)$ be a basis of $S_2(q)$ that are eigenfunctions of all the Hecke operators and have the first Fourier coefficient $\lambda_f(1) = 1$. For each $f \in H_2(q)$, let

$$f(z) = \sum_{n=1}^{\infty} n^{1/2} \lambda_f(n) e(nz), \quad z \in \mathbb{H}$$

be its Fourier expansion. The Fourier coefficients $\lambda_f(n)$ are real and satisfy the Deligne's bound (in particular, this is due to Eichler–Shimura [15] in the case of weight 2)

$$|\lambda_f(n)| \le \tau(n),\tag{1.3}$$

with $\tau(n)$ being the divisor function. For Re(s) > 1, the Hecke L-function associated to $f \in H_2(q)$ is defined by

$$L(s,f) = \sum_{n=1}^{\infty} \frac{\lambda_f(n)}{n^s} = \prod_p (1 - \lambda_f(p)p^{-s} + \varepsilon_q(p)p^{-2s})^{-1},$$

where $\varepsilon_q(\cdot)$ is the principal Dirichlet character modulo q. It can be analytically continued to the whole complex plane and has the completed L-function

$$\Lambda(s,f) = \left(\frac{\sqrt{q}}{2\pi}\right)^s \Gamma\left(s + \frac{1}{2}\right) L(s,f),$$

which satisfies the functional equation

$$\Lambda(s, f) = \epsilon_f \Lambda(1 - s, f),$$

where $\epsilon_f = q^{1/2} \lambda_f(q) \in \{\pm 1\}$ is the sign of the functional equation. Moreover, we have the following multiplicative property of the coefficients $\lambda_f(n)$,

$$\lambda_f(m)\lambda_f(n) = \sum_{d|(m,n)} \varepsilon_q(d)\lambda_f\left(\frac{mn}{d^2}\right), \quad \text{for } m,n \geqslant 1.$$
 (1.4)

If p is a prime $\neq q$, we write $1 - \lambda_f(p)Y + Y^2 = (1 - \alpha_f(p)Y)(1 - \beta_f(p)Y)$, so

$$\lambda_f(p) = \alpha_f(p) + \beta_f(p).$$

The bound (1.3) is equivalent (for n coprime with the level) with the assertion that $|\alpha_f(p)| = 1$ for all $p \neq q$. For p = q, the p-factor of L(s, f) is of degree at most 1, and we let $\alpha_f(p) = \lambda_f(p)$, which is shown to be of modulus at most 1, and $\beta_f(p) = 0$.

Now we define S(t, f) by

$$S(t, f) := \frac{1}{\pi} \arg L(1/2 + it, f),$$

where the argument arg L(1/2+it, f) is obtained by continuous variation along the line Im(s) = t from $\sigma = +\infty$ to $\sigma = 1/2$. Our main result is the following theorem.

Theorem 1.1. Let t > 0 and $n \in \mathbb{N}$ be given. For sufficiently large prime number p, we have

$$\sum_{f \in H_2(q)} \frac{S(t, f)^n}{4\pi \langle f, f \rangle} = C_n (\log \log q)^{n/2} + O_{t,n} ((\log \log q)^{(n-1)/2}),$$

where C_n is defined by

$$C_n = \begin{cases} \frac{n!}{(n/2)!(2\pi)^n}, & \text{if } n \text{ is even,} \\ 0, & \text{if } n \text{ is odd.} \end{cases}$$

Remark 1. For a holomorphic Hecke cusp form f with weight 2 and level prime number q, Theorem 1.1 and Lemma 2.3 indicate that |S(t, f)| on average has order of magnitude $\sqrt{\log \log q}$.

It is another interesting problem to consider the following probability measure μ_q on \mathbb{R} , defined by

$$\mu_q(E) := \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \mathbf{1}_E \left(\frac{S(t, f)}{\sqrt{\log \log q}} \right) \right) / \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \right),$$

where $\mathbf{1}_E$ is the characteristic function on a Borel measurable set E in \mathbb{R} . As a consequence of Theorem 1.1, we obtain the following weighted central limit theorem.

Theorem 1.2. As $q \to \infty$, the probability measure μ_q converges to the Gaussian distribution of mean 0 and variance $(2\pi^2)^{-1}$; that is

$$\lim_{q \to \infty} \mu_q([a, b]) = \sqrt{\pi} \int_a^b \exp(-\pi^2 \xi^2) d\xi$$

for any a < b.

Notation. Throughout the paper, ε and A are arbitrarily small and arbitrarily large positive real numbers, which may be different at each occurrence. As usual, $e(z) = \exp(2\pi i z) = e^{2\pi i z}$. We write f = O(g) or $f \ll g$ to mean $|f| \leqslant cg$ for some unspecified positive constant c. The sign \overline{a} denotes the multiplicative inverse of $a \pmod{r}$.

2. Preliminaries

We firstly collect some classical results as the beginning of this section.

Lemma 2.1. Let $x \ge 2$.

(1) There exist constants c_1 and c_2 , such that

$$\sum_{p \le x} \frac{1}{p} = \log \log x + c_1 + O(e^{c_2 \sqrt{\log x}}). \tag{2.1}$$

(2) We have

$$\sum_{p \leqslant x} \frac{\log p}{p} = \log x + O(1),$$

and

$$\sum_{p \leqslant x} \frac{(\log p)^2}{p} \ll (\log x)^2. \tag{2.2}$$

The Petersson trace formula is given by the following basic orthogonality relation on $H_2(q)$ (see e.g., Kowalski-Michel [8]).

Lemma 2.2. Let $m, n \ge 1$. Then

$$\sum_{f \in H_2(q)} \omega_f \cdot \lambda_f(m) \lambda_f(n) = \delta_{m,n} - 2\pi \sum_{c \equiv 0 \pmod{q}} \frac{S(m,n;c)}{c} J_1\left(\frac{4\pi\sqrt{mn}}{c}\right),$$

where J_1 is the Bessel function and S(m,n;c) is a classical Kloosterman sum,

$$\omega_f := \frac{1}{4\pi \langle f, f \rangle} = \frac{\zeta(2)}{|H_2(q)|} \cdot \frac{1}{L(1, \operatorname{sym}^2 f)} \cdot \left(1 + O\left(\frac{(\log q)^4}{q}\right)\right)$$

is the harmonic weight of f.

We record here some properties of Bessel functions will be used. The Bessel function of the first kind, $J_{\nu}(x)$ with $\nu \in \mathbb{C}$, has Taylor series about zero given by (see [3, pg. 918, Eq. 8.440])

$$J_{\nu}(x) = \left(\frac{x}{2}\right)^{\nu} \sum_{m=0}^{\infty} \frac{(-1)^m}{m!\Gamma(\nu+1+m)} \left(\frac{x}{2}\right)^{2m}.$$

Specializing to $\nu = k - 1$ with $k \ge 1$, we have the following bound for x > 0,

$$J_{k-1}(x) \ll_k \begin{cases} x^{k-1}, & \text{if } x \leq 1, \\ x^{-1/2}, & \text{if } x > 1. \end{cases}$$
 (2.3)

By a general bound for Kloosterman sums (see e.g., [7, (2.13)])

$$|S(m, n; c)| \le (m, n, c) \min \left\{ \frac{c}{(n, c)}, \frac{c}{(m, c)} \right\}^{\frac{1}{2}} \tau(c),$$

and the bound $J_1(x) \ll x$ for J-Bessel function, we derive (see e.g., [7, Corollary 2.3])

Lemma 2.3. For any integers $m, n \ge 1$ with $6\pi\sqrt{mn} \le q$, we have

$$\sum_{f \in H_2(q)} \omega_f \cdot \lambda_f(m) \lambda_f(n) = \delta_{m,n} + O\left(q^{-3/2} \frac{(m,n,q)(mn)^{1/2}}{\left((m,q) + (n,q)\right)^{1/2}} (\tau(m,n))\right).$$

We will need the following weighted version of zero-density estimate which was established by Kowalski-Michel [9, Theorem 4].

Lemma 2.4. Let q be a prime number and

$$N(f; \sigma, T) := \#\{\rho = \beta + i\gamma \mid L(\rho, f) = 0, \sigma < \beta, |\gamma| < T\}.$$

There exists an absolute constant A>0 such that for any real number T with $T\geqslant \frac{1}{\log q}$, for any $\frac{1}{2}+\frac{1}{\log q}\leqslant\sigma\leqslant 1$, and for any $c,\ 0< c<\frac{1}{2}$, one has

$$\sum_{f \in H_2(q)} \omega_f \cdot N(f; \sigma, T) \ll (1+T)^A q^{-2c(\sigma-1/2)} (\log q) T,$$

where the implied constant depends only on c.

Finally, we need the lemma of the theory of moments in probability theory (see, for example, [1, Theorem 30.2]).

Lemma 2.5. Suppose that the distribution of random variable X is determined by its moments, that the X_n have moments of all orders, and that $\lim_n E[X_n^r] = E[X^r]$ for $r = 1, 2, \cdots$. Then $X_n \Rightarrow X$.

3. An approximation of S(t, f)

In this section we will prove several lemmas and derive an approximation of S(t, f). We denote by $\rho = \beta + i\gamma$ a typical zero of L(s, f) inside the critical strip, i.e., $0 < \beta < 1$. For Re(s) > 1, we have the Dirichlet series expansion for the logarithmic derivative of L(s, f),

$$-\frac{L'}{L}(s,f) = \sum_{n=1}^{\infty} \frac{\Lambda(n)C_f(n)}{n^s},\tag{3.1}$$

where $\Lambda(n)$ denotes the von Mangoldt function, and

$$C_f(n) = \begin{cases} \alpha_f(p)^m + \beta_f(p)^m, & \text{if } n = p^m, \\ 0, & \text{otherwise.} \end{cases}$$
(3.2)

Lemma 3.1. Let x > 1. For $s \neq \rho$, and $s \neq -m - \frac{1}{2}$, we have the following identity

$$\frac{L'}{L}(s,f) = -\sum_{n \le x^3} \frac{C_f(n)\Lambda_x(n)}{n^s} - \frac{1}{\log^2 x} \sum_{\rho} \frac{x^{\rho-s}(1-x^{\rho-s})^2}{(\rho-s)^3} - \frac{1}{\log^2 x} \sum_{m=0}^{\infty} \frac{x^{-m-\frac{1}{2}-s}(1-x^{-m-\frac{1}{2}-s})^2}{(-m-\frac{1}{2}-s)^3},$$

where

$$\Lambda_{x}(n) = \begin{cases}
\Lambda(n), & \text{if } n \leq x, \\
\Lambda(n) \frac{\log^{2}(x^{3}/n) - 2\log^{2}(x^{2}/n)}{2\log^{2}x}, & \text{if } x \leq n \leq x^{2}, \\
\Lambda(n) \frac{\log^{2}(x^{3}/n)}{2\log^{2}x}, & \text{if } x^{2} \leq n \leq x^{3}, \\
0, & \text{if } n \geqslant x^{3}.
\end{cases}$$

Proof. Recall the discontinuous integral

$$\frac{1}{2\pi i} \int_{(\alpha)} \frac{y^s}{s^3} ds = \begin{cases} \frac{\log^2 y}{2}, & \text{if } y \geqslant 1, \\ 0, & \text{if } 0 < y \leqslant 1 \end{cases}$$

for $\alpha > 0$. It follows from (3.1) and (3.2) that

$$-\log^2 x \sum_{n=1}^{\infty} \frac{C_f(n)\Lambda_x(n)}{n^s} = \frac{1}{2\pi i} \int_{(\alpha)} \frac{x^u (1-x^u)^2}{u^3} \frac{L'}{L} (s+u, f) du,$$

where $\alpha = \max\{2, 1 + \text{Re}(s)\}$. By moving the line of integration all way to the left, we pick up the residues at u = 0, $u = \rho - s$ and $u = -m - \frac{1}{2} - s$ $(m = 0, 1, 2, \dots)$, and deduce that

$$\frac{1}{2\pi i} \int_{(\alpha)} \frac{x^u (1 - x^u)^2}{u^3} \frac{L'}{L} (s + u, f) du$$

$$= \frac{L'}{L} (s, f) \log^2 x + \sum_{\rho} \frac{x^{\rho - s} (1 - x^{\rho - s})^2}{(\rho - s)^3} + \sum_{m=0}^{\infty} \frac{x^{-m - \frac{1}{2} - s} (1 - x^{-m - \frac{1}{2} - s})^2}{(-m - \frac{1}{2} - s)^3}.$$

Thus we complete the proof of lemma.

Lemma 3.2. For $s = \sigma + it$, $s' = \sigma' + it'$ such that $1/2 \leqslant \sigma, \sigma' \leqslant 10$, $s \neq \rho$, $s' \neq \rho$, we have

$$\operatorname{Im}\left(\frac{L'}{L}(s,f) - \frac{L'}{L}(s',f)\right) = \operatorname{Im}\sum_{\rho}\left(\frac{1}{s-\rho} - \frac{1}{s'-\rho}\right) + O(1),$$

and

$$\operatorname{Re}\frac{L'}{L}(s,f) = \sum_{\alpha} \frac{\sigma - \beta}{(\sigma - \beta)^2 + (t - \gamma)^2} + O(\log(|t| + q)). \tag{3.3}$$

Proof. By the Hadamard factorization theorem of the entire function $\Lambda(s, f)$, we have

$$\frac{L'}{L}(s,f) = b(f) + \sum_{\rho} \left(\frac{1}{s-\rho} + \frac{1}{\rho} \right) - \frac{\Gamma'(s+1/2)}{\Gamma(s+1/2)} - \frac{1}{2} \log q + \log(2\pi),$$

for some $b \in \mathbb{C}$ with $\text{Re}(b(f)) = -\text{Re}\sum_{\rho} \frac{1}{\rho}$ (see [6, Proposition 5.7 (3)]). Note that for $z \notin -\mathbb{N}$,

$$\frac{\Gamma'}{\Gamma}(z) = -\gamma + \sum_{k \ge 1} \left(\frac{1}{k} - \frac{1}{k - 1 + z} \right),\tag{3.4}$$

where γ is the Euler constant. Using (3.4), we get that for $\frac{1}{4} \leq u$,

$$\operatorname{Im} \frac{\Gamma'}{\Gamma}(u+iv) = \sum_{k>1} \frac{v}{(k+u-1)^2 + v^2} \ll 1.$$

And for $|\arg z| \leq \pi - \varepsilon$,

$$\frac{\Gamma'}{\Gamma}(z) = \log z - \frac{1}{2z} + O_{\varepsilon} \left(\frac{1}{|z|^2} \right),\,$$

thus we complete the proof of lemma.

Let $x \ge 4$, we define

$$\sigma_x = \sigma_{x,f} = \sigma_{x,f,t} := \frac{1}{2} + 2\max\left\{ \left| \beta - \frac{1}{2} \right|, \frac{5}{\log x} \right\},\tag{3.5}$$

where $\rho = \beta + i\gamma$ runs through the zeros of L(s, f) for which

$$|t - \gamma| \leqslant \frac{x^{3|\beta - 1/2|}}{\log x}.\tag{3.6}$$

Lemma 3.3. Let $x \ge 4$. For $\sigma \ge \sigma_x$, we have

$$\frac{L'}{L}(\sigma+it,f) = -\sum_{n \leqslant x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma+it}} + O\left(x^{1/4-\sigma/2} \left| \sum_{n \leqslant x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x+it}} \right| \right) + O\left(x^{1/4-\sigma/2} \log(|t|+q)\right),$$

and

$$\sum_{\rho} \frac{\sigma_x - 1/2}{(\sigma_x - \beta)^2 + (t - \gamma)^2} = O\left(\left|\sum_{n \le x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it}}\right|\right) + O\left(\log(|t| + q)\right).$$

Proof. This proof follows [11, Lemma 4.3] closely, and we give the details here for completeness. By (3.3), we have

$$\operatorname{Re}\frac{L'}{L}(\sigma_x + it, f) = \sum_{q} \frac{\sigma_x - \beta}{(\sigma_x - \beta)^2 + (t - \gamma)^2} + O(\log(|t| + q)). \tag{3.7}$$

Moreover, if $\rho = \beta + i\gamma$ is zero of L(s, f), then $(1 - \beta) + i\gamma$ is also a zero of L(s, f). Thus we have

$$\sum_{\rho} \frac{\sigma_{x} - \beta}{(\sigma_{x} - \beta)^{2} + (t - \gamma)^{2}}$$

$$= \frac{1}{2} \left(\sum_{\rho} \frac{\sigma_{x} - \beta}{(\sigma_{x} - \beta)^{2} + (t - \gamma)^{2}} + \sum_{\rho} \frac{\sigma_{x} - (1 - \beta)}{(\sigma_{x} - (1 - \beta))^{2} + (t - \gamma)^{2}} \right)$$

$$= \left(\sigma_{x} - \frac{1}{2} \right) \sum_{\rho} \frac{(\sigma_{x} - 1/2)^{2} - (\beta - 1/2)^{2} + (t - \gamma)^{2}}{((\sigma_{x} - \beta)^{2} + (t - \gamma)^{2})((\sigma_{x} - 1 + \beta)^{2} + (t - \gamma)^{2})}.$$
(3.8)

If $|\beta - 1/2| \le \frac{\sigma_x - 1/2}{2}$, then

$$(\sigma_x - 1/2)^2 - (\beta - 1/2)^2 \ge \frac{1}{2} ((\sigma_x - 1/2)^2 + (\beta - 1/2)^2)$$
$$= \frac{1}{4} ((\sigma_x - \beta)^2 + (\sigma_x - 1 + \beta)^2).$$

Thus,

$$(\sigma_x - 1/2)^2 - (\beta - 1/2)^2 + (t - \gamma)^2 \geqslant \frac{1}{4} ((\sigma_x - 1 + \beta)^2 + (t - \gamma)^2). \tag{3.9}$$

If $|\beta - 1/2| > \frac{\sigma_x - 1/2}{2}$, then by (3.5) and (3.6) we have

$$|t - \gamma| > \frac{x^{3|\beta - 1/2|}}{\log x} > 3|\beta - 1/2|.$$

Thus,

$$(\sigma_{x} - 1/2)^{2} - (\beta - 1/2)^{2} + (t - \gamma)^{2}$$

$$= ((\sigma_{x} - 1/2)^{2} + (\beta - 1/2)^{2}) + (t - \gamma)^{2} - 2(\beta - 1/2)^{2}$$

$$\geqslant \frac{1}{2}((\sigma_{x} - \beta)^{2} + (\sigma_{x} - 1 + \beta)^{2}) + \frac{7}{9}(t - \gamma)^{2}$$

$$\geqslant \frac{1}{4}((\sigma_{x} - 1 + \beta)^{2} + (t - \gamma)^{2}).$$
(3.10)

Combining (3.9), (3.10) and (3.8), we have

$$\sum_{\rho} \frac{\sigma_x - \beta}{(\sigma_x - \beta)^2 + (t - \gamma)^2} \ge \frac{1}{4} (\sigma_x - 1/2) \sum_{\rho} \frac{1}{((\sigma_x - \beta)^2 + (t - \gamma)^2)}.$$

Using this bound and (3.7), we obtain

$$\sum_{\alpha} \frac{1}{((\sigma_x - \beta)^2 + (t - \gamma)^2)} \le \frac{4}{\sigma_x - 1/2} \left| \frac{L'}{L} (\sigma_x + it, f) \right| + O\left(\frac{\log(|t| + q)}{\sigma_x - 1/2} \right). \tag{3.11}$$

On the other hand, by Lemma 3.1, we have

$$\frac{L'}{L}(\sigma + it, f) = -\sum_{n \le x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma + it}} + \frac{w(x, \sigma, t)}{\log^2 x} \sum_{\rho} \frac{x^{\beta - \sigma}(1 + x^{\beta - \sigma})^2}{\left((\sigma - \beta)^2 + (t - \gamma)^2\right)^{3/2}} + O\left(\frac{x^{-1/2 - \sigma}}{\log^2 x}\right),$$
(3.12)

with $|w(x, \sigma, t)| \leq 1$. Next we claim that

$$\frac{x^{\beta-\sigma}(1+x^{\beta-\sigma})^2}{\left((\sigma-\beta)^2+(t-\gamma)^2\right)^{3/2}} \le 2\log x \frac{x^{1/4-\sigma/2}}{(\beta-\sigma_x)^2+(t-\gamma)^2}.$$
(3.13)

If $\beta \leqslant \frac{\sigma_x + 1/2}{2}$, then we have

$$\frac{x^{\beta-\sigma}(1+x^{\beta-\sigma})^{2}}{\left((\sigma-\beta)^{2}+(t-\gamma)^{2}\right)^{3/2}} \leqslant \frac{4x^{1/4-\sigma/2}}{(\sigma_{x}-\beta)\left((\sigma_{x}-\beta)^{2}+(t-\gamma)^{2}\right)}$$

$$\leqslant \frac{8}{\sigma_{x}-1/2} \frac{x^{1/4-\sigma/2}}{\left((\sigma_{x}-\beta)^{2}+(t-\gamma)^{2}\right)}$$

$$\leqslant \frac{4}{5} \log x \frac{x^{1/4-\sigma/2}}{\left((\sigma_{x}-\beta)^{2}+(t-\gamma)^{2}\right)}.$$

If $\beta > \frac{\sigma_x + 1/2}{2}$, then we have

$$|t - \gamma| > \frac{x^{3|\beta - 1/2|}}{\log x} > 3|\beta - 1/2| \ge 3|\beta - \sigma_x|.$$

Thus,
$$(t - \gamma)^2 > \frac{8}{9} ((\beta - \sigma_x)^2 + (t - \gamma)^2)$$
. Hence
$$\frac{x^{\beta - \sigma} (1 + x^{\beta - \sigma})^2}{((\sigma - \beta)^2 + (t - \gamma)^2)^{3/2}} \le \frac{x^{\beta - \sigma} (1 + x^{\beta - 1/2})^2}{|t - \gamma|(t - \gamma)^2} \le \frac{\log x}{x^{3|\beta - 1/2|}} \frac{9}{8} \frac{x^{\beta - \sigma} (1 + x^{\beta - 1/2})^2}{(\beta - \sigma_x)^2 + (t - \gamma)^2}$$

$$= \frac{9}{8} (\log x) (1 + x^{-(\beta - 1/2)})^2 \frac{x^{1/2 - \sigma}}{(\sigma_x - \beta)^2 + (t - \gamma)^2}$$

$$\le \frac{9}{8} (\log x) (1 + e^{-5})^2 \frac{x^{1/2 - \sigma}}{(\sigma_x - \beta)^2 + (t - \gamma)^2}$$

$$< 2(\log x) \frac{x^{1/2 - \sigma}}{(\sigma_x - \beta)^2 + (t - \gamma)^2}.$$

Using (3.11) and (3.13), we have

$$\sum_{\rho} \frac{x^{\beta-\sigma} (1+x^{\beta-\sigma})^2}{\left((\sigma-\beta)^2 + (t-\gamma)^2 \right)^{3/2}}$$

$$\leq 8 \log x \frac{x^{1/4-\sigma/2}}{\sigma_x - 1/2} \left| \frac{L'}{L} (\sigma_x + it, f) \right| + O\left(\frac{(\log x) x^{1/4-\sigma/2} \log(|t| + q)}{\sigma_x - 1/2} \right)$$

$$\leq \frac{4}{5} (\log x)^2 x^{1/4-\sigma/2} \left| \frac{L'}{L} (\sigma_x + it, f) \right| + O\left((\log x)^2 x^{1/4-\sigma/2} \log(|t| + q) \right).$$

Inserting this bound into (3.12), we have

$$\frac{L'}{L}(\sigma + it, f) = -\sum_{n \le x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma + it}} + \frac{4}{5}w'(x, \sigma, t)x^{1/4 - \sigma/2} \left| \frac{L'}{L}(\sigma_x + it, f) \right| + O\left(x^{1/4 - \sigma/2} \log(|t| + q)\right),$$
(3.14)

with $|w'(x, \sigma, t)| \leq 1$. By taking $\sigma = \sigma_x$,

$$\left(1 - \frac{4}{5}w'(x, \sigma_x, t)x^{1/4 - \sigma_x/2}\right) \frac{L'}{L}(\sigma_x + it, f) = O\left(\left|\sum_{n \leqslant x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it}}\right|\right) + O\left(x^{1/4 - \sigma_x/2}\log(|t| + q)\right).$$

Since $\left|1 - \frac{4}{5}w'(x, \sigma_x, t)x^{1/4 - \sigma_x/2}\right| \ge 1 - \left|\frac{4}{5}w'(x, \sigma_x, t)x^{1/4 - \sigma_x/2}\right| \ge \frac{1}{5}$, we have

$$\frac{L'}{L}(\sigma_x + it, f) = O\left(\left|\sum_{n \le x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it}}\right|\right) + O\left(x^{1/4 - \sigma_x/2}\log(|t| + q)\right). \tag{3.15}$$

Inserting (3.15) into (3.14) and (3.11), respectively, we complete the proof of lemma.

The following theorem provides an approximation of S(t, f).

Theorem 3.4. For $t \neq 0$, and $x \geq 4$, we have

$$S(t,f) = \frac{1}{\pi} \operatorname{Im} \sum_{n \leq x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it} \log n} + O\left((\sigma_x - 1/2) \left| \sum_{n \leq x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it}} \right| \right) + O\left((\sigma_x - 1/2) \log(|t| + q)\right),$$

where σ_x is defined by (3.5).

Proof. We have

$$\pi S(t,f) = -\int_{1/2}^{\infty} \operatorname{Im} \frac{L'}{L} (\sigma + it, f) d\sigma$$

$$= -\int_{\sigma_x}^{\infty} \operatorname{Im} \frac{L'}{L} (\sigma + it, f) d\sigma - (\sigma_x - 1/2) \operatorname{Im} \frac{L'}{L} (\sigma_x + it, f)$$

$$+ \int_{1/2}^{\sigma_x} \operatorname{Im} \left(\frac{L'}{L} (\sigma_x + it, f) - \frac{L'}{L} (\sigma + it, f) \right) d\sigma$$

$$=: J_1 + J_2 + J_3.$$

By Lemma 3.3, we have

$$J_{1} = -\int_{\sigma_{x}}^{\infty} \operatorname{Im} \frac{L'}{L}(\sigma + it, f) d\sigma$$

$$= \int_{\sigma_{x}}^{\infty} \operatorname{Im} \sum_{n \leq x^{3}} \frac{C_{f}(n)\Lambda_{x}(n)}{n^{\sigma + it}} d\sigma + O\left(\left|\sum_{n \leq x^{3}} \frac{C_{f}(n)\Lambda_{x}(n)}{n^{\sigma_{x} + it}}\right| \int_{\sigma_{x}}^{\infty} x^{1/4 - \sigma/2} d\sigma\right)$$

$$+ O\left(\log(|t| + q) \int_{\sigma_{x}}^{\infty} x^{1/4 - \sigma/2} d\sigma\right)$$

$$= \operatorname{Im} \sum_{n \leq x^{3}} \frac{C_{f}(n)\Lambda_{x}(n)}{n^{\sigma_{x} + it} \log n} + O\left(\frac{1}{\log x} \left|\sum_{n \leq x^{3}} \frac{C_{f}(n)\Lambda_{x}(n)}{n^{\sigma_{x} + it}}\right|\right) + O\left(\frac{\log(|t| + q)}{\log x}\right).$$

Taking $\sigma = \sigma_x$ in Lemma 3.3, we have

$$J_2 \leq (\sigma_x - 1/2) \left| \frac{L'}{L} (\sigma_x + it, f) \right|$$

$$\ll (\sigma_x - 1/2) \left| \sum_{n \leq x^3} \frac{C_f(n) \Lambda_x(n)}{n^{\sigma_x + it}} \right| + (\sigma_x - 1/2) \log(|t| + q).$$

We apply Lemma 3.2 to bound J_3 and get

$$\operatorname{Im}\left(\frac{L'}{L}(\sigma_x + it, f) - \frac{L'}{L}(\sigma + it, f)\right)$$

$$= \sum_{\rho} \frac{(\sigma_x - \sigma)(\sigma + \sigma_x - 2\beta)(t - \gamma)}{\left((\sigma_x - \beta)^2 + (t - \gamma)^2\right)\left((\sigma - \beta)^2 + (t - \gamma)^2\right)} + O(1).$$

Hence

$$|J_{3}| \leq \sum_{\rho} \int_{1/2}^{\sigma_{x}} \frac{(\sigma_{x} - \sigma)|\sigma + \sigma_{x} - 2\beta||t - \gamma|}{((\sigma_{x} - \beta)^{2} + (t - \gamma)^{2})((\sigma - \beta)^{2} + (t - \gamma)^{2})} d\sigma + O(\sigma_{x} - 1/2)$$

$$\leq \sum_{\rho} \frac{\sigma_{x} - 1/2}{(\sigma_{x} - \beta)^{2} + (t - \gamma)^{2}} \int_{1/2}^{\sigma_{x}} \frac{|\sigma + \sigma_{x} - 2\beta||t - \gamma|}{(\sigma - \beta)^{2} + (t - \gamma)^{2}} d\sigma + O(\sigma_{x} - 1/2).$$

If
$$|\beta - 1/2| \le \frac{1}{2}(\sigma_x - 1/2)$$
, then for $1/2 \le \sigma \le \sigma_x$,
 $|\sigma + \sigma_x - 2\beta| = |(\sigma - 1/2) + (\sigma_x - 1/2) - 2(\beta - 1/2)|$
 $\le |\sigma - 1/2| + |\sigma_x - 1/2| + 2|\beta - 1/2| \le 3|\sigma_x - 1/2|$.

Thus,

$$\int_{1/2}^{\sigma_x} \frac{|\sigma + \sigma_x - 2\beta||t - \gamma|}{(\sigma - \beta)^2 + (t - \gamma)^2} d\sigma \leqslant 3(\sigma_x - 1/2) \int_{-\infty}^{\infty} \frac{|t - \gamma|}{(\sigma - \beta)^2 + (t - \gamma)^2} d\sigma \leqslant 10(\sigma_x - 1/2).$$

If $|\beta - 1/2| > \frac{1}{2}(\sigma_x - 1/2)$, then

$$|t - \gamma| > \frac{x^{3|\beta - 1/2|}}{\log x} > 3|\beta - 1/2|$$

and for $1/2 \leq \sigma \leq \sigma_x$,

$$|\sigma + \sigma_x - 2\beta| \le |\sigma - 1/2| + |\sigma_x - 1/2| + 2|\beta - 1/2| \le 3|\sigma_x - 1/2| \le 6|\beta - 1/2|.$$

Thus,

$$\int_{1/2}^{\sigma_x} \frac{|\sigma + \sigma_x - 2\beta||t - \gamma|}{(\sigma - \beta)^2 + (t - \gamma)^2} d\sigma < \int_{1/2}^{\sigma_x} \frac{|\sigma + \sigma_x - 2\beta|}{|t - \gamma|} d\sigma$$

$$\leq \int_{1/2}^{\sigma_x} \frac{6|\beta - 1/2|}{3|\beta - 1/2|} d\sigma = 2(\sigma_x - 1/2).$$

By Lemma 3.3, we obtain

$$|J_3| \leq 10(\sigma_x - 1/2) \sum_{\rho} \frac{\sigma_x - 1/2}{(\sigma_x - \beta)^2 + (t - \gamma)^2} + O(\sigma_x - 1/2)$$

$$= O\left((\sigma_x - 1/2) \left| \sum_{n \leq x^3} \frac{C_f(n)\Lambda_x(n)}{n^{\sigma_x + it}} \right| \right) + O\left((\sigma_x - 1/2)\log(|t| + q)\right).$$

Thus we complete the proof of lemma.

Theorem 3.5. Under the GRH, we have

$$S(t, f) \ll \frac{\log(|t| + q)}{\log\log(|t| + q)}.$$

Proof. We have $\sigma_x = \frac{1}{2} + \frac{10}{\log x}$ by mean of the GRH. By (1.3),

$$|C_f(p^m)\Lambda_x(p^m)| \ll \log p.$$

Thus,

$$\left| \operatorname{Im} \sum_{n \leq x^3} \frac{C_f(n) \Lambda_x(n)}{n^{\sigma_x + it} \log n} \right| \ll \sum_{n \leq x^3} p^{-1/2} \ll \frac{x^{3/2}}{\log x},$$

and

$$(\sigma_x - 1/2) \left| \sum_{n \le x^3} \frac{C_f(n) \Lambda_x(n)}{n^{\sigma_x + it}} \right| \ll \frac{1}{\log x} \sum_{p \le x^3} p^{-1/2} \log p \ll \frac{x^{3/2}}{\log x}.$$

Then the theorem follows by taking $x = (\log(|t| + q))^{2/3}$ in Theorem 3.4.

4. Proof of Theorems 1.1 and 1.2

Lemma 4.1. Let t > 0 be given. For prime number q sufficiently large and $x = q^{\delta/3}$ with $0 < \delta < \frac{6c}{8n+3A+3}$, we have

$$\sum_{f \in H_2(q)} \frac{(\sigma_{x,f} - 1/2)^{4n} x^{4n(\sigma_{x,f} - 1/2)}}{4\pi \langle f, f \rangle} \ll_{t,n,\delta,A} \frac{1}{(\log q)^{4n}},$$

where $\sigma_{x,f}$ is defined by (3.5), c and A are as in Lemma 2.4.

Proof. By the definition of $\sigma_{x,f}$,

$$(\sigma_{x,f} - 1/2)^{4n} x^{4n(\sigma_{x,f} - 1/2)}$$

$$\leq \left(\frac{10}{\log x}\right)^{4n} x^{40n/\log x} + 2^{4n+1} \sum_{\substack{\beta > \frac{1}{2} + \frac{5}{\log x} \\ |t - \gamma| \leq \frac{x^{3|\beta - 1/2|}}{\log x}}} (\beta - 1/2)^{4n} x^{8n(\beta - 1/2)}.$$

On the other hand,

$$\sum_{\substack{\beta > \frac{1}{2} + \frac{5}{\log x} \\ |t - \gamma| \leqslant \frac{x^{3|\beta - 1/2|}}{\log x}}} (\beta - 1/2)^{4n} x^{8n(\beta - 1/2)}$$

$$\leqslant \sum_{j=5}^{\frac{1}{2} \lfloor \log x \rfloor} \left(\frac{j+1}{\log x} \right)^{4n} x^{8n \frac{j+1}{\log x}} \sum_{\substack{\frac{1}{2} + \frac{j}{\log x} < \beta \leqslant \frac{1}{2} + \frac{j+1}{\log x} \\ |t - \gamma| \leqslant \frac{x^{3|\beta - 1/2|}}{\log x}}} 1$$

$$\leqslant \frac{1}{(\log x)^{4n}} \sum_{j=5}^{\frac{1}{2} \lfloor \log x \rfloor} (j+1)^{4n} e^{8n(j+1)} N\left(f; \frac{1}{2} + \frac{j}{\log x}, |t| + \frac{e^{3(j+1)}}{\log x}\right).$$

By Lemma 2.4, there exists an absolute constant A > 0 such that

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \sum_{\beta > \frac{1}{2} + \frac{5}{\log x} \atop |t - \gamma| \leq \frac{x^{3|\beta - 1/2|}}{\log x}} (\beta - 1/2)^{4n} x^{8n(\beta - 1/2)}$$

$$\leq \frac{1}{(\log x)^{4n}} \sum_{j=5}^{\frac{1}{2} \lfloor \log x \rfloor} (j+1)^{4n} e^{8n(j+1)} \sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} N\left(f; \frac{1}{2} + \frac{j}{\log x}, |t| + \frac{e^{3(j+1)}}{\log x}\right)$$

$$\ll \frac{1}{(\log x)^{4n}} \sum_{j=5}^{\infty} (j+1)^{4n} e^{8n(j+1)} \left(1 + |t| + \frac{e^{3(j+1)}}{\log x}\right)^A q^{-2c\frac{j}{\log x}} \left(|t| + \frac{e^{3(j+1)}}{\log x}\right) \log q$$

$$\ll_{t,n,A,\delta} \frac{\log q}{(\log x)^{4n+A+1}} \sum_{j=5}^{\infty} (j+1)^{4n} e^{(8n+3A+3-\frac{6c}{\delta})j}$$

$$\ll_{t,n,A,\delta} \frac{1}{(\log q)^{4n}}$$

provided that $0 < \delta < \frac{6c}{8n+3A+3}$. In addition, by Lemma 2.3,

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left(\frac{10}{\log x} \right)^{4n} x^{40n/\log x} \ll \frac{1}{(\log x)^{4n}} \ll \frac{1}{(\log q)^{4n}}.$$

Thus we complete the proof of lemma.

For a positive parameter x (to be chosen later), let

$$M(t,f) := \frac{1}{\pi} \operatorname{Im} \sum_{p \le x^3} \frac{C_f(p)}{p^{1/2+it}}, \text{ and } R(t,f) := S(t,f) - M(t,f),$$

where $C_f(p) = \alpha_f(p) + \beta_f(p) = \lambda_f(p)$.

Lemma 4.2. We have

$$R(t,f) = O\left(\left| \text{Im} \sum_{p \leqslant x^3} \frac{C_f(p)(\Lambda_x(p) - \Lambda(p))}{p^{1/2 + it} \log p} \right| \right) + O\left(\left| \text{Im} \sum_{p \leqslant x^{3/2}} \frac{C_f(p^2)\Lambda_x(p^2)}{p^{1 + 2it} \log p} \right| \right) + O\left((\sigma_x - 1/2)x^{\sigma_x - 1/2} \int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma\right) + O((\sigma_x - 1/2) \log(|t| + q)) + O(1).$$

Proof. By Theorem 3.4,

$$\begin{split} R(t,f) &= S(t,f) - M(t,f) \\ &= \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^3} \frac{C_f(p) (\Lambda_x(p) p^{1/2 - \sigma_x} - \Lambda(p))}{p^{1/2 + it} \log p} + \frac{1}{\pi} \operatorname{Im} \sum_{m=2}^{\infty} \sum_{p^m \leqslant x^3} \frac{C_f(p^m) \Lambda_x(p^m)}{p^{m(\sigma_x + it)} \log p^m} \\ &+ O\left((\sigma_x - 1/2) \left| \sum_{m=1}^{\infty} \sum_{p^m \leqslant x^3} \frac{C_f(p^m) \Lambda_x(p^m)}{p^{m(\sigma_x + it)}} \right| \right) + O\left((\sigma_x - 1/2) \log(|t| + q) \right). \end{split}$$

Using the bound (1.3), we deduce that

$$\sum_{m=3}^{\infty} \sum_{p^m \leqslant x^3} \frac{C_f(p^m) \Lambda_x(p^m)}{p^{m(\sigma_x + it)}} = O(1), \quad \text{and} \quad \sum_{m=3}^{\infty} \sum_{p^m \leqslant x^3} \frac{C_f(p^m) \Lambda_x(p^m)}{p^{m(\sigma_x + it)} \log p} = O(1).$$

Note that

$$\left(\sigma_{x} - 1/2\right) \left| \sum_{p \leqslant x^{3/2}} \frac{C_{f}(p^{2})\Lambda_{x}(p^{2})}{p^{2(\sigma_{x} + it)}} \right| \ll \left(\sigma_{x} - 1/2\right) \sum_{p \leqslant x^{3/2}} \frac{\log p}{p}$$

$$\ll \left(\sigma_{x} - 1/2\right) \log x \ll (\sigma_{x} - 1/2) \log q.$$

Thus,

$$R(t,f) = \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^3} \frac{C_f(p)(\Lambda_x(p) - \Lambda(p))}{p^{1/2 + it} \log p} - \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)(1 - p^{1/2 - \sigma_x})}{p^{1/2 + it} \log p}$$

$$+ \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^{3/2}} \frac{C_f(p^2)\Lambda_x(p^2)}{p^{1 + 2it} \log p^2} + \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^{3/2}} \frac{C_f(p^2)\Lambda_x(p^2)(p^{1 - 2\sigma_x} - 1)}{p^{1 + 2it} \log p^2}$$

$$+ O\left((\sigma_x - 1/2) \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)}{p^{\sigma_x + it}} \right| \right) + O\left((\sigma_x - 1/2) \log(|t| + q)\right) + O(1).$$

Note that for $1/2 \leq a \leq \sigma_x$,

$$\left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)}{p^{a+it}} \right| = x^{a-1/2} \left| \int_a^\infty x^{1/2-\sigma} \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} d\sigma \right|$$

$$\leqslant x^{\sigma_x - 1/2} \int_{1/2}^\infty x^{1/2-\sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} \right| d\sigma.$$

Thus,

$$\left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)(1-p^{1/2-\sigma_x})}{p^{1/2+it}\log p} \right| = \left| \int_{1/2}^{\sigma_x} \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)}{p^{a+it}} da \right|$$

$$\leqslant (\sigma_x - 1/2)x^{\sigma_x - 1/2} \int_{1/2}^{\infty} x^{1/2-\sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} \right| d\sigma,$$

and

$$\left| (\sigma_x - 1/2) \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p)}{p^{\sigma_x + it}} \right| \leqslant (\sigma_x - 1/2) x^{\sigma_x - 1/2} \int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma.$$

Moreover,

$$\left| \sum_{p \leqslant x^{3/2}} \frac{C_f(p^2) \Lambda_x(p^2) (p^{1-2\sigma_x} - 1)}{p^{1+2it} \log p} \right| \ll \sum_{p \leqslant x^{3/2}} \frac{1}{p} (1 - p^{1-2\sigma_x}) \ll \sum_{p \leqslant x^{3/2}} (\sigma_x - 1/2) \frac{\log p}{p}$$

$$\ll (\sigma_x - 1/2) \log q.$$

Thus we complete the proof of lemma.

Proposition 4.3. Let t > 0 be given. For prime number q sufficiently large and $x = q^{\delta/3}$ with sufficiently small $\delta > 0$, we have

$$\sum_{f \in H_2(q)} \frac{M(t, f)^n}{4\pi \langle f, f \rangle} = C_n(\log \log q)^{n/2} + O_{t,n}((\log \log q)^{n/2-1}), \tag{4.1}$$

and

$$\sum_{f \in H_2(q)} \frac{|R(t,f)|^{2n}}{4\pi \langle f, f \rangle} = O_{t,n}(1). \tag{4.2}$$

Here C_n is defined by

$$C_n = \begin{cases} \frac{n!}{(n/2)!(2\pi)^n}, & \text{if } n \text{ is even,} \\ 0, & \text{if } n \text{ is odd.} \end{cases}$$

Proof. Recall that

$$M(t,f) = \frac{1}{\pi} \operatorname{Im} \sum_{p \leqslant x^3} \frac{C_f(p)}{p^{1/2 + it}} = \frac{-i}{2\pi} \left(\sum_{p \leqslant x^3} \frac{\lambda_f(p)}{p^{1/2 + it}} - \sum_{p \leqslant x^3} \frac{\lambda_f(p)}{p^{1/2 - it}} \right).$$

Set $x = q^{\delta/3}$ for a suitably small $\delta > 0$ (to be specified later). Thus we have

$$M(t,f)^{n} = \frac{(-i)^{n}}{(2\pi)^{n}} \left(\sum_{p \leqslant q^{\delta}} \frac{\lambda_{f}(p)}{p^{1/2+it}} - \sum_{p \leqslant q^{\delta}} \frac{\lambda_{f}(p)}{p^{1/2-it}} \right)^{n}.$$

A general term in the expansion of the above has the form

$$\frac{\lambda_f(p_1)^{m(p_1)+n(p_1)}}{p_1^{m(p_1)(1/2+it)}(-1)^{n(p_1)}p_1^{n(p_1)(1/2-it)}} \times \dots \times \frac{\lambda_f(p_r)^{m(p_r)+n(p_r)}}{p_r^{m(p_r)(1/2+it)}(-1)^{n(p_r)}p_r^{n(p_r)(1/2-it)}},$$
(4.3)

where $p_1 < p_2 < \dots < p_r \le q^{\delta}$, $m(p_j) + n(p_j) \ge 1$, and $\sum_{j=1}^r (m(p_j) + n(p_j)) = n$.

Now we discuss the contribution from the general term (4.3) in the following cases.

Case (I): In the general term (4.3), $m(p_{j_0}) \neq n(p_{j_0}) \pmod{2}$ for some j_0 . With the Hecke relation (1.4), the numerator of this general term (4.3) can be written as a sum whose terms are all of the form $\lambda_f(m)\lambda_f(n)$ where $m \neq n$. Since for these terms $\delta_{m,n} = 0$, we see from Lemma 2.3 that the contribution from the general term (4.3) to the moment (4.1) is

$$\ll_{n} \sum_{p_{1} < p_{2} < \dots < p_{r} \leqslant q^{\delta}} p_{1}^{-\frac{1}{2}(m(p_{1}) + n(p_{1}))} \dots p_{r}^{-\frac{1}{2}(m(p_{r}) + n(p_{r}))} q^{-\frac{3}{2} + \frac{\delta n}{2}(1 + \varepsilon)} \\
\ll_{n} \left(\sum_{p \leqslant q^{\delta}} p^{-\frac{1}{2}} \right)^{r} q^{-\frac{3}{2} + \frac{\delta n}{2}(1 + \varepsilon)} \ll_{n} q^{-\frac{3}{2} + \frac{\delta n}{2}(2 + \varepsilon)},$$

which is negligible by taking $0 < \delta < \frac{1}{n}$.

Case (II): In the general term (4.3), $m(p_j) \equiv n(p_j) \pmod{2}$ for all j, and $m(p_{j_0}) + n(p_{j_0}) \ge 4$ for some j_0 . In this case, n is even and n > 2r, so $r < \frac{n}{2}$. By using Hecke relations (1.4), one sees that it is possible to have resulting terms $\lambda_f(m)\lambda_f(n)$ with m=n. Using Lemma 2.3, the contribution to the moment (4.1) such terms is bounded by the diagonal term of size ≈ 1 . The contribution from the off-diagonal terms is clearly negligible compared to 1, given that $0 < \delta < \frac{1}{n}$. Combining the bound (1.3) and (2.1), we have the contribution from this general

term to the moment (4.1) is

$$\ll_n \sum_{p_1 < p_2 < \dots < p_r \leqslant q^{\delta}} p_1^{-\frac{1}{2}(m(p_1) + n(p_1))} \dots p_r^{-\frac{1}{2}(m(p_r) + n(p_r))} \\
\ll_n \left(\sum_{p \leqslant q^{\delta}} p^{-1} \right)^r \ll_n (\log \log q)^{\frac{n}{2} - 1}.$$

It remains to discuss the following: In the general term (4.3), $m(p_j) \equiv n(p_j) \pmod{2}$ and $m(p_j) + n(p_j) = 2$ for all j. Clearly n must be even, say n = 2m and so r = m.

Case (III): $m(p_{j_0}) = 2$ or $n(p_{j_0}) = 2$ for some j_0 . We deduce that the contribution from these terms to (4.1) is at most $O((\log \log q)^{\frac{n}{2}-1})$ by using (1.3) and the convergence of $\sum_p p^{-1-it}$ for $t \neq 0$.

Case (IV): $m(p_j) = n(p_j) = 1$ for all j. The contribution from these terms to (4.1) is

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \binom{2m}{m} (m!) (m!) \frac{(-1)^m (-i)^{2m}}{(2\pi)^{2m}} \sum_{p_1 < p_2 < \dots < p_m \leqslant q^{\delta}} \frac{\lambda_f(p_1)^2 \cdots \lambda_f(p_m)^2}{p_1 \cdots p_m}.$$

By the Hecke relations, we have $\lambda_f(p_1)^2 \cdots \lambda_f(p_m)^2 = \lambda_f(p_1 \cdots p_m) \lambda_f(p_1 \cdots p_m)$. Applying Lemma 2.3, we have the above equals

$$\frac{(2m)!}{(2\pi)^{2m}} \sum_{\substack{p_1 < p_2 < \dots < p_m \leqslant q^{\delta} \\ p_j \text{ distinct}}} \frac{1}{p_1 \cdots p_m} \cdot \left(1 + O\left(q^{-3/2}(p_1 \cdots p_m)(\tau(p_1 \cdots p_m))\right)\right)$$

$$= \frac{(2m)!}{m!(2\pi)^{2m}} \sum_{\substack{p_1, p_2, \dots, p_m \leqslant q^{\delta} \\ p_j \text{ distinct}}} \frac{1}{p_1 \cdots p_m} + O\left(q^{-3/2} \sum_{\substack{p_1, p_2, \dots, p_m \leqslant q^{\delta} \\ p_j \text{ distinct}}} 1\right)$$

$$= \frac{(2m)!}{m!(2\pi)^{2m}} (\log \log q)^m + O_m \left((\log \log q)^{m-1}\right).$$

Now the asymptotic formula (4.1) follows from Cases (I)–(IV).

Next we are ready to prove (4.2). Recall that $\sigma_x = \sigma_{x,f}$ depending on f. By Lemma 4.2,

$$\sum_{f \in H_{2}(q)} \frac{|R(t,f)|^{2n}}{4\pi \langle f, f \rangle} \\
\ll \sum_{f \in H_{2}(q)} \frac{1}{4\pi \langle f, f \rangle} \left| \operatorname{Im} \sum_{p \leqslant x^{3}} \frac{C_{f}(p)(\Lambda_{x}(p) - \Lambda(p))}{p^{1/2 + it} \log p} \right|^{2n} + \sum_{f \in H_{2}(q)} \frac{1}{4\pi \langle f, f \rangle} \left| \operatorname{Im} \sum_{p \leqslant x^{3/2}} \frac{C_{f}(p^{2})\Lambda_{x}(p^{2})}{p^{1 + 2it} \log p} \right|^{2n} \\
+ \sum_{f \in H_{2}(q)} \frac{(\sigma_{x} - 1/2)^{2n} x^{2n(\sigma_{x} - 1/2)}}{4\pi \langle f, f \rangle} \left(\int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^{3}} \frac{C_{f}(p)\Lambda_{x}(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma \right)^{2n} \\
+ \sum_{f \in H_{2}(q)} \frac{(\sigma_{x} - 1/2)^{2n}}{4\pi \langle f, f \rangle} \left(\log(|t| + q) \right)^{2n}. \tag{4.4}$$

Since

$$|\Lambda_x(p) - \Lambda(p)| = O\left(\frac{\log^3 p}{\log^2 x}\right)$$
 and $C_f(p^2) = \lambda_f(p^2) - \varepsilon_q(p)$,

the first two terms is of O(1) by the argument as (4.1). The last term is of O(1) by Lemma 4.1. For the third term, it follows from Cauchy's inequality that

$$\sum_{f \in H_2(q)} \frac{(\sigma_x - 1/2)^{2n} x^{2n(\sigma_x - 1/2)}}{4\pi \langle f, f \rangle} \left(\int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma \right)^{2n}$$

$$\leq \left(\sum_{f \in H_2(q)} \frac{(\sigma_x - 1/2)^{4n} x^{4n(\sigma_x - 1/2)}}{4\pi \langle f, f \rangle} \right)^{1/2}$$

$$\times \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left(\int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma \right)^{4n} \right)^{1/2}.$$

By Hölder's inequality with the exponents 4n/(4n-1) and 4n,

$$\left(\int_{1/2}^{\infty} x^{1/2-\sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} \right| d\sigma \right)^{4n}$$

$$\leq \left(\int_{1/2}^{\infty} x^{1/2-\sigma} d\sigma \right)^{4n-1} \left(\int_{1/2}^{\infty} x^{1/2-\sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} \right|^{4n} d\sigma \right)$$

$$= \frac{1}{(\log x)^{4n-1}} \int_{1/2}^{\infty} x^{1/2-\sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p)\Lambda_x(p)\log(xp)}{p^{\sigma+it}} \right|^{4n} d\sigma.$$

Moreover, using Lemma 2.3 and the bound (2.2), we have

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right|^{4n}$$

$$\ll \sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left(\sum_{p \leqslant x^3} \frac{\left| \Lambda_x(p) \log(xp) p^{1/2 - \sigma} \right|^2}{p} \right)^{2n}$$

$$\ll \left(\sum_{p \leqslant x^3} \frac{\left| \Lambda_x(p) \log(xp) p^{1/2 - \sigma} \right|^2}{p} \right)^{2n} \ll \left(\sum_{p \leqslant x^3} \frac{(\log p)^2}{p} (\log x)^2 \right)^{2n} \ll (\log x)^{8n}.$$

Thus,

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left(\int_{1/2}^{\infty} x^{1/2 - \sigma} \left| \sum_{p \leqslant x^3} \frac{C_f(p) \Lambda_x(p) \log(xp)}{p^{\sigma + it}} \right| d\sigma \right)^{4n}$$

$$\ll \frac{1}{(\log x)^{4n - 1}} \int_{1/2}^{\infty} x^{1/2 - \sigma} (\log x)^{8n} d\sigma \ll (\log x)^{4n}.$$

Using this bound and Lemma 4.1, we have the third term in (4.4) is of O(1). Thus we complete the proof of proposition.

Proof of Theorem 1.1. By the binomial theorem, we have

$$S(t,f)^n = M(t,f)^n + O_n \left(\sum_{\ell=1}^{\infty} |M(t,f)|^{n-\ell} |R(t,f)|^{\ell} \right).$$

For $1 \le \ell \le n$, we apply the generalized Hölder's inequality and Proposition 4.3, and get

$$\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} |M(t, f)|^{n-\ell} |R(t, f)|^{\ell}$$

$$\ll \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \right)^{\frac{1}{2}} \left(\sum_{f \in H_2(q)} \frac{|M(t, f)|^{2n}}{4\pi \langle f, f \rangle} \right)^{\frac{n-\ell}{2n}} \left(\sum_{f \in H_2(q)} \frac{|R(t, f)|^{2n}}{4\pi \langle f, f \rangle} \right)^{\frac{\ell}{2n}}$$

$$\ll_{t,n} (\log \log q)^{(n-\ell)/2} \ll_{t,n} (\log \log q)^{(n-1)/2}.$$

Proof of Theorem 1.2. The *n*-th moment of μ_q is

$$\int_{\mathbb{R}} \xi^n d\mu_q(\xi) = \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \left(\frac{S(t, f)}{\sqrt{\log \log q}} \right)^n \right) / \left(\sum_{f \in H_2(q)} \frac{1}{4\pi \langle f, f \rangle} \right).$$

Using Theorem 1.1 and Lemma 2.3, we obtain that for all n,

$$\lim_{q \to \infty} \int_{\mathbb{R}} \xi^n d\mu_q(\xi) = C_n = \sqrt{\pi} \int_{\mathbb{R}} \xi^n \exp(-\pi^2 \xi^2) d\xi.$$

By the theory of moments in probability theory (see Lemma 2.5), we complete the proof of theorem.
