

### **Assaf Rappaport – Chief Executive Officer & Co-Founder**

Assaf Rappaport is the Chief Executive Officer and co-founder of Wiz. Previously, Assaf was CEO and co-founder of Adallom, a leading Cloud Access Security Broker (CASB), before its acquisition by Microsoft in July 2015. At Microsoft he led the Cloud Security group and served as the General Manager of Microsoft Israel's R&D Center. With 1,500 employees, Microsoft Israel was named Israel's best place to work 2 years in a row under his leadership. In his earlier days, Assaf managed several strategy-focused projects in Israel and Australia while working for McKinsey & Company. Assaf is a former Captain of the elite 8200 intelligence unit of the Israel Defense Forces.
