2.1 WORKSHOP ON PROTECTION OF CULTURAL HERITAGE IN ROME – ITALY

A training workshop on the protection of cultural properties was carried out in Rome (Italy), from 7th to 18th October 2019, organized by the Carabinieri Military Police (TPC) in conjunction with the African Union Commission (AUC), and the Italian Ministry of Foreign Affairs and international Cooperation. The training workshop which targeted senior heritage managers, focused on the legislation and investigative techniques, covering several sub-themes including, illicit trafficking of cultural property; importance of heritage documentation/ cataloguing; engagement of police force and immigration officials in prevention of crimes related to the import and export of cultural property; operations of the judiciary system in protection of cultural heritage; and, database management. The main thrust of the training workshop was to equip African professionals dealing with cultural heritage and antiquities with basics in combating illicit trafficking of cultural heritage as provided for by international conventions. Institutions and African countries represented, were: The African World Heritage Fund, African Union Commission, Botswana, Egypt, Ethiopia, Gambia, Ghana, Kenya, Lesotho, Nigeria, Rwanda, Seychelles, South Africa, Tanzania, Uganda and Zimbabwe.
