INTRODUCTION

PGIM, Inc. and its affiliates comprising Prudential's global asset management businesses (together, "PGIM," "we" or "us") respect your privacy and are committed to protecting it. We provide this Privacy Statement to inform you on how we may collect, use, share, and retain information about you and your choices.

WEBSITES COVERED BY THIS PRIVACY STATEMENT

This Privacy Statement describes our practices solely in connection with information that we collect through PGIM.com and other websites operated by us from which you are accessing this Privacy Statement (the "Websites"), as well as the social media pages that we control from which you are accessing this Privacy Statement (the "Social Media Pages") (together with the Websites, the "Services").

The Privacy Statement does not apply to other websites, platforms, or activities that have their own privacy statements. For example, it does not apply to personal information which we collect in providing services to institutional investors and customers, which is covered in our separate PGIM Institutional Privacy Notice. We also have separate privacy policies for California residents and certain job applicants to our European affiliates and operations. PERSONAL INFORMATION

Personal Information is information that identifies an individual or relates to an identifiable individual. The Services may collect Personal Information such as name, postal address, telephone number, and email address. You can find more information about the types of Personal Information we collect and use in the "How We Use Your Personal Information" section below.

HOW WE COLLECT PERSONAL INFORMATION

We need to collect Personal Information to provide the Services. If you do not provide the information requested, we may not be able to provide the Services. If you disclose

any Personal Information relating to other people to us or to our service providers in connection with the Services, you represent that you have the authority to do so and to permit us to use the information in accordance with this Privacy Statement.

We and our service providers collect Personal Information in a variety of ways, including:

- **Through the Services.** For example, you may provide us with your name, address, email address, and telephone number when you request that a PGIM representative contact you, when you fill out a survey or form, or when you sign up for a newsletter.
- **From Other Sources.** We receive your Personal Information from other sources, such as publicly available databases and joint marketing partners when they share the information with us.

HOW WE USE PERSONAL INFORMATION

We and our service providers use Personal Information for a variety of business purposes. The chart below describes these different purposes, related activities, the categories of Personal Information involved and, where applicable, the associated legal bases. We have also indicated where Personal Information is required to carry out the purpose and related activities.

HOW WE DISCLOSE PERSONAL INFORMATION

We disclose Personal Information to:

- **The appropriate PGIM organization or affiliate** so it can respond to your request.
 - A listing of our affiliates and their locations can be provided by contacting your Client Service Representative or pgim.privacy@pgim.com for a listing of our affiliates and their locations.
- **To our third-party service providers, to facilitate services they provide to us.**
 - These can include providers of services such as website hosting, data analysis, fraud prevention, information technology and related infrastructure provision, customer service, email delivery, auditing, and other services.
- **By using the Services, you may elect to disclose Personal Information.**
 - On other services to which you can post information and content (including, without limitation, our Social Media Pages). Please note that any information you post or disclose through these services will become public and may be available to other users and the general public.

Note: We do not sell or share Personal Information. We do share information internally and with certain third parties. These third parties are our business partners and contractors, and they are bound by contracts, agreements, and monitoring to ensure that your data is treated with utmost protection and respect. Each third-party is carefully vetted, to ensure that they have adequate protection in place to protect your data before we agree to work with them.

OTHER USES AND DISCLOSURES OF PERSONAL INFORMATION

We also use and disclose Personal Information as necessary or appropriate, especially when we have a legal obligation or legitimate interest to do so:

- **To comply with applicable law and regulations.**
 - This can include laws outside your country of residence.
- **To cooperate with public and government authorities.**

- To respond to a request or to provide information we believe is necessary or appropriate.
- These can include authorities outside your country of residence.
- **To cooperate with law enforcement.**
 - For example, when we respond to law enforcement requests and orders or provide information we believe is important.
- **For other legal reasons.**
 - To enforce our terms and conditions.
 - To protect our rights, privacy, safety, or property, and/or that of our affiliates, you, or others.
- **In connection with a sale or business transaction.**
 - We have a legitimate interest in disclosing or transferring Personal Information to a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer or other disposition of all or any portion of our business, assets, or stock (including in connection with any bankruptcy or similar proceedings). *Such third parties may include, for example, an acquiring entity and its advisors.*

OTHER INFORMATION

“**Other Information**” is any information that does not reveal a person’s specific identity or does not directly relate to an identifiable individual. The Services collect Other Information such as:

- The number of visitors to our site;
- The pages visited on our site;
- The features used;
- How long a visitor stays;
- The domain name of the site from which visitors connect to our site;
- Browser and device information; or
- Information that has been aggregated in a manner such that it no longer reveals your identity.

We and our service providers may collect Other Information in a variety of ways, including: Adobe Analytics, pixel tags, a browser or device; physical location; device

We respond to browser do-not-track signals. In some instances, we may combine Other Information with Personal Information. If we do, we will treat the combined information as Personal Information for as long as it is combined.

HOW WE PROTECT YOUR INFORMATION

We seek to use reasonable organizational, technical, and administrative measures to protect personal information within our organization. Unfortunately, no data transmission or storage system can be guaranteed to be 100% secure. SENSITIVE INFORMATION

Unless specifically requested, we ask that you not send us, and you not disclose, any sensitive Personal Information (e.g., information related to racial or ethnic origin, political opinions, religion or other beliefs, health, biometrics or genetic characteristics, criminal background, or trade union membership) on or through the Services or otherwise to us.

In your request, please make clear what Personal Information you would like to have changed or suppressed from our database, as applicable. For your protection, we may only implement requests with respect to the Personal Information associated with the particular email address that you use to send us your request (or include in the webform, letter, or call details), and we may need to verify your identity before implementing your request. We will try to comply with your request as soon as reasonably practicable.

Please note that we may need to retain certain information for recordkeeping purposes, to meet legal obligations, and/or to complete any transactions that you began prior to requesting a change or deletion.

You always have the right to lodge a complaint with a Data Protection Authority for your country or region or in the place of the alleged misconduct.

RETENTION PERIOD

We will retain personal information for the period necessary to fulfil the purpose(s) for which it was obtained unless a longer retention period is required or permitted by applicable law.

The criteria used to determine our retention periods include:

- The length of time we have an ongoing relationship with you and provide the Services to you;
- Whether there is a legal obligation to which we are subject (for example, certain laws require us to keep records of certain transactions for a certain period before we can delete them); or
- Whether retention is advisable considering our legal position (such as in regard to applicable statutes of limitations, litigation, or regulatory investigations).

THIRD-PARTY WEBSITES

CROSS-BORDER TRANSFER
