Measurement of the W mass with the ATLAS detector

We investigate the posibility of improving the W mass measurement at ATLAS.G iven the high statistics of both W and Z bosons expected at the LHC, we estimate that a precision of 7 MeV per channel can be reached with 10 fb 1 .

1. Motivation

The Standard M odel (SM) is a very predictive fram ework. Given precise measurements of $_{Q \, E \, D}$, G, and $_{Z}$, the W boson mass plays a central role, as it allows for both a SM cross check, confronting predictions of the W and top quark masses [1] with measurements [2, 3], and limits on the SM Higgs boson mass [4]. Finally, constraints on the contributions of other heavy particles, like supersymmetric particles [5] can be obtained. The W mass precision has continually improved with statistics, yielding the current world average of m $_{W} = 80.398$ 0:025 GeV [6]. Further improvement will translate into more precise indirect predictions of the SM Higgs mass.

2. Event selection

The simulated W and Z boson signal and associated background samples used in this study are computed using the PYTHIA general purpose event generator [7], with photon radiation in W and Z decays treated via an interface to PHOTOS [8]. The size of the expected samples are computed assuming the NLO W and Z cross-sections, as obtained from RESBOS [9], and simulated with complete simulation of the ATLAS detector using GEANT4 [10].

At hadron colliders, W and Z events can be detected and reconstructed in the e_e , ,ee, and nal states. In the following, the term lepton (') will refer to either an electron or muon. Electrons are measured using the inner detector (ID) and electrom agnetic calorimeter (EMC). They are reconstructed and identified with an electron of about 65%, while rejecting background from jets up to one part in 10^5 . The transition region from barrel to endcap in the EMC (1:3 < j j < 1:6) is not used. For muons, the ID is used together with the muon spectrometer with a reconstruction electron of about 95%. Backgrounds are less than for electrons, and diminished using isolation. The transverse momentum of the neutrino is inferred from the transverse energy in balance as determined by the calorimeters. The relative energy resolution is typically 1.5% for electrons and 2.0% for muons, while the missing transverse momentum (MET) has a resolution of 15-25% [11].

The W signal is extracted by selecting events with one isolated lepton $(p_T^{'}>20\,\text{GeV})$ and $j \cdot j < 2.5$) along with signi cant M ET due to the undetected neutrino $(E_T^{'}>20\,\text{GeV})$. These selections have a total e-ciency (trigger and selection) of about 20% (40%) for the electron (m uon) channel, providing a sample of about 4 10^7 (8 10^7) events. The backgrounds are at the 3% (6%) percent level. Likewise, the Z signal is required to have two opposite sign leptons $(p_T^{'}>20\,\text{GeV})$ and $(p_T^{'}>20\,\text{GeV})$. The e-ciency of this selection is about 10% (30%) in the electron (m uon) channel, yielding samples of about 2 $(p_T^{'}>20\,\text{GeV})$ events.

While the invariant mass can be determined in Z boson events, the observables most sensitive to mw are:

The reconstructed lepton transverse m om entum , $\dot{\textbf{p}}$.

The reconstructed W transverse m ass,

 $q = \frac{q}{2p_T^{'}p_T^{}(1-\cos(\ \cdot\))}.$

Based on the $p_T^{'}$ and m_T^{W} distributions, m_W can be extracted by comparing the data to a set of models (template distributions) obtained by varying the value of the W boson mass parameter in the event generation. W ith 10 fb 1 of data the statistical precision is about 2 MeV for each channel, roughly matching that of the smaller but more precise Z samples.

For the above procedure to work in practice, one must predict the $p_T^{'}$ and m_T^{W} distributions as a function of the W mass. These distributions are however a ected by many elects, which need to be included correctly in order to avoid biases in the mass to the impact of mechanisms a ecting the W mass determination is estimated by producing template distributions of $p_T^{'}$ and m_T^{W} unaware of the elect under consideration, and thing them to distributions including this elect. The resulting bias yields the corresponding system atic uncertainty.

3. Calibration and experimental uncertainties




Figure 1: Left: A verage calibration using 3.5 10^5 Z ! ee events. R ight: Di erential (linearity) calibration as a function of p_T (8 bins) and (2 bins) with same data. The two calibrations agree with each other and the generated value.

The precise know ledge of the Z m ass and width [1] allows for an accurate determination of the lepton energy scale and resolution. Given a sample of 30700 reconstructed Z! ee events (L 100 pb 1) with 85 < m $_{\rm ee}$ < 97 GeV, an average m ass scale (de ned as = $m_{\rm Z}^{\rm reco} m_{\rm Z}^{\rm truth}$) of = 0.9958 0.0003 was obtained on a fully simulated example sample (see Figure 1 left).

In order to correctly propagate the Z calibration m easurem ent to the W sam ple, the scale needs to be m easured as a function of energy. The high statistics expected at LHC allows for the re nement of doing the above calibration di erentially in p and (here in 8 2 bins), exploiting the energy distribution of the decay leptons, and hence m easuring the linearity of the detector response.

Each event is assigned to a category (i;j), according to p_T bins (16 in total) of the two leptons (choosing i-j). For each category (i;j), the reconstructed sample is compared to the known Z lineshape, and a Z mass resolution function R_{ij} is obtained from requiring that its convolution with the theoretical lineshape matches the reconstructed distribution. The Z mass resolutions R_{ij} result from combining two lepton momentum resolutions R_i and R_j as $R_{ij} = R_i - R_j$. Given N lepton bins and thus lepton resolution functions to determine, there are N (N + 1)=2 Z mass resolution functions, and thus the overconstrained system can be solved by a global N t, allowing for a determination of the detector response for all combinations of p_T and (see Figure 1 right).

Once the lepton scale is established, the Z transversem omentum will also serve to scale them easured hadronic recoil to the Z, which together with the measured lepton transverse momentum de nest hem issing transverse energy. Finally, \tag and probe" methods [12] will allow to determ ine the lepton reconstruction e ciency.

Backgrounds are small and mostly from well known similar heavy boson decays yielding true leptons (estimated from simulation), or from dijet events (estimated using two independent discriminators) faking leptons.

4. Theoretical uncertainties

M ost QCD mechanisms a ecting W distributions carry signi cantuncertainty, but a ect W and Z events in a similar way. This is the case for non-perturbative contributions, but also for parton density (PDF) e ects. At the LHC, the W and the Z are essentially sensitive to high-Q 2 sea partons, and a variation of these parameters will a ect the W and Z distributions (in particular y_W and y_Z) in a highly correlated way. Since the usage of the Z for calibration e ectively makes the analysis a measurement of the W to Z mass ratio, the impact of correlated e ects is strongly constrained. Evaluation was based on variation of parameters.

The W width uncertainty was assumed to diminish at the LHC. The impact of QED radiation was evaluated by varying the order of the QED calculation by PHOTOS and considering general LEP precision. For details, see [14].

5. Results and Conclusion

The system atic uncertainties are sum m arized in Table II for 10 fb^{-1} of data. A ssum ing expected detector perform ance and required theoretical tools to be available, the result is a precision on m $_{\rm W}$ of 7 M eV per channel. Additional calibration processes and combining independent m easurem ents m ay bring further improvement.
