Dark Matter in the USSM

W e discuss the neutralino dark m atter w ithin classes of extended supersym m etric m odels, referred to as the USSM, containing one additional SM singlet H iggs plus an extra Z^0 , together w ith their superpartners the singlino and bino'.

1 Introduction

M odels with additional U (1) gauge group provide an elegant solution to the of the m inimal supersymmetric standard model (MSSM). The Higgs/Higgsino mass term $\hat{H}_1\hat{H}_2$ of the M SSM is replaced by $\hat{S}\hat{H}_1\hat{H}_2$ (with a dimensionless coupling), where the additional super elds is a singlet under the Standard M odel (SM). The vacuum expectation value hS i then not only dynam ically generates a SUSY Higgs/Higgsino mass near the weak scale as required but also results in an increased Higgs boson mass upper bound which in turn gives a welcome reduction in electroweak ne tuning. Moreover, by gauging the A belian U (1)_X sym m etry arising from the $\hat{S}\hat{H}_1\hat{H}_2$ term the troublesome axion is avoided via the Higgs mechanism resulting in a massive Z 0 gauge boson [1]. The essential additional elem ents of such a scenario then consist of two extra super elds relative to those of the M SSM, namely the singlet super $eld\hat{S}$ and the U (1)_x gauge super $eld B^0$. The USSM is then de ned as a model with the MSSM super elds plus these two additional super elds at the TeV scale. Since it does not include other super elds necessary for cancelation of the ferm ionic $U(1)_X$ gauge anomalies, it has to be considered as a truncation of a complete m odel. For exam ple, identifying the Abelian gauge group as a subgroup of E 6 with complete 27 dim ensional representations of matter down to the TeV scale solves the anomaly problem, while requiring further the right-handed neutrinos to be singlets under U $(1)_X$ (for a see-saw m echanism) de nes the theory uniquely as the E_6 SSM [2].

For the USSM we adopt the charge assignment under the extra U $(1)_X$ as in the E₆SSM and study the physics and cosm ology in this sim plied setting to learn about crucial features which will be relevant to any complete model involving an additional U $(1)_X$ gauge group and a singlet. This talk, which updates the preliminary results presented previously [3], is based on the recent comprehensive analysis of neutralino dark matter in the USSM in [4], where full details (and an extensive list of references) can be found.

2 The USSM model

C om pared to the M SSM the particle spectrum is extended by a new CP-even H iggs boson S, a gauge boson Z 0 and two neutral {inos: a singlino S and a bino' B 0 . O ther sectors are not enlarged but the sferm ion scalar potential receives additional D-term s.

W ith two additional degrees of freedom the neutralino sector cannot be solved analytically any more. However, since the original MSSM and the new degrees of freedom are coupled weakly, an approximate analytical solution can be found following a two-step diagonalization procedure [5]. First—the 4—4 MSSM and the new 2—2 singlino-bino's sectors are separately diagonalised; second—a block (diagonalization provides approximate solutions.




Figure 1: Neutralino m ass spectrum.

Since U (1)_X forbids the singlino m ass term (in contrast to the NM SSM) the m ini seesaw structure of the singlino-bino'm ass m atrix in plies a singlino (dom inated lightest neutralino in the lim it of large bino' m ass. Figure 1 shows the neutralino m ass spectrum as a function of the soft bino' m ass param eter M $_1^0$ in a GUT-scale unifying scenario M $_1^0$ = M $_1$ = M $_2$ =2, where M $_1$; M $_2$ are the U (1); SU (2) m ass param eters respectively; tan = 5, other param eters are chosen so that the elective = 600 GeV, the heavy M $_{\rm Z_2}$ = 950 GeV, and the pseudoscalar Higgs m $_{\rm A}$ = 500 GeV.

3 Results

The presence of new singlino and bino' states greatly modi es the phenomenology of the neutralino sector both at colliders and in cosmology-related processes. It is informative to consider the general form of the interactions that arise from the singlino and bino' components of the lightest neutralino before presenting our numerical results.

The interactions of the bino'com ponent, which is always subdom inant due to the see-saw structure of the neutralino m ass m atrix, closely m irror those of the bino component, except for the dierent coupling constant and charges under the new U (1). On the other hand, the $\hat{S} \hat{H}_u \hat{H}_d$ term in the superpotential gives rise to a new type of neutralino coupling: the lightest neutralino with signicant singlino and higgsino components will couple strongly to Higgs bosons with a signicant H_u or H_d component, usually the lighter Higgs bosons, $H_{1;2}$ and A in the spectrum. Moreover, the absence of the singlet cubic term S^3 , in contrast to the NM SSM, implies that the singlino-dominated LSP needs an admixture of MSSM higgsinos to annihilate through s-channel Higgs bosons. Since the singlino component does not interact with the SU (2) or U (1)_Y gauginos or with fermions, a signicant singlino component in the lightest neutralino will suppress couplings to Worn Z1 bosons and to fermions.

3.1 Relic density

The di erences between the M SSM relic density calculation and the USSM calculation arise through the extension of the particle spectrum and through the new interactions that are introduced. We have implemented all new interactions into the microMEGAs[6] code which takes full account of all annihilation and coannihilation processes and calculates their elect whenever they are relevant.




Figure 2: The relic density across varying M $_1^{\,0}$

Figure 2 shows the relic density as a function of M $_1^0$. Ignoring initially the resonance e ects, a general trend in the relic density from a large value at low M $_1^0$, down to a lower value at around M $_1^0$ = 0:75 TeV and then back to larger values at high M $_1^0$ is easily understood as this follows the evolution of the LSP from bino through higgsino to singlino, see Figure 1.

Beyond this general behavior there are interesting resonance structures as the LSP mass rst increases with the $\rm M_1^0$ increase reaching a maximum of 560 G eV at $\rm M_1^0$

 $800~{\rm G~eV}$ and then falls down crossing all possible s-channel resonances twice. Starting from $M_0^0 = 0$ we rst arrive at a little dip in the relic density around $M_0^0 = 250$ G eV due to the s-channel H $_2$ =A resonance, and a little wiggle around M $_1^0$ = 500 G eV due to Z $_2$ =H $_3$ as the LSP has not yet developed an appreciable singlino component. The rst appreciable dip in the relic density occurs around M $_{0}^{1}$ = 0.8 TeV where $_{CDM}$ h² drops to 0.02. Here the LSP has a strong higgsino com ponent which enhances the annihilation via the s-channel Z $_2$ =H $_3$ resonances considerably. Increasing M $_1^0$ further, the LSP m ass increases, going o -resonance (hence local maximum in the relic density), until it reaches its maximum of at M $_{0}^{1}$ 800 G eV. From now on the LSP mass decreases and its nature becomes singlinodom inated. A round M $_{1}^{0}$ = 1:5 TeV it once again hits the Z $_{2}$ =H $_{3}$ resonance. However, this tim e the LSP is predom inantly singlino. A lthough pure singlino neutralinos do not couple to the singlet H iggs, so the H $_3$ resonance is subdom inant, they couple strongly to the Z 0 and annihilate very e ciently. As a result, the relic density drops to $2 10^{-3}$. The kink at M $_{0}^{0}$ = 2.5 TeV develops as the LSP m assdrops below threshold for production of H $_{1}\mathrm{A}$ in the nal state. Increasing M_1^0 further we nd a pseudoscalar H iggs resonance at $M_1^0 = 3.5$ TeV, the top threshold at M 0_1 = 5 TeV, the light H iggs threshold at M 0_1 = 11 TeV, the light H iggs resonance at M $_{1}^{\,\,0}=\,14$ TeV $\,$ and the Z $\,$ resonance at M $_{1}^{\,\,0}=\,19$ TeV .

3.2 Direct detection




Figure 3: The elastic spin-independent (left) and spin-dependent (right) LSP-proton cross section as a function of M $_{1}^{0}$

C om pared to the M SSM , the spin-dependent elastic scattering receives an additional contribution due to a heavy Z $_2$ gauge boson, while the spin-independent one gets contributions from additional H iggs as well as from interactions generated by the $g_1^0B^{-0}(H_iH_i+S)$ and $H_i(SH_j+H_jS)$ couplings. In Figure 3 the spin-independent as well as spin-dependent elastic cross section of the lightest neutralino on the proton is shown as a function of M_1^0 (restricted to $0\{3\text{ TeV}$, as beyond this range cross sections fall monotonically). Referring to Fig.1, it is easy to understand the M_1^0 behavior of the cross section. For M_1^0 below 800 GeV, the LSP is mostly a mixture of the M SSM states. It starts as a bino and as M_1^0 approaches 500 GeV, it receives an appreciable admixture of both higgsinos. As a result both $_{SD}$ and $_{SI}$ rst rise and then fall. The fall is due to the diminishing bino component, which reduces the Higgs contribution to $_{SI}$, and increases the cancelation in $c_{34} = N_{13} f_1 N_{14} f_2$, that controls the Z contribution to $_{SD}$. At M_1^0 800 GeV the discontinuities reject crossing of two lightest states since the mixing with singlino forces the second-lightest state to become the lightest. At this point $_{SI}$ drops by a factor 3. As the singlino component of the

LSP increases with M $_1^0$ the H $_1^{\circ}$ SH $_j$ term becomes responsible for the little rise of the cross section. On the other hand, $_{\text{SD}}$ jumps by a factor 6 at the discontinuity since the mixing with singlino upsets the cancelation in c_{34} . With further increase of M $_1^0$ the LSP becomes almost a pure singlino which explains a steady fall of both cross sections.

4 Sum m ary

The USSM ,despite itsm odest additional particle content compared to the MSSM or NMSSM, leads to a surprisingly rich and interesting dark matter phenomenology which distinguishes it from these models. There are many cases where successful relic abundances may be reached, either through a proper balance of the singlino/higgsino mixture, or through a balance of the singlino mass against the mass of a boson that mediates annihilation in the s-channel. The dierence in the Higgs spectrum and the singlino interactions results in signicant dierences in the direct detection predictions as well.
