Executive Sum m ary

In the last few years there has been interest in a new generation of high intensity multi-G eV proton accelerators. At Ferm ilab, two possible proton driver schem es have been proposed to enable the M ain Injector (M I) beam power to be increased by about a factor of ve to 2 m egawatts. The presently favored schem e is based on a new 8 G eV superconducting (SC) linac that utilizes, and helps develop, Linear Collider technology.

The interest in a new Ferm ilab Proton Driver is motivated by the exciting discoveries that have been made in the neutrino sector; namely that neutrinos have mass and that neutrinos of one avor can transform them selves into neutrinos of a di erent avor as they propagate over m acroscopic distances. This is exciting because it requires new physics beyond the Standard M odel. However, we do not yet have a com plete know ledge of neutrino masses and mixing. Understanding these neutrino properties is in portant because neutrinos are the most common matter particles in the universe. In number, they exceed the constituents of ordinary matter (electrons, protons, neutrons) by a factor of ten billion. They probably account for at least as much energy in the universe as all the stars combined and, depending on their exact m asses, m ight also account for a few percent of the so-called \dark m atter". In addition, neutrinos are important in stellar processes. There are 70 billion per second stream ing through each square centim eter of the Earth from the Sun. Neutrinos govern the dynam ics of supernovae, and hence the production of heavy elements in the universe. Furtherm ore, if there is CP violation in the neutrino sector, the physics of neutrinos in the early universe might ultimately be responsible for baryogenesis. If we are to understand \why we are here" and the basic nature of the universe in which we live, we must understand the basic properties of the neutrino.

To identify the best ways to address the most in portant open neutrino questions, and to determ ine an elective, fruitfulU S.role within a global experimental neutrino program, the American Physical Society's Divisions of Nuclear Physics and Particles and Fields, togetherwith the Divisions of A strophysics and the Physics of Beams, have recently conducted a \Study on the Physics of Neutrinos". This study recommended \... as a high priority, a comprehensive U.S. program to complete our understanding of neutrino mixing, to determ ine the character of the neutrino mass spectrum, and to search for CP violation among neutrinos", and identied, as a key ingredient of the future program, \A proton driver in the megawatt class or above and neutrino superbeam with an appropriate very large detector capable of observing CP violation and measuring the neutrino mass-squared di erences and mixing parameters with high precision." The proposed Fermilab Proton Driver would, together with a suitable new detector, full lithis need by providing a 2m egawatt proton beam at M ain Injector (M I) energies for the future \Neutrinos at the M ain Injector" (N uM I) program.

The NuM I beam is unique. It is the only neutrino beam that has an appropriate energy and a su ciently long baseline to produce, due to matter e ects, signi cant changes in the e ective oscillation parameters. These matter e ects can be exploited to determ ine the pattern of neutrino masses. Furtherm ore, when com bined with measurements from the much-shorter-baseline T2K experiment being built in Japan, an appropriate NuM I-based experiment could exploit matter e ects to achieve a greatly enhanced sensitivity to CP violation in the neutrino sector.

To obtain su cient statistical sensitivity to determ ine the pattern of neutrino m asses and search for CP violation over a large region of parameter-space will require a new detector with a ducial mass of tens of kilotons and a neutrino beam with the highest practical intensity. Hence, the primary motivation for the new Ferm ilab Proton D river is to enable an increase in the M I beam power to the maximum that is considered practical. The achievable sensitivity to the pattern of neutrino m asses, and to CP violation, will depend on the unknown neutrino m ixing angle _13. Experiments using the NuM I beam in the Ferm ilab Proton D river era would be able to search for a nite _13 with a sensitivity well beyond that achievable with the present NuM I beam , or at future reactor experiments.

In the presently favored 8 G eV SC linac proton driver scheme the M I ll time is very short (< 1 m s), which means that the M I can deliver 2 megawatts of beam at any energy from 40 to 120 G eV, and improvements to the M I ramp time can further increase the beam power. The short ll time also means that the majority of the 8 G eV cycles will not be used by the M I. Hence the SC linac could support a second high-intensity physics program using the primary beam at 8 G eV with an initial beam power of 0.5 megawatts, upgradeable to 2 megawatts (a factor of 64 increase of the present 8 G eV Booster beam). Both the primary proton beams (M I and 8 G eV) could be used to create neutrino beam s. Both these beams are needed for an extensive program of neutrino scattering measurements. These measurements are not only of interest in their own right, but are also needed to reduce the systematic uncertainties on the neutrino oscillation measurements which arise from our limited know ledge of the relevant neutrino cross sections.

A lthough neutrino oscillations provide the primary motivation for interest in the Ferm ilab Proton Driver, the participation in recent proton driver physics workshops has been broader than the neutrino physics community. Note that intensem uon, pion, kaon, neutron, and antiproton beam s at the Ferm ilab Proton Driver would o ergreat exibility for the future program, and could support a diverse program of experiments of interest to particle physicists, nuclear physicists, and nuclear-astrophysicists. In particular, as the Large Hadron Collider (LHC) and International Linear Collider (ILC) begin to probe the energy frontier, a new round of precision avor physics experiments would provide information that is complementary to the LHC and ILC data by indirectly probing high m ass scales through radiative corrections. This would help to elucidate the nature of any new physics that is discovered at the energy frontier. Examples of specic experiments of this type that could be supported at the Fermilab Proton Driver include (i) at the MI: K^+ ! + -, K_{I} ! 0 -, and K_{L} ! $^{0}e^{+}e$, and (ii) using the 8 GeV primary beam to produce an intense low energy muon source: muon (q 2) measurements and searches for a muon electric dipole moment, ! e , and ! e conversion. Should no new physics be discovered at the LHC and/or ILC then, for the foreseeable future, precision m uon, pion, kaon, and neutron measurements at a high-intensity proton source may provide the only practical way to probe physics at higher mass scales.

The main conclusions presented in this report are:

- 1. Independent of the value of the unknown m ixing angle $_{13}$ an initial Ferm ilab Proton D river long-baseline neutrino experiment will make a critical contribution to the global oscillation program.
- 2. If $_{13}$ is very small the initial Ferm ilab Proton D river experiment will provide the most stringent limit on $_{13}$ and prepare the way for a neutrino factory. The expected $_{13}$ sensitivity exceeds that expected for reactor-based experiments, or any other accelerator-based experiments.
- 3. If $_{13}$ is su ciently large the initial Ferm ilab Proton Driver experiment will precisely measure its value, perhaps determ ine the mass hierarchy, and prepare the way for a sensitive search for CP violation. The value of $_{13}$ will guide the further evolution of the Proton Driver neutrino program.
- 4. The Ferm ilab Proton D river neutrino experiments will also make precision measurements of the other oscillation parameters, and conduct an extensive set of neutrino scattering measurements, some of which are important for the oscillation program. Note that the neutrino scattering measurements require the highest achievable intensities at both M I energies and at 8 G eV.
- 5. The Ferm ilab Proton D river could also support a broad range of other experiments of interest to particle physicists, nuclear physicists, and nuclear astrophysicists. These experiments could exploit antiproton- and kaon-beams from the M I, orm uon-, pion-, or neutron-beams from the 8 G eV linac. These \low energy" experiments would provide sensitivity to new physics at high mass scales which would be complementary to measurements at the LHC and beyond.

1 Introduction

In the last few years there has been interest in a new generation of high intensity multi-GeV proton accelerators capable of delivering a beam of one or a few m eqawatts. The interest in these high-intensity accelerators is driven by the exciting discoveries that have been made in the neutrino sector; namely that neutrinos have mass and that neutrinos of one avor can transform them selves into neutrinos of a di erent avor as they propagate over m acroscopic distances. This requires new physics beyond the Standard M odel (SM). To identify the most important open neutrino physics questions, evaluate the physics reach of various proposed ways of answering the questions, and to determ ine an e ective, fruitfulU S. role within a global experim ental neutrino program, the American Physical Society's Divisions of Nuclear Physics and Particles and Fields, together with the Divisions of Astrophysics and the Physics of Beams, have recently conducted a \Study on the Physics of Neutrinos". The resulting APS report [1] recommended \... as a high priority, a comprehensive U.S. program to com plete our understanding of neutrino mixing, to determ ine the character of the neutrino mass spectrum, and to search for CP violation among neutrinos." The APS study identied, as a key ingredient of the future program, \A proton driver in the megawatt class or above and neutrino superbeam with an appropriate very large detector capable of observing CP violation and measuring the neutrino mass-squared di erences and m ixing param eters with high precision." A Ferm ilab Proton Driver would, together with a suitable new detector, ful 11 this need by providing a 2 m egawatt proton beam at M ain Injector (M I) energies for the future \Neutrinos at the M I" (N uM I) program .

Ferm ilab hosts the U S. accelerator-based neutrino program and, with the recently com pleted NuM I beam line, is operating the longest-baseline neutrino beam in the world. The NuM I beam will, for the foreseeable future, provide the only acceleratorbased neutrino baseline that is long enough form atter e ects to signi cantly change the e ective neutrino oscillation parameters. These matter e ects can be exploited to answer one of the key questions in neutrino physics, namely: W hich of the two presently viable patterns of neutrino mass is the correct one ? Furtherm ore, when com bined with measurements from the much shorter-baseline T2K experiment being built in Japan, an appropriate NuM I-based experimental program could exploit matter e ects and achieve a greatly enhanced sensitivity to CP violation in the neutrino sector.

To obtain su cient statistical sensitivity to determ ine the pattern of neutrino m asses and search for CP violation over a large region of parameter -space will require a new detector with a ducial mass of a few tens of kilotons, and a neutrino beam with the highest practical intensity. Hence, the primary motivation for the new Ferm ilab Proton Driver is to provide an increase in the M I beam power to them axim um that is considered practical, namely 2 m egawatts. The achievable sensitivity to the pattern of neutrino m asses, and to CP violation, will depend on the unknown neutrino m ixing angle 13. Experiments using the N uM I beam in the Ferm ilab Proton D river era would be able to search for a nite 13 with a sensitivity well beyond that achievable with the present N uM I beam, the T 2K beam, or at future reactor experiments. For this reason the APS neutrino study report recommended a new proton driver be

constructed as early as is practical. In the illustrative road m ap given in the APS report, construction begins in 2008, with operation beginning in 2012. In the longer term, should ₁₃ turn out to be close to or beyond the limiting sensitivity of the rst round of Ferm ilab Proton D river experiments, the Ferm ilab Proton D river would o er options for further upgrades to the detector and/or beam line to yield another stepw ise in provement in sensitivity. There would also be an option to develop the Ferm ilab Proton D river complex to support a neutrino factory.

The preferred Ferm ilab Proton D river scheme is based on a new 8 GeV superconducting (SC) linac that utilizes, and helps develop, Linear Collider technology. The M I lltime is very short (< 1 m s), which means that the M I can deliver 2 megawatts of beam at any energy from 40 to 120 GeV, and that improvements to the M I ramp time can further increase the beam power. The short lltime also means that the majority of the 8 GeV cycles will not be used by the M I. This docum ent sum m arizes the physics opportunities that would be provided by a new proton driver at Ferm ilab. In particular, the physics that could be done with a 2 m egaw att M I beam, and the physics that could be done with a 0.5 - 2 m egaw att 8 G eV beam. Sections 2 and 3 describe respectively the potential neutrino oscillation and neutrino scattering physics program s. Section 4 describes the broader physics program using m uon-, pion-, and neutron-beam s produced with a high intensity prim ary proton beam at 8 G eV, and using kaon- and antiproton-beam s produced with the M I prim ary proton beam. An overview of the com plete proton driver program is given in Section 5, and a sum m ary in Section 6.

2 Neutrino O scillations

Neutrinos are the most common matter particles in the universe. In number, they exceed the constituents of ordinary matter (electrons, protons, neutrons) by a factor of ten billion. They probably account for at least as much energy in the universe as all the stars combined and, depending on their exact masses, might also account for a few percent of the so-called \dark matter". In addition, neutrinos are important in stellar processes. There are about 7 10^{10} cm² sec¹ streaming through the Earth from the Sun. Neutrinos govern the dynamics of supernovae, and hence the production of heavy elements in the universe. Furthermore, if there is CP violation in the neutrino sector, the physics of neutrinos in the early universe might ultimately be responsible for baryogenesis. If we are to understand \why we are here" and the basic nature of the universe in which we live, we must understand the basic properties of the neutrino.

In the last few years solar, atm ospheric, and reactor neutrino experiments have revolutionized our understanding of the nature of neutrinos. We now know that neutrinos produced in a given avor eigenstate can transform them selves into neutrinos of a di erent avor as they propagate over m acroscopic distances. This means that, like quarks, neutrinos have a non-zero mass, the avor eigenstates are di erent from the mass eigenstates, and hence neutrinos mix. However, we have incom plete know ledge of the properties of neutrinos since we do not know the spectrum of neutrino masses, and we have only partial know ledge of the mixing among the three known neutrino avor eigenstates. Furtherm ore, it is possible that the sim plest three- avor mixing scheme e is not the whole story, and that a com plete understanding of neutrino properties will require a more com plicated fram ework. In addition to determ ining the param eters that describe the neutrino sector, the three- avorm ixing fram ework must also be tested.

The SM cannot accommodate non-zero neutrino mass term swithout som em odi cation. W e must either introduce right-handed neutrinos (to generate D irac m ass term s) or allow neutrinos to be their own antiparticle (violating lepton num ber conservation, and allow ing M a jorana m ass term s). Hence the physics of neutrino m asses is physics beyond the Standard M odel. A lthough we do not know the neutrino m ass spectrum, we do know that the masses, and the associated mass-splittings, are tiny com pared to the masses of any other fundam ental ferm ion. This suggests that the physics responsible for neutrino mass will include new components radically di erent from those of the SM . Furtherm ore, although we do not have com plete know ledge of the mixing between di erent neutrino avors, we do know that it is qualitatively very dierent from the corresponding mixing between dierent quark avors. The observed di erence necessarily constrains our ideas about the underlying relationship between quarks and leptons, and hence m odels of quark and lepton uni cation in general, and G rand U ni ed Theories (G U T s) in particular. Note that in neutrinom assm odels the seesaw mechanism [2{6] provides a quantitative explanation for the observed small neutrino m asses, which arise as a consequence of the existence of right-handed neutral leptons at the GUT -scale. Over the last few years, as our know ledge of the neutrino oscillation param eters has improved, a previous generation of neutrino m ass m odels

has already been ruled out, and a new set of models has emerged speci cally designed to accommodate the neutrino parameters. Further improvement in our knowledge of the oscillation parameters will necessarily reject many of these models, and presumably encourage the emergence of new ideas. Hence neutrino physics is experimentally driven, and the experiments are already directing our ideas about what lies beyond the Standard Model.

O ur desire to understand both the universe in which we live and physics beyond the SM provides a compelling case for an experimental program that can elucidate the neutrino mass spectrum, measure neutrino mixing, and test the three-avor mixing framework. It seems likely that complete knowledge of the neutrino mass splittings and mixing parameters is accessible to accelerator-based neutrino oscillation experiments. In the following we rst introduce the three-avor mixing framework and identify the critical measurements that need to be made in the future oscillation physics program. The sensitivity of the Fermilab program based on a new Proton Driver is then considered in the context of the global experimental program.

2.1 O scillation Fram ework and M easurem ents

There are three known neutrino avor eigenstates = ($_{e}$; ;). Since transitions have been observed between the avor eigenstates we now know that neutrinos have non-zero m asses, and that there is mixing between the avor eigenstates. The m ass eigenstates $_{i} = (_{1}; _{2}; _{3})$ with m asses $m_{i} = (m_{1}; m_{2}; m_{3})$ are related to the avor eigenstates by a 3 3 unitary m ixing m atrix U ,

Four num bers are needed to specify all of the m atrix elements, namely three m ixing angles ($_{12}$; $_{23}$; $_{13}$) and one complex phase (). In terms of these parameters

where c_{jk} cos $_{jk}$ and s_{jk} sin $_{jk}$. Neutrino oscillation measurements have already provided some know ledge of U, which is approximately given by:

W e have limited knowledge of the (1,3)-element of the mixing matrix. This matrix element is parametrized by $s_{13}e^i$. We have only an upper limit on $_{13}$ and no knowledge of . Note that $_{13}$ and are particularly important because if $_{13}$ and sin are non-zero there will be CP violation in the neutrino sector.

N eutrino oscillations are driven by the splittings between the neutrino m ass eigenstates. It is useful to de ne the di erences between the squares of the m asses of




Figure 1: Current experim ental constraints on the three mixing angles $_{12}$, $_{23}$, and $_{13}$ and their dependence on the two known mass-squared di erences m $_{12}^2$ and m $_{23}^2$. The star indicates the most likely solution. Figure taken from [1].


the mass eigenstates $m_{ij}^2 m_i^2 m_j^2$. The probability that a neutrino of energy E and initial avor will \oscillate" into a neutrino of avor is given by P (!) = $\frac{1}{2}$ jexp(iH t) j ij, which in vacuum is given by

If neutrinos of energy E travel a distance L then a measure of the propagation time t is given by L=E.Non-zero m $^2_{ij}$ will result in neutrino avor oscillations that have maxim a at given values of L=E, and oscillation amplitudes that are determined by the matrix elements U $_i$, and hence by $_{12}$; $_{23}$; $_{13}$, and .

O ur present know ledge of the neutrino m ass splittings and m ixing m atrix, has been obtained from atm ospheric [8,9], solar [10{15], reactor [16{18], and accelerator-based [19] neutrino experiments, and is summarized in Fig. 1. The solar-neutrino experiments and the reactor experiment K am LAND probe values of L=E that are sensitive to m $^2_{21}$, and the m ixing angle $_{12}$. Our know ledge of these parameters is shown in the left panel of Fig. 1. The atm ospheric-neutrino experiments and the accelerator based experiment K 2K probe values of L=E that are sensitive to m $^2_{32}$, and the m ixing angle $_{23}$. Our know ledge of these parameters is shown in the central panel of Fig. 1. Searches for $\$_{e}$ transitions with values of L=E corresponding to the atm ospheric-neutrino scale are sensitive to the third m ixing angle $_{13}$. To date these searches have not observed this transition, and hence we have only an upper limit on $_{13}$, which comes predom inantly from the CHOOZ reactor experiment [16], and is shown in the right panel of Fig. 1.

The mixing angles tell us about the avor content of the neutrino mass eigenstates. Our knowledge of the m $^2_{ij}$ and the avor content of the mass eigenstates is summarized in Fig. 2. Note that there are two possible patterns of neutrino mass. This is because the neutrino oscillation experiments to date have been sensitive to the magnitude of m $^2_{32}$, but not its sign. The neutrino spectrum shown on the left

in Fig. 2 is called the Norm al M ass H ierarchy and corresponds to m $\frac{2}{32} > 0$. The neutrino spectrum shown on the right is called the Inverted M ass H ierarchy and corresponds to m $\frac{2}{32} < 0$. The reason we don't know the sign of m $\frac{2}{32}$, and hence the neutrino m ass hierarchy, is that neutrino oscillations in vacuum depend only on the m agnitude of m $\frac{2}{32}$. How ever, in m atter the elective parameters describing neutrino transitions involving electron-type neutrinos are modiled in a way that is sensitive to the sign of m $\frac{2}{32}$. An experiment with a su ciently long baseline in matter and an appropriate L=E can therefore determ ine the neutrino m ass hierarchy.

Finally, it should be noted that there is a possible complication to the simple three- avor neutrino oscillation picture. The LSND [20] experiment has reported evidence form uon anti-neutrino to electron anti-neutrino transitions for values of L=E which are two orders of magnitudes an aller than the corresponding values observed for atmospheric neutrinos. The associated transition probability is very small, of the order of 0.3%. If this result is con rm ed by the M iniBooNE [21] experiment, it will require a third characteristic L=E range for neutrino avor transitions. Since each L=E range implies a di erent m ass-splitting between the participating neutrino m ass eigenstates, con rm ation of the LSND result would require m ore than three m ass eigenstates. This would be an exciting and radical development. Independent of whether the LSND result is con rm ed or not, it is important that the future global neutrino oscillation program is able to make further tests of the three- avor oscillation fram ew ork.

In sum mary, to complete our know ledge of the neutrino mixing matrix and the

pattern of neutrino m asses we must measure $_{13}$ and $_{13}$ determ ine the sign of m $_{32}^2$, and test the three-avorm ixing fram ework. The primary, initial goal for a Ferm ilab Proton D river will be to make these measurements.

2.2 The Importance of the Unanswered Questions

N on-zero neutrino m asses require physics beyond the SM . The determ ination of neutrino m asses and m ixing will discrim inate between various neutrino m odels and yield clues that will help determ ine w hether physics beyond the SM is described by a GUT or som e other theoretical fram ew ork.

The basic neutrino questions that $w \in w$ ould like to address w ith a Ferm ilab Proton D river are:

W hat is the order of m agnitude of $_{13}$?

Is the mass hierarchy norm alor inverted?

Is there CP violation in the neutrino sector and what is the value of ?

These questions are discussed in the following sections.

2.2.1 The importance of 13

Neutrino oscillation experiments have shown that two of the neutrino mixing angles ($_{23}$ and $_{12}$) are large. This was a surprise since the corresponding mixing angles in the quark mixing matrix are small. We have only an upper limit on the third neutrino mixing angle $_{13}$. From this limit we know that $_{13}$ is much smaller than $_{23}$ or $_{12}$. How every e have no good reason to expect it to be very small. P redictions from recent models are listed in Table 1. M ost of the presently viable neutrino m assmodels predict that $_{13}$ is close to the present bound. A value of $_{13}$ much smaller than the bound would suggest a new avor symmetry that suppresses this mixing. How ever, even if $_{13}$ is exactly zero at the GUT scale, radiative corrections would be expected to drive its value away from zero at laboratory energies. In any case determ ining the order of magnitude of $_{13}$ will discrim inate between theoretical models (Table 1) and provide crucial guidance toward an understanding of the physics of neutrino m asses.

In addition to its theoretical in portance, the size of $_{13}$ has in portant experimental consequences. If $_{13}$ is within an order of magnitude of its present bound we will probably know its value before the \Proton D river Era". A Ferm ilab Proton D river would then enable the mass hierarchy to be determined and a search for CP violation to be made. If $_{13}$ is small (sin² 2 $_{13} < 0.01$) we will not know its value before the initial Ferm ilab Proton D river program would then in prove our know ledge of $_{13}$ and prepare the way for a second generation program. If sin² 2 $_{13} < 0.005$ the initial Ferm ilab Proton D river experiment would establish its value and m ight also determine the mass hierarchy, but would not be su ciently sensitive to search for CP violation. A second generation program will be required. The options for this second generation include an upgraded detector with or without

a new beam line, and a neutrino factory driven by the Proton D river. Note that the value of $_{13}$ will determ ine which facilities and experiments will be needed beyond the initial Ferm ilab Proton D river experiments to complete the neutrino oscillation program.

2.2.2 The importance of the Mass Hierarchy

Speci c neutrino m ass m odels are usually only compatible with one of the two possible neutrino m ass hierarchies (norm allor inverted). A measurement of the sign of m $_{31}^2$ would therefore discriminate between models. For example, GUT models with a standard type I see saw mechanism tend to predict a norm all hierarchy (see, for example, the reviews R efs [58,59]), while an inverted hierarchy is often obtained in models that employ avor symmetries such as L_e L L [60,61].

A determ ination of the sign of m $^2_{31}$ would also have some consequences for neutrinoless double beta decay experiments. A negative m $^2_{31}$ would imply a lower limit on the elective mass for neutrinoless double beta decay (in the case of M a jorana neutrinos) which would be expected to be within reach of the next generation of experiments.

2.2.3 The importance of CPV iolation and

Leptogenesis [62], in which CP violation in the leptonic Yukawa couplings ultimately results in a baryon asymmetry in the early Universe, provides an attractive possible explanation for the observed baryon asymmetry. In the most general case, the CP phases involved in leptogenesis are not related to the low-energy CP phases that appear in the electrive neutrino mass matrix [63,64]. However, speci c neutrino mass models can yield relationships between the CP violation relevant to leptogenesis and the low-energy CP phases. Indeed, to successfully obtain leptogenesis some models require a non-zero phase (see, for example, R efs [53,65]). Hence, although a measurement of CP violation in the neutrino sector would not establish leptogenesis as the right explanation for the observed baryon asymmetry, it would be suggestive and a measurement of would discriminate between explicit neutrino mass models.

2.2.4 Other Oscillation Physics

W ith a Proton D river the Ferm ilab neutrino program would provide a path to the ultim ate sensitivity form easurem ents of $_{13}$, them ass hierarchy, and CP violation. In addition to these crucial measurem ents, to discrim inate between di erent theoretical models, it will also be in portant to in prove the precision of the other oscillation parameters ($_{12}$; $_{23}$; m $_{21}^2$; m $_{32}^2$). Note that $_{23}$ is of particular interest as its current, poorly determined, value is consistent with maximal mixing in the (2,3) sector. Is this mixing really maximal? Furthermore the level of consistency between the precisely measured values of the parameters in the various appearance and disappearance modes will test the 3 avor mixing fram ework, possibly leading to further exciting discoveries. The Ferm ilab Proton D river would not only address the value of $_{13}$, the mass hierarchy, and CP violation, but would also provide a more comprehensive set of measurements that could lead to further unexpected surprises.

2.3 Evolution of the Sensitivity to $_{13}$

In the com ing years we can expect in provements in our know ledge of the oscillation parameters from the present generation of running experiments (M in BooNE, K am – LAND, K 2K, M INOS, SNO, SuperK) and experiments under construction (T 2K). Beyond this a new generation of reactor and accelerator based experiments are being proposed (for example the D ouble-CHOOZ reactor experiment and the NO A experiment using the Fermilab N uM I beam). In the coming decade the search for a non-zero $_{13}$ is of particular importance since, not only is $_{13}$ the only unmeasured mixing angle, but its value will determine the prospects for determining the mass hierarchy and making a sensitive search for CP violation.




Figure 3: The $\sin^2 2_{13}$ sensitivity lim it at the 90% CL for M NOS, CARUS, and OPERA combined, D ouble-Chooz, T2K, 2^{nd} generation reactor experiment (Reactor-II), and NO A. The left edges of the bars are obtained for the statistics lim its only, whereas the right edges are obtained after successively switching on systematics, correlations, and degeneracies, i.e., they correspond to the nal $\sin^2 2_{13}$ sensitivity lim its. The gray-shaded region corresponds to the current $\sin^2 2_{13}$ bound at 90% CL. For the true values of the oscillation parameters, we use $jm \frac{2}{31}j = 2.0 \ 10^{-3} \text{ eV}^2$, $\sin^2 2_{23} = 1$, $m \frac{2}{21} = 7.0 \ 10^{-5} \text{ eV}^2$, $\sin^2 2_{12} = 0.8 \ [14,67\{69\}$, and a norm alm ass hierarchy. Figure extended version from R ef. [66].

In this section we describe the expected evolution of our sensitivity to $_{13}$ over the next ten to fleen years, a time period that includes a rst generation of Ferm ilab Proton Driver experiments. A list of relevant experiments and their characteristics is given in Table 2. The $\sin^2 2_{13}$ sensitivities for these experiments are summarized in Fig. 3, where the other oscillation parameters have been chosen to correspond to the

present central values. Note that in general the sensitivities of the accelerator based experim ents are dom inated by statistical uncertainties. To make further progress will require larger detectors and higher intensity beam s. Reactor-based experiments, by contrast, are dom inated by system atic uncertainties.




Figure 4: Anticipated evolution of the $\sin^2 2_{13}$ discovery reach for the global neutrino program. The curves show the 3 sensitivities for each experiment to observe a non-zero value of $\sin^2 2_{13}$. The bands reject the dependence of the sensitivity on the CP violating phase. The calculations are based on the experiment simulations in Refs. [66,70] and include statistical and systematic uncertainties and parameter correlations. They assume a normal hierarchy and m $2_{31}^2 = 2.5 \ 10^{-3} \ eV^2$, $\sin^2 2_{23} = 1$, m $2_{21}^2 = 8.2 \ 10^{-5} \ eV^2$, $\sin^2 2_{-12} = 0.83$. All experiments are operated with neutrino running only and the full detector mass is assumed to be available right from the beginning. The starting times of the experiments have been chosen as close as possible to those stated in the respective LO Is. Reactor-II and FPD refer, respectively, to a 2nd generation reactor experiment and to the Ferm ilab Proton Driver.




Figure 5: A nticipated evolution of the $\sin^2 2_{13}$ discovery reach for the global neutrino program . See caption for Fig. 4 for details. The branching point" refers to the decision point for the experimental program (rather than the Ferm ilab Proton Driver), i.e., between an upgraded beam and/or detector and a neutrino factory program. The upgrade 2ndG enPDExp (Second Generation Proton Driver Experiment) is assumed to start ten years after T2K starts and the curve uses numbers from the T2HK proposal. The neutrino factory is assumed to start about ten years after the branching point and to switch polarity after 2.5 years.

In interpreting Fig. 3 it is in portant to note that it shows the 90% sensitivity in contrast to the 3 discovery reach shown in Figs. 4 and 5. The 90% sensitivity is calculated by setting the \true" value of $\sin^2 2_{13}$ equal to zero in the calculation and then nding the limit on $\sin^2 2_{13}$ that can be set at 90% con dence given all possible values of and them ass hierarchy. It is the appropriate quantity to calculate if one wants to understand how low an experiment can set a limit on the value of $\sin^2 2_{13}$. The 3 discovery reach is calculated by nding the value of $\sin^2 2_{13}$ that can be distinguished from zero at 3 con dence. It is the appropriate quantity if one is interested in know ing when one can determ ine that $\sin^2 2_{13}$ is non-zero. Because of the correlated e ects of $\sin^2 2_{13}$, and the hierarchy (am ong others) we can determ ine that $\sin^2 2_{13}$ is non-zero well before measuring its actual value. From the perspective of a Ferm ilab Proton D river program the 3 discovery reach is the more relevant quantity as the interest is in knowing that $\sin^2 2_{13}$ is non-zero. Then one can set a bout designing an optim ised program to go after CP violation and them ass hierarchy.

2.3.1 Conventional Beam Experiments

M INOS is a muon-neutrino disappearance experiment that is expected to conm the oscillation interpretation of the atm ospheric neutrino data and to better determine the associated jm² j. M INOS will also have some capability to detect electron-neutrino appearance, and hence has some sensitivity to $_{13}$. However, this sensitivity is limited.

M INOS is just beginning to take data. In the coming 5 years we expect M INOS to determ ine $_{13}$ if it is very close to the present bound. M INOS is also expected to reduce the uncertainty on jm $_{31}^2$ jto about 10%.

In Europe, the CNGS program consists of two experiments, ICARUS and OPERA, designed to study tau-neutrino appearance with an L/E corresponding to the atmospheric neutrino oscillation scale. They will also have sensitivity to electron-neutrino appearance, and hence to $_{13}$. The CNGS experiments are expected to begin running in a few years. After 5 years of data taking, the combined sensitivity of ICARUS, OPERA, and MINOS will enable $\sin^2 2$ $_{13}$ to be determined if it exceeds 0.06.

2.3.2 0 -A xis Experiments

Looking further into the future, signi cant progress could be made with a new longbaseline experiment that exploits the NuM I beam line, together with a Proton Driver, and a detector that is optimized to detect $_{\rm e}$ appearance. A line of NuM Iupgraded experiment has yet received nal approval, we might imagine that NO A, or an equivalent experiment, is approved, constructed, and becomes operational in 5-10 years from now. After 5 years of data taking we would expect NO A to determ ine $\sin^2 2_{13}$ if it exceeds 0:02.

In Japan the JPARC beam line for T2K, a high-statistics, o -axis, second generation version of K2K, has been approved, and is expected to be completed in 2009. With 5 years of data taking T2K is expected to determ in $\sin^2 2_{13}$ if it exceeds 0.02. The combined NO A and T2K sensitivity would be in the range 0.01-0.02.

2.3.3 R eactor Experim ents

A new generation of reactor experiments are being proposed with detectors and baselines chosen to be sensitive to $_{13}$. A lthough choices still have to be made to determ ine which of these experiments are supported, it seems reasonable to assume that one or two reactor experiments will be executed in the coming decade. The Double-CHOOZ experiment appears to be furthest along in the approval process. This experiment is expected to determ ine $\sin^2 2_{13}$ if it exceeds 0.03. Beyond this, a more ambitious reactor experiment, referred to in Table 2 as Reactor II, might be expected to reach a sensitivity $\sin^2 2_{13}$ approaching 0.01 at 90% condence (the curves in Figs. 4 and 5 are for 3 discovery). This sensitivity is limited by systematic uncertainties but, if achieved, will be slightly better, for some values of , than the corresponding sensitivity expected for T 2K or NO A, but worse for other values of .

2.3.4 The Evolution

The anticipated evolution of the $\sin^2 2_{13}$ discovery reach of the global neutrino oscillation program is illustrated in Fig. 4. The sensitivity is expected to improve by about an order of magnitude over the next decade. This progress is expected to be accomplished in several steps, each yielding a factor of a few increased sensitivity. During this rst decade the Ferm ilab program will have contributed to the improving global sensitivity with M INOS, followed by NO A.M INOS is the on-ram p for the US long-baseline neutrino oscillation program .NO A would be the next step. Note that we assume that NO A starts taking data with the existing beam line before the Proton D river era. The Proton D river would take NO A into the fast lane of the global program . A lso note that the accelerator based and reactor based experiments are com plementary. In particular, the reactor experiments m ake disappearance measurements, limited by system atic uncertainties. The NO A experiment is an appearance experiment, limited by statistical uncertainties, and probes regions of parameter space beyond the reach of the proposed reactor experiments.

2.4 Ferm ilab Proton Driver O scillation Physics Program

Independent of the value of $_{13}$ the initial Ferm ilab Proton Driver long-baseline neutrino experiment (NO A+FPD) is expected to make an important contribution to the global oscillation program. If $_{13}$ is very small NO A+FPD would be expected to provide the most stringent limit on this in portant parameter, and prepare the way for a neutrino factory. If $_{13}$ is su ciently large, NO A+FPD would be expected to measure its value, perhaps determine the mass hierarchy, and prepare the way for a sensitive search for CP violation. The evolution of the Fermilab Proton Driver physics program beyond the initial experiments will depend not only on $_{13}$, but also on what other neutrino experiments will be built elsewhere in the world. In considering the long-term evolution of the Fermilab Proton Driver program werm ust take into account the uncertainty on the magnitude of $_{13}$ and consider how the global program might evolve.

We begin by considering the evolution of the program if $\sin^2 2_{13} < 0.01$. In this case we will know that ultimately we will need a neutrino factory to complete all of the in portant oscillation measurements. The initial Fermilab Proton Driver experiment would be a search experiment that would improve the limit on, or establish the value of, 13. Fig. 5 shows a longer-term version of the $\sin^2 2_{13}$ discovery reach versus time plots shown in Fig. 4. The initial Fermilab Proton Driver experiment would begin to explore the region below $\sin^2 2_{13}$ 0.01 and could be upgraded to further improve the sensitivity by a factor of a few. The neutrino factory would ultimately provide a two orders of magnitude improvement in sensitivity.

We have no reason to expect a very small value for $_{13}$. Hence, as the global program achieves increasing sensitivity to $_{13}$, at any time a nite value might be established, and the focus of the program will change from searching for evidence for

e transitions to measuring $_{13}$, determining the mass hierarchy, and searching for CP violation. To explore how in this case the Fermilab Proton Driver would contribute to the global program we consider four cases:

Case 1: No Fermilab Proton Driver and no upgrade to the T2K beam.

Case 2: An upgrade to the T2K beam, but no Ferm ilab Proton Driver.

Case 3: A Fermilab Proton Driver, but no upgrade to the T2K beam.

Case 4: Both a Fermilab Proton Driver and an upgraded T2K beam.

The prospects for determ ining the neutrino mass hierarchy and discovering CP violation depend upon the values of $_{13}$ and . Figures 6,7,8 and 9 show as a function of $\sin^2 2_{13}$, for various combinations of experiments, the fraction of all possible values of for which the mass hierarchy can be determined (left panels) and CP violation can be discovered (right panels).




Figure 6: Case 1: N o Ferm ilab Proton D river and no upgrade to the T 2K beam . Regions of parameter space where the mass hierarchy (left) and CP violation (right) can be observed at 95% CL and at 3 , respectively. Note that CP violation would not be visible at all and T 2K alone is not sensitive to the hierarchy. NO A, T 2K, etc are de ned in Table 3.

The rst case, where there is no Ferm ilab Proton Driver and no upgrade to the T2K beam, is shown in Fig.6. Note that even by combining T2K and NO A data, one cannot arrive at a 3 determination for CP violation. If, in addition to no Ferm ilab Proton Driver, there is no NO A then T2K alone will not be able to determine the




Figure 7: C ase 2: A n upgrade to the T 2K beam, but no Ferm ilab P roton D river. Regions of parameter space where the mass hierarchy (left) and CP violation (right) can be observed at 95% CL and at 3, respectively. NO A, T 2K, etc are de ned in Table 3.




Figure 8: Case 3: A Ferm ilab Proton Driver, but no upgrade to the T2K beam . Regions of parameter space where the mass hierarchy (left) and CP violation (right) can be observed at 95% CL and at 3, respectively. NO A, T2K, etc are de ned in Table 3. The addition of T2K data would not signi cantly change the position of these curves.




Figure 9: Case 4: Both a Ferm ilab Proton Driver and an upgraded T2K beam. Regions of parameter space where the mass hierarchy (left) and CP violation (right) can be observed at 95% CL and at 3, respectively. NO A, T2K, etc are de ned in Table 3.

m ass hierarchy. NO A would provide som e sensitivity to the mass hierarchy, which would be som ewhat improved by combining NO A and T2K results.

The second case, where there is no Ferm ilab Proton Driver but the T2K beam is upgraded, is shown in Fig. 7. We assume that NO A is built, which will provide some sensitivity to the mass hierarchy. In this case, there is some parameter space where CP violation can be seen at 3, which expands dram atically if there is a 20-fold increase in detector mass which would happen if Hyper-K am iokande were to be built. However, there would always be a signi cant fraction of for which there would be an am biguity due to the uncertain mass hierarchy, which means that a degenerate CP conserving solution may overlap the CP violating solution and destroy the CP violation sensitivity. Since the baseline is 295 km, substantial beam and detector upgrades to T2K make only a modest impact on the mass hierarchy sensitivity for a lim ited fraction of the parameter space.

The third case, shown in Fig. 8, is where there is a Ferm ilab Proton Driver, but no T 2K upgrade The curves show various options: either running with one or more detectors located at di erent o axis angles from the NuM I beam line, or with a new long baseline experiment with a new beam line. Note that the Ferm ilab Proton Driver yields a dram atic improvement in the potential to determ ine them asshierarchy, which compares favorably with Case 2. The initial Ferm ilab Proton Driver experiment would have limited sensitivity to CP violation, but further upgrades to the beam line and detector would provide a signi cantly improved sensitivity which is again favorable when compared to Case 2.

The fourth case, shown in Fig.9, is where there is a both a Ferm ilab Proton D river and an upgraded T 2K program. If in the initial program the uxes are increased, but detectors are not upgraded, then there is some in provement in sensitivity over C ase 3, particularly for the mass hierarchy at large $\sin^2 2_{13}$.

In presenting the impact of a Ferm ilab Proton D river on the global neutrino program we have featured an o -axis narrow band beam experiment, NO A.R ecently a group from Brookhaven has proposed an alternative approach which exploits an on-axis broad band beam with a long baseline (L = 2540 km corresponding to BNL to the Hom estake m ine) [71]. To understand whether this approach could also be in plem ented at Ferm ilab calculations have been made [72] for a baseline of 1290 km, corresponding to FNAL to the Hom estake mine. The resulting precision in the $(\sin^2 2_{13};)$ plane is found to be comparable to or better than the L = 2540 km case. Whether the broadband beam concept is better or worse than the o -axis concept depends critically on the assumed background levels for the broadband experiment. A third alternative has been proposed in which a broad energy range is covered by a set of narrow band beam s going to the same detector, the tighter energy spread signi cantly reducing backgrounds. One of these neutrino beam s would be produced using the 8 G eV linac beam, and would require the highest practical primary beam power (2 m egawatts). Whichever is ultimately preferred, the Ferm ilab Proton D river would be able to accommode any of these alternatives.

In sum m ary, although we do not know the value of $_{13}$ or at what point in time its value will be known, we do know that the Ferm ilab Proton Driver will o er choices that will enable it to provide a critical contribution to the global program. In all the cases considered, without a Ferm ilab Proton Driver the sensitivity to the neutrino m ass hierarchy will be very limited.

3 Neutrino Scattering

W hile neutrino oscillation experim ents probe the physics of neutrino m asses and m ixing, neutrino scattering experim ents probe the interactions of neutrinos with ordinary m atter, and enable a search for exotic neutrino properties. A complete know ledge of the role of neutrinos in the Universe in which we live requires a detailed know ledge of neutrino m asses, m ixing, and interactions.

O ur present know ledge of the neutrino and anti-neutrino scattering cross sections in matter is limited. The next generation of approved neutrino scattering experiments, including M INER A [73] in the NuM I beam line and M in BooNE [21] using neutrinos from the Ferm ilab Booster, are expected to greatly in prove our know ledge. In particular, within the next few years we anticipate that precise measurements will be made of neutrino scattering on nuclear targets. However, we will still lack precise measurements of:

Anti-Neutrino scattering on nuclear targets.

Neutrino and anti-neutrino scattering on nucleon (hydrogen and deuterium) targets.

Neutrino-electron scattering.

The anti-neutrino rates per primary proton on target are, depending on energy, a factor of 3-5 less than the neutrino rates. The interaction rates on nucleon targets are an order of magnitude less than the corresponding rates on nuclear targets, and the cross-section for neutrino-electron scattering is considerably smaller than that on nucleons. Hence, beyond the presently approved program, a factor of 10-100 increase in data rates will be required to complete the neutrino and anti-neutrino scattering measurem ents.

C om pleting the program of neutrino and anti-neutrino scattering measurements is in portant for two reasons that will be expanded upon in the following sections.

- 1. Neutrino scattering experim ents can improve our know ledge of the fundam ental properties of neutrinos.
- 2. Neutrino and antineutrino scattering provide a unique tool for probing the structure of m atter and obtaining a m ore com plete understanding of the nucleon in general, and its avor and spin content in particular.

The neutrino scattering program is of interest to a broad community of particle physicists, nuclear physicists, and nuclear-astrophysicists.

3.1 Fundam ental N eutrino P roperties

N eutrino scattering experiments serve to further our understanding of fundamental neutrino properties. M easurements of neutrino-nucleus cross-sections are needed to constrain the systematic uncertainties of neutrino oscillation experiments. M easurements of neutrino-electron scattering, a process with a robust theoretical cross-section, can probe non-standard neutrino properties and couplings.

3.1.1 Cross-Section M easurem ents for O scillation Experiments

To measure neutrino oscillation probabilities it is necessary to know the composition, intensity, divergence, and energy spectrum of the initial beam, and also know all the relevant neutrino and anti-neutrino cross-sections. A well designed \near detector" setup enables the initial beam to be well characterized, and provides cross-section m easurem ents with adequate precision for the oscillation program. In practice it has proved necessary to have m ore than one type of near detector. The K 2K Experiment used both a near detector that replicated the far detector, and additional near detector tors optimized to learn m ore about the underlying cross-sections. The M INOS near detector replicates the far detector [73] has been designed to learn m ore about the underlying and nuclear e ects.

Neutrino scattering experiments will play a key role in allowing future precision oscillation experiments to reach their ultimate sensitivity. To obtain the most precise value of m $^2_{32}$ (which is eventually required to extract mixing angles and the CP-violating phase) we must better understand and quantify the nuclear processes interposed between the interaction of an incoming neutrino and measurement of outgoing particles in the detector. Extracting mixing parameters such as $_{13}$, and ultimately the neutrino mass hierarchy and CP phase, also requires much better understanding of the neutral current resonant and coherent cross-sections that contribute to the background. The precision measurement of nuclear elects and exclusive cross-sections will provide the necessary foundation for the study of neutrino oscillation with high-luminosity beams at the Fermilab Proton Driver. The unprecedented statistical power will otherwise be compromised by systematic uncertainties from poorly known cross-sections.

The same careful study of cross-sections and nuclear e ects must be performed with anti-neutrinos to understand matter e ects and CP violation. To approach the same statistical accuracy with anti-neutrinos as with neutrinos, and thus have the same impact on oscillation measurement systematics many more protons on target are needed. This is due to a factor of 1.5 - 2.0 in the number of $^+$ to produced and an additional factor of 2.0 to 3.0 in the cross-section ratio. The M INER A proposal assumes about 9 10^{20} POT in a 3 ton ducial volume for neutrino studies. This implies that for those measurements that are statistics limited, one would need (30 50) 10^{20} POT for an anti-neutrino scattering experiment to approach similar statistical accuracy. The combination of a Fermilab Proton Driver and somewhat larger ducial volume would make this a feasible experiment.

3.1.2 Neutrino-Electron Scattering

The SM predictions for neutrino-electron elastic scattering have little theoretical uncertainty, and a measurement of e! e scattering can therefore be used to search for physics beyond the SM. Since it is now known that neutrinos have non-zero mass, a neutrino magnetic moment becomes a possibility. W ithin the SM, modied to include nite neutrino masses, neutrinos may acquire a magnetic moment via radiative




Figure 10: Dierential cross section versus electron recoil kinetic energy, T, for e! events. The electrow eak contribution is linear in T (bottom m ost line), while contributions from nonzero neutrino m agnetic m om ents yield sharp rises at low T. The m agnetic m om ent is given in units of the Bohr m agneton $_{\rm B}$.

corrections. With m = 1 eV, the resulting magnetic moment would be $3 \ 10^{19}$ _B where $_{B} = e=2m_{e}$ is the Bohr magneton. This value is too small to be detected. Hence, a search for a neutrino magnetic moment is a search for physics beyond the SM.

The current best limit on the muon neutrino magnetic moment is 6.8×10^{10} _B from LSND e elastic scattering [74]. This sensitivity may be substantially improved by precisely measuring the elastic scattering rate as a function of electron recoil energy. An electrom agnetic contribution to the cross section from the magnetic moment will show up as an increase in event rate at low electron recoil energies (see Fig. 10). A high statistics measurement, made possible by the Fermilab Proton Driver, would enable a gain in precision of 10–30 over the LSND measurement. This sensitivity is su cient to begin to test some beyond-the-Standard-M odel predictions (which can be as large as 10¹¹ _B). The lower neutrino energy means that a beam created by 8 G eV protons (rather than 120 G eV) would be preferred.

3.2 Fundam ental Properties of M atter

N eutrinos and anti-neutrinos have only weak interactions making them unique probes of the properties of matter at both the nucleon and nuclear level. W ith the high statistics available from the Ferm ilab Proton Driver a variety of high precision measurements become possible.

Parton D istribution Functions

The study of the partonic structure of the nucleon, using the neutrino's weak probe, will complement the on-going study of this subject with electrom agnetic probes at Jlab. The unique ability of the neutrino to \taste" only particular avors of quarks enhances any study of parton distribution functions. W ith the high statistics and carefully controlled beam systematics from the Fermilab Proton Driver, it should be possible to isolate the contribution of individual quark avors to the scattering process.




Figure 11: The d=u ratio showing the uncertainty due to nuclear e ects in the deuteron. Figure taken from R ef. [75].

O ur know ledge of the parton distributions is still very incom plete. Even the valence PDFs are not well known at large x. The ratio of d=u is norm ally determ ined by comparing scattering from the proton and neutron. Since no free neutron target exists, the deuteron is used as a neutron target. This makes little di erence at sm all x, but uncertainties in the nuclear corrections become substantial for x larger than about 0.6, and make determ ination of the ratio essentially in possible for x larger than about 0.8, as shown in Fig. 11. The ratio of d=u can be determ ined without any nuclear structure e ect corrections by using neutrino and anti-neutrino scattering on hydrogen. Only a MW -scale Proton D river can produce anti-neutrino uxes su ciently intense for this measurem ent to be made.

Generalized Parton Distribution Functions

O ne of the most exciting developments in the theory of the structure of the nucleon has been the introduction of generalized parton distributions (GPD s) [76{80]. The usualPDFs are sensitive only to the longitudinalmomentum distributions of the parton. The GPD s give a more complete picture of the nucleon in which the spatial distribution can be determined as a function of the longitudinalmomentum distribution. However, the GPDs are discult to access experimentally as they require

m easurement of exclusive nalstates. The most promising reaction to date is deeply virtual C ompton scattering (DVCS), i.e. $p(e;e^{0} p)$. These measurements are either underway or planned at JLab. However, a complete determination of the GPDs requires avor separation which can only be accomplished using neutrinos and antineutrinos. A lthough M INER A will measure GPDs on carbon, nuclear e ects will ensure that this will be considerably inferior to a measurement on the proton. A true GPD measurement would require p(; n) and n(; p) reactions using hydrogen and deuteron targets. Estimates for this \weak DVCS" process are currently being made by A.Psaker [81]. The CC cross section at 2 G eV is of order 10⁴¹ cm² and the NC about 10 times smaller. These small cross sections will clearly require the higher intensity neutrino beam s that the Ferm ilab Proton D river could deliver.

Strange Q uarks and the Spin Structure of the N ucleon

The NC elastic scattering of neutrinos and anti-neutrinos on nucleons (N ! Ν, N! N) provides information about the spin structure of the nucleon. In particular, these scattering processes are sensitive to the isoscalar spin structure that results from strange quark contributions. Determ ination of the strange quark contribution to the nucleon s has been a major component of the JLab program [82], but such measurem ents are strongly in uenced by theoretical assumptions. A precise m easurem ent of NC elastic scattering would provide a direct m easurem ent of s that is insensitive to theoretical assumptions [83]. The ideal measurement would be of the (p! p)/(n! p) cross-section ratio on a deuterium target. The ultimate goal in this program requires measuring NC elastic scattering with both neutrinos and anti-neutrinos, with a large event sample, on nucleon targets, which will require a megawatt-scale proton source to produce a narrow band neutrino beam of su ciently high intensity. Note also that this measurement should be done using the low er energy neutrino beam from 8 G eV protons (rather than 120 G eV). These low er energies m inim ize the background of neutrino induced neutrons from the surrounding environm ent as well as feed down backgrounds from other neutrino interactions.

E lastic Form Factors

The distributions of charge and m agnetism within the nucleus can be param eterized using two elastic form factors: the electric form factor G_E and the m agnetic form factor G_M . For m any years it was assumed that both the charge and m agnetic distributions fall exponentially. However, precision m easurements at JLab [84,85] have shown that this is not the case, with the charge appearing to have a broader spatial distribution than that of m agnetism. A lthough the reason for this is not understood, it does appear to be an indication of angular m on entum between the quarks. To understand this m ore deeply it is desirable to precisely m easure the weak form factor. This can be done through parity violation in electron-nucleon scattering, with limited precision. In neutrino-nucleon elastic (or quasi-elastic) scattering nearly half the cross section is due to the weak form factor, m aking it a m uch better probe. Proposed m easurements of the weak form factor (e.g. the M INER A experiment)

use scattering from nucleons in nuclei. A lthough the statistical precision will be reasonably good, there is an uncertainty in both extracting the form factor from scattering from a bound nucleon due to nalstate interactions and other conventional e ects, as well as the possibility of modi cation of the form factor by the nuclear m edium. Thus, m easurem ent of the form factor using neutrino scattering on hydrogen and deuterium is essential. This will require the intensity available at a m egawatt-scale Proton D river.

D uality and R esonance P roduction

Although QCD appears to provide a good description of the strong interaction, we have a very poor understanding of the transition from the domain where quarks and gluons are the appropriate degrees of freedom to the domain best described using baryons and m exons. In the region of m odest Q^2 (1-10 G eV 2) the scattering of electrons on nucleons is dom inated by resonance production, and can also be described using the same form alism as DIS. Experiments at JLab [86] have, quite unexpectedly, found that the F_2 structure function measured in the resonance region closely follows that m easured in the D IS region. The phenom enon, called quark-hadron duality, has also been observed in other processes, such as e^+e^- annihilation into hadrons. The origins of duality are not well understood [87{94]. It is expected to exist for neutrino scattering, though it m ay m an ifest itself quite di erently. O f particular interest would be a measurem ent of the ratio of neutron to proton neutrino structure functions at large x. The next decade of experiments should provide some information on the validity of duality using neutrinos. However, high precision m easurem ents using antineutrinos and nucleon (hydrogen and deuterium) targets will be required in order to fully explore the origins of duality and hence the high uxes of the Ferm ilab Proton Driver will be needed.

Strange Particle Production

M easurements of the production of strange mesons and hyperons in neutrino NC and CC processes (e.g. $n ! K^{+ 0}$ and $p ! K^{+ 0}$) provide input to test the theoreticalm odels of neutral current neutrino induced strangeness production [95,96]. In addition, such strangeness production is a signi cant background in searches for proton decay based on the SUSY -inspired proton decay mode $p ! K^{+}$. The existing experimental data on these channels consists of only a handful of events from bubble chamber experiments. There are plans to measure these reactions using the existing K 2K data and the future M INER A data. M INER A will collect a large sample (10;000) of fully constrained $n ! K^{+ 0}$ events. However, the anti-neutrino measurements will require a more intense (megawatt-scale) proton source.

4 The Broader Proton Driver Physics Program

In the past, high precision measurem ents at low energies have complem ented the experim ental program at the energy frontier. These low energy experiments not only probe m ass scales that are often beyond the reach of colliders, but also provide com plem entary inform ation at mass scales within reach of the energy frontier experim ents. Examples of low energy experiments that have played an important role in this way 2) m easurem ents, searches for m uon and kaon decays beyond those are muon (g predicted by the SM, and measurements of rare kaon processes. A summary of the sensitivity achieved by a selection of these experiments is given in Fig. 12. It seems likely that these types of experiment will continue to have a critical role as the energy frontier moves into the LHC era. In particular, if the LHC discovers new physics beyond the SM , the measurement of quantum corrections that manifest them selves in low energy experiments would be expected to help elucidate the nature of the new physics. If no new physics is discovered at the LHC then precision low energy experin ents m ay provide the only practical way of advancing the energy frontier beyond the LHC in the foreseeable future.

4.1 M uon Physics

Solar-, atm ospheric-, and reactor-neutrino experim ents have established Lepton F lavor Violation (LFV) in the neutrino sector, which suggests the existence of LFV processes at high mass scales. Depending on its nature, this new physics might also produce observable e ects in rare muon processes. Furthermore, CP violation in the charged lepton sector, revealed for example by the observation of a nite muon Electric Dipole M om ent (EDM), might be part of a broader baryogenesis via leptogenesis picture. Hence, the neutrino oscillation discovery enhances the motivation for a continuing program of precision muon experiments. In addition, the expectation that there is new physics at the TeV scale also motivates a new round of precision m uon experiments. LFV m uon decays and the m uon anom alous m agnetic m om ent a = (q 2)=2 and EDM are sensitive probes of new dynamics at the TeV scale. In general, with su cient sensitivity, these experiments would help elucidate the nature of new physics observed at the LHC. As an example, in SUSY models the muon (g 2) and EDM are sensitive to the diagonal elements of the slepton mixing matrix, while LFV decays are sensitive to the o -diagonal elements. If SUSY is observed at the LHC we will probably have some know ledge of the slepton mass scale. Precision m uon experiments would provide one of the cleanest measurements of tan and of the new CP violating phases. It is possible that no new physics will be observed at the LHC. In this case precision m uon experiments might provide, for the foreseable future, one of the few practical ways to probe physics at higher mass scales. Note that the Brookhaven (q 2) Collaboration have reported a value for (q 2) that is 2.7 standard deviations away from the SM prediction. Noting that the muon (q 2)is sensitive to any new heavy particles that couple to the muon, it is possible that the current m easurem ents are providing an early indication of the existence of new TeV-scale particles. Higher precision m easurem ents are well m otivated.

In the following, after describing the muon source at the Fermilab Proton Driver, the expected sensitivity of muon EDM, (g 2), and LFV decay experiments is discussed. Table 4 summarizes the expected in provements in sensitivity.

4.1.1 The M uon Source

Low energy high precision muon experiments require high intensity beams. Since most of the 8 G eV Fermilab Proton D river beam from the SC linac would not be used to 11




Figure 13: Schem atic of the solenoid-based m uon source discussed in the text. The perform ance of this channel has been simulated using the MARS code.

the M I, it would be available to drive a high intensity m uon source. In addition to high intensity, precision m uon experiments also require an appropriate bunch structure, which varies with experiment. In the post-collider period it might be possible to utilize the Recycler R ing to repackage the 8 GeV proton beam, yielding a bunch structure optimized for each experiment. The combination of Proton D river plus Recycler R ing would provide the front-end for a unique m uon source with intensity and exibility that exceed any existing facility.

The Recycler is an 8 G eV storage ring in the M I tunnel that can run at the sam e time as the M I. The beam from the Ferm ilab Proton D river SC linac that is not used to llthe M I could be used to llthe Recycler R ing approximately ten times per second. The ring would then be emptied gradually in the 100 m s intervals between linac pulses.

The ring would then be emptied gradually in the 100 m s intervals between linac pulses. Extraction could be continuous or in bursts. For example, the Recycler Ring could be loaded with one linac pulse of 15 10^{14} protons every 100 m s, with one m issing pulse every 1.5 seconds for the 120 G eV M I program. This provides $1.4 10^{22}$ protons at 8 G eV per operational year (10^7 seconds). In the Recycler each pulse of $1.5 10^{14}$ protons cons of 0.25 10^{12} protons/bunch with a pulse width of 3 ns. A fast kicker allows for the extraction of one bunch at a time. The beam structure m ade possible by the Proton D river linac and the Recycler Ring is perfect for ! e conversion experiments, muon EDM searches and other muon experiments where a pulsed beam is required. Slow extraction from the Recycler Ring for ! e and ! 3e searches is also possible.




Figure 14: Beam requirements for new muon experiments. Shown are the expected sensitivity goals at the time of the Ferm ilab Proton Driver, the number of muons needed to achieve that sensitivity, the muon suppression between pulses, the length and separation of pulses and the momentum spread of the muon beam.

The performance of the strawman muon source shown in Fig. 13 has been sim – ulated using the MARS code. The evolution of the pion and muon uxes down the decay channel is shown in Table 5. The scheme will yield 0.2 muons of each sign per incident 8 G eV proton. W ith 1:4 10^{22} protons at 8 G eV per operational year (corresponding to 2 m egawatts) this would yield $3 10^{21} \text{ m}$ uons per year. This muon ux greatly exceeds the ux required to make progress in a broad range ofm uon experiments (see Fig. 14). However, the muons at the end of the decay channel have low energy, a large momentum spread, and occupy a large transverse phase space. W ithout further manipulation their utilization will be very ine cient. The interface between the decay channel and each candidate experiment has yet to be designed. In Japan a Phase Rotated Intense Slow M uon Source (PR ISM) based on an FFAG ring that reduces the muon energy spread (phase rotates) is being designed. This phase rotation ring has a very large transverse acceptance (800 mm m rad) and a momentum acceptance of 30% centered at 500 M eV/c. PR ISM reduces the momentum spread to 68 M eV/c and 1 2% respectively. Hence, a

PR ISM -like ring downstream of the decay channelm ight accept a signi cant fraction of the muon spectrum and provide a relatively e cient way to use the available muon ux. Explicit design work must be done to verify this, but it should be noted that a muon selection system that utilizes only 1% of the muons available at the end of the decay channel will still produce an adequate muon ux for most of the cutting-edge experiments described in the following sections.

Finally, a new 8 GeV multi-MW Proton Driver at Ferm ilab, together with an appropriate target, pion capture system, decay channel, and phase rotation system could provide the rst step toward a Neutrino Factory based on a muon storage ring. The additional system s needed for a neutrino factory are a cooling channel (to produce a cold muon beam occupying a phase space that ts within the acceptance of an accelerator) an acceleration system (which perhaps would use the Proton Driver SC linac), and a storage ring with long straight sections.

4.1.2 Electric Dipole M om ent

Electric D ipole M om ents violate both parity (P) and time reversal (T) invariance. If CPT conservation is assumed, a nite EDM provides unambiguous evidence for CP violation. In the SM EDMs are generated only at the multi-loop level, and are predicted to be many orders of magnitude below the sensitivity of foreseeable experiments. Observation of a nitem uon EDM (d) would therefore provide evidence for new CP violating physics beyond the SM.CP violation is an essential ingredient

of alm ost all attempts to explain the matter-antimatter asymmetry of the Universe. However, the measured CP violation in the quark sector is known to be insu cient to explain the observed matter-antimatter asymmetry. Searches for new sources of CP violation are therefore wellmotivated.

A number of extensions to the SM predict new sources of CP violation. Supersymmetric models in which nite neutrino masses and large neutrino mixing arise from the seesaw mechanism provide one example. In these models d can be signi cant. There are examples in which the interactions responsible for the masses of right-handed Majorana neutrinos produce values of d as large as 5 10^{23} e-cm. This is well below the present limit d < 3:7 10^{19} e-cm, but would be within reach of a new dedicated experiment at a high intensity muon source. The muon EDM group has proposed an experiment and a new beam line at JPARC to obtain a sensitivity of 10^{24} e-cm. This sensitivity would still be limited by statistics. Higher muon intensities would help, although the measurement would also be rate limited. To obtain a sensitivity of $0 (10^{26})$ e-cm would require an improved beam structure with many short pulses, each separated by at least 500 s. Hence, depending on the fate of the JPARC proposal, a muon EDM experiment at a Fermilab Proton D river would be designed to obtain a sensitivity som ewhere in the 10^{24} - 10^{26} e-cm range.

4.1.3 M uon (g 2)

The Brookhaven (g 2) Collaboration has reported a value that is 2.7 standard deviations from the SM prediction. This could be an early indication of new physics at the electroweak symmetry breaking scale. Physics that would a ect the value of (g 2) include m uon substructure, anom alous gauge couplings, leptoquarks, and SUSY. For example, in a m inim al supersymmetric m odel with degenerate sparticle m asses the contribution to a = (g 2)/2 could be substantial, particularly for large tan . W ith degenerate SUSY masses, the estimated range of masses that correspond to the observed a are 100 - 450 G eV for tan = 4 40. Hence the present (g 2) experiment is probing the mass range of interest for electroweak symmetry breaking. W ith further data taking the BNL experiment m ight be able to improve sensitivity

by a factor of a few. To make progress beyond this will require either an upgraded storage ring or a new ring, and a higher intensity muon source at, for example, the Ferm ilab Proton D river.

The current m easurement of a is accurate to 0.46 (stat) 0.27 (sys) ppm. A proposed upgrade to the current program could increase the overall precision from 0.5 ppm to 0.2 ppm. A new experiment at the Ferm ilab Proton Driverm ight in prove this precision by an order of magnitude, which would be accomplished by reducing the systematic error by a factor of seven and increasing the statistical sample by a factor of 200. To fully exploit this in provement in experimental precision a corresponding improvement in the precision of the theoretical prediction will be required, which will need a very high precision measurement of hadronic production in e⁺ e collisions from threshold to 2:5 GeV.

4.1.4 Rare Muon Decays

If a negative muon is stopped in a target it will be captured by an atom and then cascade down to the 1s atom ic level. In the SM the muon will either decay in orbit or will be captured by the nucleus with the emission of a neutrino. In LFV models beyond the SM the muon can also be converted into an electron in the eld of the nucleus (! e conversion) or can undergo non-SM decays (! e , ! eee, ...). If the SM is extended to include the seesaw mechanism with right-handed neutrinos in the mass range 10^{12} to 10^{15} G eV, the predicted LFV decay branching ratios are unobservably sm all. However in SUSY seesaw models, the resulting LFV decay branching ratios can be signi cant. The predicted branching ratios depend upon the origin of SUSY breaking. Muon LFV decay searches therefore place constraints on SUSY breaking schemes.

Consider rst ! e. The present limit on the decay branching ratio is 1:2 10 11 . Within the context of SUSY models, this limit already constrains the viable region of parameter space. The MEG experiment at PSI is expected to reach a branching ratio sensitivity of 10¹⁴ by the end of the decade. The MEG measurem ent will provide constraints on SUSY parameter space com plem entary to those obtained by the LHC experiments. If MEG observes ! e then both a higher statistics experiment and new searches for other non-SM decay modes will be well motivated. If MEG only obtains a limit, further progress will also require a more sensitive experiment. In either case, a ! e experiment at a new Fermilab Proton Driver would provide a way forward provided a high sensitivity experiment can be designed to exploit higher stopped muon rates. Progress will depend upon in provem ents in technology to yield in proved background rejection and higher rate capability. To illustrate the possible gains in the ! e sensitivity consider an experiment that uses pixel detectors to track both the decay positron and the electron-positron pair from the converted photon. It has been shown that if BTeV pixel technology is used in an idealized geometry with 10% of the coverage of the old MEGA experiment, then a sensitivity comparable to the expected MEG sensitivity might be obtained at a beam line of the sort proposed by the BNL MECO experiment. The main limitation in using BTeV pixel technology would come from scattering in the fairly thick detectors. We can anticipate the developm ent of much thinner pixel detectors. If the pixel thickness can be reduced by a factor of 10, coverage increased to 50% of the MEGA coverage, and the readout rate im proved by a factor of 20, then the resulting single event sensitivity would be improved by about two orders of magnitude.

Now consider ! e conversion. W ithin the context of som e SUSY extensions to the SM, the ! e conversion rate is related to the ! e branching ratio:

where Z is the proton number for the target nucleus, Z_{eff} is the elective charge, and F (q²) is the nuclear form factor. The ! e conversion rate normalized to the muon capture rate in T i is then given by:

The prediction is model dependent, and hence searches for both ! e and ! e conversion are well motivated. The apparent suppression of the ! e conversion rate with respect to the ! e decay rate is in practice compensated by the higher sensitivity achievable for the conversion experiments. The PR ME experiment has been proposed at JPARC to improve the sensitivity to 0 (10¹⁹). Proton econom ics may well determ ine the fate of PR ME. If PR ME is not able to proceed at JPARC it might be accommodated at the Fermilab Proton Driver.

4.2 Other Potential Opportunities

A Ferm ilab Proton D river that would provide high intensity beam sat both M I energies and at 8 G eV would o er trem endous exibility for the future physics program, and would enable a vigorous experimental endeavor that extends into and beyond the next two decades. In addition to supporting experiments that exploit lepton beam s (neutrinos, anti-neutrinos, and m uons), a Ferm ilab Proton D river could support a variety of experiments using secondary hadron beam s. A lthough the possibilities have not all been explored, some speci c illustrative examples using kaon, pion, neutron, and antiproton beam s have been considered.

4.2.1 Kaon Experiments using the MIBeam

M any crucial features of the quark- avor sector, such as the nature of the couplings, can only be probed indirectly using rare decays. Examples from the past include the avor changing neutral current (FCNC) suppression via the G M m echanism and CP violation, both discovered with K-decays. O fparticular in portance are the ultra-rare FCNC m odes K⁺ ! ⁺ and K_L ! ⁰ . The SM predictions for these branching ratios are extraordinarily precise, Br(K⁺ ! ⁺) = (8.0 1.1) 10¹¹ [97,98] and Br(K_L ! ⁰) = (3.0 0.6) 10¹¹ [99,100]. These decays probe quark avor physics in s ! d transitions. The K ! m odes are ideally suited for this purpose since they are predicted in the SM with high theoretical accuracy. The intrinsic theoretical uncertainty on BR (K_L ! ⁰) is <1% and it is expected to

reach 6% for BR (K ⁺ ! ⁺), where the charm quark m ass uncertainty dom inates. The variety of conceivable new physics scenarios involving K ! is very large. W ithin m any supersymm etric m odels, enhancem ents of between 3 and 10 times larger than SM expectation are possible [101{103}. In generic m odels of new physics a 10% m easurem ent of Br(K $_{\rm L}$! ⁰) constrains the new physics scale to exceed 1280 TeV [104].

The world sample of K + ! + consists of 3 candidate events observed by the com bined BNL-E787 and BNL-E949 experiments. The experimental central value for the branching ratio is $1.5^{+1.3}_{0.9}$ 10 10 , consistent with the SM expectation. There are currently no observed candidates for K $_{\rm L}$! $^{\rm 0}$. A new generation of experiments has been proposed to observe 50-100 of each of these decay modes within the next 10 years. In the K_L sector, the initiatives are KEK 391a and the follow-up experiment at JPARC (LO I-05). In the K⁺ sector, the initiatives are JPARC-LO I-04, NA 48/3 at CERN, and P940 at Ferm ilab. In the Proton Driver era, assuming the presently proposed experiments meet their 50-100 event goal, a reasonable next goal would be to carry out m easurem ents at the 1000 event level. The near term experiments are already pushing the limit of detector technology and so progress will require in provem ents in detection technique. A ssum ing this is the case the required num ber of protons on target can be estimated by assuming a KAM I-like beam line and detector for the K_{L} ! ⁰ case, and using e ciency numbers from the KAM I proposal. For the K⁺ ! ⁺ case, sim ilar quantities can be extrapolated from the P940 proposal. The required numbers of protons on target are given in Table 6.

Recently two additional decay modes have received attention: $K_L ! ^0 ee [105]$ and $K_L ! ^0$. These decay modes are fully reconstructible, and therefore are signi cantly easier to identify than K ! . There are no large backgrounds that could \feed-down" and fake the signal. The only serious backgrounds are $K_L ! ee$ and which occur with a branching ratio of about 10 7 and can be reduced by kinem atic cuts to obtain an elective residual background level of 10^{10} . A lthough this exceeds the expected signal by an order of magnitude, the background is at over the signal region and with su cient statistics the signal peaks would enable extraction of the branching ratios.

4.2.2 Pion Experiments using the 8 GeV Beam

P ion experim ents can provide precision tests of the SM , and help provide a better understanding of the theory of strong interactions. P ion experim ents at the Ferm ilab

Proton Driver would use the 8 GeV beam and only need a power of 0.5 m egawatts.

Pions are the lightest hadrons. Their decay modes are few and simple, and they therefore provide an exquisite laboratory for testing fundamental symmetries. It is generally agreed that the next important step in pion decay physics is to accurately measure the branching ratio of the decay $^+$! e^+ () ($_{e2}$) and normalize it to $^+$! $^+$ () ($_2$). The double ratio BR ($_{e2}$)/BR ($_2$) is theoretically clean, probes e- universality in weak charged decays, and is predicted [106] in the Standard M odel to have a value of (1:2356 0:0001) 10⁴. Beyond-the-SM scenarios typically preserve lepton universality in weak charged decays, and so it is believed to be a deeply fundamental symmetry. The current world average of the double ratio is (1:230 0:004) 10⁴. In comparison with lepton universality tests in -decays or W -decays, the pion system's experimental precision is 3-10 times better and is unlikely to be surpassed.

In addition, the $_{\rm e2}$ measurement provides the normalization for measurements of the decay $^+$! e^+ e^0 decays (). The uncertainty on the $_{\rm e2}$ measurements dominate the external systematic uncertainties on the measurement. This is of interest because the CKM matrix element $V_{\rm ud}$ can be extracted cleanly from measurements. The current best measurement [107] yields $V_{\rm ud}$ = 0.9728(30). The world average is $V_{\rm ud}$ = 0.9738(5), which is dominated by measurements from superallowed nuclear decays. However, in the future, in proved measurements would allow a theoretically cleaner extraction of $V_{\rm ud}$, and in proved precision provided the statistical and systematic uncertainties can be decreased. Finally, other rare pion decay modes that provide opportunities for searches for new physics are 0 ! 3, 0 ! 4, and 0 !

The PIBETA experiment at PSI is the current state-of-the-art charged pion decay experiment. PIBETA uses stopped pions. Neutral pion decays are studied using the charge-exchange reaction $p! ^{0}n$. It is believed that the decay-at-rest technique is now at its systematic limit. At a Proton Driver, progress could be made by using decay-in-ight techniques.

Lightm eson and baryon spectroscopy probes the con nem ent and symmetry properties of QCD.Beyond the usualmeson and baryon states, QCD predicts exotic bound con gurations of quarks and gluons which include hybrids (e.g. $q\bar{q}g$ and q^3g), pure gluon states (e.g. g^2 and g^3), and multiquark states ($q^2\bar{q}^2$, $q^4\bar{q}$, ...). Only a small fraction of these exotic states have been observed. O bservation of these states, together with measurements of their masses and widths, and determination of their quantum num bers, is needed to compare to the predictions of lattice gauge theory, ux tube models, etc. The spectrum of $q\bar{q}m$ esons is well known below 1.5 G eV. Above 1.5 G eV the low angularmomentum states are poorly known. This is the region where many exotic states are expected. For example, lattice gauge theory calculations predict glue balls with masses from 2-5 G eV.

O ur know ledge of the baryon spectrum is also incom plete. The only reasonably well-known excited light baryon state is the D (1232), whose properties are known to

5%. The properties of a few other excited states, the lowest in each partial wave, are known to 30%. Properties of other 'known' states have much larger uncertainties. Therefore higher precision information is needed and missing states must be sought

in N , K , K scattering experiments.

The nuclear physics community has invested heavily in experimental and theoretical programs aimed at better understanding QCD. The agship DOE nuclear physics program for spectroscopy currently uses the electrom agnetic beam facilities at JLab. However, since the production mechanisms for the various exotic states are not well understood, it is important to use dienent types of beam. Indeed, the electrom agnetic probes available at JLab cannot be analyzed without accounting for the hadronic intermediate states. Hence, pion beam experiments at an upgraded Proton Driver would permit progress in light meson and hadron spectroscopy that would complement the JLab program. The measurements would also provide tests of lattice QCD, and are therefore of interest to the particle physics community. The beam and detector requirements for meson and baryon spectroscopy studies are quite modest. The low energy secondary pion and kaon beams derived from the 8 G eV primary proton beam would be used. A high duty cycle would be desirable, and hence a bunch stretcher would be required.

4.2.3 Neutron Experiments using the 8 GeV Beam

H igh power proton beam s of a few G eV can produce copious num bers of spallation neutrons. A Ferm ilab Proton D river operating at 8 G eV and 2 m egawatts could produce neutron beam s with an intensity that is comparable to those from the m ost intense neutron sources in the world. The Ferm ilab Proton D river could therefore support one or m ore specialized neutron experim ents that, because of their requirements (e.g. pulse structure needs), are either unlikely to be supported at existing or planned neutron spallation facilities, or could be perform ed m uch better at the Ferm ilab Proton D river. Som e exam ples of candidate experim ents that are of particular interest to particle physicists are searches for neutron-antineutron oscillations, searches for a neutron electric dipolem om ent (EDM), and precision m easurements of the neutron lifetim e.

Neutron-antineutron oscillations require baryon num ber violation, with a change in baryon number of two units. Searches for neutron-antineutron oscillations are therefore complementary to searches for nucleon decay, which requires a change in baryon number of one unit. Thus, neutron-antineutron oscillation searches provide a unique test of the fundamental stability of matter. The current limit on a possible transition time between the free neutron and antineutron is 10 years [108]. This sensitivity is essentially statistics limited. Since there are no suitable neutron sources available for a new experiment, at present there are no concrete plans to improve this sensitivity. The Ferm ilab Proton Driver could provide a cold neutron source with an average ux equivalent to that of a 20 m egawatt research reactor, and enable an estimated 2-3 orders of magnitude in provement in sensitivity.

Neutron EDM and lifetime experiments can be pursued using ultra cold neutrons (UCNs) which have su ciently low kinetic energy that they can be conned in material or magnetic bottles. However a beam of UCNs does not exist, and the proposed next generation experiments must therefore produce UCNs in situ from an incident cold neutron beam. Recently a novel suggestion for the production of UCNs using a

spallation target has been undergoing tests at the Los A lam os N eutron Science C enter (LANSCE) and elsewhere. The new UCN source concept uses a small target that is very closely coupled to a solid deuterium UCN converter. This makes it possible to signi cantly increase the density of UCN beyond that obtained using traditional cryogenic moderators, and would therefore be of bene t to the neutron EDM and lifetime experiments which are statistically limited. At the Fermilab Proton Driver one SC linac pulse every few seconds could be used to drive a national UCN facility for neutron EDM and lifetime experiments, and a variety of other scientic program s.

4.2.4 Antiproton Experiments using the MIBeam

The antiproton source at Ferm ilab is a unique facility. A lthough built and primarily used to collect antiprotons for the Tevatron Collider, over the years it has also been used to support a more diverse set of experiments which include putting the world's most stringent limits on the antiproton lifetime, studying charmonium states, and providing the rst unam biguous observation of atom ic antihydrogen. These experiments were performed at the Fermilab Antiproton Accumulator, which provides the world's most intense source of antiprotons. In the Proton Driver era, beyond the period of Tevatron Collider operations, there will exist only one, or possibly two, other antiproton sources in the world - one at GSI, and possibly one at CERN. The Ferm ilab antiproton source would continue to be the most intense in the world. Indeed, the Ferm ilab Proton Driver would be expected to enable an increase in the intensity of the present source by about a factor of two. Hence, the Ferm ilab antiproton source would continue to be a unique facility. The possible antiproton experiments that could be pursued in the future have not been exhaustively studied. However two examples have been considered: The continuation of quarkonium formation studies, and a search for CP violation in hyperon decays.

The study of the charm onium and bottom onium systems has been crucial in unraveling the short-distance properties of the strong interaction. A signi cant number of important measurements have been made in studies of antiproton-proton formation of charm onium. Note that a gas-jet target experiment in an antiproton storage ring can (i) achieve an energy spread of 10–100 keV (compared with a few M eV in an e⁺ e experiment) allowing precise measurements of heavy-quarkonium masses and widths, and (ii) study the formation of all non-exotic mesons (only 1 states can be directly formed by e⁺ e annihilation). Know ledge of the charmonium and bottom onium spectra is incomplete. There are states to discover, and their masses and widths can help us better understand the strong interaction. For example, in charmonium the h_c must be con med, the signi cant mass discrepancy between the BELLE and BABAR sightings of the $_{c}^{0}$ resolved, the h_c and $_{c}^{0}$ widthsmeasured, and the other narrow states identi ed and characterized, namely the $_{c2}(1^{1}D_{2})$, $_{2}(1^{3}D_{2})$ [X (3872)?], $1^{3}D_{3}$, $2^{3}P_{2}$, and $1^{1}F_{4}$.


There are only a few particle-antiparticle systems that are experimentally accessible and are sensitive to new sources of CP violation. The hyperon-antihyperon system, which can be made in a gas-jet target experiment at the Fermilab antiproton source, is one example. Seeking a deeper understanding of CP violation is important

if we are to understand baryogenesis. The Standard M odel (SM) predicts a slight CP asym m etry in the decays of hyperons [109{115]. Physics beyond the SM can result in large enhancements in this CP asym m etry. For example, the supersymmetric calculation of H e et al. [116] predicts asymmetries that are up to two orders of m agnitude larger than the SM prediction. A lthough as yet unpublished, the Ferm ilab H yperCP data is expected to yield measurements of and decays with su cient sensitivity to observe CP violation in hyperon decays if it is an order of magnitude larger than the SM prediction. Provided systematic uncertainties can be controlled, an experiment at the Ferm ilab antiproton source could in prove this sensitivity by an order of magnitude, and hence be su ciently sensitive to observe CP violation at the level predicted by the SM , and precisely measure any enhancement that m ight be present due to new physics.

5 Compatibilities and Proton Econom ics




Figure 15: Proton Driver bunch structure and the Main Injector cycle.

The proton driver design that is currently favored consists of an 8 GeV H Linac that initially would produce a 0.5 m egawatt beam , and that can eventually be upgraded to produce a 2 m egawatt beam . A small fraction of the 8 GeV beam would be used to ll the M I with the maximum beam that, with some modest improvements, it can accelerate. This would yield a 2 m egawatt beam at M I energies. Hence the upgraded proton source would deliver two beams that can be simultaneously used for experiments: a 2 m egawatt beam at M I energies, and eventually an alm ost 2 m egawatt beam at 8 GeV. To illustrate this the cycle structure is shown in Fig. 15. The M I would receive one pulse from the Linac every 1.5 sec. The cycle time is dominated by the time to ram p up and ram p down the M I energy. The 14 Linac pulses that are available, while the M I is ramping and at at top, would provide beam for an 8 GeV program.

The initial NO A long-baseline program would be expected to be the primary user of the 2 m egawatt M I beam. The high-energy neutrino scattering program also needs this beam, and would be expected to coexist with NO A. The other candidate uses of the M I beam include supporting experiments at an antiproton source, and supporting kaon experiments. The antiproton source could operate in parallel with the M I neutrino program with a modest reduction in the available POT for the NuM I

beam . The kaon program , in contrast to the neutrino program , would require a slow extracted beam . However, with an additional storage ring, it is possible that a kaon program could be run during neutrino running with only a m inor im pact on the POT available for the neutrino program . This could be accomplished by fast extraction of a fraction of the M I bunches and transfer into a stretcher ring. The protons stored in the ring would then be slow ly extracted for the kaon program . A ring in the Tevatron tunnel would be ideal for this purpose.

The candidates for using the 8 GeV beam are a low energy neutrino scattering experiment, a pion program, a muon program, and a neutron program. The neutrino scattering experiment requires short pulses with large gaps between pulses so that beam -unrelated backgrounds can be suppressed. The pion program requires a beam stretcher to produce long pulses and hence m inim ize the instantaneous intensity. Many experiments in the muon program require a CW beam with bunches that are short compared to the muon lifetime with gaps between bunches of several muon lifetim es. Hence all of these program s will require an additional storage ring to manipulate the bunch structure. It is possible that, in the post-collider era, this storage ring could be the Recycler. Noting that each of these 8 GeV sub-program s requires a di erent bunch structure it is natural to consider a scenario in which they run sequentially rather than in parallel. To illustrate this, we can in agine that initially an 8 G eV neutrino scattering experim ent is the prim ary user of the 8 G eV beam, followed by (or possibly interleaved with) one or more pion experiments. In a second phase the facility is upgraded to include a low energy muon source, and one or more low energy muon experiments become the primary user(s). In a third phase, if required, the muon source could be developed to become the front-end of a neutrino factory. This could be a very long-term 20 - 30 year plan.

6 Summary

There is a compelling physics case for a Proton D river at Ferm ilab. This upgrade to the existing accelerator complex ism otivated by the exciting developments in neutrino physics. Independent of the value of the unknown neutrino mixing parameter $_{13}$, a 2 m egawatt M ain Injector proton beam would facilitate, over the coming decades, one or more long-baseline neutrino experiments that would make critical contributions to the global neutrino oscillation program. The NuM I beam is the only neutrino beam in the world with an appropriate energy and a long enough baseline form atter e ects to signi cantly change the elective oscillation program can be exploited to:

Probe smaller values of $_{13}$ than can be probed with reactor-based experiments or with any existing or approved accelerator-based experiment.

If $_{13}$ is not very small, determ ine the neutrino mass hierarchy and greatly enhance the sensitivity of the global neutrino program to CP violation.

If $_{13}$ is very small, establish the most stringent limit on $_{13}$ and prepare the way for a neutrino factory driven by the Proton D river.

The M I neutrino oscillation physics program would be supplemented with a broad program of neutrino scattering measurements that are of interest to particle physicists, nuclear physicists, and nuclear astrophysicists. The neutrino scattering program would utilize both the Proton D river upgraded NuM I beam, and neutrino and antineutrino beams generated using the protons available at 8 G eV. The overall neutrino program motivates the highest practical primary beam intensities at both M I energies and at 8 G eV. In practice thism eans 2 m egawatts at M I energies and 0.5-2 m egawatts at 8 G eV.

A dditional physics program s could also be supported by the Proton D river. In particular, the Proton D river could support (i) a program of low energy experiments that probe the TeV mass scale in a way that is complementary to the LHC experiments, and (ii) a program of low energy experiments that are of interest to the nuclear physics community and that is complementary to the JLab program. The possibilities using the 8 G eV beam include (i) the development of a very intense muon source with a bunch structure optimized for (g-2), muon EDM, and LFV muon decay experiments, (ii) a program of low energy pion experiments, and (iii) some speci c experiments using spallation neutrons. The possibilities using the M I beam include a program of kaon experiments, and some speci c experiments using the antiproton source.

For decades to come, a Ferm ilab Proton Driver would support an exciting world class neutrino program that would address some of the most fundam ental open questions in physics, and could also support a broader program of low energy experiments.
