TITLE IX OPTIONS*

1. SUPPORTIVE MEASURES

Meet with a Civil Rights & Compliance Office (CRCO) staff member, who will explain the processes available to you. You can request supportive measures, which may include a No Contact Order, academic support, counseling, and other services, regardless or whether or not you choose to participate in an investigation.

2. INFORMAL RESOLUTION

You may initiate an informal resolution at any time. This allows you to explore whether your concerns can be resolved without an investigation.

3. FORMAL INVESTIGATION

An investigator will meet separately with you, the person you are accusing of wrongdoing, and any witnesses. The investigator will collect evidence through interviews and documents. All parties have the opportunity to respond to the evidence and present further relevant evidence.

4. HEARING

In certain investigations, a hearing is required to determine whether a policy violation occurred. A hearing officer oversees a live hearing, at which parties can have questions asked of each other and witnesses. If a violation is found, parties may submit statements regarding sanctions, and the hearing officer can recommend sanctions. The university will send a decision letter to parties with findings and sanctions, if applicable.
