JOINT COMMUNIQUE

The Government of the Republic of South Africa and the Government of the Republic of Costa Rica, desirous of promoting relations of friendship and cooperation in conformity with the interest and desire of their two peoples, have decided to establish diplomatic relations between the two countries at Ambassadorial level as from the date of signing of this Joint Communique.

The two Governments have agreed to develop friendly relations and cooperation between the two countries on the basis of the principles enshrined in the Charter of the United Nations, convinced that it will be of mutual benefit for both peoples.

IN WITNESS WHEREOF, the undersigned, being duly authorised thereto, have signed this Joint Communique in the English and Spanish languages, both texts being equally authentic.


