

## PRIVACY NOTICE

### [Events organized by the Agency, which are live, streamed](#)

The European Union Agency for Fundamental Rights (FRA) processes the personal data of a natural person in compliance with Regulation 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

This privacy notice explains FRA's policies and practices regarding its collection and use of your personal data, and sets forth your privacy rights. We recognise that information privacy is an ongoing responsibility, and we will update this notice where necessary.

## PRIVACY NOTICE

### 1. Why do we collect personal data?

We collect personal data in the context of an event or a meeting organisation as well as to inform participants of any follow-up activities after the event.

### 2. What kind of personal data does the Agency collect?

The Agency collects personal data related to identification and contact details like name, surname, email address, phone, mobile or fax number, organisation. In some cases, bank account information may be requested during the registration process in case the Agency decides to reimburse any participants.

Minutes, photos and videos of the events could be collected as well in some cases. In such cases, you will be notified during the registration process.

Some or the entire event may be live streamed on the Internet (Facebook) opened to people following FRA's page. The live stream may also be recorded and a recording of the live stream may be made available after the event on FRA website.

Biography information might be collected from the panellists and shared with participants, and in some instances published on the FRA or event's website – subject to your consent.

### 3. How do we collect your personal data?

The Agency may collect personal data using different methods i.e. through an online form, through emails or paper format, recording devices.

### 4. Who is responsible for the processing your personal data?

The Agency is the legal entity responsible for the processing of your personal data and determines the objective of this processing activity. The Head of Communications & Events Unit is responsible for this processing operation.

Limited data are stored at Facebook for the duration of the livestream.

### 5. Which is the legal basis for this processing operation?

Organising various events is necessary for the functioning of the Agency. Therefore, the processing is lawful under Article 5(a) of the Regulation (EU) No 2018/1725.

In addition, since the participation to the events is not mandatory, the processing of the personal data is also in accordance with Article 5(d) of Regulation (EU) No 2018/1725.

### **6. Who can see your data?**

Your personal data are stored in an electronic database. Access to the database is restricted to authorized staff members who are dealing with the organisation of the event and the files concerned are password protected. In some cases, external contractors have access to this information but their access and purpose of use are governed by specific contractual clauses to ensure adherence to the data protection regulations.

Livestream recording will be available to people following FRA's page, and the video recording might be uploaded on FRA's website.

### **7. Do we share your data with other organisations?**

Personal data is processed by the Agency and livestream recording as well as photos from the event will be accessible via Facebook and FRA's website.

In case that we need to share your data with other third parties, you will be notified to whom your personal data has been shared with.

### **8. Do we intend to transfer your personal data to Third Countries/International Organizations?**

No, however data available on Facebook might be transferred to third countries.

### **9. When we will start the processing operation?**

We will start the processing operation upon your registration for the event.

### **10. How long do we keep your data?**

The Agency will keep your personal data for one year from the date of the event.

### **11. How can you control your data?**

You can access, modify or delete your personal data by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu). More details are provided below.

### 11.1. How valuable is your consent for us?

1. Since the participation in the event is not mandatory, the processing is lawful because “the data subject has unambiguously given his or her consent”. The consent will be collected through the registration form or at the day of the event, in a separate and distinct manner. Moreover, you have the right to withdraw your consent at any time, and we will delete your data or restrict its processing.

Consent for the live streaming will be collected either via e-mail prior to the event or via a registration form at the event. A clearly designated area outside of the video cameras will be provided for any participants who do not consent to appear in the live stream.

### 11.2. Your data protection rights

Under data protection law, you have rights we need to make you aware of. The rights available to you depend on our reason for processing your information. You are not required to pay any charges for exercising your rights.

#### a. Can you access your data?

You have the right to receive confirmation whether or not we process your personal data. Furthermore, you can have access to such data, as well as obtain copies of your data undergoing processing, at any time and free of charge, by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu).

#### b. Can you modify your data?

You have the right to ask us to rectify your data you think is inaccurate or incomplete at any time by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu).

#### c. Can you restrict us from processing your data?

You have the right to block the processing of your personal data at any time by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu) when you contest the accuracy of your personal data or when the Agency no longer needs the data for completing its tasks. You can also block the processing activity when the operation is unlawful, and you oppose to the erasure of the data.

#### d. Can you delete your data?

You have the right to ask us to delete your data at any time by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu) when the processing activity is unlawful.

## PRIVACY NOTICE

### **e. Can you request the transfer of your data to a third party?**

This only applies to information you have given us. You have the right to ask that we transfer the information you gave us from one organisation to another, or give it to you. The right only applies if we are processing information based on your consent or under a contract or in talks about entering into a contract and the processing is automated.

You are not required to pay any charges for exercising your rights. We have (time period) to respond to you.

### **f. Do you have the right to object?**

Yes, you have the right to object at any time by sending an email request to [event@fra.europa.eu](mailto:event@fra.europa.eu) when you have legitimate reasons relating to your particular situation. Moreover, you will be informed before your information is disclosed for the first time to third parties, or before it is used on their behalf, for direct marketing purposes.

The Agency will address your requests within 15 working days from the receipt of the request.

### **g. Do we do automated decision making, including profiling?**

## **12. What security measures are taken to safeguard your personal data?**

The Agency has several security controls in place to protect your personal data from unauthorised access, use or disclosure. We keep your data stored on computer systems with limited access to a specified audience only.

## **13. What can you do in the event of a problem?**

a) The first step is to notify the Agency by sending an email to [event@fra.europa.eu](mailto:event@fra.europa.eu) and ask us to take action.

b) The second step, if you obtain no reply from us or if you are not satisfied with it, contact our data protection officer (DPO) at [dpo@fra.europa.eu](mailto:dpo@fra.europa.eu).

c) At any time you can lodge a complaint with the EDPS at <http://www.edps.europa.eu>, who will examine your request and adopt the necessary measures.
