

SAMSUNG HOME APPLIANCE SUMMER LAUNDRY PAIR OFFER TERMS AND CONDITIONS

Offer description. Purchase a qualifying Samsung Washer and Dryer (see Appendix A for list of eligible products) from a participating retailer (“Qualifying Purchase”) and receive a \$50 Samsung Prepaid Mastercard® (after submitting valid offer claim as described below). All purchases must occur in the same transaction and be on the same receipt. **Offer limited to one (1) claim per household. Offer is not valid on purchases made from Lowe’s, Best Buy, The Home Depot, Costco, Conn’s Home Plus, P.C. Richard & Son, Sam’s Club, Spencer’s TV & Appliance.
