

Based on NITI Ayog's SDG India Index 2020-21 Report




NITI Ayog is the nodal agency of Government of India, coordinating the achievement of Sustainable Development Goals (SDGs) across center and states. NITI Aayog has developed an Indexing framework to assess the progress of the States on SDGs. SDG India Index & Dashboard

2020-21, Partnership in the Decade report has been released by the NITI Aayog on June 2021. In the SDG India Index 2020-21 performance of States on 15 SDGs, 70 SDG Targets consisting of 115 Indicators has been scored and ranked.




Figure 1: India and Punjab Composite Index Score comparison from 2018 to 2021



SDG Baseline report was released by NITI Aayog in 2018. In December 2019, SDG India Index & Dashboard 2019 was released, in which performance of States on 100 Indicators across 54 SDG Targets of 16 SDGs was scored and ranked.

In June 2021, SDG India Index & Dashboard 2020-21 has been released, in which performance of States on 115 Indicators across 70 SDG Targets of 15 SDGs was scored and ranked.


Figure 2: SDG India Index 2020-2021 State Ranking



Punjab is ranked 12th among the States in overall ranking. State of Punjab has scored Composite Index Score of 68 which is 6-point improvement viz-e-viz 2019-20 which was 62. Punjab has elevated from category of Performer in 2018-19

to the category of Front Runner in 2020-21. Though the composite score has shown considerable improvement, but the ranking of State has remained the same at 12.

Figure 3: Punjab SDG-wise index score 2020-21




Highlights - Performance of Punjab on SDGs

- For SDG 11 (Sustainable Cities and Communities) Punjab is ranked 1 among States and for SDG 7 (Affordable & Clean Energy) State is ranked 1 along with 14 other states
- State has shown progress in 7 SDGs i.e. SDG 1
 (No Poverty) ,2 (Zero Hunger) ,3 (Good Health & Wellbeing), 7 (affordable & Clean Energy),10
 (Reduce Inequality),11 (Sustainable Cities and Communities) ,12 (Responsible Consumption and Production)
- States's performance has declined in 7 SDGs i.e. SDG 4 (Quality Education) ,5 (Gender Equality), 6 (Clean Water and Sanitation), 8 (Decent Work and Economic Growth),13 (Climate Action),15 (Life on Land) and 16(Peace and Justice Strong Institution)
- On SDG 9 (Industry, Innovation and Infrastructure) there is no change
