Acknowledgements

This volume is the belated outcome of the Seventh British-Dutch Colloquium of historians of Christianity, held at the University of Kent's Canterbury campus from 10–13 April 2008. The conference, organised under the auspices of the *Commission Internationale d'Histoire et d'Études du Christianisme* (CIEHC) focused on the theme of 'Religious Leadership.' The contents of this volume reflect many aspects of the themes which were addressed at the meeting, examined across a wide geographical and chronological range.

Following the conference, and despite all efforts, editorial management turned out to be almost more challenging than religious leadership itself. For that reason, Jan Wim Buisman (Leiden University) joined the enterprise as an external editor in 2010. However, a combination of high work pressure and academic reorganization projects created further delays and almost killed the projected publication. One consequence was that Theo Clemens handed over his editorial role to Marjet Derks (Radboud University Nijmegen) in January 2012. We are grateful for his involvement in the initial stages. We also thank Robert Swanson (University of Birmingham) for reviewing the essays of those contributors for whom English is not their usual written language.
