A document comprising the recommendations by the consultants on the monitoring and evaluation of the documentation was submitted to the TIR Administrative Committee at its February 2020 session (ECE/TRANS/WP.30/AC.2/2020/8). It included, inter alia, a follow up to the OIOS recommendation emanating from Report 2019/010 on the approval of extrabudgetary contributions identified by the Audit of the TIR Convention. ECE member States did not agree to amend the existing guidance on XB approval process. The secretariat of ECE has taken note of this decision and requests OIOS to close this recommendation without implementation. While ECE secretariat cannot change its framework for approval of XB projects without the consent of its membership, it will include in its updated risk register the requirement that essential review and approval of projects relating to Conventions be performed by the respective governing bodies, to the extent possible. On 13 November 2020 ECE received a letter from the Ethics Office, recommending three actions: (a) Establishment of an independent oversight over funds allocated to ECE for the purpose of eTIR. The secretariat presented this mechanism during the 74th session of the TIR Administrative Committee, in February 2021 (ECE/TRANS/WP.30/AC.2/151, para. 57) and the Committee welcomed the progress (para. 61). This aspect of the recommendation will be closed once AC.2 accepts the oversight role, based on the provisions of Annex 8 of the TIR Convention which deals, inter alia, with composition, functions and rules of procedure of AC.2 on 9 June 2021 (ECE/TRANS/WP.30/AC.2/152). (b) Preparation of a new Memorandum of Understanding with IRU capturing all the recommendations provided by the Ethics office.
