THE FEDERAL GOVERNMENT THIS WEEK LAUNCHED A NEW STRATEGY FOR THAT BUDGET.

INSTEAD OF RELEASING THEIR NEW MEASURES ON THE DAY OF THE BUDGET, THEY PLAN TO SPEND THE NEXT TWO WEEKS ANNOUNCING NEARLY ALL OF IT BEFORE THE DOCUMENT IS EVEN TABLED.

EARLIER THIS MONTH FINANCE MINISTER CHRYSTIA FREELAND SIGNALLED THE BUDGET WOULD FOCUS ON BUILDING A, QUOTE, MIDDLE CLASS LIFE FOR THE NEXT GENERATION AND THAT SAME MESSAGE WAS REITERATED THIS WEEK. >> WE HAVE A PLAN TO BUILD A CANADA THAT WORKS BETTER FOR YOU, WHERE YOU CAN GET AHEAD, WHERE YOUR HARD WORK PAYS OFF, WHERE YOU CAN BUY A HOME, AND WHERE YOU CAN REALIZE THE INCREDIBLE PROMISE OF OUR GREAT COUNTRY AND GET A FAIR CHANCE AT MIDDLE CLASS LIFE.

ANNOUNCEMENTS ARE FOCUSED ON
HOUSING AND MORE SPECIFICALLY ON
RENTERS.

THE LIBERALS ARE PLEDGING TO CREATE A NEW CANADIAN RENTER'S BILL OF RIGHTS TO REQUIRE LANDLORDS TO DISCLOSE THEIR PROPERTY'S RENTAL PRICE HISTORY AND LAUNCH A NEW \$15 MILLION TENANT PROTECTION FUND AS WELL AS AMEND THE CANADIAN MORTGAGE CHARTER TO MAKE YOUR RENT COUNT TOWARDS YOUR CREDIT SCORE. - >> Vassy: I LISTENED VERY CLOSELY TO YOUR GOVERNMENT'S ANSWERS TO THE OPPOSITION AND PREMIERS THIS WEEK ON THE PRICE ON CARBON AND UPCOMING INCREASE TO THAT PRICE.

I HEARD YOU AND YOUR COLLEAGUES SAY CANADIANS ARE GETTING MORE BACK IN THE REBATE, THEREFORE IT ISN'T AN AFFORDABILITY ISSUE. AND ANY POLITICIAN THAT INCIDENT MATES OTHERWISE IS

ESSENTIALLY -- INTIMATES
OTHERWISE IS ESSENTIALLY LYING
TO CANADIANS F IT ISN'T AN
AFFORDABILITY ISSUE, WHY DID YOU
PAUSE THE TAX FOR THREE YEARS ON
HOME HEATING OIL?

>> WELL, IT IS JUST TRUE AND IT IS A FACT TO SAY THAT EIGHT OUT OF TEN CANADIAN FAMILIES GET MORE MONEY BACK, BUT THE ONE EXCEPTION TO THAT WAS ACTUALLY PEOPLE WHO WERE LIVING ON HOME HEATING OIL.

IT IS THREE TO FOUR TIMES AS COSTLY AS NATURAL GAS, DEPENDING ON THE PROVINCE THAT YOU'RE IN, AND IT ESCALATED SIGNIFICANTLY. CERTAINLY MANY OF THE FOLKS THAT LIVE ON HEATING OIL ARE LIVING -- ARE IN THE LOWER INCOME BRACKET.

SO IT WAS REALLY IMPORTANT FROM AN AFFORDABILITY PERSPECTIVE THAT WE ACTUALLY ADDRESS THAT SO WHAT WE ARE DOING OF COURSE THE PAUSE ON -- NOT ELIMINATION, A PAUSE ON THE PRICE ON POLLUTION, IS PROVIDING FREE HEAT PUMPS TO PEOPLE SO THEY CAN SAVE MONEY GOING FORWARD.

>> Vassy: BUT IF THE ISSUE WAS THE READINESS AND SORT OF COST OF AN ALTERNATIVE, WHY NOT JUST PROVIDE THE ALTERNATIVE FOR FREE AND INCREASE THE REBATE? WAS IT JUST ACQUIESCING TO POLITICAL PRESSURE? >> THE REBATE IS PAID TO PEOPLE ACROSS A PROVINCE. AS YOU KNOW WHATEVER IS COLLECTED IN A PROVINCE IS REDISTRIBUTED WITHIN A PROVINCE. BUT IT'S REDISTRIBUTED ON AN AVERAGE BASIS SO THOSE THAT ACTUALLY WERE USING HOME HEATING OIL WERE SIGNIFICANTLY WORSE OFF THAN EVERYONE ELSE. SO THE PAUSE WAS INTENDED TO RELIEVE THAT PRESSURE, BUT THE PROGRAM THAT ACTUALLY PROVIDES THE HEAT PUMP IS INTENDED TO ENSURE THAT PEOPLE CAN ADDRESS THAT ISSUE, ADDRESS CARBON EMISSIONS, REDUCE THEIR ENERGY COSTS.

IT WILL SAVE MANY PEOPLE
THOUSANDS OF DOLLARS A YEAR ONCE
THEY INSTALL A HEAT PUMP.
SO IT WAS REALLY AN
AFFORDABILITY MEASURE TO ADDRESS
A PARTICULAR CASE WHERE THERE
WAS A CHALLENGE BECAUSE PEOPLE
ON AVERAGE WHO HAD HOME HEATING
OIL WERE NOT GETTING AS MUCH
BACK TO COVER THE HOME HEATING
OIL COSTS.

THAT'S NOT TRUE OF NATURAL GAS OR ELECTRICITY.

>> Vassy: THE PEOPLE YOU
REFERENCE MORE FREQUENTLY THIS
WEEK, TO BACK UP THE POINT YOU
MADE, THE 200 ECONOMISTS WHO
SIGNED THAT LETTER, SOME OF
THEM, IN PARTICULAR PROFESSOR
CHRIS REGAN WHO IS INSTRUMENTAL
IN DESIGNING THE CARBON PRICE IN
THE FIRST PLACE, ACTUALLY SAID
THIS ABOUT YOUR DECISION TO DO
SO IN ATLANTIC CANADA OR MORE
LARGELY WITH HOME HEATING OIL.

HE SAID CARBON PRICING WORKS AT LOW COST TO REDUCE GREENHOUSE GAS EMISSIONS PRECISELY BECAUSE IT LETS THE MARKET, NOT POLITICIANS, IDENTIFY LOW COST ACTION.

WHEN THE FEDERAL GOVERNMENT EXEMPTED HOME HEATING OIL LAST FALL IT WEAKENED THAT PRINCIPLE AND IGNITED A POLITICAL FIREARM STORM.

IN ADDITION IT CREATED MARKET UNCERTAINTY BY SETTING EXPECTATION THAT IS FUTURE POLITICAL CHALLENGES MIGHT LEAD TO FURTHER POLICY EROSION. IS HE WRONG?

>> WELL, I KNOW CHRIS WELL, AND CERTAINLY I AGREE WITH THE FIRST PART OF HIS STATEMENT, WHICH IS ALL THE DATA SHOWS AND THE 200 ECONOMISTS CONFIRM IT IS BY FAR THE MOST EFFICIENT LOWEST COST WAY TO REDUCE CARBON EMISSIONS. IF YOU BELIEVE IN THE SCIENCE OF CLIMATE CHANGE AND WANT TO REDUCE.

>> Chris:S LEAST LOSTLY FOR TAX IS A PRICE ON POLLUTION. I DON'T AGREE WITH CHRIS WITH RESPECT TO THE HOME HEATING OIL PAUSE BECAUSE THAT WAS A VERY SIGNIFICANT CASE.

WE CAME OUT OF COVID, THERE WAS HIGH INFLATION, THEN INTEREST RATES WENT UP TO CURB INFLATION. AFFORDABILITY CHALLENGES BECAME VERY ACUTE.

GO BACK TO THE BEGINNING.
AT THE END OF THE DAY, PEOPLE
LIKE MR. POILIEVRE WHO MAKE THE
ARGUMENT THAT THE PRICE ON
POLLUTION CREATES AFFORDABILITY

HOUSE OF COMMONS IS SAYING DON'T LISTEN TO THE EXPERTS. WHO SHOULD PEOPLE BELIEVE? I THINK IT'S PRETTY CLEAR WHO PEOPLE SHOULD BELIEVE. >> Vassy: THE GENESIS OF MY QUESTIONS OF YOU AND THE GOVERNMENT IS NOT WHAT MR. POILIEVRE SAYS; IT'S WHAT THE WOMAN FROM NEW BRUNSWICK SITTING ON THE PLANE NEXT TO ME A FEW DAYS AGO SAID IN HER WORRY ABOUT THE DEGREE TO WHICH THE TAX THAT YOUR GOVERNMENT IS LEVYING SHE SAYS HAS DISPROPORTIONATELY AFFECTED HER. WHEN YOU TALK ABOUT, FOR EXAMPLE, THE LEVEL OF ACUTENESS OF AFFORDABILITY CRISIS, WHAT ABOUT SMALL BUSINESS OWNERS, INDIGENOUS PEOPLE, AND FARMERS, THREE GROUPS OF PEOPLE YOUR GOVERNMENT IDENTIFIED IN 2019 AS BEING DISPROPORTIONATELY IMPACTED?

GET THE MOST NET MONEY BACK.
IN TERMS OF SMALL BUSINESSES,

BACK TO SMALL BUSINESSES,
HOPEFULLY TO INVEST IN ENERGY
EFFICIENCY IMPROVEMENTS.
THERE IS MONEY THAT IS FLOWING
BACK AND WILL FLOW BACK TO
INDIGENOUS COMMUNITIES.

AND THAT IS THE SAME THING IS TRUE FOR THE FARMING COMMUNITY. IN ADDITION WITH RESPECT TO THE FARMING COMMUNITY, ONE OF THE THINGS THAT'S OFTEN NOT DISCUSSED IS AT THE VERY BEGINNING OF THE DESIGN OF THE TAX, A NUMBER OF ON-FARM FUELS WERE ACTUALLY EXCLUDED FROM THE PRICE.

>> Vassy: YOU HAVEN'T MADE NO INVESTMENTS IN THOSE THREE GROUPS BUT THE FIRST NATIONS FROM ONTARIO ARE TAKING YOU TO COURT BECAUSE THEY DO FEEL THAT THEY ARE CONTINUALLY MORE DISPROPORTIONATELY IMPACTED BY THE CARBON TAX AND THAT DOESN'T ANSWER THE QUESTION ABOUT WHERE THE \$2.4 BILLION THAT YOUR GOVERNMENT IS SITTING ON HAS GONE AND IF IT WILL IN FACT FLOW TO THE THREE GROUPS YOU IDENTIFIED AND IF SO, WHEN. >> AS I SAY, THE COMMITMENT HAS ALWAYS BEEN THE MONEY THAT'S COLLECTED WILL FLOW BACK.
