# **A BILL**

To amend the Individuals with Disabilities Education Act to require notification with respect to individualized education program teams, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Think Differently about*  
5 *Education Act of 2023”.*

6 **SEC. 2. NOTIFICATION REQUIREMENT FOR IEP TEAMS.**

7        *Section 614(d)(1)(B) of the Individuals with Disabil-*  
8 *ities Education Act (20 U.S.C. 1414(d)(1)(B)) is amend-*  
9 *ed—*

10            *(1) in clause (iv), by redesignating subclauses (I)*  
11 *through (III) as items (aa) through (cc), respectively*  
12 *(and by conforming the margins accordingly);*

13            *(2) by redesignating clauses (i) through (vii) as*  
14 *subclauses (I) through (VII), respectively (and by con-*  
15 *forming the margins accordingly);*

16            *(3) in the matter preceding subclause (I), as so*  
17 *redesignated, by striking “The term” and inserting*  
18 *the following:*

19                    *“(i) IN GENERAL.—The term”; and*

20            *(4) by adding at the end the following:*

21                    *“(ii) NOTIFICATION REQUIRED.—With-*  
22 *in a reasonable timeframe prior to the first*  
23 *convening of the individualized education*  
24 *program team for a child with a disability*  
25 *for a school year, the local educational*

1                    *agency that serves such child shall notify*  
2                    *the parent of such child that such parent*  
3                    *may, under clause (i)(VI), include other in-*  
4                    *dividuals who have knowledge or special ex-*  
5                    *pertise regarding the child, including re-*  
6                    *lated services personnel as appropriate, as*  
7                    *part of the individualized education pro-*  
8                    *gram team.”.*
