

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see press release dated Mar. 1st, 2016), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 305,911 own shares during the period between 07 February 2022 and 11 February 2022 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 329,675 own shares and consequently this results in a net reduction of 23,764 own shares.
