

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see press release dated Mar. 1st, 2016), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 179.774 own shares during the period between 20 September 2021 and 24 September 2021 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 190.500 own shares and consequently this results in a net reduction of 10.726 own shares.
