

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see <u>press release dated Mar. 1st, 2016</u>), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 350,241 own shares during the period between 28 March 2022 and 01 April 2022 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 202,247 own shares and consequently this results in a net increase of 147,994 own shares.
