### Repurchase of shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 78,270 own shares during the period between 16 October 2023 and 20 October 2023 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 71,001 own shares and consequently this results in a net increase of 7,269 own shares.
