

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see press release dated Mar. 1st, 2016), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 118.000 own shares during the period between 19 August and 23 August 2019 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 54.000 own shares and consequently this results in a net redemption of 64.000 shares.
