Repurchase of shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 23,500 own shares during the period between 09 October 2023 and 13 October 2023 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 74,200 own shares and consequently this results in a net reduction of 50,700 own shares.
