

Repurchase of own shares in the context of the liquidity contract

In the framework of the liquidity contract (see [press release dated Mar. 1st, 2016](#)), Proximus announces today that Kepler-Cheuvreux on behalf of Proximus has bought 47,000 own shares during the period between 18 July 2022 and 22 July 2022 on Euronext Brussels.

During the same period, Kepler-Cheuvreux on behalf of Proximus has sold 45,501 own shares and consequently this results in a net increase of 1.499 own shares.
