Preparatory Process for the Summit of the Future

Excellency,

Dear Colleagues,

We extend our sincere gratitude to all delegations for their committed engagement and ongoing support, as we enter the final stages of our journey towards the Summit of the Future that will take place on 22-23 September 2024. Together, we have achieved significant progress over the past months. It is now critical that we make the most of our limited time to finalize our work on the Pact for the Future.

Enclosed to this letter is the next revised draft (Rev. 2) of the Pact for the Future. This version was prepared based on the feedback we received during the third reading of the Pact for the Future, which concluded with an Ambassadorial-level meeting on 27 June. Building on the mandate received from Member States, we have sought to maintain the structure, tone, and level of ambition of the Pact. Adjustments to the text were made with a view to bridging differences.

To begin our informal consultations on the basis of the Rev. 2 of the Pact for the Future, we cordially invite you to a

Closed Informal Consultation at Ambassadorial-level

on Monday, 29 July and Tuesday, 30 July (if needed)

10 a.m. – 1 p.m. and 3 p.m. – 6 p.m. in the ECOSOC Chamber / CR-11.

Ambassadors are invited to provide initial comments on the Rev. 2 and engage in a focused and substantive negotiation on the Chapeau.

Following the negotiation on the Chapeau, we will proceed with **expert-level consultations on each of the five chapters**. The objective will be the focused fine-tuning of the text to achieve consensus on outstanding contentious issues. The introduction of new issues or actions and digressions into details will not be considered.

We recall that the success of the Summit depends on our ability to maintain a high level of ambition, while keeping the Pact concise and actionable. This requires diligence, flexibility and political resolve from all delegations, in line with our agreed principles and shared goal of achieving consensus on the Pact before the end of the 79th Session.

The **roadmap** outlined below will guide us in the coming weeks, as we strive to put a finalized text under silence by early August.
