Dedicated APN

1. Definitions

- "APN" means the Access Point Name a logical point of entry onto an IP network for mobile devices.
- "Data only SIM" means the SIMs that allows data access only (e.g.no Voice service)
- "Dedicated APN" means the APN that is dedicated and personalized to specific customer with limited access to customer's SIMs only.
- "IPsec" means encrypted tunnel across the public network.
- "Mobile Network" means the mobile network of Vodafone Qatar.
- **"Private IP (Internet Protocol)"** address means an IP addresses for use within a private network or intranet and not for use in a public network such as the Internet.
- "Vodafone" means Vodafone Qatar P.Q.S.C, commercial registration No. 39656, PO Box 27727 Doha Qatar

1. Tariff Terms and Conditions

- 1.1 Vodafone's Business General Terms and Conditions and General Fixed Services Schedule and Mobile Service Schedule of the Master Service Agreement ("**MSA**") shall apply.
- 1.2 Where a product or service which a Customer uses has specific terms and conditions published on Vodafone's website and/or other marketing material, those specific terms and conditions will also apply.
- 1.3 Vodafone may from time to time offer and publish promotions that modify this tariff document, and such modifications will apply for the stipulated time.
- 1.4 The minimum contractual period shall be three (3) months ("**Minimum Subscription**"). Cancellation of the Service prior to that time will result in applicable charges due and payable for the entire three-month Minimum Subscription period.
- 1.5 Vodafone may as per the Article 3.9 of the Retail Tariff instructions (RTI) offer up to 20% discount on the products or services from time to time on a permanent or promotional basis.

2. Service Description

2.1 Dedicated APNs are also known as Private or Corporate APN. These types of APNs are typically set up to terminate their traffic onto a Customer's network. Once a corporate user has established a connection on the Dedicated APN, the mobile device will be able to exchange data with the customer's corporate

network.

- 2.2 A Dedicated APN has a unique ID that identifies the traffic. An APN is assigned to each SIM card that belongs to a specific corporate, thus completely separating the private APN from other public APNs.
- 2.3 Authentication of the SIM card gets access through the APN, ensuring that only the Customer's own subscriptions can be used to send and receive data by that route.

3. APN Plans

3.1 The charges for the Service will comprise some or all of the following components, depending on the Option selected on the Order:

(vi) Out of Shared Data Pool charge

• Customer shall pay 0.85 QAR per each 1 MB for any out of Shared Data Pool charges.

(vii) Shared Data Pool model

- Shared data pool model allow customers to aggregate all the data usage of all users that are provisioned onto the Dedicated APN.
- For Dedicated APN with shared data pool model, customers will purchase a monthly recurring pool of data which will be shared by the subscribers that are provisioned onto the APN.
- Each shared data pool has an unbundle rate and out of bundle rate. The in bundle rate is the data rate that customer is paying when consuming a bundle. The out of bundle rate is the rate that customers charged (per MB) when the customer has consumed the recurring data bundle.
- Any unused portion of the data bundle that is not consumed within a given month can't be transferred to the next month.

4. Roaming

- 4.1 The Customer may only use the Plan outside the State of Qatar:
 - i. upon Vodafone prior written approval
 - ii. to a maximum of thirty (30) calendar days ("Roaming Duration"); and
 - iii. subject to compliance with the rules and regulations in the overseas jurisdiction in which they are being used (including roaming regulations).
- 4.2 Standard roaming charges will apply when the Plan is used outside of the State of Qatar. If Customer exceeds the Roaming Duration, then Vodafone shall have the right to suspend and/or terminate the Plan or any part of it.
