  on our website and/or other marketing material, those specific terms and conditions will also
  apply.
- Vodafone may from time to time offer and publish promotions that modify this tariff document, and such modifications will apply for the stipulated time.
- The minimum contractual period shall be three (3) months ("Minimum Subscription") excluding any free promotional months. Cancellation of the Service prior to that time will result in applicable charges due and payable for the entire remaining months of the three (3) months Minimum Subscription period. Additional cancellation charges are detailed in Section 5, below.
- Vodafone may as per the Article 3.9 of the Retail Tariff instructions ("RTI") offer up to 20% discount on the products or services from time to time on permanent or promotional basis.



### 2. Service Description

2.1 GigaBusiness Service enables customers to access the internet through Vodafone's network. The speed of the service achieved is dependent on the network coverage.

If the customer disconnects before 24 months has been completed the customer is obliged to return the 5G Router to a Vodafone Qatar retail store in a good working condition. A customer failing to return the 5G Router in a good working condition will attract a penalty of QR 75 per month for each of the remaining months of the first 24 months.

- In the event the customer who orders a Wi-Fi Extender device terminates their Service before the expiry of twelve (12) billable months (from the day the Wi-Fi Extender is made available to the customer), the customer will be liable to pay Vodafone Three Hundred (300) QAR per Wi-Fi Extender device. The twelve (12) month period will not include any period of service during which the Services were suspended for any reason, including non-payment.

<sup>\*\*\*</sup>To enable the 5G service the Customer's premises must be in a 5G enabled area. If Customers relocate to non 5G areas or are found not be using the 5G network then Vodafone will downgrade the customers to 4G plans or other appropriate plans based on the Customers usage and requirements. Customer to return their 5G indoor CPE in such case.
